



Meanwhile, Indian community members around the world staged massive protests against the terror attack, demanding justice for the victims. Demonstrations were organized in Canada, Denmark, England, France, Finland, Germany, Spain, and the United States.

Family members of several victims revealed that terrorists had approached them individually and inquired about their religion -- those who identified themselves as Hindu were executed on the spot.

In response to the attack, India imposed a series of stringent measures against Pakistan, including the expulsion of Pakistani military attaches, suspension of the key Indus Waters Treaty, and immediate closure of the Attari land-transit post.

Sketches of three terrorists suspected of being involved in the Pahalgam attack have been released.

The suspects have been identified as Hashim Musa alias Suleman and Ali Bhai alias Talha Bhai, both residents of Pakistan, and Adil Hussain Thoker, a native of Anantnag district. IANS

In his speech, he said, "We have gathered here today in deep sorrow and solemn reflection as we pay tribute to the innocent lives lost in the recent terror attack in the Union territory of Jammu and Kashmir in India. ANI

## Khalistan sympathizer Jagmeet Singh quits as NDP leader after defeat in Canada election

OTTAWA: Once a kingmaker in Canadian politics, Jagmeet Singh announced he is quitting as the leader of the National Democratic Party (NDP) after he lost his own election to parliament and his party suffered a rout.

A Khalistan sympathizer at heart, Singh influenced

former Prime Minister Justin Trudeau, who depended on him to keep his minority government in power, against India.

Now, he has been personally defeated, and his party faces irrelevance.

From the 24 seats the NDP had in the last House of Commons, it was down to an expected seven seats this time, having won four and leading in three.

"I'm disappointed that we could not win more seats, but I'm not disappointed in our movement," Singh told his supporters.

He said that he would give up the party's leadership as soon as a new leader is elected.

He came in third in the Burnaby Central constituency in British Columbia, trailing the Liberal Party winner and the Conservative Party candidate.

A lawyer by profession, he became the leader of the NDP in 2017 and was elected to parliament in 2019.

He extended his party's support to Trudeau, whose

#### Pak minister holds emergency press meet at 2 am, says India's military action within 24 to 36 hours

ISLAMABAD: Amid looming fears of strong action from India in the wake of the Pahalgam terror attack, Pakistan Federal Minister for Information and Broadcasting Attaullah Tarar held an emergency press meet at 2 a.m. Wednesday (30th April), saying that there were 'intelligence reports of military action against their country within the next 24 to 36 hours'.

Addressing an emergency press conference, Tarar said credible intelligence-based information has warned of an Indian military action.

"We have credible intelligence-based information that India is planning a military offensive against Pakistan within the next 24 to 36 hours. Any action by India will be responded to with full force," he said.

"Pakistan will defend its territory at all costs and will respond with its full might. The nation will defend its sovereignty and territorial integrity by all means necessary. If India tries to impose a war on Pakistan, it will be solely responsible for the disastrous and devastating costs," he added.

Tarar also called on the international community to take note of India's "planned aggression" against Pakistan, stating that even though Islamabad offered cooperation in a neutral and credible investigation, New Delhi has not provided any proof of Islamabad's involvement in the Pahalgam attack. *IANS*  Liberal Party lacked a majority, without joining the government.

But last year, he announced his party was pulling its support for Trudeau, who quit this year, unable to face a vote of confidence without the NDP.

> At the beginning of the year, the NDP had 17.4 percent support in the aggregation of polls by the Canadian Broadcasting Corporation.

However, the NDP suffered collateral damage in US President Donald Trump's tariff war on Canada and threats to annex it.

As Canadians rallied to the beleaguered Liberal Party as the country's best defense, NDP's support halved to 8.1 percent on the eve of the election.

Last year, Singh called on Trudeau to impose sanctions on India.

He accused India of being behind the attacks on Khalistanis and demanded action against Indian diplomats.

Trudeau obliged him by expelling six Indian diplomats. Additionally, after Khalistanis attacked worshippers at

a Hindu temple in Brampton, Ontario, Singh turned on India, saying, "What we need to see is an end to the violence; we need to see a firm stance against the Indian government." *IANS* 

#### Pakistan cancels all flights to PoK amid escalating tensions with India

ISLAMABAD: Pakistan announced cancellation of all domestic flights to Gilgit and Skardu amid escalating tensions with India after last week's Pahalgam attack in which 26 innocent civilians lost their lives.

"The decision to suspend the flights to the northern regions was made after a review of national airspace safety protocols. All other flights to the northern areas of Pakistan have also been temporarily halted as a precautionary measure," said an official.

A strict monitoring of foreign flights has also been initiated with major focus on international airlines crossing over from India. As per details, the Pakistan Civil Aviation Authority (CAA) has been instructed to scrutinize all inbound foreign aircrafts.

After the high-level meeting of the Pakistan's National Security Committee (NSC), it was decided to give a reciprocal response to India's decisions to shut down the Wagah-Attari border, declare defense and security advisors at Pakistan High Commission as Persona Non Grata, cancelling visas for Pakistani nationals under SAARC, and putting the IWT in abeyance, etc.

Pakistan has already shut down its airspace for Indian airlines in response to New Delhi's measures, including the suspension of the Indus Waters Treaty (IWT), following the terror attack in Kashmir. In this regard, a Notice for Airmen (NOTAMN) was issued, banning Indian carriers from the Pakistan skies, initially for one month. *IANS* 

#### "Only way to solve Kashmir problem is for India to go and take PoK": Indian-origin UK politician

NEW DELHI: Lord Meghnad Desai, a British politician of Indian origin and member of the House of Lords, has called for India to take over Pakistan-occupied Kashmir (PoK) to resolve the longstanding Kashmir issue.

Desai made the statement in response to the April 22 Pahalgam terror attack, which killed 26 tourists.

In conversation with ANI, Desai emphasised that taking over PoK is the only way to solve the Kashmir problem.

"I think the only way to solve the Kashmir problem now is for India to go and take it [Pakistan-occupied Kashmir] over. We have the accession letter of the king. So it belongs to us," he said.

He urged the Indian government to take a stern response to the attack and make it clear that India will take over PoK if such incidents continue.

"I think the Pahalgam incident was very shocking. One of the most shocking incidents there has been. This is, in fact, the ultimate limit in the Kashmir dispute. I hope the Government of India really takes a very stern response to it and makes it quite clear that if this goes on, India will have to take over Pakistanoccupied Kashmir," he said.

Desai expressed hope that Prime Minister Narendra Modi intends to solve the Kashmir problem once and for all.

"I'm hoping that that's what the Prime Minister was telling us all, that he intends to solve the problem once and for all," he said.

Meanwhile, the United Kashmir People's National Party (UKPNP) held a virtual conference to vehemently denounce the terrorist attack on tourists and civilians in Pahalgam, Jammu and Kashmir, on April 22, 2025, labeling it as a "crime against humanity," which resulted in the tragic loss of at least 26 innocent lives and left many others injured.

The participants of the conference extended their heartfelt condolences to the bereaved families and conveyed their wishes for a speedy and full recovery to those injured in the brutal attack.

In Jammu and Kashmir, intense counter-terrorism operations are underway at multiple locations across Jammu and Kashmir in the wake of the Pahalgam terror attack, sources familiar with the matter told ANI. *ANI*

# Indian-origin US Congressman introduces articles of impeachment against President Donald Trump

WASHINGTON DC: Congressman Shri Thanedar has introduced articles of impeachment against President Donald Trump, citing a sweeping abuse of power and flagrant violations of the US Constitution.

According to Thanedar, Trump's actions are not only unconstitutional but also pose a clear and present danger to American democracy.

"Donald Trump has already done real damage to our democracy. But defying a unanimous 9-0 Supreme Court ruling? That has to be the final straw. It's time we impeached Donald J. Trump," he said.

He said that El Salvador's national, Kilmer Garcia, was wrongfully deported.

"The court said the wrongfully deported Kilmer Garcia must be allowed to return and receive due process. Trump ignored it. He ignored the Constitution. He ignored the very checks and balances that keep our democracy intact. This isn't an isolated incident. It's part of a dangerous, deliberate pattern," he said.

Citing these reasons, he said he intro-

duced a resolution to impeach Trump, outlining seven articles of impeachment.

"Article 1, obstruction of justice and abuse of executive power. From denying due process to unlawful deportations, Trump defied court orders. Article 2, taking away Congress's power of the purse. damaging tariffs and threatened military invasions of our allies," he said.

Thanedar said that Trump cracked down on the free speech of journalists and created an unlawful office of the Department of Government Efficiency under Tesla CEO Elon Musk.

According to Thanedar, Trump's actions are not only unconstitutional but also pose a clear and present danger to American democracy. "Donald Trump has already done real damage to our democracy. But defying a unanimous 9-0 Supreme Court ruling? That has to be the final straw. It's time we impeached Donald J. Trump," he said

Trump dismantled agencies and froze funds without permission from Congress," he said.

He further accused Trump of international aggression.

"Article 3, abuse of trade powers and international aggression. He imposed

"Article 4, violation of First Amendment rights. He has retaliated against journalists, attorneys, and critics for exercising their right to free speech. Article 5, creation of an unlawful office, establishing the socalled Department of Government Efficiency, DOGE, and giving Elon Musk unconstitutional power over our government and personal data," he said. Thanedar accused Trump of engaging in bribery and trespassing on the judiciary.

"Article 6, bribery and corruption. He has dismissed criminal cases, solicited payments from foreign governments, and coerced legal settlements for personal and political gain. Article 7, tyrannical overreach. Finally, and most importantly, he is attempting to consolidate unchecked power and erode the constitutional limits of the presidency. In this country, we have presidents, not kings. That's not just misconduct, it's impeachable misconduct. This isn't leadership, it's tyranny," he said.

Thanedar said that if these issues go unchecked, it would mean that the President is above the Constitution. He then urged all lawmakers to back him in the decision.

"If we let this stand, we are saying the president is above the law, that the United States Constitution is optional. I won't be silent, and I'm calling on all my colleagues, Democrats, Republicans, and independents, to stand up with me. Enough is enough. Donald J. Trump must be impeached," he said. *ANI* 

#### Indian students at Harvard protest Pakistani delegates' visit, urge US to revoke their visas

WASHINGTON, DC: Protesting the upcoming visit of Pakistani delegates to the campus, Indian students at the Harvard Kennedy School have written to US Secretary of State Marco Rubio requesting him to revoke the visas of Pakistani officials in the aftermath of the recent "faithbased massacre" in Jammu and Kashmir's Pahalgam where Pakistansponsored terrorists killed 26 people. sacre," Indian students Surabhi Tomar and Abhishek Chaudhari wrote the letter on behalf of concerned students at Harvard University to Rubio.

"Even more troubling is the response from Pakistani state officials. While the Pakistani Foreign Ministry issued perfunctory condolences, other leaders have simultaneously issued veiled threats toward India and reaffirmed their support for



#### US crematoriums urged to become Hindu-friendly

CHICAGO: As Hindu population is growing in the USA, Hindus are urging crematoriums nationwide to become Hindufriendly; ensuring dignity and adherence to religious customs, prioritizing the soul's liberation and spiritual progress towards moksh (liberation).

Rajan Zed, an activist , in a statement in Nevada said that crematorium companies should become more flexible in respectfully accommodating and honoring deeply held traditional antyeshti rituals and rites; including facilities for ceremonial washing of the body, coffin handling, facilitating shipping ashes to India, etc.

Crematoriums should offer live-streaming services for families-friends abroad and proviguidance/services for the legal and respectful scattering of ashes in local water-bodies.

Zed, President of Universal Society of Hinduism, suggested crematoriums send their staff for training in Hindu funeral rites and customs and respectful communication with the families about their specific needs.

Zed suggested crematoriums to allow placing of rice-balls (pind) near the deceased and burning of incense. Crematoriums should carry Om symbol, Trishul (trident) and lotus imagery to be displayed/used during the cremation ceremony.

# Hundreds of Indians mainly Hindu Americans held a peaceful protest in Fremont

FREMONT, CA: In a heartfelt show of solidarity and sorrow, Indian Americans held peaceful demonstrations in Fremont on April 26 to express outrage over the brutal Pahalgam terrorist attack, which killed several Hindu tourists. Participants chanted slogans for strict action against the perpetrators, and urged stronger action to prevent future atrocities. Over 400 plus Hindu Americans gathered in Fremont to honor 28 lives lost in Kashmir from Islamic terrorist attack backed by Pakistan. Jewish Americans joined the protest and stood in solidarity with Hindu brothers. This event was organized by various local Hindu organizations that came on a common platform to condemn the heinous terrorist act.

Members of the Indian and Jewish community expressed deep anguish over the tragic events that once again stained the beautiful Kashmir Valley.



They condemned the brutal killing of innocent Hindu tourists by terrorists and emphasized that violence can never achieve any legitimate goals.

The majority of the participants wore Black, and held placards reading "Stop Killing Innocents", "Indian Americans Against Terror", "Justice for Kashmir Victims", and "Hindu Lives Matter". Speakers at the event called for stronger measures to prevent targeted attacks against Hindus. The protestors waved the Indian tricolor and held banners that read 'Declare Pakistan a Terrorist State - Pahalgam Hindu massacre'. The gathering not only highlighted the global Indian community's concern for homeland security but also sent a strong message of unity and resilience against terrorism.

Terrorists opened fire in Jammu and Kashmir's Pahalgam on Tuesday, killing 28 people, mostly Hindu tourists, in the deadliest attack in the Valley since the Pulwama strike in Gate Bridge, San Francisco, Shri Bhagavad Gita Park in Ontario, Canada; Denny Park in Seattle; Pioneer Boulevard in Artesia, California; the University of Texas in Dallas; and in Atlanta,



2019. The Resistance Front (TRF), a proxy of the banned Pakistan-based Lashkar-e-Taiba (LeT), claimed responsibility for the attack.

Similar vigils were organized across North America, including at City Hall, San Jose, Golden Georgia.

FBI Director Kash Patel said in a post on X that the agency sends its condolences to all the victims of the recent terrorist attack in Kashmir - and will continue offering our full support to the Indian Government.

# Eye Foundation of America organizes fundraising gala in New Rochelle, New York

NEW YORK: "Every child deserves to see the world with clarity and purpose. Let's join hands to eradicate childhood blindness and unlock a brighter future for generations to come," said Dr. Vadrevu K. Raju, a world-renowned ophthalmologist, philanthropist, and the founder of the Eye Foundation of America (EFA) m during a Spring Fundraiser Gala in New Rochelle, New York on April 12, 2025.

"I was born in a rural village in India, poor and legally blind, with no opportunity to exist," Sam Maddula, Pharm.D., a distinguished leader, visionary entrepreneur, and dedicated philanthropist, said. Sam went on to add, how his life turned from darkness to light as his parents stumbled upon an Eye Camp that the Eye Foundation of America had set up in 1987 in rural Andhra Pradesh. "It is this organization that rescued me from a life of darkness. The Eye Foundation of America helped me



get a visa to the United States. Dr VK Raju himself, performed dual corneal transplant surgery on me two weeks after my second birthday in the United States. He did it, working with the Eye Foundation for free. He cured me just like that, with the magic of his hands. I could see my life went from literal darkness to pure sunlight."

Sam shared his life story virtually with the audience during the Gala. This life-changing miracle is one of the mil-

lions of Eye Surgeries that The Eye Foundation of America, led by the legendary Dr. VK Raiu has done in the past half a century, transforming the lives of millions of children, who are born every year with vision impairment.



# Targeting of Hindu Americans delegates by the radically progressive: The SB 509 Quagmire

ecently, Governor Newsom called his party 'toxic' and out of touch" in a refreshing and informative podcast (LA Times, March 30th, 2025). I appreciate what Newsom is trying to do. His aim is to rebrand the left. "Because our party's getting our ass kicked. Because the Democratic Party brand is 'toxic' and 'out of touch'. Because people don't think we make any damn sense. They think we make noise. They don't think we have their values. You fill in the generic them. They think we're elite. We talk down to people and we talk past people. They think we just think we're smarter than other people, that we're so judgmental and full of ourselves," said Governor Newsom.

Despite Newsom's willingness to ask open-ended questions, he omitted something I wish he hadn't. He forgot to mention the: 1) gas lighting of Hindus (2023 SB 403), 2) chiding and shunning of Hindus (2020 Dismantling Global Hindutva Conference), and 3) bashing of Hindus (AB 3027, SB 509) by the extreme left progressives within the Democratic Party.

"Due to our opposition to SB 509, we the elected Hindu delegates in the Democratic Party are facing intimidation in the social media by Hinduphobic elements within the party," said Satish Chandra Vale, an elected Hindu American Delegate in the California Democratic Party and the National Convenor of Americans4Hindus (A4H).

The Hindu delegates cited the detrimental impact of SB 509 on society such as safeguarding our right to free speech, and compromised social harmony. Satish Chandra Vale and the other four Hindu delegates felt helpless & dejected at the leftist progressive Democrats for gas lighting their own Party's delegates. This dissent from the party's mainstream narrative led to the bludgeoning backlash and bullying from certain "anti-Hindu Elements" within the Democratic Party.

Americans4Hindus (A4H), a bipartisan political organization founded by Dr Romesh Japra that engages in political activism and public policy education has strongly opposed California's SB 509 - a transnational repression bill - warning that its vague framing and lack of transparency will lead to the unfair targeting of Hindus and Indian Americans. Currently SB 509 has passed through the Public Safety Committee and the Government Organization Committee. While the California Senate was debating the bill, SB 509, several members of Sikhs for Justice (SFJ), a terrorist organization advocating the creation of Khalistan, lined up outside to show their support for the legislation, according to a report in AsAmNews, a San Francisco-based news portal focusing on Asian American and South Asian Communities. Khalistan leader Pannun threatens attacks on Hindu temples, including Ayodhya. Indian-American Hindus and Sikhs who oppose the bill argued that it risks indoctrinating local police with dual loyalty tropes, thus painting diaspora community members as being "proxies" of foreign governments.

"My uncle was shot to death in 1984 by the same supporters who support the ide-

Samir Kalra, Managing Director, Hindu American Foundation, and a Civil Rights Attorney, vowed to oppose the bill. "SB 509 lacks the adequate guardrails necessary to prevent OES (Office of Emergency Services) training on transnational repression from being politicized," Kalra testified at the Governmental Organization Committee Hearing on April 8th 2025. "This bill would label anyone who criticizes or uses digital technology to track the activities of terrorists or separatist movements as being radicalized by state-sponsored propaganda".

Senator Ann Caballero, Assemblymember Jasmit Bains and Assemblymember Soria have introduced SB 509, which would allocate state funds

# Mexico-US relations: A model for diplomacy

Media conference hosted by American Community Media (ACoM) on April 25th delved into why Schoenbaum was able to successfully maintain a good relationship with the Trump administration and its strategic significance to U.S.-Mexico relations. Mexican President Claudia Sheinbaum adopted a calm and rational attitude and chose to continue negotiations and cooperation with the Trump administration at all levels. This diplomatic strategy of neither confrontation nor compromise allowed Mexico to obtain extensions and exceptions when the United States imposed additional tariffs. Larry Rubin, President of the American Society of Mexico, pointed out that such diplomatic tactics reflect the important strategic interests between Mexico and the United States. He emphasized that despite its tough stance on foreign affairs, Mexico has chosen to prioritize stable bilateral relations, especially cooperation in economics and homeland security. Rubin also said that trade cooperation between Mexico and the United States is crucial to both countries, and emphasized the status of the United States as Mexico's largest trading partner.

Alberto Diaz-Cayeros, former Director of the Center for Latin American Studies at Stanford University, emphasized the importance of trade agreements (such as the United States-Mexico-Canada Agreement, USMCA) in the diplomacy of the two countries. He believes that Trump's trade policy is more motivated by geopolitical considerations than just pursuing trade interests. Diaz-Cayeros pointed out Mexico's pragmatic diplomacy has allowed it to continue to maintain bilateral trade and cooperation without being overly confrontational. He also mentioned that when dealing with US-Mexico trade issues, the Schonbaum administration not only focused on the continuity of economic cooperation, but also responded flexibly to geopolitical relations.

Ask NAPCA

n this column, we will aim to raise awareness about osteoporo sis, highlighting the importance of early screening and timely diagnosis, with a special focus on older women in the Asian American, Native Hawaiian, and Pacific Islander communities.

# Q1. What is osteoporosis? I heard that Asian American women are facing high risk of osteoporosis.

Osteoporosis is a condition that weakens bones, making them more likely to break. It affects about 54 million adults, increasing the risk of fractures, disability, and loss of independence. 1 in 2 women over 50 will experience a fracture in her lifetime. 2 out of 3 women with osteoporosis and a high risk of fracture will break a bone.

Asian American women are at particularly high risk due to naturally lower bone density and dietary factors. Many Asians are lactose intolerant, leading to lower calcium intake as dairy products, a main source of calcium, are often avoided.

Without adequate calcium and vitamin D, bones become weaker, increasing the likelihood of fractures. Despite having one

of the highest rates of osteoporosis, Asian American women are less likely to be screened or treated for the condition compared to other populations.

# Q2. What are the hidden dangers of fractures from osteoporosis?

Osteoporosis is more common than people realize. Many times, breaking a bone is the first sign of the condition, so it is often called a "silent disease". For older Asian American women, who are often caregivers in their families, a fracture can be life changing.

60% of people with osteoporosis never fully regain their independence after a fracture. Many face longer hospital stays, higher surgical risks, and prolonged rehabilitation. Chronic pain and reduced mobil-



ity can lead to isolation, depression, and an increased risk of death. Studies show that 32% of people die within a year of a hip fracture, and 10% die within a year of a spinal fracture.

NAPCA is dedicated to improving the quality of life of older Asian American, Native Hawaiian, and Pacific Islander adults. We urge all older adults, especially women, to prioritize osteoporosis screening and treatment to prevent further bone loss and reduce the risk of fractures.

#### Q3. What should older AANHPI older women do to learn bone health, screenings, and treatment options?

Osteoporosis is a serious condition, but it is often overlooked in the Asian Ameri-

PACIFIC NG Fewer than 20% of patients who suffer os-

teoporosis are properly assessed and treated. According to the National Health



and Nutrition Examination Survey, only 7% of postmenopausal women report taking osteoporosis medication.

Older AANHPI adults, especially women, are strongly encouraged to prioritize bone health by undergoing bone density screening every year and treatments to prevent further bone loss and reduce the risk of fractures. If you or a loved one are at risk, speak with your healthcare provider about bone health, screenings, and treatment options to stay strong and independent for years to come. Prevention and early treatment can make a big difference.

The election was marked as one of the most unpredictable in Canadian history, with Carney, Conservative Leader Pierre Poilievre, NDP Leader Jagmeet Singh, Bloc Quebecois Leader Yves-Francois Blanchet, and Green Party co-Leader Jonathan Pedneault leading their respec-

#### Pakistani cybercriminals hack three websites of Rajasthan Govt

JAIPUR: Pakistani hackers targeted three Rajasthan government websites and defaced them with anti-India messages.

The Pakistani cybercriminals targeted multiple government websites in Rajasthan, with the latest being the Education Department's official portal.

Rajasthan Education Minister Madan Dilawar took cognizance of the incident and activated the Department's Information Technology wing.

The "compromised" website has since been temporarily shut down while recovery operations are underway.

Cybersecurity agencies have also been notified, and an investigation has been launched to identify the hacking group responsible and assess the extent of any potential data breach.

As of now, no sensitive data leaks have been confirmed, but a comprehensive audit of all departmental systems is ongoing as a precautionary measure.

This incident follows a similar cyber attack on Monday (28 Apr.), where hackers breached the websites of the Department of Local Self Government (DLB) and the Jaipur Development Authority (JDA), defacing them with pro-Pakistan propaganda. Both those websites have since been restored. *IANS*  tive parties in a highly competitive race.

The election took place against the backdrop of tariff threats and repeated attacks from US President Donald Trump, who referred to Canada as the "51st state of the United States." According to an IPSOS poll conducted by Global News, the Liberal Party held a four-point lead on 28 April.

> Carney had called an early election after dissolving Parliament, seeking a renewed mandate in what he described as "the most significant crisis of his lifetime," citing Trump's trade actions and threats to Canadian sovereignty.

His background as a former central banker and strong economic credentials, coupled with his rejec-

tion of Trump's annexation rhetoric, earned him the highest approval ratings among federal leaders.

Unlike his predecessor, Trudeau, whose tenure saw strained relations with India following his allegations regarding the killing of NIA-designated terrorist Hardeep Nijjar, Carney has publicly advocated for improving ties with India. He notably extended condolences following the Pahalgam terror attack, signaling a commitment to strengthening India-Canada relations. *ANI* 

#### Panic in Pakistani leadership; Navy vessels on standby, airspace restricted as country expects Indian strike

NEW DELHI: Amid the ongoing standoff between India and Pakistan over the Pahalgam attack in Jammu and Kashmir, the Pakistani military, it seems, has started preparing for Indian military action.

Sources in the country's military establishment said that Pakistani Navy vessels, including its frigates and submarines, have already positioned themselves in their respective harbors in the sea to be able to tackle any possible Indian movement.

Meanwhile, the Pakistan Air Force has reduced flying operations by over 50 per cent, and only essential operations are being conducted to avoid confusion in the airspace, sources said.

Earlier, faced with mounting global pressure, a jittery Pakistan leadership resorted to accusations against India following the deadly Pahalgam incident that killed 26 people.

The Federal Minister for Information & Broadcasting, Attaullah Tarar, had issued a statement claiming that Pakistan has "credible intelligence" suggesting India plans to launch military action against the nation within the next 24-36 hours.

In a post on X, Tarar wrote, "Pakistan has credible intelligence that India intends to carry out military action against Pakistan in the next 24-36 hours on the pretext of baseless and concocted allegations of involvement in the Pahalgam incident." *ANI*

#### New biosensor platform to detect preeclampsia in pregnant women

CHENNAI: A team of Indian researchers has developed a new biosensor platform that can test and diagnose preeclampsia -- is a life-threatening complication caused by hypertension -- among pregnant women in 30 minutes.

Preeclampsia, which typically develops after 20 weeks of pregnancy, affects 2-8 percent of pregnancies worldwide.

While traditional methods to detect preeclampsia are timeconsuming, and require huge infrastructure and trained personnel, the new platform offers rapid, on-site, and affordable screening at an early stage. Timely treatment is crucial to minimize both maternal and neonatal morbidity and mortality rates.

The team led by the Indian Institute of Technology Madras (IIT) Madras, along with the Vellore Institute of Technology developed the Plasmonic Fiber Optic Absorbance Biosensor (P-FAB) technology using fiber optics sensor technology.

They focused on Placental growth factor (PIGF) -- an angiogenic blood biomarker used widely for the diagnosis of preeclampsia. *IANS*

# Even light exercise can help slow cognitive decline in people at risk of Alzheimer's: Study

WASHINGTON DC: Researchers at University of California San Diego and Wake Forest University have found that both low and moderate-high intensity exercise could be valuable tools in the fight against Alzheimer's.

The new research, published as two papers in Alzheimer's and Dementia: The Journal of the Alzheimer's Association, describes the results of the EXERT study (Exercise in Adults with Mild Memory Problems).

It is a multi-site clinical trial of lower or moderate-high intensity exercise in sedentary older adults with amnestic mild cognitive impairment, a major risk factor for Alzheimer's dementia.

The researchers also compared their results to an existing dataset of comparable individuals who only received usual care, such as regular check-ups with health care providers and medication management.

Individuals with amnestic mild cognitive impairment, a condition characterized by memory com-

with this condition progressing to Alzheimer's each year.

"This is a critical time to intervene in this population, because they don't have dementia yet, but



plaints and objective memory decline, are at high risk of developing Alzheimer's dementia, with approximately 16% of people are at a very high risk," said Aladdin Shadyab, Ph.D., M.P.H., lead author of one of the new papers and associate professor at the UC San Diego Herbert Wertheim School of Public Health and Human Longevity Science and School of Medicine.

"Together, these findings show us that even low-intensity exercise may slow cognitive decline in at-risk older adults," added Shadyab.

"EXERT was one of the first large clinical trials of exercise that partnered with the YMCA and its trainers to bring the intervention closer to home for research participants," said Howard Feldman, M.D., ADCS director.

"This approach brings us one step closer to its implementation in the community," added Howard.

EXERT included nearly 300 sedentary older adults with mild cognitive impairment who were randomly assigned to either moderate-high intensity aerobic training or lower-intensity stretching, balance and range of motion activities.

Participants completed their assigned exercise 3-4 times per week for 12 months under the supervision of a YMCA trainer, and the study also included regular assessments of cognitive function and brain volume.

Though the researchers expected to see further cognitive decline in EXERT participants, they found that cognitive function remained stable for both exercise groups over the course of the study.

This suggests that both lower and higher intensity exercise could slow cognitive decline.

Another possible explanation for the results is that participating in research itself, regardless of the treatment, may offer protection against cognitive decline due to the intellectual and social stimulation involved. *ANI* 

# Chemicals in food containers, medical equipment behind spike in heart disease deaths: Lancet

NEW DELHI: Daily exposure to certain chemicals used in plastic items like food containers or medical equipment could be linked to an increase in deaths due to heart disease worldwide, according to a study published in the journal Lancet eBiomedicine recently.

Researchers at New York University Langone Health said that the chemicals, called phthalates, are in widespread use globally.

Phthalates found in cosmetics, detergents, solvents, plastic pipes, and bug repellants have for decades been linked with an increased risk of conditions ranging from obesity and diabetes to fertility issues and cancer. The new study focused on a kind of phthalate called di-2ethylhexyl phthalate (DEHP), which is used to make food con-

response (inflammation) in the heart's arteries, which can potentially lead to heart attack or stroke.

However, the new analysis

Previous studies linked their exposure with an overactive immune

estimated that DEHP exposure contributed to 356,238 deaths, or more than 13 percent of all global mortality from heart disease in 2018 among men and women ages 55 through 64.

"By highlighting the connection between phthalates and a leading cause of death across the world, our findings add to the vast body of evidence that these chemicals present a tremendous danger to human health," said lead author Sara Hyman, an associate research scientist at NYU Grossman School of Medicine.

For the research, the team used health and environmental data from dozens of population surveys to estimate DEHP exposure across 200 countries and territories. The information included urine samples containing chemical breakdown products left by the plastic additive. *IANS*

# New study links ultra-processed foods to preventable premature deaths

NEW DELHI: Do you regularly eat ready-to-eat-or-heat foods? Beware, a recent global study showed that the consumption of such ultra-processed foods (UPFs) can significantly increase the risk of preventable premature deaths.

Previous studies have linked UPFs -- rich in sodium, trans fats, and sugar -- with 32 different diseases including cardiovascular disease,

obesity, diabetes, some types of cancer, and depression.

The new study analyzed data from nationally representative dietary surveys and mortality data from eight countries (Australia, Brazil, Canada, Chile, Colombia, Mexico, United Kingdom, and the US).

The findings published in the American Journal of Preventive Medicine, show that premature deaths attributable

to consumption of UPFs increase significantly according to their share in individuals' total energy intake.

The study reinforces the call for global action to reduce UPF consumption, supported by regulatory and fiscal policies that foster healthier environments.

UPFs are ready-to-eat-or-heat industrial formulations made with ingredients extracted from foods or synthe-

sized in laboratories, with little or no whole foods in their composition.

"UPFs affect health beyond the individual impact of the high content of critical nutrients (sodium, trans fats, and sugar) because of the changes in the foods during industrial processing and the use of artificial ingredients, including colorants, artificial flavors, and sweeteners, emul-

> sifiers, and many other additives and processing aids, so assessing deaths from allcauses associated with UPF consumption allows an overall estimate of the effect of industrial food processing on health," said lead investigator Eduardo AF Nilson, from the University of Sao Paulo in Brazil.

> The team initially estimated a linear association between the dietary share of

UPFs and all-cause mortality so that each 10 percent increase in the participation of UPFs in the diet increases the risk of death from all causes by 3 percent.

Then, using the relative risks and the food consumption data for all countries (ranging from 15 percent of the total energy intake in Colombia to over 50 percent of the calories in the US), they built a model. *IANS* 

#### Israeli researchers discovered stress in pregnancy affects baby's brain before birth

JERUSALEM: Israeli researchers have discovered that stress experienced by mothers during pregnancy affects the fetus's brain.

The discovery led by researchers from the Hebrew University of Jerusalem (HU) could pave the way for new treatments or interventions to support a baby's healthy development after birth, Xinhua news agency reported.

Published in the journal Molecular Psychiatry, the study revealed that maternal stress during pregnancy could "reprogram" key molecular pathways in the fetus, particularly the cholinergic system -- a network of nerve cells responsible for regulating stress responses and inflammation.

The researchers analyzed blood samples from 120 newborns and their mothers collected at birth, focusing on small RNA molecules known as tRNA fragments (tRFs), many of which originate from mitochondrial DNA.

These molecules play a critical role in regulating cellular functions and responses to stress.

"We found that even before babies take their first breath, the stress their mothers experience can shape how their bodies manage stress themselves," said Prof. Hermona Soreq, from the Hebrew University of Jerusalem. *IANS*

#### Gold may touch \$3,300 per ounce in 2025 amid global worries

NEW DELHI: Gold prices could climb to \$3,300 per ounce in 2025, driven by concerns over slowing economic growth in the US, increasing geopolitical tensions, and rising fiscal deficits, a new report said recently.

This has led to renewed interest in gold as a safe investment option, especially as equity markets see corrections, as per a report by Capitalmind Financial Services Private Limited.

The report highlights that gold has proven to be a strong and reliable asset for Indian investors over the long term.

Despite its price volatility in global markets, gold has consistently delivered positive returns in Indian rupee (INR) terms.

In fact, the study points out that gold has never had a negative decade in INR, while it faced two decades of negative returns in US dollar (USD) terms.

Anoop Vijaykumar, Head of Research at Capitalmind, said that gold plays a dual role. It acts as a store of value over the long run while also being a volatile asset prone to short-term ups and downs.

For Indian investors, however, the depreciation of the rupee against the dollar has made gold a relatively safer bet.

"While gold may not generate cash flows or compound like equities, its low correlation with other assets makes it essential for diversification," he added. IANS

# Apple to shift all US iPhone assembly to India by 2026

CUPERTINO: In a strategic move driven by escalating trade tensions between the United States and China, Apple is set to transition all production of iPhones destined for the US market to India.

According to GSM Arena, the shift comes in the wake of ongoing trade policies and tariffs imposed during the administration of former President Donald Trump.

Apple's decision to ramp up its production in India aligns with its broader goal of diversifying manufacturing operations away from China.

With more than 60 million iPhones sold annually in the United States alone, the company is looking to reduce its reliance on Chinese manufacturing and find a more economically viable alternative.



This move is not entirely new for Apple. The company's shift toward manufacturing in India began back in 2017, when it partnered with Wistron, a Taiwanese contract manufacturer, to begin producing iPhone 6s and iPhone SE models at a factory in Bengaluru, India.

The initial motivation was high import taxes on Chinese goods that were imposed by the US government.

#### India, Egypt agree on closer collaboration for skill development

NEW DELHI: India and Egypt have agreed to strengthen strategic collaboration in skill development with the aim of creating a globally competitive, futureready workforce, according to an official statement issued recently.

The decision was taken at a high-level meeting held here between officials of India's Ministry of Skill Development and Entrepreneurship (MSDE) and an Egyptian delegation led by the Deputy Minister of Technical Education, Prof Ayman Bahaa El Din.

"Looking ahead, the two countries identified several promising avenues for future cooperation. These include joint certification programs, faculty and student exchanges, digital skilling and entrepreneurship initiatives, and the establishment of Centres of Excellence in priority sectors like information technology, agriculture, tourism, and green skills," the statement said.

Both delegations expressed a shared commitment to creating a globally competitive, future-ready workforce and to using their partnership as a template for broader South-South cooperation. *IANS* 

As the trade war between the two countries escalated during Trump's presidency, Apple increasingly sought to move more production outside of China.

According to GSM Arena, reports from April 2024 indicate that India now manufactures around 14 percent of all iPhones globally; with analysts predicting this number could rise to 25 percent by the end of the year.

> The company is aiming to double production in India to meet the demand for iPhones in the US, with the goal of manufacturing over 60 million devices annually by 2026.

The shift in production comes amid the imposition of aggressive tariffs on Chinese goods by the Trump administration.

Although Apple CEO Tim Cook at-

tempted to negotiate exemptions from these tariffs, GSM Arena reports that it is unlikely such relief will come to fruition.

In fact, imports from China have been subjected to a 145 percent tariff, a situation that has been challenging for companies like Apple that rely on Chinese manufacturing.

Even before President Trump's second term, Apple was already facing a 20 percent tariff rate on smartphones imported from China.

However, Apple's decision to ramp up production in India is not without its own set of challenges.

The Indian government has imposed a 26 percent tariff on products coming from the US, which was temporarily paused for 90 days to allow for ongoing negotiations between Washington and New Delhi, as per GSM Arena.

These developments come as US Vice President JD Vance is currently in India.

India has emerged as a crucial part of Apple's global manufacturing strategy. As part of its shift to India, Apple aims to expand its production footprint across the country.

The country's Bengaluru factory, which initially began producing iPhone 6s and iPhone SE models, will now be a pivotal site for the production of newer iPhone models aimed at US consumers, as per GSM Arena.

With these changes in production strategies, Apple is facing a period of significant uncertainty.

The company is preparing to report its quarterly earnings next week, and investors and analysts are keeping a close watch on how the trade situation, along with Apple's shifting manufacturing strategy, will affect its bottom line.

As per GSM Arena, in 2024, the United States accounted for approximately 28 percent of Apple's global iPhone shipments, making the US market crucial for the company's financial performance. *ANI* 

#### India-US meeting in Washington makes headway on bilateral trade agreement

NEW DELHI: As part of ongoing discussions on the India-US Bilateral Trade Agreement, representatives of India's Department of Commerce and the Office of the US Trade Representative held fruitful discussions, at a meeting in Washington, from April 23-25, to conclude the first tranche of the Bilateral Trade Agreement by Fall (September-October) of 2025, according to a statement issued by the Ministry of Commerce and Industry recently.

This follows earlier bilateral discussions held in March 2025 in New Delhi.

"During the meetings in Washington, D.C., the team had fruitful discussions on wide-ranging subjects covering tariff and non-tariff matters. The team discussed the pathway for concluding the first tranche of the mutually beneficial, multi-sector Bilateral Trade Agreement by fall of 2025, including through opportunities for early mutual wins," the

While productive sectorial expert-level engagements have taken place through the virtual format, in-person sectorial engagements are planned from

the end of May, the statement said.

The productive discussions are part of bilateral efforts in line with the Leaders' Statement of February 2025 to enhance and expand India-US economic ties and supply chain integration through the Bilateral Trade Agreement, it added.

Prime Minister Narendra Modi, during his visit to Washington in February this year, held talks with US President Donald Trump on negotiating the first tranche of a mutually beneficial, multi-sector Bilateral Trade Agreement by the fall of 2025.

The two leaders resolved to deepen the US-India trade relationship to promote growth that ensures fairness, national security and job creation. To this end, the leaders set a bold new goal for bilateral trade - 'Mission 500' - aiming to more than double total bilateral trade to \$500 billion by 2030.

Meanwhile, US Treasury Secretary Scott Bessent said many top trading partners of the United States had made 'very good' proposals to avert US tariffs, and one of the first deals to be signed would likely be with India.

Bessent told a US television news channel that President Donald Trump will be "intimately involved" in each of the trade deals with each of 15 to 18 important trading partners, but it will be important to reach agreements in principle soon. *IANS*  In Brief

#### UP becomes first State to send back all Pakistani nationals

LUCKNOW: Uttar Pradesh has become the first state in the country where 100 percent of Pakistani citizens have been sent back with Chief Minister Yogi Adityanath himself monitoring the return of Pakistani citizens to their country, Chief Minister's office said in a press release.

This comes as the Indian government has revoked all existing visas issued to Pakistani nationals, except for long-term and diplomatic visas in the wake of the Pahalgam terror attack.

CM Yogi's monitoring had a big impact. CM Yogi held a highlevel meeting and instructed the officials to take immediate action against Pakistani citizens.

On the instructions of the Chief Minister, a police team was sent to ensure the return of Pakistani citizens to their country.

# FBI arrests Wisconsin judge for allegedly obstructing immigration agents

WASHINGTON, DC: The Federal Bureau of Investigation (FBI) arrested a Milwaukee County Circuit judge and charged her in federal court for allegedly helping an undocumented immigrant avoid arrest, CNN reported.

Judge Hannah Dugan is facing two charges for hindering and concealing the person from arrest. She appeared in court initially and was released.

The arrest on federal charges is an escalation in the Trump administration's attention on the conduct of judges, especially as it is connected to immigration enforcement. The Justice Department has repeatedly said that it will carry out an investigation against local officials who do not assist federal authorities on immigration matters.

FBI Director Kash Patel said that the FBI arrested Judge Dugan as they believe that she intentionally misdirected federal agents away from the subject to be arfederal agents away from the subject to be arrested in her courthouse, Eduardo Flores Ruiz, allowing the subject -- an illegal alien -- to evade arrest."

"Thankfully, our agents chased down the perp on foot and he's been in custody since, but the Judge's obstruction created increased danger to the public. We will have more to share soon. Excellent work @FBIMilwaukee," he added.

In charging documents, investigators said that federal agents in plainclothes went to Dugan's courtroom on April 18 to arrest Flores-Ruiz. A Mexican immigrant, Flores-Ruiz had been removed from the United States in 2013. However, immigration officials learned he returned to the US illegally due to his arrest in a local domestic abuse case.

After being informed about the presence of agents by

In a post on X, Patel stated, "Just NOW, the FBI arrested Judge Hannah Dugan out of Milwaukee, Wisconsin, on charges of obstruction -- after evidence of Judge Dugan obstructing an immigration arrest operation last week. We believe Judge Dugan intentionally misdirected her courtroom deputy, the judge "became visibly angry" and said that the situation was 'absurd,' left the bench, and entered chambers," according to court documents.

Witnesses told investigators that Dugan confronted the federal agents in a public hallway, where she

asked them to leave, saying they needed a different kind of warrant to arrest him, CNN reported. Dugan directed the agents to speak with the chief judge of the courthouse.

According to court documents, several witnesses--including Dugan's courtroom deputy, the prosecutor, and the Victim Witness Specialist on Flores-Ruiz's case--allegedly recalled seeing Dugan telling Flores-Ruiz and his lawyer to leave through a "jury door," which leads to a nonpublic area of the courthouse. *ANI* 

# US Embassy files FIR against man and agent for visa fraud using fake documents

NEW DELHI: The US Embassy in New Delhi has filed an FIR against an individual and his agent for allegedly attempting to obtain a US visa using fake documents.

The FIR was filed at the Chanakyapuri Police Station under Sections 318(4)/319(2)/336(3)/340(2)/ 61(2) of the Bharatiya Nyaya Sanhita (BNS), and an investigation is underway.

According to the FIR, a representative of the US Embassy stated that on April 22, 2025, an individual identifying himself as Jatinder Singh applied for a non-immigrant visa at the US Embassy in New Delhi. Jatinder stated that he was born on February 4, 1992, in Talwandi Daddian, Hoshiarpur, Punjab, India, and presented an Indian passport as proof of his identity.

As part of the visa application process, Jatinder submitted the following documents: an employment letter from Panacea Medical Technologies Private Limited issued on April 11, 2025, and signed by the Director of Research and Development; a pay slip for the month of March 2025 issued by Panacea Medical Technologies Private Limited; a letter of invitation from the American Society of Neuroradiology dated March 22, 2025; and a visiting card in the name of Dr Jatinder Singh showing his designation as Neuro Diagnostic Manager. He also declared his marital status as married to Navdeep Kaur.

However, during the stipulated interview with US Embassy officials on April 22, 2025, Jatinder admitted that he was never employed with Panacea Medical Technologies Private Limited and had never worked as a Neuro Diagnostic Manager. He further stated that although documents showed he was married to Navdeep Kaur (DOB July 3, 1993), he was actually "single" and did not know the reference Navdeep Kaur.

Jatinder Singh stated that the fraudulent employment documents, including the visiting card, were provided to him by Rajinder Sharma, located in Jalandhar, Punjab. Singh stated that he would pay INR 15 lacs to Rajinder Sharma after the visa was issued. *ANI* 

#### Gujarat: Over 500 suspected Bangladeshi nationals caught in Vadodara

VADODARA: In a massive statewide crackdown on illegal immigration, Vadodara Police have caught more than 500 suspected Bangladesh nationals, officials said last week.

Speaking with ANI, Vadodara Police Commissioner Narsingh Komar informed us that over 500 suspects have been "intercepted" and that their document verification is underway.

Out of them, five individuals have been confirmed as Bangladeshi nationals, Narsingh Komar added.

"A special drive is being carried out in Vadodara to identify and arrest illegal Bangladeshi nationals. Police have intercepted more than 500 such suspects, and their document verification is underway. Five of them have been confirmed to be Bangladeshi nationals," Narsingh Komar said.

Narsingh Komar added that this verification drive will continue and the legal actions will be taken against confirmed Bangladeshi nationals

On 26 April, over 550 illegal immigrants from Bangladesh were detained in Ahmedabad and Surat for residing in India with forged documents, Gujarat police said.

Deportation proceedings will follow once verification and interrogation are complete, said the official.

The coordinated operations were led by multiple law enforcement units, including the Special Operations Group (SOG), Crime Branch, Anti-Human Trafficking Unit (AHTU), Prevention of Crime Branch (PCB), and local police teams. Officials confirmed that all detained individuals were in India without valid documentation and had used fake papers to establish residence.

In Surat, an overnight combing operation carried out jointly by SOG, DCB, AHTU, PCB, and local police resulted in the detention of more than 100 Bangladeshi nationals. "They had entered India illegally and were living in Surat with forged documents. After the investigation, they will be deported to Bangladesh," said Rajdeep Singh Nakum, Deputy Commissioner of Police, Special Operations Group.

A simultaneous operation was carried out in Ahmedabad around 3 am. Teams from the Crime Branch, SOG, Economic Offences Wing (EOW), Zone 6, and Headquarters detained over 450 individuals suspected to be illegal immigrants. DCP Crime Branch Ajit Rajian confirmed that more than 400 people were taken into custody during the early morning sweep.

Joint Commissioner of Police, Crime Branch, Ahmedabad, Sharad Singhal, stated that these actions were taken in compliance with orders from the Home Minister, the Commissioner of Police, and the Director General of Police.

"HM, CP and DGP had directed us that illegal immigrants must be held. The Crime Branch registered two FIRS from April 2024 till now. 127 illegal Bangladeshis were caught and 77 were deported," he said. *ANI*

# India's secondary real estate market grows to 43% share by FY25: Square Yards

May 2, 2025



NEW DELHI: The secondary real estate market in India has gained considerable traction, with its share increasing from 38 percent in the pre-pandemic period to 43 percent in the Financial Year 2025 (FY25), said a report by real estate consultancy firm Square Yards.

The secondary market refers to the buying and selling of properties that have already been owned or occupied. Observing the outcome of the report, Tanuj Shori, CEO and Founder, Square Yards said, "Interestingly, our data reveals that the growth isn't limited to primary demand alone. This growing preference for ready-to-move-in homes--particularly in well-connected and established locations--has steered more buyers toward the secondary segment."

"The uptick in secondary sales is evident not only in terms

of market share but also in absolute transaction volumes. Looking ahead, we anticipate this dual-track momentum to persist, with sustained demand continuing to drive growth across both the primary and secondary residential markets," the Square Yards Founder and CEO said.

Shori further added that looking ahead we anticipate this dualtrack momentum to persist, with sustained demand continuing to drive growth across both the primary and secondary residential markets, added.

As per Square Yards latest report, "Primary Vs. Secondary: Unpacking Demand Trends in India's Residential Market", the total number of registered residential transactions with Inspector General of Registration (IGR) across key Indian cities increased from 3.07 lakh units in FY 2019 to 5.44 lakh units in FY 2025, marking a 77 percent rise.

The report also highlights that the primary market transactions took the highest share of 57 percent, while the secondary market took the remaining 43 percent in FY 2025. Primary residential transactions refer to the first sale of a property directly from the developer to the buyer, typically involving new or under-construction homes.

The analysis covers seven major cities: Bengaluru, Hyderabad, Mumbai, Navi Mumbai, Noida & Greater Noida, Pune, and Thane. In volume terms, secondary transactions rose from 1.22 lakh units in FY 2019 to 2.33 lakh units in FY 2025.

During the same period, primary market transactions increased from 1.84 lakh units to 3.11 lakh units, the data suggests. *ANI* 



MUMBAI: The demand for homes prices Rs 1 crore and above bolstered the Indian property market in the first quarter this year, preventing overall sales of 65,250 units from hard landing, a recent report said.

Residential sales in Q1 2025 (January-March) experienced only a modest decline and added up to 65,246 units. This limited drop was primarily due to robust demand in the Rs 3-5 crore and Rs 1.5-3.0 crore segments, which helped counterbalance the slowdown in relatively affordable housing, according to a JLL report.

The steady growth in higher ticket size homes indicates increasing affluence among homebuyers, changing lifestyle

preferences and buyers prioritizing larger and premium properties. According to the report, housing sales in India's top seven cities continued to be dominated by Bengaluru, Mumbai, and Pune, which collectively accounted for 66 percent of Q1 sales. High concentration of MNCs and startups creating significant em-

ployment opportunities and ongoing infrastructure improvements make these cities increasingly attractive places to live and work.

It is interesting to note that over the last few quarters a significant share of quarterly sales volume has been contributed by projects launched during the same quarter.

Q1 2025 was no exception, with around one-fourth of its sales being contributed by quarterly new launches. Launches by reputed developers with assurance of timely delivery and steady price

appreciation, are driving the trend, the report informed. IANS

# Green Roof: Why you should have it in an Indian Home?

#### Why Green Roofs Make Sense in Indian Homes

India faces a host of environmental challenges: urban heat islands, water scarcity, air pollution, and the need for thermal comfort without excessive energy usage. A green roof directly addresses many of these issues.

#### 1. Thermal Insulation & Cooling

India's scorching summers can see temperatures rise above 45°C in many regions. Traditional concrete rooftops absorb and radiate heat, raising indoor temperatures significantly. In Delhi, a home with a green roof was found to be 4-6°C cooler indoors compared to a similar structure with a bare concrete roof. Green roofs act as natural insulators, reducing the need for air conditioning and lowering electricity bills.

#### 2. Reduction of Urban Heat Island Effect

Urban areas often become significantly warmer than surrounding rural areas due to the high concentration of buildings and roads that retain heat. This is called the Urban Heat Island Effect (UHIE).

Green roofs can counteract this by reflecting more sunlight, evaporating water through plant transpiration and cooling the air naturally.

#### 3. Rainwater Harvesting and Management

Indian cities often face two extremes-water scarcity and waterlogging. Green roofs help in both areas. How? It absorbs and delays rainwater runoff, reduces pressure on urban drainage systems and allows rainwater harvesting and groundwater recharge. A Bengaluru apartment complex with a rooftop garden was able to harvest over 10,000 liters of rainwater annually through smart drainage integration.

#### 4. Improved Air Quality

Pollution is a major concern in Indian metros. Green roofs filter air pollutants, dust, and harmful gases like NO? and CO?.

Plants absorb carbon dioxide and release oxygen, improving air quality around the house and reducing respiratory issues.

#### 5. Noise Insulation

In crowded cities like Mumbai or Chennai, noise pollution is unavoidable. Green roofs provide a natural sound barrier, especially beneficial for homes located near busy roads or railways. *www.housing.com*


them, and known to be their witness, is the Atman or Self, always like the King.

# India can play a larger role in reducing US-Iran tensions

he first round of talks between the United States and Iran on the latter's nuclear program, held in Oman on April 12, 2025, has from all accounts ended on a positive note.

The US delegation to Oman mediated discussions that lasted 2.5 hours was led by Trump envoy Steve Whitkoff while the Iranian side was led by Foreign Minister Abbas Araghchi. It is tough to miss the fact that the talks held in Oman, were the first since 2018 when President Donald Trump pulled the US out of the Joint Comprehensive Plan of Action (JCPOA, known more familiarly as the 2015 Iran nuclear deal) and were crucial to explore the possibility of getting a new deal.

Not only have both countries described the concluded meeting as "constructive," they have also confirmed that a second round of discussions will take place next

week. Given the decades long and high levels of mistrust and animosity between the US and Iran, especially with the Trump Administration, that the talks have gotten off to a "constructive" start "in a very peaceful and respectful environment" -- in Araghchi's words -- could be seen as promising.

#### India's interests in Iran

For India, which has found itself hamstrung by the vagaries of US-Iran tensions time and again over the decades, news that the two countries have started talks must be welcome news. India's Ministry of External Affairs in New Delhi hasn't yet commented on the talks, understandably, given its early days yet.

From US and other international sanctions hobbling the Chabahar port agreement to India having to "zero out" oil purchases from Iran in 2018 when Trump abandoned the JCPOA, New Delhi has had to play a tough balancing game between the two sides. One recalls that in the early 2000s, India had to keep the US happy given that New Delhi was negotiating the civil nuclear deal with Washington; that required putting the Chabahar port deal on the back burner despite it being a project of immense strategic interest to India. In fact, it was only last year (more than two decades after the two countries first agreed to develop the Iranian port to bypass Pakistan to reach out to Central Asia and Afghanistan) that India and Iran signed a 10-year agreement to develop and operate the Shahid Beheshti terminal of Chabahar port. India had taken over the management of part of the terminal in 2018.

This project is not just a gateway for India to Afghanistan and Central Asia, but potentially to Europe via the INSTC (International North South Transport Corridor). Recently, the Taliban dispensation in Afghanistan evinced interest in the Chabahar Port and it has also been used by India for delivering relief material to Afghanistan.

Add to this, India's ties with Israel (which have been on a remarkable upward trajectory since formal diplomatic rela-

tions were established in 1992) and other Gulf countries and New Delhi has had to ensure its diplomacy has always been nimble and creative to accommodate all countries and their shades of opinion.

This, especially given that India has some 9 million of its people in the Middle East/West Asia region and therefore a major source of foreign remittance besides it being a major source of fuel and foreign direct investment.

Given its huge stakes in the region, can India continue to play the role of a bystander or should it play a more proactive role? If the latter, given India's ambitions to be recognized as a regional power, what kind of a role can it play to ensure that the US and Iran stick to talks to reach a new nuclear pact?

#### Anamalai Wild Life Sanctuary and Tiger Reserve:

The Anamalai Wild Life Sanctuary is approximately 68 km, a 2 hour and 15-minute drive from Pollachi. Located at a distance of 3 km from the Topslip Tiger Reserve, the sanctuary houses a wide variety of trees such as rosewood, teakwood and bamboo. Alongside flora and wild animals, this serene getaway has other elements such as Karianshola Trek, Anaikunthi Shola, Grass hills, Manjampatti Valley, groves, waterfalls, teak forests, reservoirs and dams. However, some of these attractions would require prior permission from the respective authorities.

Anamalai Hills: If trekking is your sport, then Anamalai Hills is the place for you at Pollachi. The climb up the Hills stretching along the Western Ghats is a definite place to visit and witness the magnificence of the West! www.holidify.com

ne more terror attack and once more India is groping for a response. Military action, which the hawks are baying for, will serve the popular purpose of quenching the thirst for revenge but will have little long-term effect. Anger subsides quickly after retaliatory strikes and soon it becomes business as usual. This is what happened after the Uri and Pulwama attacks.

We should ensure that this time we don't fritter away our anger in a few hot-headed blows. There should be cool thinking and calculated action to cause lasting harm to Pakistan. Pakistan has been following the low-cost option of inflicting a thousand cuts one India through brain-washed jehadis. Innocent rade against India. It will appeal to the World Bank and also perhaps the International Court of Justice. The ICJ does not have jurisdiction in the matter but the World Bank does and India will have to be prepared to face the heat. Fortunately, the emasculation of international organizations, rampant transgressions of international law and the misuse of treaties give India a conducive global environment to go ahead and terminate this partisan treaty.

The Indus Waters Treaty was forced on India by the World Bank whose money it needed to build dams for irrigation in Punjab. The treaty gave India all the water of the three 'Eastern Rivers' - Ravi, Beas and Sutlej. The waters of the three 'West-

people in India have been bearing the brunt of the Pakistani military's policy of waging war through terror. It must be paid in its own coin.

The Indian government has downgraded diplomatic relations and cancelled visas. This is symbolic and transitory. More significant is the action on the Indus Waters Treaty, which has been kept in abeyance. But this too is essentially a temporary step. When the treaty gets reactivated, Pakistan will insist on all infrastructure built during this period to be dismantled. The treaty has a robust dispute settlement mechanism and India will have to comply. Abeyance makes sense only if it is a prelude to abrogation.

#### Terminate partisan treaty

Pakistan is already crying foul and will launch a diplomatic tiern Rivers' - Indus, Jhelum and Chenab - were given to Pakistan but India was allowed to use some of this water for irrigation and build run-of-the-river dams for hydroelectricity. Strict provisions were incorporated in the treaty to ensure that the dams did not have any storage. Pakistan was given the right to inspect any construction in India and the World Bank made itself the custodian of the treaty.

The division of the water was grossly unequal in the treaty. The Western rivers carry 80 percent of the water and are the main source of water for Ladakh (Indus), Kashmir (Jhelum) and Jammu (Chenab). Their interests were sacrificed, despite protests by them. Pakistan adopted an obstructionist attitude from the beginning. It challenged every Indian project. India amended the design of the Salal dam on the Chenab to accommodate its objections, but in the process the dam suffered due to siltation.

Later, on Baglihar and Kishanganga projects, India stood firm and Pakistan took them to dispute settlement, where India won both. But Pakistan did not relent and continued to raise disputes on every project. Last year, India proposed a review of the treaty but Pakistan rejected it.

The abrogation of the Indus treaty, on the other hand, can be done in one stroke, followed by a firm refusal to respond to any diplomatic or judicial proceedings launched by Pakistan. This one act will undo an unfair treaty, augment India's water resources and parch Pakistan.

The Indus Waters Treaty is quite unique because no other upper riparian has given this kind of share of its water to the lower riparian. In fact, the international convention on sharing river water has been ratified by only 43 countries, despite its vague provisions. Critically for India, China, which is the upper riparian by virtue of its occupation of Tibet, has not done so.

Abrogating the treaty will enable India to complete stalled projects in Jammu & Kashmir and Ladakh and plan new ones to meet the growing water needs of the region. This will take time but a beginning must be made immediately.

#### Remain strong and silent

It is tempting to draw up a long list of actions for India. The unrest in Balochistan and Khyber-Pakhtunkhwa provinces of Pakistan, for example, need diplomatic support and their controversial accession to Pakistan deserve to be publicized.

The horrific targeted attack by Pakistan based terrorist group on April 22, which killed at least 25 Indian tourists and one Nepalese national and, injured many more, bears all the hallmarks of terrorism promoted by Pakistan from its soil. The timing of the attacks during the high-profile visit of the US vice-president J.D. Vance to India highlights this was calculated to achieve maximum impact.

The attack came at the beginning of peak tourist season; right before the annual Hindu Amarnath Yatra pilgrimage that attracts thousands. It also happened soon after provocative statements from Pakistan's military chief, Asim Munir. In a recent speech, Munir said: "No power in the world can separate Kashmir from Pakistan. Kashmir is Pakistan's jugular vein."

The attack was made by gunmen who identified Hindu men demanding they recite verses from the Qur'an before killing them, while sparing women and children. This is setting off a chain of tit-for-tat moves by India and Pakistan, and raising the spectre of a full-fledged conflict between the nuclear-armed neighbors. The attack in Kashmir's southern district of Anantnag prompted anger across India. It came amid when hundreds of thousands of tourists were holidaying in the region, which has been racked by a three-decade armed rebellion.

Meanwhile, authorities in Kashmir launched a massive crackdown on terrorists and their sympathizers, razing homes of the ultras, raiding their safe havens and detaining hundreds of overground workers for questioning. India immediately took a retaliatory move by suspending the Indus Waters Treaty, which granted Pakistan control over the western rivers of the Indus system (Indus, Chenab, and Jhelum).

What really happens to the waters from these rivers? Can India realistically hold and harness them for its own use? With several dams coming up, when will India be able to turn Pakistan's tap off completely, if it wants to? Experts say, while India now has legal and diplomatic room to build storage and diversion infrastructure on the western rivers, its ability to significantly alter water flows to Pakistan in the short term remains limited due to existing infrastructural constraints and the time required to develop large-scale projects.

Eighty percent of Pakistan's farm fields depend on water from the Indus system. With the current infrastructure, India can at best store a portion of the water from flowing into Pakistan. Several projects have been planned to harness the Indus system. India held the agreement in "abeyance" until Pakistan "abjured crossborder terrorism".

India has taken several steps including cancelling all visas to Pakistani citizens and asked all to leave India immediately. The Pakistan High Commission is asked to reduce diplomatic staff including Defense personnel at the mission. Pakistan also threatened to suspend its participation in all bilateral agreements with India, including the 1972 Simla Agreement, in a retaliatory move after India said it would suspend its own participation in the Indus Water Treaty and close the land border Sunday 27 April).

The Indian government has not ruled out military action against Pakistan, and experts said a strike of some sort was a possibility. Leaders across the world condemned the terror attack and fully support India in this war against terrorism.


