60 million Baloch people 'deeply appreciate' India's unwavering resolve to expose Pakistan: Leading activist

QUETTA: Leading Baloch human rights defender Mir Yar Baloch recently wrote an 'open letter' to the Indian all-party Parliamentary delegations requesting them to include Pakistan's Baloch genocide in their agenda during their global visits aimed at exposing Pakistan's cross border terrorism.

"We, the sixty million Baloch people, deeply appreciate and commend your unwavering resolve, national unity, and collective efforts in exposing Pakistan's cross terrorism and its full scale support to Jihadists and extremists, on the international stage. Your mission, undertaken with determination and solidarity, is a beacon of hope for those who have long suffered under oppression and illegal occupation of Pakistan," read the letter

"Under the capable and visionary leadership of Prime Minister Narendra Modi, India has unified its 1.4 billion citizens into a harmonious and diverse nation. Pakistan, a duplicitous and cunning adversary, has persistently attempted to disrupt the unity between India, Balochistan, and Afghanistan by exploiting religion as a weapon. These attempts have consistently failed,"

"Under the capable and visionary leadership of Prime Minister Narendra Modi, India has unified its 1.4 billion citizens into a harmonious and diverse nation. Pakistan, a duplicitous and cunning adversary, has persistently attempted to disrupt the unity between India, Balochistan, and Afghanistan by exploiting religion as a weapon. These attempts have consistently failed," it added.

Writing "on the behalf of the Baloch community", Mir urged the Indian delegations to use their voices to inform the world about the atrocities committed against the Baloch people by Pakistan, the same enemy that India has faced for the past seven decades and has been ter-

rorizing Balochistan since 1948.

"We want the world to hear our cries; the oppression and brutality have surpassed all limits. Tragically, we are now deprived of the freedom to speak. To share our suffering, we must rely on social media, as our population of sixty million lacks a single national language television channel, a national newspaper, or even a radio station to tell our stories. Meanwhile, Pakistan's Punjab province operates two hundred TV channels, publishes nine hundred newspapers, and runs hundreds of FM and international frequency radio stations, all funded by looting our national wealth," the letter stated.

Appreciating the Indian delegates for exposing Pakistan on the global stage with evidence and reasoning, the

human rights activist called the efforts commendable.

"We believe that more should be done. We wish for your delegations to travel the world, representing India, and we, the Baloch people, want to join you in informing the world about the ongoing oppres-

sion, military operations, and extrajudicial killings in occupied Balochistan," the letter mentioned.

"India and Balochistan have both suffered from the religious extremism of a common enemy for the past seven decades. When our enemy is the same, and our national interests align, we should support each other rather than struggle separately. We are ready to meet with India's foreign delegations and brief them on Pakistan's atrocities in Balochistan so that our contribution can aid in bringing Pakistan to justice for its war crimes on the international stage. Your global reach and influence can significantly amplify our efforts," it further detailed. *IANS*

Elon Musk slams Trump's funding bill, calls it 'disgusting abomination'

WASHINGTON, DC: Tesla Chief Executive Elon Musk has intensified his criticism of US President Donald Trump's legislative agenda, describing a major spending

bill as a "disgusting abomination" in a series of posts on the social media platform X.

The tech billionaire, who recently departed his role overseeing government efficiency reforms, condemned the House-passed legislation, writing: "This massive, outrageous, pork-filled Congressional spending bill is a disgusting abomination. Shame on those who voted for it: you know you did wrong."

Musk followed his initial criticism with additional posts claiming the bill would "massively increase the already gigantic budget deficit to USD 2.5 trillion" and suggesting "Congress is making America bankrupt."

The "One Big Beautiful Bill Act" extends Trump's 2017 tax cuts whilst increasing military and border security spending. However, it also makes reductions to

Medicaid, food assistance programs and other social support schemes.

According to the nonpartisan Congressional Budget

Office, the legislation would add approximately USD 3.8 trillion to the federal government's existing USD 36.2 trillion debt over the next decade.

Senate negotiations on the bill are currently underway, with Trump personally lobbying senators to support his sweeping legislative package.

White House Press Secretary Karoline Leavitt downplayed the significance of Musk's criticism during a re-

cent briefing.

"The president already knows where Elon Musk stood on this bill. It doesn't change the president's opinion. This is one big, beautiful bill, and he's sticking to it," she said.

Musk had initially expressed disappointment with the spending package, citing concerns about budget deficits and its impact on government efficiency efforts. *ANI*

US lawmakers urge Al Safety Institute to counter China's growing Al Threat, citing DeepSeek risks

WASHINGTON DC: Chairman John Moolenaar (R-MI) and Ranking Member Raja Krishnamoorthi (D-IL) of the House Select Committee on the Strategic Competition Between the United States and the Chinese Communist Party (CCP) are calling on the Department of Commerce to enhance the responsibilities of the U.S. AI Safety Institute (AISI) to tackle the growing national security challenges posed by China's advancements in artificial intelligence, as stated in the release from the Select Committee on the Chinese Communist Party (SCCCP).

In a correspondence to Commerce Secretary Howard Lutnick, the legislators stressed that "there is a strong national security need for better understanding, predicting, and preparing for the PRC's Al progress." They pointed out the approaching January 2025 introduction of DeepSeek's large language model, R1, as a significant alert. The Committee's probe into DeepSeek uncovered "multiple national security risks, including the funneling of Americans' private data to the PRC, manipulation of the model's outputs according to PRC law, and the potential theft of U.S. Al technology through model distillation," as noted in the release.

As AI technologies advance further, the lawmakers cautioned, "the need to anticipate and prepare for PRC AI developments and to prevent strategic surprises will only become more pressing," according to Moolenaar and Krishnamoorthi, as cited by the SCCCP's release.

As per the SCCCP statement, the Committee has urged AISI to broaden its goals to address PRC AI growth, emphasizing that "a comprehensive government strategy will be necessary to ensure sustained U.S. leadership in cutting-edge AI innovation." They also pointed out AISI's "distinct technical expertise, robust collaborations with the industry, and experience in testing and evaluation" as important resources in the U.S. initiative to remain ahead of the CCP.

Moolenaar and Krishnamoorthi specified certain domains where AISI could assist in safeguarding U.S. national security, including assessing the national security strengths and weaknesses of leading PRC AI models, comparing and evaluating PRC models against U.S. models to understand the competitive scenario, aiding industry efforts to thwart PRC theft of AI technology, and formulating responses to potential shifts in the U.S.-PRC AI rivalry. The lawmakers concluded the letter by stating: "We look forward to collaborating with the AI Safety Institute to better comprehend its ongoing projects and resource requirements regarding these issues," as mentioned in the SCCCP release. *ANI*

LONDON: UK Conservative Party MP and Shadow Foreign Secretary Priti Patel has reaffirmed the shared commitment to combat terrorism during a meeting with the all-party Indian Parliamentary delegation

The delegation, led by BJP MP Ravi Shankar Prasad, met Patel and discussed mutual commitment to fight terrorism, UK-India defense and security links, enhancement of economic ties and the vibrant Indian diaspora, which serves as the living bridge connecting the two countries.

During the meeting with Patel, the delegation shared India's firm resolve in combating cross-border terrorism, conveying how Operation Sindoor exemplifies the new normal set by India in fighting terrorism.



He shared India's progress on four pillars -- Universal and Meaningful Connectivity, Space and Environmental Sustainability, and Digital Ecosystems -- under the visionary leadership of Prime Minister Narendra Modi at the recent meeting in Brasilia.

BRICS members include 11 nations --Brazil, Russia, India, China, South Egypt, Africa, the United Arab Emirates, Ethiopia, Iran, Indonesia, and Saudi Arabia.

Kids found a 'grandfather' in the Prime Minister, says Usha Vance

WASHINGTON: US Second Lady Usha Vance has said that this was a time of opportunity in the bilateral relationship with India and spoke effusively of her recent visit to India along with her husband, Vice-President J.D. Vance, and their three children for whom, she added, it was a "mindblowing" experience.

The Second Lady, who participated in a rare public interview at an event hosted by the US-India Strategic Partnership Forum recently, spoke feelingly about the bond her three children forged with Prime Minister Narendra Modi as a grandfather figure.

"This is a time of great opportunity. And I think if my husband were here, he'd say the same thing," she said when asked by the interviewer for her personal take on the bilateral relationship.

"Obviously, the US and India, their relationship has ebbed and flowed at times. There are times when one country's needs and one country's goals are different from the other. But right now, I think in the next four years and in the future, the fact that there is this established Indian-American population here and so many people in India who know the country and know the people who are here doing great things, having great opportunities."

She added: "When we were visiting recently, I was just struck by the number of people who came up to me to say how much they loved our country, how they visited family, how they visited just for pleasure, that they were hoping for a close relationship. Looking forward, and I think these personal ties actually really have something to do with it."

The Vances were in India in April for the first vice-presi-

dential visit in 13 years, coming after Vice-President Joe Biden's in 2013, when he was a part of the then President Barack Obama's administration.

The succeeding two Vice-Presidents -- Mike Pence and Kamala Harris, who is also of Indian descent, never got around to make the trip.

"It really was the trip of a lifetime for us, my children had never been to India. What would the pandemic and J.D. century mean to politics and all that, and so they'd grown up just knowing so much about this country, the stories, the food, the relationships with grandparents and friends, but they had never actually seen it. So it was just sort of mindblowing from their perspective. And then for me and J.D., I think it just could not have been any more special," Usha Vance said.

"We had the opportunity to see some of the greatest sights in north India. We're looking forward to our next trip and trying to get to the parts of the country where my family is from as well. And it just was sort of one hit after another, right? The most incredible food, the peacocks that we got to see everywhere we went, getting to see the Taj Mahal in the morning and appreciate it as the sun was just sort of coming up, and the cool skies and blue skies over in the background. And of course, as you mentioned, meeting the Prime Minister was really very special."

The Vances had met the Prime Minister Modi by this time. Their first meeting was in Paris on the sidelines of an Al summit in February.

"They were sort of sleep deprived in Paris, and they saw an Indian man with a white beard and white hair, and they just put him the grandfather category immediately. So they are very into him. They just love him. And he really cemented his status by giving our five-year-old a birthday present that day. So when we were able to visit his home, they just sort of ran up. They were hugging him. He was just incredibly kind and generous to them." *IANS*

Misinformation circulating, lot of work to be done in Washington: Shashi Tharoor

BRASILIA: Congress MP Shashi Tharoor, who is currently leading the all-party Indian parliamentary delegation in Brazil, has said that the upcoming visit to the United States will be a crucial opportunity to counter misinformation and competing narratives surrounding Operation Sindoor

His remarks come amid ongoing assertions by US President Donald Trump that his administration helped broker the ceasefire understanding between India and Pakistan - claims New Delhi firmly denies.

According to Indian officials, it was Pakistan that reached out to India with a request to halt military action following the Pahalgam terror attack, not the other way around.

Tharoor underlined the importance of setting the record straight during the delegation's final leg of international outreach, which will take them to Washington

Speaking to IANS on the sidelines of engagements in Brazil, Tharoor said, "Washington is a particularly interesting case because it is a large country, a superpower with enormous influence in the world, and there are many crosscurrents of information, misinformation, and other

narratives circulating. So, we have quite a lot of work to do there."

He added that the delegation will engage a broad spectrum of stakeholders in the US capital.

"We are engaging with a range of audiences, including

government officials, senators, and congressmen on Capitol Hill. We are also meeting with think tanks and organizations specializing in foreign policy, and also the media," Tharoor said.

The Congress MP also said that several countries need to understand that dialogue is not possible with the nations that facilitate cross-border terrorism.

Emphasizing the importance of international solidarity against terrorism, he noted,

"We're looking for solidarity in our struggle against terrorism. What is very clear in these countries is that some of these issues they understand, some they don't fully understand. And the natural instinct in many countries is to say -- why not have a dialogue? But it's very difficult to have a dialogue with people who are pointing a gun at your head, who are sending terrorists across your border. That becomes a problem." *IANS*

PM Modi congratulates Lee Jae-myung on being elected as South Korea's President

NEW DELHI: Prime Minister Narendra Modi extended his best wishes to newly-elected South Korean President Lee Jae-myung for winning the top post and expressed his eagerness to strengthen the strategic partnership between the two nations.

Democratic Party (DP) candidate Lee Jae-myung was elected President on Wednesday (June 4), after months of turmoil surrounding the impeachment and ouster of his former opponent over a botched attempt to impose martial law.

Taking to X, PM Modi posted, "Congratulations to Mr Lee Jae-Myung on being elected as the President of the Republic of Korea. Look forward to working together to further expand and strengthen the India-ROK Special Strategic Partnership."

Lee's win was a remarkable comeback after having lost to former President Yoon Suk Yeol by a razorthin margin of less than one percentage point in the previous election in 2022.

While Yoon's attempt to impose martial law in December paved the way for Lee's rise to the presidency, it also deepened the nation's political divide and increased the challenges posed by everything from the United States' tariff policies to North Korea's advancing nuclear weapons program. *IANS*

InSyncKathak's performance "Prakriti - An Ode to Mother Nature" at SFIAF 2025

n late 2024, at InSyncKathak Dance School's annual holiday party, our es teemed Guru, Anupama Srivastava, informed us all to block our calendars for Mother's Day 2025. The InSyncKathak dancers, along with Guru Anupama Srivastava, were going to be performing at the highly prestigious San Franscisco International Arts Festival (SFIAF).

Kathak is an ancient Indian classical dance form renowned for its intricate footwork, spins (chakkars) but above all, its vivid story-telling. I went to the SFIAF performance, with starry eyes and hopes of an enchanted Mother's Day afternoon. Little did I know that I was in for a real treat.

The SFIAF performance was choreographed by Anupama Ji, who is a distinguished disciple of Padmashri Guru Shovana Narayan. It was aptly titled



Prakriti, and delved into the intricate relationship between the human world and Mother Nature. It was an ode to Guru Shovana Narayan Ji's 75th birth year, and featured some of her classic choreographies, albeit with a modern-day California outlook.

The performance started with an ode to Mother Nature, titled Dhwani-Pratidhwani (Sound-Echo). True to its name, the dancers' footwork echoed through the auditorium, precise and timed accurately, following the rhythm of the percussion down to the microsecond. The footwork was the real star of this dance, a pure Nritta piece.

This was followed by OM- the cosmic dance of creation, honoring the vibrations of Om and the creation and sustenance of the cosmos. The young students, all dressed in white angarakhas, started the dance with their back to the audience, slowly unfolding and revealing their faces



to the audience. Their well-coordinated fast chakkars (spins) may have thrown the audience in a tizzy, but the young skilled dancers maintained their gaze razorsharp, their feet light and well-balanced.

The third piece of the afternoon was Panchtatva- honoring the five elements of Sky, Air, Water, Fire and Earth. The dancers were very appropriately dressed in colity strikes in the form of floods, hurricanes, tsunamis, wildfires and earthquakes, Mother Nature's creations were shown to be disturbed and destroyed. The panic and fear of these natural calamities was expertly demonstrated by the dancers through their emotions and movements.

The fourth performance of the afternoon was Dishaantar - Embracing the

change and deforestation in the modern environment. Anupama Ji and the InSyncKathak dancers skillfully showed a village transforming into a concrete jungle with unfortunate consequences for its residents such as, health scares and even death. The poignant emotions of the dancers could be felt reverberating through the audience. It was an excellent demonstration of Abhinaya, the art of skilled emoting and expressions.

tages of rapid production and flexible response to virus mutations. However, it is now questioned by the political atmosphere, which is worrying.

Dr. Benjamin Neuman, Professor of Biology, Texas A&M University said that vaccines and herd immunity are the cornerstones of the normal functioning of modern society. He criticized the current antivaccination claims as lacking scientific basis, and some politicians even advocated that each vaccine revision should be

re-conducted with a placebo-controlled trial, which may significantly delay the development and release of the vaccine and increase the risk of the disease to the public.

Dr. William Schaffner, Professor of Medicine in the Division of Infectious Diseases, Vanderbilt University School of Medicine pointed out that so far, 35 states in the United States have reported measles outbreaks, with the total number of cases exceeding 1,079, and the number of whooping cough cases has doubled from last year. He warned that diseases that vaccines have successfully eradicated, such as measles, polio and diphtheria, are now posing a renewed threat to public health due to society forgetting their dangers, the proliferation of false information and vaccine hesitancy. Taking the epidemic in the Mennonite community in western Texas as an example, he pointed out that this group may not necessarily oppose vaccines, but because they believe in natural life and reject modern medical treatment, most children are not vaccinated. Once the virus invades, it spreads rapidly, and several people have died from pneumonia.

Indian diaspora in UK lauds Op Sindoor; PM Modi's leadership against terrorism

LONDON: Members of the Indian diaspora in the UK have lauded the Prime Minister Narendra Modi-led Union government's decisive action against cross-border terrorism through Operation Sindoor and expressed pride in India giving a befitting reply to Pakistan-sponsored terror.

Following the delegation's interaction with the Indian community in London, the


members of the diaspora praised Operation Sindoor and PM Modi-led government's leadership.

The vast majority of them elected to remain in the country. And their courageous decision changed the course of our history, forever," read a statement issued by the office of the President of Trinidad and Tobago.

"On Indian Arrival Day we celebrate their rich and lasting legacy. We celebrate their courage and their resilience, and the values and traditions that sustained them throughout their years of hardship and uncertainty. And we thank them for safeguarding and passing down the

Indian-origin man fights for life after Australian police officials 'kneed him on neck'

CANBERRA: A 42-year-old Indian-origin man, Gaurav Kundi, is battling for life after a brutal arrest where he was kneed in the neck to the ground by the Australian police in Adelaide's eastern suburbs.

He is currently at the Royal Adelaide Hospital and on Recalling life support with severe brain and neck injuries, according ment caught to local media reports.

His family claimed that excessive His family claimed

His family claimed that excessive force was used during the arrest, due to which the father-of-two lost consciousness with severe injuries.

The video, which was filmed by Kundi's wife, Amritpal Kaur, shows him being forced onto Payneham Road. Pundi can be heard shouting, "I've done nothing wrong," while Kaur is also crying and claiming his innocence.

"Just 19 seconds of video because I

got panicked, and I sat on the ground with Gaurav. I kept saying he's not well, he's not well, please don't do this, just call the ambulance," she said, speaking to local Aus-

tralian media outlet 9News.

"Doctors are saying his brain is totally damaged. Maybe he will wake up if his brain works, or maybe he will not," she added.

Recalling the incident, Kaur stated that their loud argument caught the attention of a passing police patrol, and

they mistakenly interpreted it as a case of domestic violence.

"I just went out and followed him. What are you doing here? Let's get back home. You are drunk. You are not well. We will go home," she recalled.

"He just pushed me a little bit... The policeman thought he was assaulting me and doing domestic violence on the road, but the policeman was wrong. He was just drunk, and that's why he was loud, nothing else," she further stated

Kaur alleged that her husband was injured when his head was slammed into the police car and the road and that while he was on the ground; he was kneed in the neck. *IANS*

Tesla India leases Rs 25-crore service center in Mumbai

MUMBAI: Tesla India Motor and Energy Private Ltd has leased a 24,500-square-foot space in Mumbai's Kurla West to set up a service center, located close to its upcoming showroom in the Bandra Kurla Complex (BKC).

This move marks a significant step in Tesla's plans to enter the Indian electric vehicle (EV) market, although the company does not currently intend to manufacture vehicles in the country.

According to real estate documents sourced by CRE Matrix, a property data analytics firm, Tesla has signed a lease and license agreement with Bellissimo in City FC Mumbai I Private to rent the space in Lodha Logistics Park.

The agreement is for a fiveyear period, with a starting monthly rent of Rs 37.53 lakh. Over the duration of the lease, Tesla will pay nearly Rs 25 crore in total, including a security deposit of Rs 2.25 crore, as per the documents.

Tesla has made it clear that its current interest lies only in selling its vehicles in India, not in manufacturing them at the moment.

"They are not interested in manufacturing in India," Union Heavy Industries Minister H.D. Kumaraswamy said on Monday. He added that Tesla is planning to open showrooms in India purely for sales. *IANS*

Over 3.8 MT of non-biodegradable plastic waste recycled in last 3 fiscals: Adani Electricity

MUMBAI: Reaffirming its commitments towards sustainability, Adani Electricity recently said that it has channelized over 3.8 metric tons (MT) of non-biodegradable plastic waste for recycling in the last three financial years.

Ahead of World Environment Day, observed every year on June 5, Adani Electricity stated a remarkable progress in its commitment to environmental stewardship.

It particularly emphasized a drastic reduction and elimination of single-use plastics (SUP) across its operations.

"As the world observes World Environment Day -- this



year's theme of #BeatPlasticPollution, we at Adani Electricity reaffirm our unwavering dedication to environmental responsibility," said an Adani Electricity spokesperson.

"Sustainability isn't just a buzzword; it's a core principle guiding our every action. The significant reduction in single-use plastics across our operations underscores our deep commitment to building a greener future. We believe that every step, no matter how small, contributes to a larger, more impactful change for our planet and communities," the spokesperson added.

Ranging from 632.15 kg of non-biodegradable plastic

waste in FY23 to 1940 kg of non-biodegradable plastic waste in FY24, the company demonstrated a consistent upward trend in channelizing non-biodegradable plastic waste for recycling. In FY25, the figure stood at 1230 kg of non-biodegradable plastic waste recycled.

"This impressive cumulative figure of 3802.15 kilograms highlights the effectiveness of Adani Electricity's robust environmental initiatives," the company said.

The phased-out single-use plastic items include drinking water bottles and cups, as well as plastic cutlery such as forks, knives, spoons, glasses, plates, chopsticks, and

thermocol cups.

It has also eliminated plastic garbage bags (less than 75 microns), gift wrapping papers, and plastic used during Diwali decorations.

Furthermore, plastic food packaging boxes, lamination sheets for office cubicles, cello tapes and brown tapes, and various packaging materials for stores (including lugs, glands, wires, pillars, panels, ring main units (RMUs), cables, poles, ferrules, and fuse units) are no longer in use, Adani Electricity said.

Meanwhile, the company also said that it has successfully replaced single-use

plastics with more sustainable alternatives across its operations. For instance, the packaging material for pillars, panels, and RMUs has been replaced with multiple-use plastic.

Additionally, lugs, ferrules, and wires are now received in eco-friendly gunny bags, and jointing kits are received in cardboard boxes.

"Adani Electricity remains dedicated to leading the charge in environmental sustainability, constantly striving for innovative solutions to minimize its ecological footprint and inspire a greener future for all," the company said. *IANS*

sition.

This progress is the outcome of bold reforms, timely decisions, and a clear long-term vision pursued consistently under the leadership of Prime Minister Narendra Modi over the past 11 years. He had a clear vision to build a robust renewable energy ecosystem, and even as the Gujarat chief minister, he had pioneered large-scale solar projects long before clean energy became a global priority, Joshi explained.

where we began. In 2014, India's power sector was in deep crisis. Electricity shortages were chronic. *IANS*

Robust infra demand to propel investment growth in India, private sector vital: Moody's

MUMBAI: India will need massive investment to achieve its 2070 net-zero pledge as it balances energy security, affordability and transition, Moody's Ratings said on 4 June.

Achieving this pledge will necessitate substantial investment, particularly in the power sector, which is a material contributor to the nation's carbon emissions.

Over the next decade, these investments are projected to constitute 2 percent of real GDP for the electricity value chain, encompassing power generation, storage, transmission and distribution, the report mentioned.

The government's plan to reach net-zero emissions by 2070 will be contingent upon a shift in the fuel mix from the current predominantly coal-fired power toward clean and renewable energy.

However, strong economic growth implies India will also expand its coal-based power generation capacity by 32-35 percent (or around 70GW-75GW) over the next 10 years, even as it adds around 450GW of renewable energy over the same period.

"We expect the private sector to remain active in India's renewable energy sector, while government-

owned companies will also increase their role," said Abhishek Tyagi, a Moody's Vice President and Senior Credit Officer.

Solar and wind power will dominate new generation capacity additions over the next 20-25 years, with

smaller nuclear and hydropower additions, he added.

Securing diverse sources of capital, including foreign investments (both debt and equity), will be crucial to bridge the funding gap for energy transitionrelated infrastructure.

Meanwhile, the government has planned sizeable capex under its 'Maritime India Vision 2030' to augment port capacity and infrastructure over the course of next few years.

Moody's Indian affiliate ICRA expects cargo volumes to rise by 3-5 percent in FY26, driven largely by the growth in the container, petroleum products and the fertilizer segment.

Apart from the traditional segments like transportation and energy within infrastructure space, data center is emerging as a new hotspot for infrastructure investment.

ICRA expects significant investment pipeline of Rs 1.6-1.8 trillion in data center (DC) capacity addition over next 5-6 years in India, supported by rapid digitalization along with favorable policy measures. *IANS*

Study reinforces need for vaccines to help prevent hearing loss

NEW DELHI: Vaccination may play a significant role in preventing hearing loss in children and adolescents, according to a study that identified 26 infectious pathogens that can potentially cause hearing loss.

Over 1.5 billion people worldwide are affected by some degree of hearing loss. While it is often linked to ageing, a lesser known but significant cause is infections contracted during childhood and adolescence, many of which are preventable.

According to the World Health Organization, nearly 60 percent of childhood hearing loss could be prevented through public health measures such as vaccination against rubella and certain forms of meningitis.

To probe further, a team of researchers, including from Université de Montréal in Canada conducted an in-depth review of the scientific literature.

The study, published in the journal Communications Medicine, identified 26 infectious agents that can potentially cause hearing loss, including the virus responsible for common diseases such as measles as well as rubella, which is especially dangerous if contracted during pregnancy because it can harm the developing auditory system and cause congenital deafness.

The list also includes the virus that causes mumps, which can lead to sensorineural hearing loss by damaging the inner ear or auditory nerve. *IANS*

Covid cases rise in India; govt says monitoring the situation

NEW DELHI: Amid the latest wave of Covid-19, the number of SARS-CoV2 infections in the country has risen to 2,170. As many as, 511 new cases were recorded from the previous day, according to an update by the Health Ministry last Saturday. Meanwhile, 255 patients were discharged or migrated in the last 24 hours, indicating an improvement in recovery.

As per the data, the number of deaths across multiple states, since January 1, 2025, surged to 22.

Kerala with 1,147 cases is the worst-hit state, followed by Maharashtra (424), Delhi (294), and Gujarat (223).

The highest number of deaths have been reported from Maharashtra (7), followed by Kerala (5), and Delhi (2).

Meanwhile, 255 patients were discharged or migrated in the last 24 hours, indicating an improvement in recovery.

The cumulative number of recovered cases since January 1 stands at 1,170. Kerala (72),



As per the data, the number of deaths across multiple states, since January 1, 2025, surged to 22. Kerala with 1,147 cases is the worst-hit state, followed by Maharashtra (424), Delhi (294), and Gujarat (223)

Delhi (77), and Maharashtra (34) contributed the highest number of recoveries on the day.

As per the latest data from the Indian SARS-CoV-2 Genomics Consortium (INSACOG), set up under the Ministry of Health and Family Welfare, NB.1.8.1 and LF.7 -- descendants of JN.1

Covid variant in the country --are responsible for the rise in SARS-CoV-2 cases in the country.

So far, the World Health Organization (WHO) has not classified either LF.7 or NB.1.8 as Variants of Concern (VOCs) or Variants of Interest (VOIs).

While these variants may

have the capability to evade immunity, there is currently no evidence to suggest they could cause severe long-term infection.

Common symptoms associated with these variants include fever, runny nose, sore throat, headaches, fatigue, and exhaustion.

Recently, Dr. Rajiv Bahl, Director General at the Indian Council of Medical Research (ICMR) assured the country that there is nothing to worry about as the infections are not severe.

Bahl also assured that the government is actively monitoring the cases.

At the same time, he stressed the need for "increasing vigilance, and to be prepared" in case of a surge in cases.

Delhi Chief Minister Rekha Gupta has issued guidelines to all hospitals in the national Capital to ensure the availability of beds, oxygen, medicines, and vaccines.

She stated that the government is closely monitoring Covid cases and "there is no panic situation". *IANS*

Indian astronaut Shubhanshu Shukla to conduct key food, nutrition experiments in space

NEW DELHI: Indian astronaut and Group Captain Shubhanshu Shukla is set to conduct exclusive food and nutrition-related experiments onboard the International Space Station (ISS) as part of the upcoming Axiom Mission 4 (Ax-4), Union Minister Dr Jitendra Singh said recently.

The experiments - developed

under a collaboration between the Indian Space Research Organisation (ISRO) and the Department of Biotechnology (DBT), with support from NASA aim to pioneer space nutrition and self-sustaining life support systems vital for future long-duration space travel.

Dr Singh said the first ISS experiment will examine the impact



of microgravity and space radiation on edible microalgae - a high-potential, nutrient-rich food source.

The study will focus on key growth parameters and the changes in transcriptomes, proteomes, and metabolomes of various algal species in space compared to Earth conditions. *IANS*

People with irritable bowel syndrome can find relief with Mediterranean diet: Study

NEW DELHI: A team of US researchers has found that the Mediterranean diet may provide symptom relief for people with irritable bowel syndrome (IBS).

Irritable bowel syndrome affects an estimated 4-11 percent of all people, and a majority of patients prefer dietary interventions to medica-

prefer dietary interventions to medica-

tion.

The low FODMAP diet leads to symptom improvement in more than half of patients, but is restrictive and hard to follow.

Previous investigations from Michigan Medicine researchers in the US into more accessible alternative diets led to a proposed "FODMAP simple," which attempted to only restrict the food groups in the FODMAP acronym that are most likely to cause symptoms.

In the new study published in the journal Neurogastroenterology & Motility, participants were randomized into two groups, one following the Mediterranean diet and the other following the low FODMAP diet, a common restrictive diet for IBS.

In the Mediterranean diet group, 73 percent of the patients met the primary endpoint for symptom improvement, versus 81.8 percent in the low FODMAP group.

"Restrictive diets, such as low FODMAP, can be difficult for patients to adopt," said Prashant Singh, Michigan Medicine gastroenterologist and lead author on the paper. "In addition to the issue of being costly and time-con-

> suming, there are concerns about nutrient deficiencies and disordered eating when try-

> > ing a low FODMAP diet. The Mediterranean diet interested us as an alternative that is not an elimination diet and overcomes several of these limitations related to a low FODMAP diet." Kumar added.

The Mediterranean diet is already popular among physicians for its benefits to cardiovascular, cognitive, and general health. Previous research on the effect of the Mediterranean diet on IBS, however, had yielded conflicting results. While the Mediterranean diet did pro-

vide symptom relief, the low FODMAP group experienced a greater improvement measured by both abdominal pain intensity and IBS symptom severity score.

"This study adds to a growing body of evidence which suggests that a Mediterranean diet might be a useful addition to the menu of evidence-based dietary interventions for patients with IBS," said William Chey, chief of Gastroenterology at the University of Michigan. *IANS*

Covid-19: Current infection wave unlikely to cause higher burden on hospitals, say doctors


NEW DELHI: Amid nearly 4,000 active cases of Covid-19 disease in the country, health experts on Monday (02 June) assured there is no need to panic, as the current infection wave is unlikely to cause a higher burden on hospitals.

According to the latest update, shared by the Ministry of Health, there are 3,961 active Covid cases. The number of deaths across multiple states, since January 1, 2025, surged to 32. Meanwhile, 2,188 patients were discharged or migrated in the last 24 hours, indicating an improvement in recovery.

"It is highly unlikely that the current infection can cause a higher burden on the hospitals. Hence, there is no need to panic. However, the sentinel surveillance system needs to be strengthened in order to catch the outbreak in the earlier phase," Dr Harshal R. Salve, Additional Professor at the Centre for Community Medicine at AIIMS, New Delhi, told IANS.

Kerala (1,435), Maharashtra (506), Delhi (483), Gujarat (338), and West Bengal (331) have reported the highest number of cases so far.

This fresh wave has been caused by two new coronavirus variants, NB.1.8.1 and LF.7, mutations of the Omicron offspring JN.1 variant. Both were found in India, as per data from the Indian SARS-CoV-2 Genomics Consortium (INSACOG), set up under the Ministry of Health. *IANS*

Colombian national charged with voter fraud

BOSTON: A Colombian woman unlawfully residing in Boston has been indicted by a federal grand jury for identity theft offenses-including receiving rental assistance, Social Security, and Supplemental Nutrition Assistance Program benefits-as well as voter fraud under the stolen identity. The defendant also allegedly applied for a U.S passport and obtained a Massachusetts Real ID and eight other state IDs. U.S. Citizenship and Immigration Services provided valuable assistance to the investigation.

The U.S. Attorney announced Lina Maria Orovio-Hernandez, 59, was charged in a superseding indictment with one count of false representation of a Social Security number; one count of making a false statement in an application for a U.S. passport; one count of aggravated identity theft; three counts of receiving stolen government money or property; one count of fraudulent voter registration; and one count of fraudulent voting. Orovio-Hernandez was previously charged in an indictment in February 2025 and has remained in federal custody since that time.

According to court filings, Orovio-Hernandez, a Colombian national without lawful status in the United States, has lived under a stolen identity for more than 20 years. Using this stolen identity, Orovio-Hernandez allegedly obtained nine state IDs, including a Massachusetts Real ID and applied for a U.S. passport. USCIS

WASHINGTON: The United States stated that the pause on student visa interviews will end "sooner than later" and encouraged applicants to continue the application process while frequently checking for the resumption of regular services.

Secretary of State Marco Rubio has ordered US missions around the world to pause student visa interviews to incorporate expanded scrutiny of the social media footprints of applicants

An early end to the pause, as indicated by US State Department spokesperson Tammy Bruce, would relieve hundreds of thousands of students headed for the US to pursue higher studies later in the year.

16 illegal Bangladeshi Nationals apprehended in Delhi's Seemapuri area

NEW DELHI: In a significant action against illegal immigration, a joint team from the Foreigner Cell and Special Staff of Shahdara District Police apprehended 16 Bangladeshi nationals from Delhi's Seemapuri area.

As per the police, the operation was launched following credible intelligence about the movement of illegal immigrants across the Uttar Pradesh-Delhi border near the Shaheed Nagar area.

Acting swiftly on the tip-off, the police team conducted initial verification and, after confirming the information, formulated an immediate action plan. Based on surveillance and identification by the informer, the joint team intercepted the group as they attempted to enter the Seemapuri area in Delhi.

A total of 16 individuals were detained, including four adult males, five adult females, and seven minor children. All were identified as Bangladeshi nationals who had entered India without valid documents and were attempting to settle in Delhi illegally.

Another RBI rate cut to spark affordable real estate momentum: Experts

NEW DELHI: As the Reserve Bank of India (RBI) prepares for its monetary policy committee (MPC) meeting this week, industry experts said the transmission of rate cuts into lower borrowing costs is vital to sustain residential real estate demand particularly in the affordable housing segment, which is sensitive to interest rate movements.

Given the prevailing benign inflation environment and the GDP growth of 6.5 percent recorded in FY2025, the Reserve Bank is likely to proceed with a 25-bps reporate cut this Friday (June 6).

"The case for a rate cut is further supported by the revival in the liquidity conditions to a surplus of Rs 3.6 lakh crore, which enhances the effectiveness of monetary transmission. Additionally, the softening of G-sec yields reflects bond market confidence in the RBI's inflation and liquidity management and strengthens the rationale for easing rates," said Shishir Baijal, Chairman and Managing Director, Knight Frank India.

With the anticipated rate cut, the cumulative reduction in the policy rate in this cycle would be 75 bps.

However, the focus must now shift to the pace and breadth of transmission.

"While some commercial banks have begun to lower their MCLR and base rates, the adjustments have been modest. With liquidity conditions stabilizing, there is now greater scope for commercial banks to accelerate the pass-through of policy easing

to borrowers. This will be key to spurring consumer demand and private investment, ultimately supporting economic growth," Baijal noted.

The Central Bank is projected to cut the reporate by another 50 basis points (bps) this fiscal (FY26), after the 50 bps cut until April this year. *IANS*

Housing registration in Mumbai decline 4% YoY, mortgage rate cut likely to improve sales: Report

MUMBAI: The house registrations in Mumbai decline 4 percent YoY in May and down 12 percent MoM to 11,565 units, says a report by Nuvama Research.

According to report, despite the decline in the number of registrations, the total value of registrations rose 3 percent YoY to Rs 177 billion. On a monthly basis, the registration value dropped 5 percent.

In the first five months of 2025 (January to May), Mumbai recorded 61,461 housing unit registrations, which is 6 percent higher compared to the same pe-

By value, registrations rose 17 percent YoY to Rs 949 billion. The average ticket size of the registered properties also increased 11 percent YoY to Rs 14.7

In Maharashtra, the number of property registrations in May 2025 stood at 148,080 units. This is a 2 percent decline YoY but a 2 percent increase compared to April 2025.

The report also said that 80 percent of the total registrations in Mumbai were residential properties. Com-

Among these, homes sized between 500 and 1,000 square feet were the most preferred, accounting about 44 percent

The report also highlighted that the central and western suburbs were the most active areas, contributing to 87 percent of the total registrations during the

The report noted a 1 percent YoY increase in the share of registrations from central and south Mumbai. This indicates a rise in demand for premium homes in these areas, likely due to new project launches and ongoing infrastructure development.

Highlighting the outlook of the sector the report added that "A robust launch trajectory and mortgage rate cut are likely to improve sales in Mumbai going




It is for this reason, failing to see the inherent polarity in life, that we seem to have a feeling of having some kind of world which can stand by itself.

Can India ever catch up with China? Third-largest economy is stuck in middle-income trap

round 1990, India and China had roughly the same economic size and per capita income in dollar terms. China's per capita income was lower than that of India. Both were ranked between 140 to 145 out of 190 odd countries. China's economic reforms had started in 1978, but the real momentum to their growth was yet to kick in. India's reforms started in the next year i.e. 1991, thirteen years behind that of China. Fast forward to the present. These two are now the second and fourth largest economies in the world. China became the second largest economy back in 2010. India has attained the fourth rank just this past week as per the International Monetary Fund, and this was proudly announced by the Chief Executive of Niti Aayog, on the sidelines of the meeting of the Governing Council of Niti, chaired by the Prime Minister. The CEO was confident that India would overtake Germany to become the third largest economy in the next three years.

China became the second largest economy back in 2010. India has attained the fourth rank just this past week as per the International Monetary Fund, and this was proudly announced by the Chief Executive of Niti Aayog

The rise of India and China in the past three decades is nothing short of spectacular, historic and unprecedented. Together the two giants of Asia represent 40 percent of humanity. India's economic size is presently about 4.1 trillion dollars, while China is 19 trillion which is five times bigger. India's economy has grown at 6.3 percent per annum from the year 2000 till 2024 in real terms, as per World Bank. This is the fastest growth rate among large economies. In recent years the average rate of growth of India has gone up to about 7.3 percent. As compared to 1990 India's economy is now 11.5 times bigger, while the population is only 1.6 times larger. This means that the per person or per capita income has grown substantially from about 360 dollars in 1990 to 2700 dollars in 2025.

Contrasting growth paths

The contrast with China is most telling. Back in 1990 both countries had similar per capita incomes, but in 2025 China's per capita income has raced ahead to 13000 dollars, almost five times that of India. That's mostly because China's economy expanded by 51 times over the past 35 years. China was able to maintain a real growth rate of 10 percent per annum for three decades. The two countries were ranked similarly in 1990 in per capita income. But India is now rank 141 out of 197 whereas China's rank is 70. India is now firmly in the middle income bracket, as defined by the World Bank, whereas China has moved close to being considered a high income country (which is defined as above 14000 dollars per capita).

Above that threshold the World Bank lingo refers to the grouping as developed economies. India is aiming to achieve that status by 2047. For that to happen India's growth rate has to accelerate and maintain an average of 7.8 percent in dollar terms for the next twenty years. It is slightly higher than the average that has been achieved in recent years, i.e. 7.3.

Why did India fare poorly as compared to China over the period 1990 to 2025? Is it because of ignoring the potential of export led growth dominated by labor-intensive exports? Is it because of low investment in primary health and education? Is it because of the inspector raj which re-

placed the license raj which was dismantled in 1991? Is it because of India's three-tiered system of governance which hinders the ease of doing business? Or is it because India's democratic system has a cost to pay in terms of slower growth?

There are many more questions regarding India's poor performance when compared to China but pursuit of these is fruitless for now. It is time to focus on what needs to be done to achieve a high growth which is sustained for two decades, and also inclusive, so that it leads to growth in per capita incomes as well. This would mean growth of productivity, wages, household incomes and high quality jobs. If that is not achieved, then India might very well become the third largest economy by 2047, but will be stuck in the middle income trap, and per capita income may stagnate well below 10,000 dollars.



It offers a breathtaking panoramic view of the entire city, the Himalayas, its waterfalls as well as of the Bangladesh plains. A telescope is available for tourists to get a bird's eye view. Trekking up to this semi-circular Shillong Peak is highly recommended for the best views but it is often bounded by heavy fog.

Laitlum Canyons: Perched on the East Khasi Hills, Laitlum Canyons is a less explored but one of the most

Cyber Violence Is Silencing Women in Bangladesh

here's no denying that Bangladesh has stepped firmly into the digital age. Mobile screens now light up village homes; remote banking, online education, telemedicinewhat once felt futuristic is now ordinary. The country, once constrained by analog limitations, has rapidly built its digital scaffolding. And yet, in the spaces between the milestones, something unsettling is happening.

Women, far from being lifted equally by this transformation, are increasingly under threat. Not from the technology itself, but from how it's being weaponized. Cyber violence against women isn't just a growing problem-it's a

significant number of cases, the attacker is someone the victim once trusted. A partner. An acquaintance met online. A former classmate. A 2021-2022 study found that ex-boyfriends were behind one-third of cyber violence incidents involving women. Another 20 percent stemmed from digital 'friendships.' Trust is being turned into a trap. And the silence that follows is deafening.

Digital abuse and its toll

The damage doesn't remain online. It travels. It spills into class-rooms, offices, and family circles. Some women face public shame. Others leave school or change jobs. Nearly half suffer social humiliation; many face financial con-

quiet epidemic. Recent figures from the Cyber Crime Awareness Foundation show a sharp spike: cybercrime more than doubled in a single year, and nearly 60 percent of the victims were women. The Police Cyber Support for Women (PCSW) received over 9,000 harassment complaints in 2024. And those numbers barely scratch the surface. Most cases never make it to any formal system. Many women don't reportsome fear retaliation; others have simply stopped expecting justice.

The forms of abuse are not abstract. They are precise and deeply personal. Hacked profiles, revenge porn, doctored images, threats delivered through messaging apps-each method tailored to degrade and control. For many women, the screen has become a source of dread, not freedom.

A closer look reveals something even more troubling: in a

sequences. But the emotional toll-while harder to measure-is often the most lasting. In a culture that still holds women responsible for their own victimhood, a single leaked photo or false rumor can dismantle years of effort.

One high-profile case involving a Bangladeshi actress made this painfully clear. When private videos of her were leaked by a former fiance, the fallout was swift-but not for the man who betrayed her. The scrutiny, the mockery, the moral judgment-it all landed squarely on her shoulders. The technology was modern; the public reaction was anything but.

And yet, despite the rising numbers and devastating outcomes, the system charged with addressing these crimes is deeply underprepared. PCSW, while a meaningful initiative, operates within a legal and institutional structure that lags far behind the

problem it's trying to solve.

Between 2014 and 2022, Dhaka's cyber tribunal delivered verdicts in just over 200 casesout of more than 2,000 filed. That's a conviction rate of under 10 percent. Some cases drag on for years. Others quietly fade out. The justice system, as it stands, is not built to handle the velocity or complexity of digital abuse.

Part of the issue lies in training. Officers and investigators are often not equipped to understand how cybercrimes unfold. Victims are left explaining how platforms work or why online threats matter. Legal expert Salma Ali points to a critical gap: digital cases are handled like physical crimes, using tools and thinking that don't fit. As a result, victims are retraumatized, and offenders walk free.

The legal language, too, hasn't kept pace. The Information Communication Technology Act, while containing provisions on digital offenses, often falls back on general terms like "defamation." But this isn't about reputational damage in the abstract. This is about targeted, gendered harm-about control, humiliation, and coercion. Without specific laws addressing issues like non-consensual image sharing or online stalking, most cases fall through the cracks.

All of this feeds into a larger, more insidious outcome: women retreating from digital life. Some leave social media entirely. Others think twice before expressing an opinion, posting a photo, or joining a group. And as they pull back, opportunities narrow. Education, job access, civic participation-all of it increasingly runs through digital spaces. When women exit those spaces for safety, they're not just losing platforms. They're losing possibilities.




