India's proactive stance on illegal immigration hailed as US deports migrants

WASHINGTON: India's proactive stance on illegal immigration and streamlining legal mobility has come in for praise as an India-bound US C-17 military aircraft, carrying around 200 deported illegal migrants left Texas, marking President Donald Trump's first crackdown on illegal immigrants from India after assuming office last month.

The move comes after detailed discussions held between Prime Minister Narendra Modi and President Trump over a phone call on January 27 and ahead of PM Modi's forthcoming February 13-14 visit to Washington.

Similar deportation flights have left for Guatemala, Peru, Honduras and other countries since January 24 as the US President has vowed to crack down on illegal mi-

gration that has been the highlight of his Presidential election campaign. Within hours of taking office for the second time, Trump had decided to put an end to birthright citizenship and mobilize troops along the US-Mexico border.

"New Delhi has been proactive in saying that we also have no reason to support illegal immigration and that we would, as in the past, cooperate in deportation of those who have been identified by our authorities as Indian citizens. At the same time, there is a push from the US side to try and ensure that legal migration is streamlined which is an important source of talent for the country.

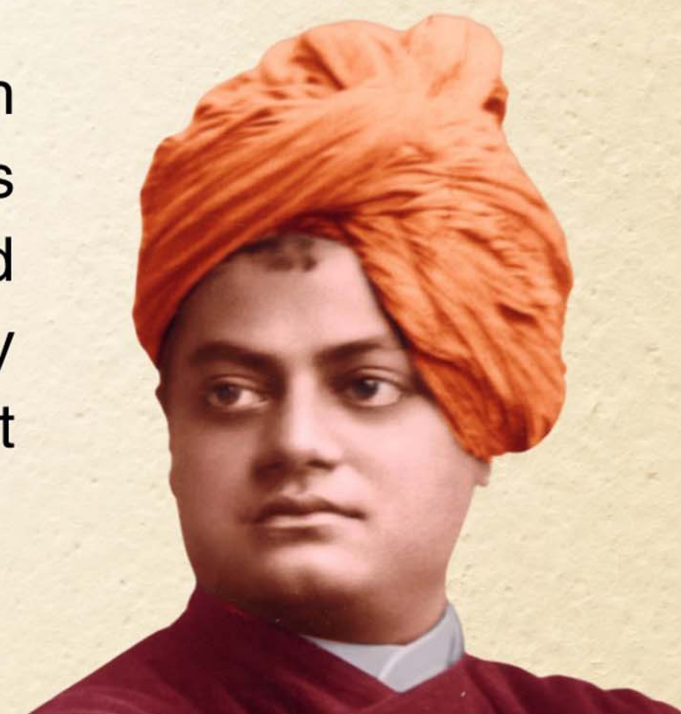

"We have always taken the view that if there are any of our citizens, who are not here legally, if we are sure that they are our citizens, we have always been open to their legitimate return to India. So it's not a position unique to the US," EAM Jaishankar told reporters in Washington, last month.

He affirmed that India's position on the issue has been "consistent" and "principled" and he did clearly convey this to the new US Secretary of State Marco Rubio.

"I understand right now that there is a certain debate going on and a resulting sensitivity which is there. But we have been consistent, we have been very principled about it, and that remains our position, and I conveyed that very clearly to US State Secretary Marco Rubio," he added.

According to immigration statistics published on the website of US Customs and Border Protection, over 90,000 Indians entered the US illegally in 2022-23.

In the US fiscal year 2024, which ended in September, more than 1,000 Indian nationals had been repatriated by charter and commercial flights, according to the then Assistant Secretary at the US Department of Homeland Security, Royce Bernstein Murray.

In October last year, US Immigration and Customs Enforcement deported Indians back home, marking a growing trend in deportations to India. *IANs*

Plane carrying Indian citizens who allegedly illegally migrated to US arrives in Amritsar

AMRITSAR: The US Air Force plane carrying Indian citizens who allegedly illegally migrated to the US arrived in Punjab's Amritsar.

Earlier, a US Embassy spokesperson said that while specific details cannot be shared, the United States is vigorously enforcing its border and immigration laws. The spokesperson emphasized that the actions taken send a "clear message that illegal migration is not worth the risk."

"I have received a number of inquiries on the report of a deportation flight to India. I can't share any details on those inquiries, but I can share, on the record,

that the United States is vigorously enforcing its border, tightening immigration laws, and removing illegal migrants. These actions send a clear message: illegal migration is not worth the risk," a US Embassy spokesperson said.

On January 24, the Ministry of External Affairs (MEA) had stated that it would facilitate the return of Indian nationals "overstaying" or residing without proper documentation in the United States or "anywhere in the world."

While addressing a press briefing in New Delhi, MEA spokesperson Randhir Jaiswal said, "We are against illegal immigration, especially because it is linked to

several forms of organized crime."

He added, "For Indians not just in the United States, but anywhere in the world, if they are Indian nationals and they are overstaying, or they are in a particular country without proper documentation, we will take them back, provided documents are shared with us so that we can verify their nationality and that they are indeed Indians. If that happens to be the case, we will take things forward and facilitate their return to India."

The deportation has already taken a political turn with the Congress claiming that the US was treating Indian citizens poorly.

"Shocking & shameful! The way the US

is deporting Indians--chained like criminals--is inhumane & unacceptable. Why is PM Narendra Modi silent? Where is self-respect? Dr S Jaishankar what are you doing to stop this humiliation of our people? Speak up & act Now," posted Congress MP Manickam Tagore.

Meanwhile, CBS News reported that U.S. Immigration and Customs Enforcement is releasing some migrant detainee. This as its detention system has exceeded maximum capacity amid a spike in arrests under President Trump. According to CBS News, space inside detention facilities was at 109% capacity, with the close to 42,000 migrant detainees. *ANI*

India-EU relationship "more important than before" in this volatile, uncertain world: EAM Jaishankar

NEW DELHI: Emphasizing the importance of the ties between India and the European Union as a "stabilizing factor" amid the global volatility and uncertainty, External Affairs Minister S Jaishankar asserted that the relationship between the two is "more important than ever before".

Delivering the keynote address at the IIC-Bruegel Annual Seminar in Delhi recently, the Foreign Minister further highlighted the interaction with the European Commission, expressing expectations for even collaboration in the future.

"In a world that promises to be so volatile and so uncertain, a stronger India-EU relationship can be an important stabilizing factor. India is certainly cognizant of the greater strategic awakening of Europe in the last few years. That too can serve as a driver of deeper engagement. We already see that happening, for example, in closer defence in security and technology cooperation. The bottom line is that the India-EU relationship is more important than

ever before," Jaishankar said.

He added, "In recent years there has

been a more intensive engagement with the European Commission. We expect

that to be even more in the coming days."

Notably, India and the EU are two of the world's largest economies having shared synergies and offering significant trade and investment opportunities. The EU is India's largest trading partner and India is the EU's 9th trading partner in terms of bilateral trade in goods.

As per the Delegation of the European Union to India and Bhutan, in 2023, the total value of EU-India trade in goods stood at Euro 113.3 billion. The EU is the main export destination for Indian goods. India exported to the EU goods worth Euro 64.9 billion, while it imported from the EU goods worth Euro 48.4 billion, thus enjoying a trade in goods surplus of Euro 16.5 billion.

The main export items from the EU to India are: machinery and mechanical appliances, aircraft, spacecraft and parts, electrical machinery and equipment. The main import items from India to the EU are: machinery, transport equipment, chemicals and related products. ANI

In a post on X, the Prime Minister said he was filled with a spirit of devotion after taking a dip in the Sangam.

"Blessed to be at the Maha Kumbh in Prayagraj. The Snan at the Sangam is a moment of divine connection, and like the crores of others who have taken part in it, I was also filled with a spirit of devotion," PM Modi said on X.

"May Maa Ganga bless all with peace, wisdom, good health and harmony," he added.

Prime Minister Narendra Modi offered puja at Triveni Sangam. After reaching Prayagraj, the Prime Minister took a boat tour on the Yamuna River with Uttar

Meanwhile, by 8 am on the day, over 3.748 million devotees had taken a holy dip in the confluence of the Ganga, Yamuna, and the mystical Saraswati, increasing the deep spiritual fervor surrounding the grand religious congregation.

PM Modi to visit White House next week on Donald Trump's invitation: Report

WASHINGTON, DC: Prime Minister Narendra Modi is set to visit the White House next week at the invitation of US President Donald Trump, Reuters reported citing a White House official.

The invitation comes days after a recent phone call between the two leaders on January 27, where both the leaders emphasized their commitment to advance the US-India strategic partnership and the Indo-Pacific Quad partnership.

During the call on January 27, Trump spoke about immigration and stressed the importance of India buying more American-made security equipment and fair bilateral trading ties.

"The two leaders discussed expanding and deepening cooperation. They also discussed a range of regional issues, including security in the Indo-Pacific, the Middle East, and Europe," the White House statement following the call read.

"The President emphasized the importance of India increasing its procurement of American-made security equipment and moving toward a fair bilateral trading relationship," it added.

The leaders also discussed plans for PM Modi's visit to the White House, and Indo-Pacific Quad partnership, with India hosting Quad Leaders for the first time later this year.

Trump to speak with Xi as China announces retaliatory tariffs

BEIJING: United States President Donald Trump is set to speak with Chinese President Xi Jinping, Al Jazeera reported recently, citing Trump's top trade adviser, Peter Navarro.

White House press secretary Karoline Leavitt did not provide a specific timeline for the Trump-Xi call but said it would happen "soon", as reported by Al Jazeera.

Meanwhile, China has announced retaliatory tariffs on US goods in response to Washington's latest trade measures. Beijing will impose a 15 per cent tariff on imports of coal and liquefied natural gas (LNG) from the US, following the American government's decision to impose 10 per cent tariffs on Chinese goods, Al Jazeera reported.


China's Ministry of Finance also said that a 10 per cent tariff would be applied to US imports, including crude oil, agricultural machinery, large-displacement vehicles and pick-up trucks, as reported by Al Jazeera.

The new measures were in response to the "unilateral tariff hike" by the US, it said, adding that Washington's decision "seriously violates World Trade Organization rules, does nothing to resolve its own problems, and disrupts normal economic and trade cooperation between China and the United States".

Beijing's tariffs, which would come into force on February 10, were announced shortly after US President Donald Trump said he would hold a call with his Chinese counterpart, Xi Jinping.

"China's retaliatory tariffs are a calibrated response rather than an outright escalation," Julien Chaisse, professor at City University of Hong Kong specializing in international economic law, told Al Jazeera. ANI

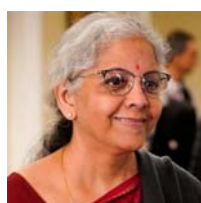

FM Sitharaman to hold post-budget meeting with RBI top brass on Feb 8

NEW DELHI: Finance Minister Nirmala Sitharaman is scheduled to address the Reserve Bank of India's central board on February 8 in a post-budget meeting to coordinate the fiscal and monetary steps required to accelerate GDP growth.

The customary meeting will take place a day after the RBI announces its monetary policy review amid expectations that it may cut interest rates for the first time in five years to spur growth as inflation has eased.

The Finance Minister has decided to stick to the fiscal consolidation path with a reduction in the fiscal deficit target to 4.4 percent of GDP for 2025-26 from 4.8 percent earlier, which has reduced the need for market borrowing by the Government.

This leaves more headroom for the RBI to adopt a soft money policy to spur growth and the Finance Minister is expected to drive home this point at the meeting. The new RBI Governor, Sanjay Malhotra, is a former Finance Ministry official and has already announced the injection of Rs 1.5 lakh crore in the banking system as the liquidity situation had become tight in the financial sector. *ANS*

India has over 300 mobile manufacturing units, exports surpass Rs 1.29 lakh cr: Ashwini Vaishnaw



NEW DELHI: India has risen to become the world's second-largest mobile manufacturer and from just 2 units in 2014, over 300 units are operational nationwide today, Union Minister for Railways and Electronics and IT, Ashwini Vaishnaw said recently.

About 99.2 percent of mobile phones sold in India are now made locally as the manufacturing value has soared to Rs 4,22,000 crore, with exports crossing Rs 1,29,000 crore in 2024. *ANS*

India is a very important market for AI, can be a leading force in world: Sam Altman

NEW DELHI: As India embarks on an exciting artificial intelligence (AI) journey, OpenAI Co-founder and CEO Sam Altman said, India is a very important market for AI and the company's second biggest market globally.

The owner of ChatGPT AI models was speaking at an event in the presence of Union Minister for Railways and Electronics and IT, Ashwini Vaishnaw.

According to Altman, who has just announced a massive \$500 billion project called 'Stargate' building new AI infrastructure in the US - with SoftBank, Oracle and MGX - over the next four years, said that India should be a leader in the AI model race.

"India is a very important market for AI. It is our second biggest market. Models are still not cheap, but they are doable. India should be a leader there of course," he told the gathering.

He also clarified that his earlier comment on India being able to make or not being able to make large language models (LLMs)

were "taken out of context".

According to Minister Vaishnaw, young entrepreneurs in the country are really focused on getting the next level of innovation that will reduce the cost and on the same lines that "we did the Chandrayaan mission,

why can't we do the same in the LLM space".

The country is likely to launch its own safe and secure indigenous AI model within six months at an affordable cost, the minister announced last month.

The Indian AI model would help the country emerge as a more reliable technological powerhouse of ethical AI solutions in the days to come. Backed by a high-end common computing facility, the IndiaAI mission is now closer to customizing indigenous AI solutions for the domestic context using Indian languages.

Scientists, researchers, developers and coders are working on multiple foundational models in this regard and with the given pace, the Union Minister expressed hope that the Indian AI model is likely to be ready within six months.

The AI model is beginning with the computation facility of roughly 10,000 GPUs. Soon, the remaining 8693 GPUs will be added. It will largely benefit researchers, students and developers in the beginning. The government has decided to give it to the users for less than Rs 100 per GPU after subsidizing 40 percent of the cost. *ANS*

Women-led Indian startups making global mark: Union Minister

NEW DELHI: Women-led startups in India are making a global mark, and they hold the promise to realize the Viksit Bharat goal, said Jitendra Singh, Union Minister of State (Independent Charge) Science & Technology.

Speaking to a delegation of the Federation of Indian Chambers of Commerce and Industry - Ladies Organization (FICCI-FLO), the Minister said that women have made a mark even in difficult sectors like the space.

He said this citing the example of India's Solar mission "Aditya L1" which is led by Nigar Shaji who became known as ISRO's "Sunny Lady".

"Women-led development is a key priority of Prime Minister Narendra Modi's governance agenda with the vision that women-led startups will place In-

dia on the global map in the years to come and our women entrepreneurs have the potential to realize that goal," Singh said.

He added that from 2014 onwards, women's empowerment has got a practical meaning with many of the welfare schemes. This includes entrepreneurship-promoting schemes like PM MUDRA and PM Vishwakarma schemes largely benefiting the women workforce. *ANS*



Tata Power posts 10 pc jump in Q3 net profit at Rs 1,188 crore

MUMBAI: Tata Power reported a robust 10 percent increase in net profit to Rs 1,188 crore for the Oct-Dec quarter of the current financial year compared to the corresponding figure of Rs 1,076 crore in the same period of 2023-24.

The Tata Group company said the strong performance was due to better realization in the core business segments comprising power generation, transmission, distribution and renewables.

The consolidated revenue of the power major during the third quarter rose 3 percent to Rs 15,793 crore from Rs 15,294 crore during the same period last year, according to the company statement.

The company's earnings before interest, taxes, depreciation, and amortization (EBITDA) increased by 7 percent to Rs 3,481 crore from Rs 3,250 crore in the year-ago period.

Tata Power said its renewable business in Q3FY25 recorded a 59 percent jump to Rs 214 crore and by 41 percent to Rs 787 crore over nine months of the current financial year. The clean and green portfolio now stands at around 6.7 GW installed and a pipeline of 10 GW, which will take the total portfolio to over 16.7 GW.



With close to 2.5 GW of rooftop installations nationwide, the Company has advanced its #GharGharSolar initiative to Tamil Nadu, building on the success in Rajasthan, Uttar Pradesh, Kerala, and Chhattisgarh.

With capex investments of Rs 3,000+ crore in the first 9 months of FY25, the Transmission & Distribution business reported 7 percent growth in net profit to Rs 370 crore in Q3FY25 and 32 percent to Rs 1384 crore in the nine months of the financial year, according to the company statement.

Praveer Sinha, CEO and Managing Director of Tata Power said the company has delivered a sustained PAT (profit after tax) growth trajectory over the last 21 quarters and that all the businesses have been contributing to this growth.

"We have emerged as a clean energy leader with a presence across the full value chain of manufacturing, EPC, and development of renewable projects along with retail supply through group captives. As an integrated power company, we offer complete energy services towards our portfolio of generation, transmission and distribution solutions to provide affordable power for all," Sinha added. *IANS*

India's premium smartphone market grows 36 pc, affordable 5G share at 80 pc

NEW DELHI: India's premium smartphone segment continued its strong double-digit growth momentum last year, with Apple, for the first time, securing a spot among the top five smartphone brands in India in Q4 2024, according to a new report.

Apple recorded a 72 percent YoY growth, capturing an 11 percent market share in Q4.

Similarly, the super-premium smartphone segment and uber-premium segment (above Rs 1,00,000) posted impressive gains, up 10 percent and 25 percent, respectively, according to the CyberMedia Research (CMR) report.

Apple's market share in the super-premium segment (Rs 50,000-Rs 1,00,000) segment skyrocketed by 82 percent YoY, while the uber-premium segment (Rs 1,00,000) surged by 32 percent YoY.

Aggressive marketing, deep festive discounts, and strong demand for both latest and previous-generation iPhones enabled this market growth, according to the report.

According to Menka Kumari, senior analyst, Industry Intelligence Group (IIG), CMR, in 2024, India's smartphone market presents a complex picture of a heterogeneous consumer base.

On one end, the premium segment continues to expand, reflecting a shift toward high-performance lifestyle statements. On the other hand, less than Rs 10,000 segment is experiencing green shoots of recovery, she mentioned.

Across price segments, affordability and accessibility initiatives are empowering consumer aspirations and driving market growth.

The India smartphone market in 2024 saw mixed trends across segments. While the affordable segment grew slightly by 1 percent YoY, the value-for-money segment declined by 7 percent, reflecting a shift toward premium smartphones, the findings showed.

The sub-Rs 10,000 5G segment saw 80 percent YoY growth in 2024, driven by new launches and rising demand for affordable, feature-rich smartphones. *IANS*



PM Modi smarter than Prez Trump, knows how to convince global leaders: Jim Rogers

NEW DELHI: Prime Minister Narendra Modi is smarter than US President Donald Trump and in the current world economic order, he is most capable of working together with the new US administration, which would be good for both the nations, veteran global investor Jim Rogers told IANS recently.

After finishing his two-day visit to Paris, PM Modi is likely to pay a two-day visit to the US beginning February 12, to hold wide-ranging talks with the US President on February 13.

Rogers said that PM Modi is going to convince many leaders in the world with his dynamic vision and capabilities, which have kept the country on the path

to become the world's third-largest economy despite geo-political uncertainties.

"PM Modi is going to meet Trump. In my view, he will be true to himself, to his own brains, that he will not get swept away by the dazzle of foreign politicians. In my view, Mr. Modi is smarter than Mr. Trump," said the 82-year-old American investor and financial commentator based in Singapore.

PM Modi will be one of the few foreign leaders to visit Washington, DC, for one-on-one talks just weeks after Trump's new administration took office.

The leaders also held a phone call last month, after which the US President said PM Modi will probably visit the White House in February.

The January 27 phone conversation was the second time the two leaders spoke after Trump's re-election - the first took place just after he had won the Presidential election in November 2024.

According to Rogers, if PM Modi continues to be true to what he knows is good for India, he's going to be fantastic.

"And I'm sure India and America can work together to be even more fantastic. PM Modi can open up the Indian economy; he is smart enough to do that. It would be good for India as well as for America," said the ace global investor.

The US President has already promised to strengthen the "great partnership" with India and PM Modi, continuing the close ties he forged in his first term. *IANS*

Mexico responds to US tariff announcement with proposal for collaboration

MEXICO CITY: Mexico's President Claudia Sheinbaum Pardo has rejected US President Donald Trump's accusations of Mexico's alleged alliances with criminal organizations. She emphasized Mexico's commitment to combating crime and drug trafficking, highlighting the need for cooperation between neighboring countries.

Trump imposes 25 percent tariffs on imports from Canada and Mexico, 10 percent on China

WASHINGTON DC: United States President Donald Trump has announced a 25 percent tariff on imports from Canada and Mexico, as well as a 10 percent tariff on goods from China, citing concerns over illegal immigration and the smuggling of drugs, including fentanyl.

The US President has taken action under the International Emergency Economic Powers Act (IEEPA), emphasizing the need to protect Americans and fulfill a campaign promise.

Trump said that the tariffs have been implemented to protect US citizens from the threats posed by illegal immigration and drug trafficking.

"Today, I have implemented a 25% Tariff on Imports from Mexico and Canada (10% on Canadian Energy), and a 10% additional Tariff on China. This was done through the International Emergency Economic Powers Act (IEEPA) because of the major threat of illegal aliens and deadly drugs killing our Citizens, including fentanyl. We need to protect Americans, and it is my duty as President to ensure the safety of all. I made a promise on my Campaign to stop the flood of

illegal aliens and drugs from pouring across our Borders, and

Christian Democratic Union Of Germany leader Friedrich Merz pushed the 'Influx Limitation Law' that advocates permanent border control with all neighboring countries and for people to be turned back at the borders, even if they make a request for asylum. DW reported.

This comes as a major setback for Merz who is running

against Olaf Scholz to be the next chancellor of Germany. The snap elections are scheduled to be held on February 23.

The polls in Germany shows that Merz has a 30 percent support and is favorite to become the Chancellor. Alternative for Germany (AfD) is in second with 20 percent support, DW reported.

"Illegal migration is not worth the risk": US Embassy spokesperson

NEW DELHI: Following the reports of a US military plane deporting migrants to India, a US Embassy spokesperson said that while specific details cannot be shared, the United States is vigorously enforcing its border and immigration laws.

The spokesperson emphasized that the actions taken send a "clear message that illegal migration is not worth the risk."

"I have received a number of inquiries on the report of a deportation flight to India. I can't share any details

on those inquiries, but I can share, on the record, that the United States is vigorously enforcing its border, tightening immigration laws, and removing illegal migrants. These actions send a clear message: illegal migration is not worth the risk," a US Embassy spokesperson said.

Notably, citing US officials, Reuters had reported that a US military plane is deporting migrants to India, marking the farthest destination for such flights under the Trump administration.

The official, who requested anonymity, said that a C-17 aircraft had departed with migrants on board, though it would not reach India only after 24 hours.

Additionally, the Pentagon has begun providing flights to deport over 5,000 immigrants held in US facilities in El Paso, Texas, and San Diego, California.

So far, military aircraft have flown migrants to Guatemala, Peru and Honduras.

Military flights are a costly way to transport migrants. According to Reuters, a military deportation flight to Guatemala last week likely cost at least USD 4,675 per

migrant, Reuters reported.

On January 24, the Ministry of External Affairs (MEA) had stated that it would facilitate the return of Indian nationals "overstaying" or residing without proper docu-

mentation in the United States or "anywhere in the world."

During a press briefing in New Delhi, MEA spokesperson Randhir Jaiswal said, "We are against illegal immigration, especially because it is linked to several forms of organised crime." ANI

Grammys host and comedian Trevor Noah earlier in the evening made an unsightly joke about Colombia and its ongoing battle with criminal activity, reports variety.com.

He said that the "Hips Don't Lie" songstress "was the greatest thing out of Colombia that isn't a Class A felony."

Trevor also talked about how the Grammy winners are chosen after a vote of 13,000 members of the Recording Academy, quipping that the voting class also included "20 million illegal immigrants."

Illegal immigration disrupting Delhi's economy, causing "notable increase of Muslim population": JNU report

NEW DELHI: Ahead of the Delhi assembly elections, the Jawaharlal Nehru University report on Illegal immigrants in Delhi revealed that the migration from Bangladesh and Myanmar has altered Delhi-NCR's socio-political and economic fabric, causing a "notable increase of Muslim population".

The JNU report elaborated on how such influx of illegal settlers has not only transformed the city's demographics but disrupted its economy, strained the resources, and also strengthened criminal networks by feeding into it.

The report also claimed that the political patronage provided to illegal immigrants, including the facilitation of voter registration, has raised concerns about electoral manipulation and democratic integrity.

The 114-page report titled - Illegal Immigrants to Delhi: Analysing Socio-economic and Political Consequences also mentioned that Illegal immigration has heightened the risk of public health crises, as overcrowded and unsanitary living conditions in migrant settlements contribute to the spread of infectious diseases.

"The presence of undocumented migrants complicates disaster response and crisis management, as these populations are often excluded from official relief efforts during emergencies," it said.

It also asserted that the porous India-Bangladesh border remains a major challenge for managing illegal immigration, with inadequate border control enabling the continued influx of migrants.

The JNU report pointed out that the lack of a comprehensive immigration policy in India has made it difficult to address the root causes of illegal migration and implement effective solutions.

"Migrants from Bangladesh and Myanmar often face discrimination and hostility from local populations, further complicating their integration into Delhi's social fabric, which creates a higher level of social tension," the report said.

It also highlighted that Illegal immigration has geopolitical implications, affecting India's relations with neighboring countries like Bangladesh and Myanmar. "Collaborative efforts are needed to address cross-border migration issues," it said.

Mentioning that the rising population density in Delhi due to migration has strained public transportation systems, the report also mentioned that the environmental impact of migrant settlements includes unregulated waste disposal, which contributes to pollution and public health hazards.

According to the findings in the JNU report, the Illegal immigration has contributed to the proliferation of criminal networks, which exploit vulnerable migrants for activities such as smuggling and trafficking.

"Efforts to deport illegal immigrants are often delayed by bureaucratic challenges the lack of cooperation from migrants' home countries, and the approach of Delhi National capital territory," it said. ANI

Israel seeks to bring in record 133,000 Thai agricultural workers in 2025

JERUSALEM: A delegation from Israel's Population and Immigration Authority, Ministry of Foreign Affairs, and Ministry of Labor, headed by the Authority's Director General, Ronen Peretz, and with the participation of the Head of the Foreign Workers Administration at the Authority, Moshe Nakash, is leaving for Thailand with the aim of promoting dialogue with the Thai government.

The discussion is intended to examine two parallel issues: Doubling the number of workers coming to work in the agricultural sector, within the framework of the existing agreement. Currently, there are approximately 38,000 Thai agricultural workers in Israel. With preparations being made for the entry of a record number of approximately 13,000 agricultural workers in 2025.

The second issue was promoting a framework agreement for additional employment sectors, including construction and industry.

The delegation will meet with relevant government officials in Thailand, hold professional meetings, and return towards the end of the week. ANI/TPS

Rs 1 lakh crore Urban Challenge Fund to implement 'Cities as Growth Hubs'

NEW DELHI: Union Finance Minister Nirmala Sitharaman, while presenting the Budget 2025-2026 in the Parliament last week, said the Government will set up an Urban Challenge Fund of Rs 1 lakh crore to implement the proposals for 'Cities as Growth Hubs', 'Creative Redevelopment of Cities' and 'Water and Sanitation' announced in the July Budget.

She further added this fund will finance up to 25 percent of the cost of bankable projects with a stipulation that at least 50 percent of the cost is funded from bonds, bank loans, and PPPs. An allocation of Rs 10,000 crore is proposed for 2025-26.

The Budget has proposed that a National Geospatial Mission will be started to develop foundational geospatial infrastructure and data. Using PM Gati Shakti, this Mission will facilitate the modernization of land records, urban planning, and design of infrastructure projects.

Sitharaman said that the Government has been giving priority to assisting urban poor and vulnerable groups. A scheme for the socio-economic upliftment of urban workers, will be implemented to help them improve their incomes, have sustainable livelihoods and, a better quality of life.

Gig workers of online platforms provide great dynamism to the new-age services economy. "Recognizing their contribution, our Government will arrange for their identity cards and registration on the e-Shram portal. They will be provided healthcare under PM Jan Arogya Yojana. This measure is likely to assist nearly 1 crore gig-workers," she said.

The Finance Minister highlighted that the PM SVANidhi scheme has benefitted more than 68 lakh street vendors giving them respite from high-interest informal sector loans. 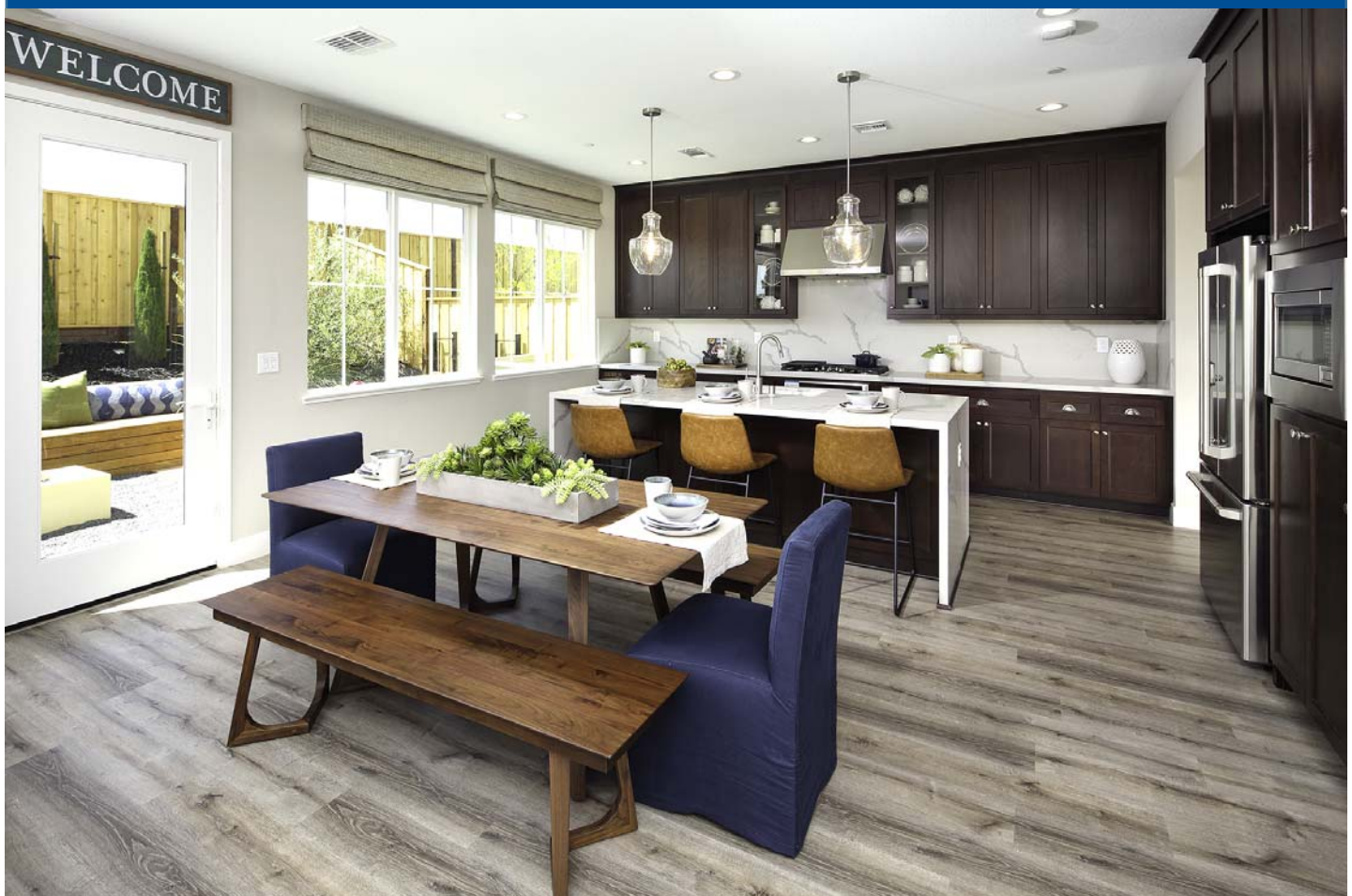

NEW DELHI: Confidence in India's economic growth remains strong and 62 percent of high-net-worth individuals (HNIs) and ultra high-net-worth individuals (UHNIs) have expressed desire to buy luxury properties in the country in the next 12-24 months, according to a recent report.

Affluent buyers believe that India will continue to be the fastest-growing major economy, with GDP growth projected to hover between 6 percent and 6.5 percent, said the annual 'Luxury Residential Outlook Survey 2025' conducted by India Sotheby's International Realty (ISIR).

The steady confidence underscores real estate's enduring appeal as a wealth-building asset. The number of ultra high-net-worth individuals in India has reached 13,600 in 2024, with projections of a 50 percent increase by 2028.

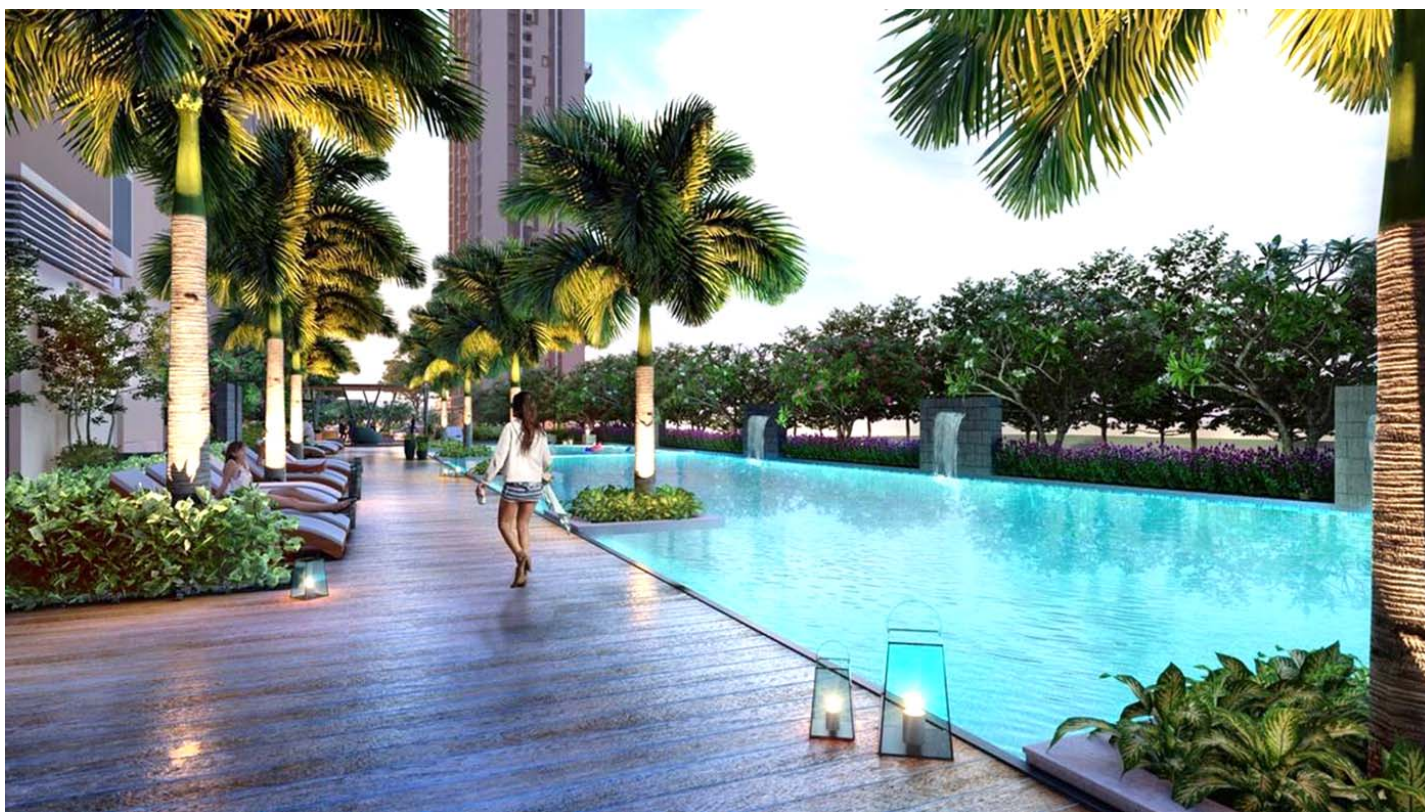
HNIs and UHNIs remain primarily motivated by capital appreciation, with 55 percent citing it as their main reason for investing in luxury residential real estate in 2025, up from 44 percent in 2024.

Nearly half of respondents expect real estate investments to deliver returns between 12 percent and 18 percent, while 38 percent anticipate returns below 12 percent.

Fewer than 15 percent foresee returns exceeding 18 percent, reflecting more realistic expectations after three years of strong gains, according to the report.

"As we look ahead to 2025, India's luxury real estate market is primed for continued growth, though with a more cautious optimism. We believe demand for trophy and bespoke luxury assets, especially spacious farmhouses and gated

community villas in hill and beach destinations will be a significant trend in the coming year," said Amit Goyal, MD of India Sotheby's International Realty.

India stands out as a frontrunner, with billionaires here experiencing a staggering 42 percent surge in collective wealth, now exceeding \$905 billion, according to the UBS "Billionaire Ambitions Report."

Over the past decade, India's billionaire count has more than doubled to 185, with their total wealth tripling. This solidifies India's position as the third-largest base for billionaires globally, just behind the US and China, Goyal noted.

The survey also highlighted a rising interest in second and holiday homes, with 54 percent of respondents considering

properties in hill or beach destinations.

Convenience is a key factor, as 55 percent prefer homes within a four-hour drive, while only 20 percent opt for international locations.

Among global markets, Dubai has overtaken London as the top choice, with US cities also gaining attention, said the report IANS

In a roundtable discussion, speakers at EMS news brief discussed the policy implications of President Trump's executive order, the impact on their lives, and attempts to push back. The executive orders issued by President Trump so far include restricting gender-affirming healthcare for transgender people under the age of 19; banning transgender people from joining the military; canceling DEI programs (diversity, equality, etc.) in government, military and other institutions. The President's executive order has deep, adverse impacts for the nation's 1.6 million transgender people. It essentially erases transgender people's existence in legal matters, healthcare, and education sites. The move comes amid a rise in hate crimes against transgender people.

Jordan Willow Evans, Executive Committee, MassEquality said she is a transgender Republican. She said that

these executive orders of Trump were formed under the promotion of a small group of people and do not represent the opinions of Americans.

Ilan H. Meyer, Ph.D., Williams Distinguished Senior Scholar of Public Policy at the Williams Institute and Professor Emeritus of Sociomedical Sciences at Columbia University believes that the Trump administration's executive order targeting LGBTQ+ is "cruel." He said anyone who knows transgender people knows their journey is an extremely stressful experience because of the harassment they can experience.

Bamby Salcedo, President and CEO of the TransLatina Coalition said they can implement whatever policies they want and can, but they are not going to defeat who we are as people. We hope to empower, above all, young people who feel afraid and insecure and I remind them that we stand on the men of warriors with great strength and we are going to prevail and continue being who we are.

There are certain food items that may not lead to sugar spikes, but can lead to poor insulin sensitivity, increase in cholesterol and slow down the metabolism. There are certain foods that people with diabetes are advised not to consume like simple carbs, beverages with added sugar, packaged foods and deep-fried foods among many others, as they raise

tongue, without any added calories. Eating carbohydrates increases the blood sugar levels and insulin is released to bring them back to normal. Artificial sweeteners are said to interfere with this process. Although short-term use of artificial sweeteners will not raise blood sugar levels, but long-term effects in humans are unknown.

3) Sugar-free products: Sugar-free does not necessarily mean carbohydrate-free or calorie-free. Although some sugar substitutes do not have calories, many of them do. If you eat many 'sugar-

8) Jaggery: While Jaggery is considered a safer alternative as compared to sugar for diabetics; it can still cause sugar spikes, even though Jaggery is

What foods people with diabetes should avoid?

1) White Rice, Bread and Flour: White bread, rice and refined-flour foods have high levels of carbohydrates. Eating such foods will significantly increase your blood sugar level. Moreover, gluten-free prod-

free' foods that may contain sweet tasting substances like sorbitol, mannitol, xylitol, isomalt, and hydrogenated starch hydrolysates. These foods affect your blood glucose just as sugar-containing foods would, in proportion to the number of carbohydrates in each serving of the food.

Global Parkinson's disease market to grow to \$7.9 bn by 2033: Report

NEW DELHI: The global Parkinson's disease (PD) market is expected to grow to \$7.9 billion by 2033 from \$3.4 billion in 2023, according to a report.

The report by data and analytics company GlobalData showed that the growth -- projected to increase at a compound annual growth rate (CAGR) of 8.9 percent -- will be particularly seen in seven major markets such as the US, France, Germany, Italy, Spain, the UK, and Japan.

Factors driving the growth include the introduction of 10 pipeline products and the increased adoption of novel levodopa delivery methods. The rising prevalence of Parkinson's due to the ageing population across the seven countries is also a contributing factor, the report said.

Further, it anticipates an increase in sales across most currently marketed Parkinson's drug classes. Specifically, levodopa therapies, catechol-o-methyltransferase (COMT) inhibitors, dopamine agonists, monoamine oxidase B (MOA-B) inhibitors, other antiparkinsonian agents, and Parkinson's dementia agents. *IANNS*

85 pc increase in cancer cases, deaths expected by 2050 in S. E Asia: WHO

NEW DELHI: South-East Asia region is expected to witness an 85 percent increase in the number of new Cancer cases and deaths, said the World Health Organization (WHO), ahead of World Cancer Day.

Each year 4 February is commemorated as World Cancer Day.

"The theme this year United by Unique is a reminder of the collective commitment against cancer," said Saima Wazed, Regional Director for WHO South-East Asia.

"WHO acknowledges every patient's unique experiences and the value of people-centered care delivered jointly by healthcare providers, families, friends, and community," she

added.

In 2022, the WHO South-East Asia Region had 2.4 million new cases of cancer, including

number of cancers of lips and oral cavity, uterine cervix, and childhood cancers. It is estimated that by 2050, there will be

She also noted the progress made in countries in the Region in the last few years. This includes a reduction in tobacco consumption.

"The Region has seen the fastest rate of decline in tobacco use which is a major risk factor for several high burden cancers," Wazed said.

Wazed said six countries have dedicated national plans for cancer control, and two countries have included cancer as part of the national NCD plan to strategically guide cancer prevention and control activities.

Eight countries have introduced nationwide Human Papillomavirus (HPV) vaccination.

The Regional Director said that 10 countries are implementing global initiatives for childhood cancer and seven countries have operational population-based cancer registries. In 10 countries, tertiary-level cancer care is generally available, reaching 50 percent or more patients in need.

However, some persisting challenges include scattered responses to cancer control. National cancer control programs and plans are not fully aligned with evidence or best practices resulting in their ineffective implementation.

Policies and guidance on control of cancer-causing agents prevalent in the Region, such as areca nut, are lacking.

Existing cancer prevention policies and programs are not fully implemented, leading to millions of avoidable cases, Wazed said. Late diagnosis and lack of national capacities to manage the increasing cancer burden also hinder cancer control. *IANNS*

World Cancer Day is observed every year on February 4. The theme this year is United by Unique, which highlights that every person has a distinct story, set of needs, perspectives, and circumstances that must be considered.

"The AB PM-JAY has significantly reduced the financial burden on patients, especially those from economically vulnerable backgrounds, who often face catastrophic health expenditures due to cancer. This scheme made evidence-based cancer treatment for people of low socioeconomic section a reality by seeking care without financial stress," Dr. Abhishek Shankar, Assistant Professor, Department of Radiation Oncology, Dr BR Ambedkar Institute Rotary Cancer Hospital at AIIMS, Delhi, told *IANNS*.

A study published in The Lancet Regional Health - Southeast Asia showed that AB PM-JAY has increased the odds of timely initiation of cancer treatment in India by 36 percent, highlighting the positive

impact of AB PM-JAY in enabling patients to access and afford cancer treatment.

AB PM-JAY, the world's largest publicly funded health insurance scheme, was launched in 2018 to provide health cover to 55 crore people, corresponding to 12.34 crore poor and vulnerable families.

Ayushman Bharat is a highly promising and beneficial scheme for underprivileged patients. The government covers up to 5 lakh rupees for treatment each year.

The scheme also offers nationwide portability, allowing beneficiaries to access treatment at any empanelled hospital across India.

As many as 31,077 public and private hospitals are empanelled under PM-JAY, according to the latest government data. *IANNS*



Drinkers with depression experience same stimulation as those without depression: Study

NEW YORK: People with alcohol use disorder (AUD) and depression experience high levels of stimulation and pleasure when intoxicated, similar to drinkers who do not have depression, according to a new study.

The study by the University of Chicago Medicine in the US reveals that counter the long-held belief that the pleasure people experience when drinking alcohol decreases with addiction and that drinking to intoxication is mainly to reduce negative feelings as a form of self-medication.

"We have this folklore that people drink excessively when they're feeling depressed and that it's really about self-medicating," said Andrea King, PhD, Professor of Psychiatry and Behavioral Neuroscience.

In this study of natural environment drinking and smart phone-based reports of the effects of alcohol in real-time, participants with AUD and a depressive disorder reported feeling acute, sustained positive and rewarding alcohol effects - just



like their non-depressed counterparts.

The study, published in the American Journal of Psychiatry, challenged conventional notions about alcohol's effects in depressed people who drink excessively and could improve treatment approaches by focusing medication and behavioral approaches more on alcohol's pleasure reward pathways and less on stress-responsive systems.

The effects of alcohol on the brain are complex, and improved understanding of the

factors that affect an individual's vulnerability to AUD and depression is critical to identify and initiate early, effective treatment.

The research followed 232 individuals across the U.S. between the ages of 21 to 35, corresponding to the period when most heavy drinking occurs in a person's lifetime.

Half of the study group met criteria for AUD in the past year and were evenly divided in terms of those who had or had not experienced a major depressive disorder in the past year. Individuals who had suicidal ideation were excluded for safety reasons, as were people who had severe alcohol withdrawal symptoms.

The researchers found that alcohol consumption reduced negative feelings, although the reduction was small and non-specific to their depression or AUD status.

The positive effects of alcohol were much higher in individuals with AUD than those without AUD and contrary to lore, similar in those with AUD and depression and those without depression. IANS

Women with twins 2x more at higher risk of heart disease: Study

NEW DELHI: Women who give birth to twin babies are two times more at risk of facing a heart problem than those with singleton births, according to a recent study.

The research, published in the European Heart Journal, showed that the mother of twins is at higher risk of hospitalization due to heart disease a year after birth.

Notably, the risk is even higher in those who had a high blood pressure condition during pregnancy, also known as preeclampsia.

The study, led by researchers from Rutgers University in the US, comes as "the rate of twin pregnancies world-

tions in the first year after birth, even if they had a pregnancy that was not complicated by high blood pressure conditions, such as pre-eclampsia," she added.

The study analyzed data on 36 million hospital deliveries in the US from 2010 to 2020.

The results showed a higher proportion of readmissions for cardiovascular disease within a year of giving birth in women with twins (1,105.4 per 100,000 deliveries) than those with singleton pregnancies (734.1 per 100,000 deliveries).

Compared to singleton pregnancies with normal blood pressure, people with twins with normal blood pressure were around twice as likely to be hospitalized with cardiovascular disease.

For those with twins with high blood pressure during pregnancy, the risk was more than eight times higher. However, one year after birth, deaths from any cause, including heart disease, were higher among patients with singleton pregnancies who had high blood pressure conditions compared to patients with twins with high blood pressure conditions, the study showed.

This suggests that the risk to mothers of twins decreases in the longer term, while the mothers of singletons may have other

pre-existing cardiovascular risk factors.

Lin said that patients undergoing fertility treatments, especially those with advanced age, obesity, diabetes, high blood pressure, or heart disease, should be advised that twin pregnancies may increase complications related to heart disease in the short term.

She also urged healthcare providers to continue follow-up for up to a year after birth for high-risk pregnancies. *IANS*

Study decodes how drinking sugary beverages raises diabetes risk

NEW DELHI: A team of US researchers has decoded the role of gut microbes in increasing the risk of diabetes after consuming sugary drinks.

The study, published in the paper appearing in the journal Cell Metabolism, shows that metabolites produced by gut microbes might play a role.

In the study, the team identified differences in the gut microbiota and blood metabolites of individuals with a high intake of sugar-sweetened beverages. They found that high sugary beverage intake -- defined as two or more sugary beverages per day -- led to changes in nine species of bacteria.

Four of these species are known to produce short-chain fatty acids -- molecules that are produced when bacteria digest fiber. These are known to positively impact glucose metabolism.



The altered metabolite profile seen in sugary beverage drinkers was associated with a higher risk of developing diabetes in the subsequent 10 years, said the researchers.

"Our study suggests a potential mechanism to explain why sugar-sweetened beverages are bad for your metabolism," said Qibin Qi, an epidemiologist at Albert Einstein College of Medicine in New York.

"Although our findings are observational, they provide insights for potential diabetes prevention or management strategies using the gut microbiome," Qi added.

The researcher noted that more than in solid foods, added sugar in beverages "might be more easily absorbed, and they have a really high energy density because they're just sugar and water". *IANS*

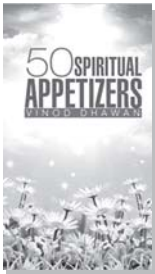

Value-neutral journalism a threatened ideal in South Asia

Journalism that aims to present facts without bias or influence is fundamental to democratic societies; it is value-neutral. Journalism that does not prioritize any particular ideology has long had a tough time operating in South Asia due to the region's complicated history, rich cultural diversity, and complex power dynamics. There is a fine line that journalists must walk in this region between exposing injustice and encountering opposition from public officials and organizations. This never-ending conflict makes one wonder how the media can maintain objectivity in this setting.

The media is crucial in countries such as Sri Lanka, Bangladesh, India, and Pakistan for influencing public opinion and ensuring that those in power are held responsible. Unfortunately, media neutrality has frequently been compromised due to its alignment with political

Just as the growth of nationalism in India has stifled dissenting opinions, it has done the same in other countries. Online harassment, threats of legal action, and social exclusion are common experiences for journalists who report on sensitive topics such as religious extremism, human rights violations, or government policies. This environment hinders news organizations' ability to conduct investigations and dissuade them from presenting fair stories. The media, on the other hand, tends to side with one political party or the other, making news coverage of both sides extremely rare.

Challenges to neutral journalism

Additionally, the challenges encountered by value-neutral journalism are illustrated by the situation in Bangladesh. The Digital Security Act and other government statutes have severely curbed press freedom. There is a high risk of detention, legal action, or even death threats for journalists who publish stories critical of government agencies or the governing party. Because of this, people are so afraid that

ideologies and power centers. Reporters often face threats of retaliation if they do not support official narratives. This isn't just happening in one South Asian country; it's a pattern where national institutions and governments have a lot of sway over the media.

Clamping down on dissent

For example, journalists in Pakistan frequently encounter a climate where voicing dissent against the government or its policies can result in charges of being "anti-state." Reporters and editors, who speak out against official policies or the military, face harassment or censorship on a regular basis. This kind of behavior discourages journalists from covering sensitive topics objectively and sends a disturbing message to the media.

Meanwhile, some journalists have abused their positions to promote their own political or corporate agendas, which has further damaged public faith in the media's ability to report the news objectively.

they are repressing their opinions in order to stay alive. Despite courageous journalists who are still exposing truths, the media as a whole is fighting for objectivity in the face of increasing pressures.

Another angle on the issue is offered by Sri Lanka. Press coverage of racial and political tensions both during and after the civil war was frequently biased. Reflecting the viewpoints of their respective communities, Sinhala-majority and Tamil media outlets offered diametrically opposed narratives. This disagreement demonstrated how challenging it is to achieve value-neutral journalism in a historically and ethnically divided society. The media still struggles with being objective when covering post-war governance and reconciliation.

India's rise a force for good in the Indo Pacific region

India celebrated its 75th year as a sovereign democratic republic on January 26. It now emerges as the power that has come of age, with its fast rising power equation and recognition. It is now the third most powerful country in Asia, according to the annual Asia Power Index 2024 by Lowy Institute, surpassing both Russia and Japan. The 2024 edition, which covered six years of data, is seen as the most comprehensive assessment to date.

The Global Firepower Index 2025 has also listed India to be the fourth most powerful military, behind the US, Russia and China. India's position is largely

precede it. While India's rapid rise will lend confidence to current partners and future allies including Quad partners Washington and Tokyo, the fraught relationship with Beijing is expected to turn in Delhi's favor with Trump back in office.

Trump, a long time friend of Modi, has more to depend on India with its growing double-edged advantage to Washington, both in India's equation with Russia and China for Trump to solidify its carrot and stick approach to both powers. The same cannot be said of other allies especially Japan, where its waning power at least as reflected in the ranking, has been

cal prowess. Its youthful, dynamic workforce and an advantageous demographic is a driving force behind this expansion, positioning India as a hub for innovation and investment. Under Modi's reforms, ventures like "Make in India" and the push towards "Atmanirbhar Bharat" further catapulted India's status as an industrial and economic base.

In the defense arena, the new push to modernize the military has seen the new focus on advanced missile systems, nuclear capacities and an expanded naval footprint and power further reinforced its status as the primary power in regional security.

Charting itself as the growing power in new sectors including digital technology, space exploration, renewable energy and quantum capacity, initiatives under the vision of Modi have seen a booming start-up economy and advances in energy transition and the initiative of Digital India have further consolidated its primary leadership in these fields.

The demographic dividend remains the standout feature. By 2030, India is projected to have the world's largest working-age population, providing a long-term boost for its economic growth and innovation.

Challenges on India's road to superpower status remain. Despite India's new rise, systemic limitations persist that limit its ability to project power far beyond its near shore, especially the east of the Malacca Strait. However, the fact that its influence remains well below the level promised by its resources suggests it still has ample potential for further growth as a major power.

India has a holistic advantage both in emerging internal settings and external presence. Demographically, it is now the world's most populous nation, surpassing China. It also has the highest birth rate in the world, with 2651 babies born every hour, more than twice of China at 1016 and more than five times of the US which stood at 418.

Trump's return to India's advantage

For India under Modi, the path towards both defense and socio-economic reform has never been more profound and far-reaching in the decades that

BUDGET FOR MIDDLE CLASS

The Union Budget in India for 2025-26 has mainly targeted the middle class, personal income tax slabs, as well as exemption to all those earning up to Rs 12 lakh per annum. There is also relief, which will extend to individuals of higher income brackets in the new tax laws. The Union Budget has been aimed at honest taxpayers and brings relief to middle-income taxpayers. It also encourages the honest taxpayers and trust factor. This is welcome.

Acknowledging the honest taxpayer and giving the relief is good politics meeting good economics. Indeed, Sitharaman underlined the Narendra Modi government's belief in the "admirable energy and ability of the middle class in nation building". That, in a way, was also an admission of the growing restiveness of a section, which has seen no real salary increase and a drying up of remunerative employment opportunities in recent times. At a time when welfare schemes targeting the lower end of the social and economic pyramid have become for all parties key to their political and economic discourse, the middle-class taxpayer imperative is stronger than ever. No wonder the word "middle-class" appears nine times in the latest budget speech, as against only three times in the last one presented just over six months.

The Indian economy today needs less fiscal stimulus and more monetary and reform stimulus. Creditably, there are no new fiscally imprudent scheme announcements in the latest budget. There is unfinished business, though. Prime Minister Narendra Modi has framed the budget as a "force multiplier" that will spur savings, investment, consumption and growth. To that effect, ensuring a higher disposable income in the hands of the taxpayer and staying away from fiscal adventurism are key but important challenges remain: Lack of investment and job creation, with knock-on effects on income and spending. The ongoing slowdown, contrary to the government's claims, predates the geo-economic fragmentation and retreat of globalisation gaining force with the return of Donald Trump and his ushering in of potential trade wars. Modi has already made some adjustments in allowing US made "Harley Davidson Motorcycles" by lowering tariffs before his upcoming meeting with Donald Trump.

The private sector has not been investing in building new capacities, despite the government cutting corporate tax rates back in September 2019 and companies sitting on huge cash piles. Even schemes such as production linked incentives have met with limited success. It has pinned hopes on the income tax-cut, leaving more disposable income in the hands of tax-paying households, which will revive sputtering consumption demand.

There should be a big push to small and medium businesses which comprises major portion of the Indian economy and incentivize corporations to invest in up-skilling their employees. Whether households choose to either spend or, simply save the tax bonanza, like corporates have done, will be known only in the months that follow. Another area that needs immediate attention is to push disinvestment with loss making Public Sector institutions. This will further give the government opportunity to spur growth. The Union Budget also put emphasis on developing semiconductor industry and solar energy, which will definitely give rise to employment amongst the youth.
