





"In Fort Wainwright, Alaska, Indian Army and US Army warriors conducted live fire drills today," the Embassy of India in Washington posted on X on Monday (8 Sent)

As part of this exercise, a total of 450 soldiers from each side are taking part in field and command post exercises while also engaging with subject-matter experts (SMEs) to further strengthen operational synergy.

According to the Indian Embassy, recently, during the field training component of the exercise, soldiers from the Indian



army and the US army rehearsed various battle drills together.

The Indian Army contingent, comprising 450 personnel led by a battalion of the Madras Regiment, arrived in Fairbanks on August 31.

They are training alongside US soldiers from the 1st Battalion, 5th Infantry Regiment ("Bobcats"), part of the 1st Infantry Brigade Combat Team (Arctic Wolves), 11th Airborne Division.

The 2025 edition is one of the largest bilateral military exercises for the Indian Army in terms of troops mobilized.

This edition includes mountain and high-altitude operations under sub-arctic conditions, heliborne and air-mobility integration, backed by artillery and aviation assets

Additionally, it will also focus on elec-

tronic warfare, surveillance, and counterdrone systems, medical evacuation and combat casualty care in field conditions, and live-fire tactical drills to validate seamless interoperability.

Yudh Abhyas currently stands as a flagship, high-complexity Army-to-Army exercise and has become one of the cornerstones of India-US military cooperation. India conducts more military exercises with the US than with any other country, the Indian Embassy mentioned.

"India conducts more military exercises with the US than with any other country. These exercises, including Yudh Abhyas, Malabar, COPE India, Vajra Prahar, Tiger Triumph and several others, are central to building interoperability and forging mutual trust. It demonstrates how our two democracies continue to work towards peace, security and prosperity, including in the Indo-Pacific region," the Embassy added. *IANS* 

## US Supreme Court allows immigration raids in LA amid crackdown in Chicago

WASHINGTON: In a major legal victory for the Trump administration, the US Supreme Court on 8 September lifted a lower court injunction that had barred Immigration and Customs Enforcement (ICE) from conducting indiscriminate immigration

raids in the Los Angeles area

The 6-3 decision granted an emergency appeal from the Trump administration, allowing agents to resume operations while the case proceeds in the 9th US Circuit Court of Appeals.

The Supreme Court majority provided no explanation, but Justice Brett Kavanaugh concurred separately, noting that agents could

question based on "common sense criteria" such as day labor employment or limited English proficiency.

Kavanaugh also wrote, "The Judiciary does not set immigration policy or decide

enforcement priorities."

Justice Sonia Sotomayor dissented, joined by the two other liberal judges, writing, "We should not have to live in a country where the Government can seize anyone who looks Latino, speaks Spanish,

and appears to work a low-wage job."


In July, a US District Judge ruled that the raids likely violated constitutional rights and prohibited stops based on race, ethnicity, or language.

After the 9th Circuit Court declined to block the order in early August, the Trump administration moved to the Supreme Court with an emergency petition.

The ruling comes as the Department of Homeland Security announced that it has started its campaign, called "Operation Midway Blitz," against illegal migrants in Chicago. *IANS*

## Simulated invasion shows China targeting Taiwan's energy lifelines, says US-based think tank

TAIPEI: A prominent US-based think tank has cautioned Taiwan to urgently address critical weaknesses in its energy infrastructure, warning that its dependence on Qatari liquefied natural gas (LNG) could leave it vulnerable to Chinese geopolitical pressure, as reported by the Taipei Times.

According to the Taipei Times, the Foundation for Defense of Democracies (FDD) released a report following a tabletop simulation held in July that explored potential Chinese strategies to disrupt Taiwan's energy supplies.

The two-day exercise involved experts from Taiwan, Japan, Australia, and the UK and simulated a cyber-enabled economic warfare (CEEW) campaign aimed at crippling Taiwan's LNG and coal imports.

The FDD warned that China could use

a combination of cyberattacks, diplomatic maneuvers, and military intimidation to interfere with Taiwan's energy lifelines, particularly its LNG shipments from Qatar, which accounts for around 30% of the nation's gas imports. The report argued

generates nearly half of its electricity from LNG and relies entirely on imports for both gas and coal. With limited energy storage capacity, any significant disruption could force the government to make tough decisions between sustaining essential ser-

that Qatar, despite its long-term energy agreement with Taiwan, could yield to Beijing's influence.

According to the Taipei Times, Taiwan

vices and keeping its vital semiconductor industry running.

To reduce risk, the FDD suggested that Taiwan diversify its LNG sources, potentially by securing more imports from the United States, even at higher prices, while also investing in additional storage, renewable energy, and even considering a return to nuclear power. The report also called for stronger grid infrastructure and cyber defense capabilities.

Taiwan phased out its last operational nuclear reactor in May 2024 as part of a longstanding policy shift. However, the think tank argues that reactivating nuclear plants might now be necessary for national security, as highlighted by the Taipei Times.

The FDD urged stronger coordination with global allies. As noted by the Taipei Times, countries like Australia, Japan, and the US could play key roles in safeguarding Taiwan's energy resilience in the event of a crisis. ANI

## PoJK PM accused of terror links; Amjad Ayub Mirza slams PoJK govt for promoting terror

LONDON: Pakistan-occupied Jammu and Kashmir (PoJK) Prime Minister Chaudhry Anwar ul Haq is facing severe criticism for openly endorsing terrorism and aligning with jihadi organizations.

PoJK activist and political analyst Amjad Ayub Mirza has accused him of using his position to promote radical ideology, warning that his actions pose a direct threat to peace and stability in the region.

Speaking in a strong statement, Mirza alleged that Haq has been inviting extremist organizations to his public meetings and has made open calls for jihad.

"You see, this is no secret that the Prime Minister of Pakistan-occupied Jammu and Kashmir himself has been inviting all the Jihadi organizations to his public meetings and has been raising slogans of Al-Jihad, Al-Jihad and he has publicly confessed that his government is going to facilitate Jihad in Indian Kashmir," Mirza said.

He questioned why Haq has not been prosecuted by the United Nations for promoting terrorism.

"He is promoting terrorism publicly and there are public statements, his press

statements, he has been quoted in the media but he still remains the Prime Minister of Pakistan-occupied Jammu and Kashmir. He has been supporting all the rallies that have been taking place in Muzaffarabad and other places," he

Mirza also highlighted the deep-rooted political suppression in the region, describing PoJK as nothing more than a colony the civil rights, economic rights and political rights movement," he asserted.

He pointed to the rise of the Joint Awami Action Committee (JAAC), a growing people's movement in PoJK, which he said has become a legitimate representative of the people's will.

"The Joint Awami Action Committee is the only legitimate representative of the people's will in Pakistan-occupied Jammu

under Pakistan's control.

"Pakistan-occupied Jammu and Kashmir is a colony of Pakistan and one of the main jobs that has been designated to the so-called Legislative Assembly and the government of Pakistan-occupied Jammu and Kashmir is to suppress public discontent, to suppress public mobilization against the government and to suppress

and Kashmir. This has never happened in the past 78 years that the masses have agreed to support one entity, and that entity is the Joint Awami Action Committee. Therefore, the Joint Awami Action Committee is looked upon as a threat not only by the Pakistan-occupied Jammu and Kashmir government but also by the Pakistani government," Mirza explained. ANI

## Northern Alliance in splinters, India deepens pragmatic engagement with Taliban

NEW DELHI: More than four years after the Taliban returned to power in Kabul following the withdrawal of U.S. troops in 2021, Afghanistan's political reality has shifted irreversibly.

Once the most formidable opposition to the Taliban, the Northern Alliance | - which held sway in the 1990s and early 2000s from its stronghold in Panjshir Valley - has now all but collapsed, reduced to scattered voices abroad with little to no support at home or internationally.

Ahmad Massoud, son of the legendary anti-Taliban commander Ahmad Shah Massoud, has attempted to revive his father's legacy by positioning himself as the de facto leader of a resistance front.

He has reportedly, in the past few months, organized conferences in Western capitals, hoping to galvanize political and financial backing. IANS

## 'Oli's ego has turned to ashes': Nepal residents react after PM's resignation amid protests

KATHMANDU: As Nepal's Prime Minister K.P. Sharma Oli resigned amid mass protests sweeping across the country, the announcement on Tuesday (9 Sept) was met with mixed emotions - from anger to relief - as citizens accused him of leading a "corrupt" and "oppressive" government and some declared that "Oli's ego has turned into ashes".

IANS spoke to several residents of Nepal, who expressed their reactions to the resignation, calling it inevitable after days of civil unrest and growing youth-led demonstrations.

"This was expected. Prime Minister Oli had no option left but to resign. His government was corrupt and completely detached from the public's needs," a resident said.

"More than 42 cabinet ministers have stepped down. There is no law and order left. I fear the military may soon take over "

Another protestor said: "Oli's resignation was bound to happen. Ministers are resigning one after the other. Let's see what comes next."

Condemning the use of force during

the protests, one resident said: "It's unacceptable that guns were used against protestors. What happened was wrong. But now, Oli has finally stepped down."

Pointing to systemic issues, another citizen said: "Under Oli's government, corruption thrived. The people of Nepal received nothing in return. The youth, especially students and teenagers, took action-and it's commendable."

Another added: "The situation left Oli

# Mauritius PM Ramgoolam begins 8-day India visit, receives warm welcome in Mumbai

MUMBAI: Mauritian Prime Minister Navinchandra Ramgoolam arrived in Mumbai for a State visit to India, to further strengthen the Enhanced Strategic Partnership between the two nations.

The Mauritian PM will be in India till September 16. This is his first overseas bilateral visit to India in his present term.

"A visit that will further strengthen the India-Mauritius

Enhanced Strategic Partnership. Warm welcome to PM Dr. Navinchandra Ramgoolam of Mauritius as he arrives in Mumbai on a State Visit to India," the Ministry of External Affairs (MEA) said in a post on X.

He is scheduled to attend a business event in Mumbai. During his visit to India, Ramgoolam will call on President Droupadi Murmu and hold discussions with Prime Minister Narendra Modi to further the Enhanced Strategic Partnership.

Apart from Mumbai, the Mauritian PM is scheduled to travel to Varanasi, Ayodhya and Tirupati.

Varanasi is all decked up for PM Modi and Mauritian PM Ramgoolam's visit on September 11 with elaborate arrangements and decorations.

Earlier, Ramgoolam had visited India in 2014, as the only non-SAARC leader invited to attend the swearing-in ceremony of PM Modi and the Council of Ministers.

In a press release, the MEA stated, "India and Mauritius share a close and special relationship rooted in shared historical, cultural and people-to-people ties. As India's key maritime neighbor in the Indian Ocean Region, Mauritius holds a special place in India's Vision MAHASAGAR (Mutual and Holistic Advancement for Security and Growth Across Region) and the 'Neighbourhood First Policy' and is a key partner in the Global South"

The ministry said that the Mauritian PM's visit to India, following the visit of PM Modi to the East African nation in March 2025, will advance the "strong and enduring bonds" between the two countries.

PM Modi went to Mauritius in March for a two-day State visit at the invitation of Ramgoolam to attend the country's 57th National Day celebrations.

During the visit, he held a bilateral meeting with Ramgoolam and Mauritian President Dharam Gokhool.

Mauritius was one of the handful of important countries with which independent India established diplomatic relations in 1948, even before the independence of Mauritius.

The relationship has been characterized by a high level of trust and mutual understanding at the leadership level and continued high-level political engagement, according to the MEA. *IANS* 

## Japan PM and Asia's defense against tariffs

NEW DELHI: On his way to attend the Shanghai Cooperation Organization (SCO) summit in Tianjin, China, Prime Minister Narendra Modi made a two-day official visit to Japan in late August.

In deliberations with the then Prime Minister Shigeru Ishiba of Japan, the two premiers appreciated the partnership over the last decade and held discussions on ways to strengthen it.

The two countries adopted a 10-year roadmap to deepen the India-Japan Special Strategic and Global Partnership. This included Japan committing to double its investment in India to JPY 10 trillion (roughly USD 67 billion).

India and Japan also pledged to work jointly in other areas, including high-speed rail, metro systems, enhancing financial, SME, agri-business, and ICT collaboration etc.

Around the same time, Japan's top trade negotiator Ryosei Akazawa called off his US visit at the last minute. The sudden decision was linked to bilateral issues that still needed to be debated at the administrative level. *IANS* 

## "Israel and India negotiating with US administration over tariffs now": Israel's Finance Minister

NEW DELHI: Israel's Finance Minister Bezalel Smotrich expressed optimism about reaching an agreement with the US on tariffs, despite current trade tensions.

Speaking in Delhi with ANI, Smotrich highlighted the long-standing relationships between India, Israel, and the US, noting that differences are natural but can be resolved through dialogue.

Smotrich praised the strong appreciation between the leaders of the three countries - Prime Minister Narendra Modi, President Donald Trump, and Prime Minister Benjamin Netanyahu. He emphasized that Israel and India share common values, friends, enemies, and economic interests, which form a strong foundation for their relationship.

"India and America go back many years. Israel and India go back many years... Each of the bilateral relations goes back many years and it's perfectly okay that there are differences within this relationship. There is a great appreciation between each of the three leaders, Prime Minister Modi, President Trump and Prime Minister Netanyahu. Both of our countries, Israel and India, are negotiating with the United States administration over tariffs nowadays." *ANI* 

# C.P. Radhakrishnan elected new Vice President

NEW DELHI: NDA nominee and Maharashtra Governor C.P. Radhakrishnan was on Tuesday 9 September, elected as the new Vice President, securing a comfortable victory in what was billed as a rare 'South' electoral contest.

Announcing the results, Rajya Sabha Secretary-General P.C. Mody said that Radhakrishnan polled 452 first preference votes, defeating opposition nominee and former Supreme Court judge Justice B. Sudarshan Reddy, who received 300 first preference votes.

The election witnessed a strong turnout with 752 members casting their votes out of the total 782 in the electoral college.

The Vice President is chosen by an electoral college comprising members of both Houses of Parliament - 233 elected and 12 nominated members of the Rajya Sabha (which presently has five vacancies) and 543 members of the Lok Sabha (one vacancy). This year's contest carried symbolic weight as both candidates hailed from the South.

Radhakrishnan, a veteran leader from Tamil Nadu with a long-standing association with the Rashtriya Swayamsevak Sangh (RSS), was pitched by the NDA as a grassroots leader with administrative experience.

Justice Reddy (retd), from Telangana, was projected by the opposition as a distinguished legal mind who could strengthen constitutional values in the second-highest office of the land.

The election was conducted through a secret ballot, following the system of proportional representation by means of a single transferable vote.

Radhakrishnan's victory adds to the NDA's tally of key constitutional positions.

The election was necessitated by the sudden resignation of incumbent Jagdeep Dhankhar, whose term was to last till 2027, in July.

As the Vice President, Radhakrishnan will also function as the ex officio Chairman of the Rajya Sabha, a role that places him at the heart of parliamentary proceedings, amid the frequent disruptions that have affected the sessions of both houses. *IANS*

# India's gold ETFs attract \$233 million in August

NEW DELHI: India's gold exchange-traded funds (ETFs) saw net inflows of \$233 million in August 2025, marking a 67 percent jump from the \$139 million reported in July, as per World Gold Council data.

This marks the third straight month of inflows globally, and the fourth month of inflows in India, highlighting steady investor appetite for the yellow metal. Except for March and May, every month of 2025 has seen inflows.



In India, the price of 24-carat gold per gram is at Rs 10,634 on Monday (8 Sept), according to data published by the India Bullion and Jewelers Association (IBJA).

Year-to-date inflows in ETFs stood at \$1.23 billion, just shy of the full-year total of \$1.29 billion for 2024. India's gold ETFs attracted approximately \$310 million in 2023, up from \$33 million in 2022. *IANS*


# US proposes new annual approval system for Samsung, SK Hynix semiconductor equipment shipments to China

SEOUL: Instead of the previously more flexible regulations, the U.S. Department of Commerce is considering a new system of granting annual approvals for semiconductor equipment shipments to Chinese factories operated by Samsung Electronics Co. and SK Hynix Inc., as per a report by Pulse, the English service of Maeil Business Newspaper Korea.

Although still under review, the permanent comprehensive status applied until now will no longer be available. However, the worst-case scenario, requiring case-by-case approval for every single piece of equipment brought into the Chinese plants, appears to have been avoided.

Citing Bloomberg, the recent report stated that, during discussions with South Korea last week, the U.S. Commerce Department proposed a "site license" system.

Under this arrangement, companies such as Samsung and SK Hynix, which operate semi-

conductor fabs in China, would submit detailed annual lists of the equipment, components, and materials they need, and obtain U.S. government approval on a yearly basis.

The "site license" system is stricter than the Validated End-User (VEU) program, which granted indefinite comprehensive approval for importing equipment into China.

The Trump administration revoked VEU status for Samsung and SK Hynix after about three years. "While the site license is procedurally more complex than VEU, it is seen as a sec-

ond-best option that allows Korean semiconductor companies to continue running their Chinese plants," the report noted.

The Trump administration has consistently argued that the VEU system, introduced under the previous Biden administration, was a regulatory loophole and has maintained its stance against reinstating it.

As a result, the industry had feared a worst-case scenario of requiring approval for every shipment of equipment.

According to U.S. federal estimates, the two companies could have been forced to seek as many as 1,000 approvals annually. If site licenses are introduced, Korean chipmakers would be spared from having to obtain approval every time they import equipment.

The report, citing Bloomberg, stated that the plan could be viewed as a practical compromise, offering more predictability than case-by-case permits. ANI

## 'Airbnb adds Rs 113 billion to India's GDP, supports 1.11 lakh jobs last year'

NEW DELHI: Hospitality major Airbnb contributed Rs 113 billion to India's economy in 2024, helping support 111,000 jobs while contributing Rs 24 billion in wage income, according to a new report.

New research by Oxford Economics, commissioned by Airbnb, shows that the platform made a significant contribution to India's economy in 2024.

Airbnb-supported tourism helped support approximately 38,000 jobs in transport and storage, 19,600 in food and beverage services, 16,800 in wholesale and retail trade, and 10,700 in manufacturing.

Last year, domestic travellers comprised around 91 percent of Airbnb guests in India, a notable rise from approximately 79 percent in 2019.

According to the report, this was fuelled by a surge in domestic travel, corresponding to stronger demand from younger Indian Airbnb guests, and positioned India as one of Airbnb's fastest growing markets.

Among international guests, the largest inbound sources were the United States, United Kingdom, Canada and Australia. In 2024, Airbnb guest spending in India reached Rs 112 billion, which includes both accommodation and

non accommodation expenses.

The report further mentioned that Airbnb's footprint accounted for 0.5 percent of India's travel and tourism GDP in 2024, and

supported 0.2 percent of tourism-related employment equivalent to one in every 417 tourism-related jobs.

Beyond front-line tourism



sectors, Airbnb-generated activity injected significant value into the wider economy: contributing Rs 31 billion in transport and storage, Rs 15 billion in agriculture, Rs 13 billion in real estate and Rs 12 billion in manufacturing.

"India's tourism sector is driven by strong demand amongst domestic travellers. From bustling urban cities to tranquil small towns, Indian travellers are exploring the richness and diversity of their own country," said James Lambert, Director of Economic Consulting Asia for Oxford Economics. IANS

# India, Israel sign Bilateral Investment Agreement to bolster economic ties

Scindia said, "The reliability of the postal network combined with the speed of UPI means families across borders can send money faster, safer and at much lower cost. It reaffirms that public infrastructure built for citizens can be linked across borders to serve humanity better."

# Textile sector needs incentive cushion as 50% US tariffs too steep to absorb: Report

NEW DELHI: The textile industry in India urgently requires an incentive cushion; as the recently imposed 50 percent tariffs by the United States are too steep for exporters to absorb, according to a recent report by Emkay Research.



The report highlighted that such high tariff levels will lead to erosion of already low margins in the sector, which is struggling to stay competitive in global markets.

It stated, "Around 50 percent US tariffs--too steep to absorb--will require incentive cushion."

The report noted that the additional 10 percent baseline

tariff imposed by the US on April 2, 2025, has already started impacting margins.

In the 90-day window after the fresh duty, the tariff burden was equally shared between exporters and customers in order to protect margins.

However, with cumulative tariffs now at around 50 percent, exporters are finding it difficult to bear the pressure, leading to margin stress and inventory overhang.

The report highlighted that government support is crucial, especially for micro, small and medium enterprises (MSMEs). Unlike large exporters, MSMEs lack balance-sheet strength and are highly vulnerable to disruptions in international trade.

While near-term disruption is evident, the report said medium-term cushioning factors such as domestic demand, free trade agreements (FTAs), and structural

reforms provide tailwinds.

However, it added that the timeline for relief measures will be vital for stability. India's global textile market share stands at around 4 percent, much lower than Bangladesh at 13 percent and Vietnam at 9 percent, with execution challenges slowing FTA gains. *ANI* 

# U.S.-India Business Council applauds Trump, Modi positive remarks, urges to conclude trade deal

NEW DELHI: The U.S.-India Business Council (USIBC) has welcomed the recent positive remarks made by President Donald Trump and Prime Minister Narendra Modi.

## India in touch with Albanese govt, diaspora: MEA

NEW DELHI: India remains in touch with the Australian government and various diaspora organizations over the recent anti-immigrant protests that took place in the country, the Ministry of External Affairs (MEA) said recently.

While addressing a media briefing, MEA spokesperson Randhir Jaiswal stated that the Indian High Commission in Australia had shared concerns raised by Indian community members with the Australian government before the protests. The High Commission had received a formal response from the Australian side, where they acknowledged that the protests were of concern for diverse communities in Australia.

When asked about the antiimmigration protests in Australia and singling out of Indians, Jaiswal responded, "We all are aware that anti-immigrant protests happened in several cities in Australia on 31st of August. Our High Commissioner and Consulate Generals in Australia, they were in regular touch with the Australian Government as also with our community members in this regard. As you know that we have a large diaspora in Australia, almost about a million. Before the protests took place, our High Commission conveyed whatever concerns that were shared with them by the Indian community members to the Australian government. In response, we actually received a formal response from the Australian side, where they acknowledged that the protests in Australia may be of concern for Australia's diverse communities."

"At the same time, we would have seen that senior leaders and politicians, both from the Australian government side and also from the opposition side, they have issued statements supporting the multicultural identity of Australia. They've also recognized the role played by the Indian Australian community in the overall progress and development of Australia and they appreciate and acknowledge this role very much. On our side, we continue to firmly believe that diversity is strength. IANS

## US to restrict visas of Central Americans "acting" on behalf of China: Marco Rubio

WASHINGTON DC: US Secretary of State Marco Rubio announced that United States would restrict visas of Central American Nationals who are "acting" on behalf of the Chinese Communist Party (CCP) to carry out activities that undermine the rule of law in Central America.

The press statement by Marco Rubio announced a new visa restriction policy to allow the US to restrict US visas for "Central American nationals who, while in Central American countries and intentionally acting on behalf of the Chinese Communist Party (CCP), knowingly direct, authorize, fund, provide significant support to, or carry out activities that undermine the rule of law in Central America."

The statement emphasized that the United States is committed to "countering China's corrupt influence in Central America and stopping its attempts to subvert the rule of law."

It also mentioned that steps are being taken to impose visa on a number of Central American nationals who have previously engaged in such activities.

"As a result, these individuals and their immediate family members will be generally ineligible for entry into the United States," the statement read.

Secretary Rubio said that these actions reaffirm President Trump's commitment to protect America's economic prosperity and national security interests in

The raid at the Hyundai Metaplant in Ellabell, Georgia, houses an electric vehicle battery plant jointly operated by South Korea-based companies Hyundai and LG Energy Solution, as reported by CNN.

Of the 475 people detained, about 300 of them were South Korean, officials said as cited by CNN.

The raid is being seen as one of the most extensive immigration raids in recent American history.

CNN reported that the South Korean government has been actively working along with the Korean Embassy in Washington DC and the Consulate General in Atlanta for securing a release of the workers. ANI

## "Bullying the small": China criticizes US over Central America visa restrictions

BEIJING: China has criticized United States of America for imposing visa restrictions on Central American nationals and for accusing the region's exchanges with China, calling it "yet another example of the US-style diplomacy of "bullying the small."

A statement by the Chinese Ministry of Foreign Affairs (MFA) spokesperson read, "China deplores the US' groundless attacks, coercive diplomacy, and interference in China's relations with these countries."

The spokesperson further added, "Weaponizing visas will not scare off the sober-minded. Nor will it hold back the flourishing ties between China and Central American

Last month, China had similarly voiced its opposition to the US announcement of tariffs against India. The Spokesperson of China's Ministry of Foreign Affairs, Guo

Jiakun, in his press briefing while responding to media queries, called the act an "abuse of tariffs," highlighting Beijing's consistent criticism of what it saw as coercive US trade and diplomatic policies.

When asked for comments on Trump's executive order to place an additional 25 percent tariff on India for its purchases of Russian oil, he said, "China's opposition to the abuse of tariffs was consistent and clear."

"China opposed the US politicizing tech and trade issues and using them as weapons to maliciously blockade and go after China. The US should earnestly protect the legitimate and lawful rights and interests of Chinese

nationals." he added.

Trump's order drew criticism from within the country as House Foreign Affairs Committee Dems warned that Trump's actions risked the carefully developed US-India relationship.

In a post on X, House Foreign Affairs Committee

Dems said, "RM Gregory Meeks: Trump's latest tariff tantrum risked years of careful work to build a stronger US-India partnership. We have deep strategic, economic, and people-to-people ties. Concerns should be addressed in a mutually respectful way consistent with our democratic values." ANI

The poster shared by Trump reads, "Chipocalypse Now".

Earlier this week, Trump signed an Executive Order, which reverted the Department of Defense's name to the Department of War.

According to ABC News, Illinois Governor JB Pritzker confirmed that federal

immigration enforcement could intensify in Chicago this

At a press conference earlier this week, Pritzker said US Immigration and Customs Enforcement (ICE) would be ramping up operations, with as many as 300 agents expected to be deployed.

The New York Times also reported that Department of Homeland Security officials would arrive at Chicago's Naval Station Great Lakes this week, with enforcement expected to continue for at least 30 days in the wider Chicago area.

> The latest move follows repeated attacks by Trump on Chicago's Democratic leadership, crime levels, and handling of immigration. He has previously described the city as a "mess."

Earlier this year, Trump dispatched federal agents and troops to Los Angeles and Washington, saying that the step was necessary to tackle crime and enforce immigration law, according to NYT.

According to The New York Times, Chicago is home to 2.7 million residents, has an estimated 150,000 undocumented immigrants, nearly 8 percent of the city's households. The scale

of the planned enforcement has raised concerns among migrant families, community groups, and local leaders, many of whom fear mass detentions and deportations.

Hundreds of residents and immigrant rights groups have pledged to mobilize in downtown Chicago at the first signs of ICE raids. ANI

"We are deeply concerned and feel a heavy sense of responsibility over the arrests of our nationals," Cho said, adding that the Ministry of Foreign Affairs had activated its Overseas Citizens Protection Task

He stressed that the economic activities of South

Korean companies investing in the United States should not be "unjustly fringed" upon during law enforcement operations. Cho also instructed officials to provide active consular support for those detained.

## WHO says mpox no longer a global public health emergency

GENEVA: The World Health Organization (WHO) has said that the spread of mpox (monkeypox) in Africa no longer represents a Public Health Emergency of International Concern (PHEIC).

WHO's Emergency Committee has met every three months to evaluate the outbreak of mpox, Xinhua news agency reported.

"Yesterday, they met again and advised me that in their view, the situation no longer represents an international health emergency. I have accepted that advice." said WHO Director-General Tedros Adhanom Ghebreyesus in the media briefing last week Friday.

"This decision is based on sustained declines in cases and deaths in Congo, and in other affected countries, including Burundi, Sierra Leone, and Uganda," Tedros said.

"We also have a better understanding of the drivers of transmission, the risk factors for severity, and the most affected countries have developed a sustained response capacity," he added.

However, the WHO also said that lifting the emergency declaration does not mean the threat is over, "nor that our response will stop, and we note the Africa CDC's decision yesterday that mpox remains a continental emergency." *IANS*

# US Health Secretary grilled in Senate on vaccine stance, CDC shake-up

WASHINGTON: US Health Secretary Robert Kennedy Jr. faced tough grilling from the Senate Finance Committee over his decision to fire Centers for Disease Control (CDC) Director Susan Monarez and his views on vaccines

In the three-hour-long hearing held last week, Kennedy faced bipartisan fury -- with many Republican lawmakers joining hands with Democrats to target him

On the firing of CDC Director Monarez last week, Kennedy said that she was untrustworthy.

Monarez wrote an article in the Wall Street Journal accusing Kennedy of making a "deliberate effort to weaken America's public-health system and vaccine protections".

Kennedy rejected those allegations.

"By the way, a month ago, you were voting against her because you thought she was either incompetent, ineligible, or unsuited to the task. Now I agree with

you," the US Health Secretary told Democratic Senator Elizabeth Warren.

On Covid-19 vaccines, War-

Warner asked Kennedy whether he agreed that "a million Americans died from Covid", Kennedy Jr. responded: "I don't know how guidelines.

Since assuming office, Kennedy has introduced several contentious shifts in US vaccine policy -- restricting eligibility for Covid-19 shots and dismissing all 17 members of the CDC's vaccine advisory panel, replacing some with allies from the antivaccine movement.

The hearing comes a day after Florida announced that it plans to become the first US state to end all vaccine mandates, including for diseases like chicken pox, measles, polio and mumps.

The American Medical Association criticized the move, warning, "this unprecedented rollback would undermine decades of public health progress and place children and communities at increased risk".

Covid-19 was the third leading cause of death in the US in 2020 and 2021, fourth in 2022 and 10th in 2023, according to data from the US Centers for Disease Control and Prevention. *IANS*

"The launch of HUENA reflects our strong commitment to antimicrobial stewardship and addressing the growing challenge of Anti-Microbial Resistance (AMR). We believe this innovation will notably improve patient outcomes, while reducing reliance on antibiotics. *IANS* 

# S. Korea aims to double bio exports by 2030 to enter global top 5

SEOUL: South Korea has outlined a plan to help the biohealth industry double its exports by 2030 and join the world's top five.

Under the "K-Bio Leap Strategy" unveiled at a seminar in Songdo, west of Seoul, the government outlined new targets for the industry, which also include the fostering of three new blockbuster drugs and ranking third globally in clinical trials by 2030.

South Korea is competitive in contract development and manufacturing (CDMO) services and biosimilars, ranking around 10th globally with biopharmaceutical exports of US\$5.8 billion last year, reports Yonhap news agency.

The country aims to double its exports in the field in the next five years.

To speed market entry, the government plans to shorten the review period for

biosimilars from 406 days to 295 days, and cut the time for reimbursement listing under the national health insurance program from 330 days to 150 days.

The global pharmaceutical market reached \$1.74 trillion last year -- about three times the size of the semiconductor market -- and is growing at an average annual rate of 4.7 percent, according to government data. IANS

## GST on 33 cancer drugs, rare disease medicines slashed to 0 from 12 pc: FM Sitharaman

NEW DELHI: In a historic move, the Union government has slashed the Goods and Services Tax (GST) rates for 33 cancer drugs and rare medicines -- from 12 to zero percent.

The decision taken by the GST Council, chaired by Finance Minister Nirmala Sitharaman, recently, rationalized the indirect tax structure, cutting

the current four slabs down to two -- scrapping the 12 percent and 28 percent rates, while retaining the 5 percent and 18 percent

"GST on 33 life-saving drugs and medicines has come down from 12 percent to zero," Finance Minister Sitharaman said.

The Union government also slashed GST rates for other life-saving drugs.

As per the revision, life-saving drugs, health-related products, and some medical devices will see a rate cut from 12 percent/18 percent to 5 percent or nil.

"From 5 to 0 and 3 life-saving drugs and medicines used for the treatment of cancer, rare diseases and other severe chronic diseases," the Finance Minister added.

"There are several drugs and medicines coming down

to 5 percent from 12 percent. Similarly, spectacles and goggles for correcting vision are also coming down to 5 percent from 28 percent," she said.

The changes in GST rates on services will be implemented from September 22.

The GST revision will also slash rates for health insurance, medical oxygen, and diagnostic kits.

GST on individual health and life insurance premiums has been reduced to nil (which currently stands at 18 percent).

The Finance Minister said the move will make insurance more affordable for the common man and help expand coverage across the country.

The GST rates have been

slashed from 18 percent to 5 percent on various medical apparatus and devices used for medical, surgical, dental or veterinary usage or for physical or chemical analysis

The GST rates have been reduced from 12 percent to 5 percent on various medical equipment and supplies devices such as wadding gauze, bandages, diagnostic kits and reagents, blood glucose monitoring system (Glucometer) medical devices, etc. *IANS* 

# Why lowering BP threshold to less than 120/80 mm Hg may be good for Indians

NEW DELHI: With cases of hypertension or high blood pressure rising significantly in India, particularly among young adults, lowering the BP threshold to less than 120/80 mm Hg by the American Heart Association (AHA) may help raise awareness and push for earlier interventions in the country, said health experts.

Hypertension is one of the most important modifiable factors in preventing heart disease, stroke, and death.

For the first time since 2017, the AHA recently updated its guidelines for people with high blood pressure. The guidelines revamped BP readings: from a 130/90 mm Hg threshold for diagnosis earlier, the AHA now defines normal blood pressure as less than 120/80 mm Hg.

"The updated BP guidelines by the AHA are highly relevant for the Indian population due to India's rapidly growing rates of hypertension," Dr Mukesh Goel, Senior Consultant, Cardiothoracic and Cardiovascular Surgery, Heart and Lung Transplant Surgery, from a leading city-based hospital, told IANS.

"For India, these changes are significant: With nearly 200 million individuals estimated to have hypertension, lowering the BP threshold for diagnosis means a much larger segment of the population is now classified as hypertensive, raising awareness and pushing for earlier interventions," he added. *IANS*


## **Book Review**

amini Khare, born and raised in Kanpur, Uttar Pradesh, comes from a family deeply rooted in education. Holding a master's degree in economics, with her thesis dedicated to the development of India, she has long nurtured a passion for history and cultural heritage. Living in the United States, Ms. Khare became increasingly aware that many young people of Indian origin were only partially familiar with India's historical legacy. This awareness led her to reflect upon the need to illuminate India's past-not only as a record of struggle and sacrifice but also as a testimony to resilience and achievement.

Her recently published book, Sonar Bharat, represents this endeavor. The book highlights India's journey since its independence 75 years ago, celebrating its resilience and growth. Drawing upon historical texts, archival materials, and digital resources, Ms. Khare revisits India's civilizational journey from the era of Chandragupta Maurya, often described as India's "Golden Age," through the succession of rulers who made the subcontinent known as the "Sone Ki Chidiya" (Golden Bird) of Asia. She also examines the profound impact of successive invasions that transformed India's cultural and economic land-



scape, while underscoring the nation's enduring vitality and capacity for renewal.

In narrating India's struggle under colonial rule, Ms. Khare does not overlook its darkest chapters.

The Jallianwala Bagh massacre of April 13, 1919-when hundreds of unarmed civilians were killed under the command of General R.E.H. Dyer-stands as a stark reminder of the brutality of imperial oppression. Equally, the Bengal famine of 1943, which claimed the lives of millions, revealed the devastating consequences of exploitative policies that left the populace vulnerable and destitute. These episodes, alongside the countless sacrifices of freedom fighters, form the backdrop against which India's independence was finally realized in 1947.

Sonar Bharat is more than a historical survey; it is a cultural meditation on India's post-independence trajectory. Seventy-five years after freedom from colonial rule, Ms. Khare emphasizes the necessity of recognizing both the intellectual and material contributions of India's leaders and citizens in shaping a modern nation. Equally, she urges renewed attention to rural development, which she regards as the backbone of India's future. In this respect, her work aligns with the vision of Mahatma Gandhi, who

declared in Young India (October 1921): "If the village perishes, India will perish too." Ms. Khare identifies three essential components for sustainable rural development: small-scale industries, accessible secondary education, and reliable healthcare.

Published by the Indian Association of Southern California (IASC), Sonar Bharat reflects a collaborative spirit, enriched by community dialogue and constructive

critique. It aspires not only to preserve memory but also to provoke reflection on the pathways of cultural continuity and social transformation in India.

## Expanding Surveillance of Immigrants - At What Cost?

he U.S. government has steadily expanded its use of surveillance tools, often under the banner of fighting fraud, stopping crime, or detecting undocumented immigrants. But those same tools, from DMV database access and facial recognition to cell phone tracking and data broker contracts, are now building a vast infrastructure that reaches far beyond immigration enforcement. This digital dragnet has the potential to place every American under unprecedented scrutiny. By compiling and cross-linking personal information, the state increases the risk of political targeting, identity theft, and massive data breaches. Panelists at the ACom conference examined these developments, highlighting the most recent trends under this administration, and what safeguards are needed to protect democracy and civil liberties.

W2 and 1099 income tax return forms filed by taxpayers, "which are now sent directly to ICE's immigrant database.

Nicole Alvarez, Senior Policy Analyst for Technology Policy at the Center for Ameri-

tion and Customs Enforcement (ICE) signed a memorandum of cooperation to allow the sharing of taxpayer information for the purpose of targeting and deporting immigrants. This move has seriously de-

viated from the principle that the data must be used only for its original purpose.

Alvarez warned that the government is promoting cross-departmental data centralization and integrating tax, social security and other information into a single database.

Emerald Tse, Associate Georgetown's Center on Privacy & Technology said immigrant communities have long been under the pressure of digital surveillance. A report released by the center in 2022 revealed that ICE has extensive access to databases such as water and electricity companies, vehicle management agencies, etc., and monitors the daily life of the majority of the U.S. population. In 2024, another report revealed that the Department of Homeland Security collects immigrants' DNA on a large scale and incorporates it into the national criminal investigation database CODIS for "predictive monitoring" of future crimes. She emphasized that these data collections often have nothing to do with crime, and even involve children and people who have not been prosecuted.

Sophia Cope, Senior Staff Attorney at the Electronic Frontier Foundation reminded that the current administration required visa and ESTA visa-free applicants to provide social media accounts for the past five years as early as its first term. "This not only affects the applicants, but also their friends and relatives in the United States may be implicated due to online interactions, leading to a chilling effect on speech." She added that the current government has even announced that it will expand "continuous review" and conduct long-term social media monitoring of various visa holders in the country. Cope reminded that although U.S. citizens cannot be refused entry, if they refuse to unlock the device, they may still be detained for several hours or even have the device confiscated. For green card holders and visa holders, the risk is higher, which may result in the revocation of status or direct denial of entry.

# California state transportation calls for applicants to the interagency Equity Advisory Committee

First convened in 2023, the 15member Equity Advisory Committee advises on how to achieve meaningful outcomes in transportation, environmental justice and equitable economic opportunities, especially in transportation planning and programming. The application period is open from September 8, and closes Sunday, October 19.

"The Equity Advisory Committee is a vital partner in our mission to build a transportation system that truly serves all Californians," said CalSTA Secretary Toks Omishakin. "Equity is not only a goal, but a guiding principle in every decision we make. I encourage passionate community leaders and advocates to apply to the committee and help us continue this transformative work."

"Equity Advisory Committee members continue to help shape billions of dollars in transportation investments," said Commission Chair Darnell Grisby. "We encourage Californians from all backgrounds and all parts of the state to apply to join us in advancing this critical work to address historic inequities and elevate community voices in our decision-making."

"Caltrans is committed to strengthening our partnerships, amplifying community voices, and supporting safe and reliable transportation both on and off the state highway system. The Equity Advisory Committee continues to be central to this mission. I encourage Californians from all walks of life to learn more about the Committee and consider contributing to this important work," said Caltrans Director Dina El-Tawansy.

Members of the Equity Advisory Committee review, advise and make recommendations on transportation related plans, programs and policies to CalSTA, the Commission and Caltrans. Committee members serve two-year terms, of which there are, three vacancies for the 2026-2028 term. Committee members are eligible for a \$100 per diem for their service. Members must be a resident of California and clearly demonstrate a history of equity-centered personal or professional experience or community leadership, or be actively engaged in transportation equity, policy, programming, advocacy or related fields such as health, air quality, climate, housing, community development or socio-economic development. Priority will be given to candidates who have demonstrated experience developing and implementing community-derived policies in partnership with government or similar institutions.

The Committee currently includes a

range of perspectives and expertise representing tribal and indigenous communities and community-based organizations including climate and air quality, housing and environmental justice and equity, and transportation and mobility rights organizations. Committee expertise also includes individuals and organizations offering perspectives regarding accessibility and the needs of older adults and people with disabilities and reflects different geographic areas of the state, especially rural areas.

# India has 106-mn sq. ft. of real estate development potential within transit nodes: Report

NEW DELHI: India has an opportunity to develop over 106 million square feet of real estate within major transit nodes, such as Metro stations, train stations, and inter-state bus terminals, across the country's top eight cities, a recent report said.

"The Delhi-NCR region demonstrates the highest potential for transit-oriented real estate development, estimated at 32 million square feet (sq. ft.)," CBRE, a real estate consulting firm, said in its report.

This significant capacity is attributed to the region's expanding Metro system, ISBTs, and city railway stations.

Mumbai holds the secondhighest potential at 20 million sq. ft., followed by Chennai with an estimated 13 million sq. ft., according to the report.

Other key cities such as Hyderabad, Kolkata, Chennai, Ahmedabad and Pune are also seeing transit-oriented development (TOD)-linked real estate activity, though at different scales, as mass transit networks



expand.

TOD includes both commercial and residential projects, alongside dedicated spaces for activities such as walking and cycling, and spots offering multimodal transport integration designed around major transport hubs, the report stated.

Transit-oriented development corridors are also accelerating the rise of mixed-use ecosystems, integrating residential, of-

fice, retail, and leisure spaces, reducing commute times and supporting compact, connected growth.

"TOD paves the way for vibrant, mixed-use communities that are not only commercially viable but also sustainable and livable. As Metro networks and transport hubs continue to expand across urban India, transitoriented development will play a pivotal role in shaping inclusive,

accessible, and future-ready cities," said Anshuman Magazine, Chairman and CEO - India, South-East Asia, Middle East and Africa, CBRE.

As per the report, in Delhi-NCR, planned projects such as Dwarka ISBT, Aerocity ISBT, and Jewar International Airport, and existing hubs such as Sarai Rohilla and Hindon Airport, offer high potential for transit-oriented development.

In Mumbai, these places include railway stations like Bandra, Dadar, Mumbai CST and the upcoming Navi Mumbai International Airport.

Moreover, hubs such as Chennai Airport, Maduravoyal Expressway and Chennai Peripheral Ring Road can unlock potential transit-oriented real estate, the report noted.

"Transit-Oriented Development is fast emerging as a game-changer for India's urban growth story. ## Rs 90 lakh-Rs 1.5 crore segment emerges as 'most preferred' among 36 pc Indian homebuyers

NEW DELHI: More than 36 percent of potential homebuyers in India chose the Rs 90 lakh to Rs 1.5 crore segment as their "most preferred" option in the first half of

2025, suggesting a greater trend towards premium and luxury real estate, a recent report said.

Meanwhile, 25 percent prefer homes priced between Rs 45 lakh and Rs 90 lakh, ANAROCK said in its report.

According to the report, more than 65 percent of the prospective buyers are entering the market as end-users, with investors appearing to be taking a measured pause.

"Among all cities, Bengaluru has the largest share (43 percent) of buyers seeking property specifically for investment; the remaining 57 percent are end-users," the report noted.

Around 63 percent of buyers consider real estate as the 'most preferred' investment asset class -- a 4 percent increase over the previous year.

other participants. Same is the case even when competing in the market. Collaborate with the system to get all the vendors their deserving customers, including yourself.


Another question is, "If the other person is holding on to 'I vs You' with me,



### Mob Rule, Institutionalized

The decision to arrest the organizers rather than the attackers is more than a bureaucratic misstep. It is a dangerous signal. It legitimizes the heckler's veto: shout loudly enough, disrupt forcefully enough, and the state will not only look the other way but hand over your opponents to the police.

This, in turn, creates a vicious cycle. Each disruption emboldens the next, each comes "terrorism," nothing is. This is not only an affront to due process but also a strategic blunder. It blurs the distinction be-

litical critics, who deserve protection. The result: the state weakens its own credibility and erodes public trust.

#### **Echoes of the Past**

Bangladesh has been here before. Under the ousted regime, fraudulent cases were the norm; the magistrates were pliant, the police complicit, and dissent criminalized. 

# US tariffs, remittances and regional ripples: India's external balance management being closely watched

SAHASRANSHU DASH

he United States' decision to impose a 50 per cent tariff on a wide range of Indian exports is more than a bilateral trade dispute-it is a stress test for India's external sector with implications for the broader South Asian economy. Exports to the US constitute a major source of foreign currency, while remittances-totaling USD 137.7 billion in 2024-remain a lifeline for millions of households. Any major disruption in either could ripple across regional supply chains, reduce employmentlinked inflows, and shift trade advantages toward competitors like Bangladesh.

#### External Pressure, Not Crisis

First, the good news. Despite these headwinds, India is far from a balance-of-payments criports and foreign direct investment provide an additional layer of stability.

Yet vulnerabilities persist. A sharp contraction in export revenues, slowed remittances, or negative portfolio flows could still put pressure on the current account and the rupee. While reserves provide a buffer, they are not a panacea for systemic shocks

India's relative insulation from external volatility owes much to its partial capital account openness under the Foreign Exchange Management Act. Partial convertibility, which allows controlled flows of capital in and out of the country, has acted as an effective stabilizer during

The external debt-to-GDP ratio remains moderate by emerging market standards, and the rupee's flexible exchange rate provides room to absorb shocks.

Historical context helps explain why India is better positioned than in the past. In 1991, India faced a severe payments crisis, forcing emergency loans from the IMF. Similarly, the 2013 "taper tantrum" exposed emerging markets to sudden capital outflows, but India's reserves and macroprudential tools helped contain instability. Today, structural inflows from services ex-

shocks. Individuals face annual outward remittance limits under the Liberalized Remittance Scheme, corporates must comply with reporting and hedging requirements, and portfolio investors navigate quantitative caps and route-based entry conditions.

This framework has proven stabilizing during periods of stress. During the 2008 global financial crisis and the 2013 "taper tantrum," India avoided severe capital flight thanks to constrained cross-border flows, ample reserves, and macroprudential tools, allowing policymakers to focus on domestic liquidity and credit support. Yet, rising protectionism worldwide raises a pressing

question: are these arrangements sufficient to withstand simultaneous disruptions in trade and remittances, particularly when regional economies are also exposed to similar shocks?

## Short-Term Measures to Cushion Shocks

Partial convertibility, if used proactively, can serve as an immediate buffer. The Reserve Bank of India has tools to intervene in foreign exchange markets without threatening reserve adequacy. Historical instruments such as the 2013 swap facility for non-resident deposits, which attracted over USD 30 billion, could be revived

Other tactical measures include incentivizing NRI deposits through temporary rate adjustments, issuing diaspora bonds, and expanding access for global investors in government securities. Digital corridors for remittance flows and rupee-based trade settlement can reduce transaction costs and slow the outflow of foreign currency. While these measures provide breathing room, they remain tactical responses rather than a substitute for a long-term strategic framework.

## Lessons from Global Comparisons

Singapore and South Korea offer useful insights for India. Singapore maintains one of the most open financial systems globally but stabilizes through a transparent, exchange-rate-centered monetary policy and deep domestic savings mobilized through institutions like the Central Provident Fund and sovereign wealth funds.

The way things are going for India, in relation to Trump's slapping of 50% tariff, India really needs to turbocharge its economy. As per several leading experts, as also India's Foreign Minister, S Jaishankar, who stated that seeking protection for an international trading system is fair, just and non-discriminatory, the world requires constructive and cooperative approaches to promote trade that is sustainable. Neither increasing barriers and complicating transactions, nor linking of trade measures to nontrade matters would be helpful, he said while addressing the BRICS virtual summit, convened by Brazilian President Luiz Inacio Lula da Silva.

Calling for fair economic practices, Jaishankar focused on the need for BRICS to address global conflicts, work towards reforms of global institutions and, help member states reduce trade deficits that's important in context of India's own trade with China and Russia. While PM Narendra Modi didn't participate in the meeting, the Russian President Vladimir Putin and his Chinese counterpart Xi Jinping joined the summit that saw Lula calling for more trade and financial integration among Brics nations to beat, what he described, without naming US, as 'tariff blackmail'.

"International trading system is based on the foundational principles of open, fair, transparent, non-discriminatory, inclusive, equitable and a rules-based approach with special and, differential treatment for developing countries. India believes this should be protected and nurtured," Jaishankar said. He said while the world as a collective is seeking a stable and predictable environment for trade and investment, it is imperative that economic practices are fair, transparent and to everyone's benefit.

India's Sherpa, Amitabh Kant at a recent CII summit said, when there are multiple disruptions our objective should be to proof it against such shocks. That means creating reliable redundant short-term supply chains. It is also essential to democratize manufacturing and production and encourage their growth in different geographies. Kant felt that this economic growth is possible only if the country fires on all cylinders and not just depend on the services segment. This would require higher output from the manufacturing front and better productivity in the agriculture sector. He added, India needs to off-load government run Public Sector Units and help private sector to take over industries to boost growth. For India to maintain 7.8% growth, it needs to create better and efficient power supply to the industries. India also needs to reform labor laws and create more jobs in several sectors such as tourism and hospitality.

Even though India's infrastructure has seen major growth, it needs to enhance the logistics sector to boost movement of goods at a much faster rate in the present scenario. What Trump has done may be a short term set back to India and several Global South countries. But this may be the wakeup call for BRICS countries to unite and share their common wealth and knowledge to restructure their economies.

What Trump fails to see is, in the long-term US might lose the leadership position it holds on trade and economies of the world. And if the US dollar loses its sheen the biggest loser will be none other but America.



The fort was described by the famous author Rudyard Kipling as "more the work of Goblins than of men". Sadly, time took its toll on this

magnificent structure, and most of the majestic and fascinating architecture of the fort is now in ruins.

Moti Mahal: Bundi is a small town in the Hadoti region of Rajasthan, which lies 250 km away from the capital city of Rajasthan and 39 km from Kota. The town is famous for its picturesque forts, steep-wells (baolis), palaces, lakes, and reservoirs. Moti Mahal is one of the unmatched attractions of the town. Along with the his-
