

# Washington issues updated India-US trade framework fact-sheet; drops pulses, agriculture; says India 'intends' to buy 500 bn USD of US products

WASHINGTON, DC: The White House has updated its factsheet on the India-US trade framework a day after its initial release, softening several key assertions related to India's commitments on purchases, tariffs, and digital trade.

The revisions come after last week's announcement of a framework for an interim reciprocal trade agreement aimed at boosting bilateral commerce. The framework for the Interim Agreement was finalized following a phone conversation between Prime Minister Narendra Modi and US President Donald Trump.

In the original version of the factsheet, it was stated, "India committed to buy more American products and purchase over USD 500 billion of US energy, information and communication technology, agricultural, coal, and other products."

The revised factsheet now says India "intends" to buy more American products and omits the term "agricultural" from the list of product categories.

Changes were also made in the tariff section. The earlier document noted, "India will eliminate or reduce tariffs on all US industrial goods and a wide range of US food and agricultural products, including dried distillers' grains (DDGs), red sorghum, tree nuts, fresh and processed fruit, certain pulses, soybean oil, wine and spirits, and additional products."

## 394 international observers, 197 foreign journalists to monitor Bangladesh election

DHAKA: At least 394 international election observers and 197 foreign journalists have arrived in Bangladesh to observe the country's 13th general election and the referendum on the July National Charter, the Chief Adviser's Press Wing said in a recent statement.

Of the international observers, 80 represent various international organizations.

A total of 240 observers are from bilateral countries, including independent European observers.

Another 51 are individuals affiliated with different global institutions.

"The number of international observers for the upcoming polls is more than double that of the controversial general election held on January 7, 2024. By comparison, the 12th, 11th, and 10th general elections were monitored by 158, 125, and just four international observers, respectively," the statement added.

Key organizations sending observer missions include the Asian Network for Free Elections (ANFREL), with 28 observers, and the Commonwealth Secretariat, with 27.

The US-based International Republican Institute (IRI) has deployed 19 observers, while the National Democratic Institute (NDI) has sent one.

Other organizations include the Organization of Islamic Cooperation (OIC), with two observers, the International Conference of Asian Political Parties (ICAPP), with two, and the European External Action Service, with one.

In addition to the European Union, observers are arriving from 21 countries.

These include Pakistan (8), Bhutan (2), Sri Lanka (11), Nepal (1), Indonesia (3), and the Philippines (2). ANI

The updated version removes the reference to "certain pulses" from this list.

On digital trade, the initial factsheet mentioned, "India will remove its digital services taxes" and "committed to negotiate a robust set of bilateral digital trade rules that address discriminatory or burdensome practices and other barriers to digital trade."

The current version drops the claim that "India will remove its digital services taxes" and retains only that "India committed to negotiate a robust set of bilateral digital


trade rules."

Under the proposed arrangement, the US will reduce tariffs on Indian goods to 18 percent from the current 50 percent.

As part of the broader engagement, US President Donald Trump has removed the 25 percent tariffs imposed on India in August last year over purchases of Russian oil, noting that New Delhi has committed to stopping direct or indirect imports of oil from Moscow and has undertaken "significant steps" in this direction. ANI

# Canada: 10 dead, including shooter, in Tumbler Ridge school shooting in British Columbia

VANCOUVER: A tragic shooting at Tumbler Ridge Secondary School in rural northeast British Columbia has left 10 people dead, including the suspect, CBC News reported, marking one of the deadliest incidents in the region's recent history.

The Royal Canadian Mounted Police (RCMP) confirmed that six people were found dead inside the high school. Another person died on the way to hospital, and two more were discovered at a residence

Additional RCMP officers, including those from the Major Crime Unit, are being deployed to assist with the investigation. Authorities are working with the local school district to reunite students with their parents and guardians.

"This was a rapidly evolving and dynamic situation, and the swift co-operation from the school, first responders, and the community played a critical role in our response," North District Chief Supt. Ken

believed to be connected to the incident. The shooter was confirmed dead earlier this afternoon from what police described as a "self-inflicted injury."

CBC News reported that two people were airlifted to hospital with serious or life-threatening injuries, while another 25 are being assessed for non-life-threatening injuries at the local medical center.

Police stated they do not believe there are any other suspects or any ongoing risk to the public. Officers are searching other homes and properties in the community to check for anyone else who may be injured or linked to the incident.

Floyd wrote in a statement.

"Our thoughts are with the families, loved ones, and all those impacted by this tragic incident. This has been an incredibly difficult and emotional day for our community, and we are grateful for the co-operation shown as officers continue their work to advance the investigation," the statement added.

CBC News noted that the Tumbler Ridge Health Centre was placed on restricted access during the response, with non-urgent visits discouraged. Normal operations are set to resume tomorrow at 9 am MT.

NEW DELHI: French President Emmanuel Macron will be on a three-day official visit to India from February 17-19 at the invitation of Prime Minister Narendra Modi, the Ministry of External Affairs (MEA) announced on Tuesday.

During the visit, Macron will also attend the AI Impact Summit in New Delhi on February 19. He will hold discussions with PM Modi on strengthening bilateral cooperation in various sectors as enshrined in the Horizon 2047 Roadmap, the MEA stated.

The India-AI Impact Summit 2026 announced by PM Modi at the France AI Action Summit is scheduled for February 19-20 in New Delhi.

"In addition, the leaders will discuss regional and global issues of mutual interest, including cooperation in the Indo-Pacific. The two leaders will also be in Mumbai to jointly inaugurate the India-France Year of Innovation, which will be celebrated

throughout 2026 in both countries," the MEA statement detailed.

Macron's visit to India comes after PM Modi's visit to France in February 2025 and showcases the mutual trust and depth of Strategic Partnership, as well as the shared commitment of the two countries to deepen it further. On January 26, Emmanuel Macron extended warm greetings to Prime Minister Modi and the people of India on Republic Day. He even confirmed his visit to India in February, aiming to continue building the bilateral partnership.

Sharing a photo of himself and PM Modi from their visit to Jaipur in 2024 on X, Macron wrote, "What a wonderful memory of the Republic Day we shared together in 2024! My dear friend Prime Minister Narendra Modi, dear Indian friends, my very best wishes on this great day of celebration. See you in February to continue building together!" IANS

## Diplomacy, international law to resolve border dispute with India: Former Nepal PM Prachanda

KATHMANDU: The Nepali Communist Party (NCP), led by former Prime Minister Pushpa Kamal Dahal 'Prachanda', has vowed to work toward settling the border dispute with India through diplomatic dialogue and international law.

Unveiling the party's commitment paper ahead of the March 5 elections, party co-ordinator Dahal said the disputes over Lipulekh, Limpiyadhura, and Kalapani would be resolved through diplomatic talks and in accordance with international law.

Both Nepal and India claim the territory along Nepal's northwestern border as their own, although it has remained under India's effective control. Both countries have incorporated the areas into their official political maps.

Relations between the two countries deteriorated sharply when the government led by former Prime Minister K P Sharma Oli issued Nepal's new political map in 2020 by incorporating these disputed territories, and Nepal's parliament amended the constitution accordingly. The border dispute has long remained one of the key irritants in bilateral relations. IANS

## Balochistan conflict has roots stretching back to Pakistan's independence: Report

KABUL: The recent attacks in Balochistan highlight not only security challenges but also what critics describe as long standing political failures to address the province's grievances as the roots of growing violence in the province go back to Pakistan's independence, a report has highlighted.

An article in Afghanistan's leading news agency Khaama Press mentioned that the recent attacks in Balochistan highlight not only security challenges but also what critics describe as long standing political failures to address the province's grievances. Documented human rights concerns - particularly enforced disappearances and alleged extrajudicial killings - have created an environment where, according to activists, peaceful dissent faces criminalization and armed resistance appears to some as the only avenue for change.

On January 31, the Baloch Liberation Army (BLA) launched 'Operation Herof 2.0', carrying out coordinated attacks in 12 districts, including Quetta, Gwadar and Mastung. According to official figures, 17 police personnel and 31 civilians were killed during the operation. Pakistani forces claimed that 145 insurgents were killed in retaliation while the BLA has disputed this statistics. The attacks carried out by BLA involved gun assaults, suicide bombings, and the temporary seizure of police stations and government facilities.

Reports have now surfaced about intensified security operations in Balochistan, sparking concerns among rights activists about treatment of local residents, Khaama Press reported.

"The recent violence in Balochistan represents not an isolated incident but a dramatic escalation in a conflict with roots stretching back to Pakistan's independence. Understanding the crisis requires examining historical grievances, documented human rights violations, economic disparities, and what critics describe as political failures," an opinion piece stated.

Balochistan accounts for 44 percent of Pakistan's land area but it comprises six percent of the country's total population. It remains Pakistan's poorest province, with approximately 70 percent of residents living in multidimensional poverty and unemployment at 33 percent. IANS

## China agent gets four years in US jail

WASHINGTON: A California-based political operative has been sentenced to four years in federal prison for acting as a covert agent of the People's Republic of China and influencing local US politics.

Yaoning "Mike" Sun, 65, was sentenced to 48 months by United States District Judge R. Gary Klausner of the Central District of California, the Department of Justice said. Sun pleaded guilty in October 2025 to one count of acting as an illegal agent of a foreign government.

According to the Justice Department, Sun acted at the direction of Chinese government officials from at least 2022 to January 2024 without notifying the US Attorney General, as required by law.

"For years, Sun received and executed taskings from Chinese government officials, distorted our public discourse by disseminating Chinese propaganda, and surveilled groups in the United States that China viewed as threatening its interests as part of a campaign of intimidation," said Assistant Attorney General for National Security John A. Eisenberg. /ANS

## 'India emerges as viable third pole in fragmented global economy'

NEW DELHI: With the United States, China, and Russia creating a hostile world, Europe and Canada have no choice but to deepen ties with India, according to an article in Washington-based online publication 'The National Interest'.

"Caught between de-risking China and hedging against American volatility, Europe has turned to India as a strategic alternative. India offers scale without China's level of geopolitical and normative baggage. It is not a substitute for the US security umbrella, nor a replica of China's manufacturing ecosystem, but it represents a viable third pole in an increasingly fragmented global economy," states the article written by Dr Jianli Yang.

The article highlights that Canada faces the same situation as Europe. This is reflected in Prime Minister Mark Carney's cautious outreach to China aimed at diversifying partnerships and reducing exposure to unilateral shocks from the USA. And yet keeping space to maneuver between Washington and Beijing.

Despite strained Canada-India relations in recent years, driven by diplomatic and security disputes, Ottawa may realistically

follow Europe's path and treat India as a pragmatic hedge.

Demographically, India's young, English-speaking workforce and growing purchasing power enhance its long-term appeal. Strategically, its rivalry with China and insistence on strategic autonomy align it more naturally with transatlantic interests than Beijing's vision of authoritarian-led globalization," the article observed.

The report also mentions that India has its protectionist instincts, bureaucratic inertia, and insistence on autonomy, which will pose a problem for both Europe and Canada. "But in a global order characterized by disruption and distrust, India's very flexibility -- its ability to engage all sides without fully binding itself to any -- may be its greatest asset. *IANS*

## Trade deal will increase India's share in US plastics market: Industry

NEW DELHI: The India-US trade deal has brought a major business opportunity for domestic plastic exporters, which will help the country increase its share in the US plastics market, according to industry leaders.

Speaking to IANS, Arvind Goenka, Managing Director (MD) of RMG Polymers India

Limited, said, "The India-US trade deal will open up a large US market for domestic plastic exporters."



"India's quick-commerce ecosystem is moving from scale-first growth to efficiency and intelligence-led expansion," said Anupama Bhimrajka, VP, Marketing, foundit.

The demand is strong for professionals across "data analytics, product technology, and supply chain strategy, as companies focus on improving forecasting accuracy, optimizing inventory movement, and strengthening customer experience," it said. *IANS*

Pak stares at \$1.2 bn of vaccine import bill by 2031 as India halts supply

NEW DELHI: The disruption in affordable pharmaceutical imports from India, especially vaccines, has sharply increased Pakistan's financial burden and the country stares at an annual import bill of \$1.2 billion by 2031, according to reports.

The disruption due to last year's military clashes exposed Islamabad's heavy reliance on foreign manufacturing and donor support for routine immunization as the country provides 13 vaccines free of cost but with zero domestic vaccine production, reports said.

Pakistan Health Minister Mustafa Kamal said a halt in Indian vaccine shipments is already hurting the economy and the situation could be direr when international support for vaccine procurement ends by 2031.

"Pakistan contributes 51 of the cost now, and unless we start local production of vaccines, we will face an annual import bill of \$1.2 billion by 2031," the minister was quoted as saying in reports.

The minister further said that Pakistan has traditionally procured cheap vaccines for immunization and other requirements from India through Global Alliance for Vaccines and Immunization (GAVI). Gavi served as a global purchasing and funding platform for poorer countries. *IANS*

## AstraZeneca Pharma India receives CDSCO approval for Durvalumab indication in cancer treatment

## Working with India in war on drugs: US

NEW YORK: In a major collaboration with Indian law enforcement in the war on drugs, US authorities have cracked down on online drug-traffickers linked to the country who are allegedly responsible for six overdose deaths in the US.

The US Drug Enforcement Agency (DEA) said that they arrested four people in the US and seized 200 websites linked to a "transnational criminal organization" (TCO) based in India during "Operation Meltdown".

"Leveraging its global reach, DEA actively collaborates with our Government of India law enforcement partners to identify, investigate, and dismantle dangerous criminal organizations that engage in these types of illegal drug trafficking operations," the agency said.

DEA Administrator Terrance Cole, announcing the crackdown, said: "This case demonstrates how foreign-based traffickers exploit our healthcare sys-

tem, hide behind the internet, and use people inside the United States to move dangerous drugs under the guise of legitimate commerce."

The DEA and the US prosecutor's office for Eastern

who used these online pharmacies, and it has sent more than 20,000 letters to the public requesting information in support of this ongoing investigation, "dangerous drugs under the guise of legitimate commerce."



New York, based in Brooklyn, said they seized the websites, which they said were made to look like genuine pharmacy sites but were dispensing drugs illegally.

The DEA said that it had identified thousands of customers

The TCO, which the officials did not identify, had been under investigation since 2022 by the DEA field office in Colorado, the agency said.

Following that up, DEA field offices across the US conducted several raids from January 27,

arresting the four people, who were also not identified, it said.

The DEA said that it also issued five, Immediate Suspension Orders (ISO), and one Order to Show Cause (OTSC) against the "pharmacies" that may have had some form of DEA registration.

According to the DEA, the "online pharmacies" that it took down had US website addresses and professional-looking designs to falsely make them appear legitimate.

The counterfeit medications they dispensed "are often made with fentanyl or methamphetamine and taking them can lead to serious health risks, including harmful side effects, ineffective treatment, and even death", it said.

Investigators found that the online pharmacies and their co-conspirators illegally dispensed and shipped diverted medications, without valid prescriptions, to customers throughout the US, violating the Controlled Substances Act, the DEA said.

Through these operations, the drug traffickers were "dangerously infiltrating a closed system of distribution intended to keep patients safe" by requiring doctors' prescriptions, it said.

President Donald Trump had made the war on illegal drugs, particularly fentanyl, a key goal.

According to the US government, 73,000 people died of drug overdose in the US during the 12-month period ending in August.

Trump threatened China, the major source of precursor chemicals for making fentanyl, with tariffs and other punitive actions. *IANS*

# 80 pc of Bangladesh's health budget is wasted: Top executive

NEW DELHI: Bangladesh's healthcare system has become capable of meeting the majority of domestic demand, but chronic mismanagement and poor planning are draining nearly four-fifths of the sector's public spending, according to AM Shamim, general secretary of the Bangladesh Private Hospital, Clinic and Diagnostic Owners Association.

In a recent interview with Bangladesh's The Daily Star newspaper, he said "Our national health budget stands at around Bangladeshi Taka 42,000 crore. But nearly 80 percent of that is wasted. Equipment that isn't needed is purchased, while the ones we do need often sit idle and unused."

The problem is not a lack of resources

but their deployment. For instance, he said that at Labaid Cancer Hospital, two linear accelerator (LINAC) machines deliver radiotherapy to between 160 and 220 patients a day.

In contrast, he emphasized, "Government cancer hospitals have 8-12 LINAC machines, yet they treat fewer patients. That's not a technical issue -- it's purely a matter of management."

Red tape compounds the dysfunction. Noting that there were once around 17,500 licensed hospitals and diagnostic centers, he said that number has now dropped to just 3,000 hospitals and 7,000 diagnostic centers.

"To set up a hospital, you need approvals from at least 18 different agencies,

ranging from fire services, the Department of Environment, narcotics control, boiler inspection, generator compliance, and more," he was quoted as saying.

"The main issue is that licenses remain valid for just one year. By the time one agency completes its inspection, the year is already over. This opens the door for delays, bribes, and inefficiencies," he added.

The government extended the license validity to two years last month. But Shamim warned that the underlying problems remain.

He argued that the country has reached a point of functional self-reliance in healthcare delivery, even as deep structural flaws continue to threaten efficiency, accountability and public trust.

The Labaid MD pointed to the sharp fall in outbound medical travel as one of the indicators of the system's growing capacity. He claimed that medical visas to India, once routine for Bangladeshi patients seeking treatment, have fallen to a tenth of their previous levels over the past 18 months. /ANS

**US bill seeks to end H-1B visa program**

WASHINGTON: A Republican lawmaker introduced legislation to end the H-1B visa program, arguing that it disadvantages American workers and prioritizes foreign labor over US citizens.

US Representative Greg Steube announced the introduction of the Ending Exploitative Imported Labor Exemptions Act, known as the EXILE Act.

The bill would amend the Immigration and Nationality Act by discontinuing the H-1B visa program, which allows US companies to hire foreign workers in specialty occupations.

"Prioritizing foreign labor over the well-being and prosperity of American citizens undermines our values and national interests," Steube said.

"Our workers and young people continue to be displaced and disenfranchised by the H-1B visa program that awards corporations and foreign competitors at the expense of our workforce," he said.

"We cannot preserve the American dream for our children while forfeiting their share to non-citizens," Steube added. "That is why I am introducing the EXILE Act to put working Americans first again."

According to his office, the EXILE Act would amend Section 214(g)(1)(A) of the Immigration and Nationality Act to end the H-1B program entirely. The material states that more than 80 percent of H-1B visa recipients are Indian or Chinese nationals, with priority often given to younger workers. *IANS*

## Global Hindu alliance urges action on Bangladesh abuses

WASHINGTON: A global alliance of Hindu and multi-faith groups called for urgent international action to protect Hindus in Bangladesh. The groups cited what they said was a sustained pattern of violence, intimidation, and forced displacement.

The appeal was coordinated by the Hindus Advancing Human Rights Initiative, or HAHRI. It is an initiative of HinduPACT. The group said more than 125 organizations and individuals from 15 countries have signed the letter.

The letter urges governments and international bodies to intervene.

"The Hindus of Bangladesh are the indigenous peoples of the country entitled to have their life and culture protected from discrimination under the UN Convention on the Rights of Indigenous Peoples, 2007," said Rahul Sur, Executive Director of HAHRI. "What we are seeing is the exact opposite. It is not episodic violence or isolated lawlessness. It is a sustained human rights crisis rooted in impunity."

The letter documents killings and mob violence. It cites attacks on temples and homes. It also points to the use of blasphemy allegations to target Hindus.

It highlights the public killing of Dipu Chandra Das on December 18, 2025. He was accused of blasphemy. Video of the killing spread widely online. The incident drew global attention.

According to the submission, Bangladesh recorded 2,673 attacks on minorities between August 2024 and November 30,

alone tell a devastating story," Shah said. "A democracy cannot selectively protect rights. When a minority shrinks at this scale under persistent violence and intimidation, it is a failure of the

state and of the global system meant to prevent such outcomes."

The alliance said Hindus made up about 22 percent of Bangladesh's population in 1951. That figure is now under 7 percent. It said about 230,000 Hindus leave the country each year.

The group described the trend as ethnic and religious cleansing. It said the migration is not voluntary.

The letter calls on the United States to act. It asks Washington to send a fact-finding team. It urges trade penalties. It calls for refugee protection for persecuted Hindus. It also asks for a review of Bangladesh's role in UN peacekeeping missions.

The appeal urges the European Union to impose punitive tariffs. It also calls for an EU investigative mission.

The groups want United Nations bodies to condemn the abuses. They ask for an independent inquiry into the violations.

HAHRI said rallies were held in more than 25 US cities. The group also launched a petition to the UN High Commissioner for Human Rights. It said thousands of people worldwide have signed it. *IANS*

## Pakistan set to deport 20,000 Afghan refugees awaiting relocation to US: Report

ISLAMABAD: Pakistan has planned to deport nearly 20,000 Afghan refugees who have been waiting for resettlement in the United States, local media reported.

Pakistan's federal government will issue orders for senior provincial authorities and police in Islamabad, Balochistan, Punjab, Sindh, Khyber Pakhtunkhwa, Paki-

stan-occupied Kashmir and Pakistan-occupied Gilgit-Baltistan (PoGB) to facilitate the deportation of Afghan refugees, Afghanistan's leading Khaama Press agency highlighted citing a report from Pakistan's 'The Nation' newspaper.

Majority of these refugees left Afghanistan after Taliban seized power in 2021 and they have been waiting for more than

three years to relocate to other countries. In recent months, Pakistan has already deported some Afghan refugees who were included in the US resettlement lists, citing doubts regarding Washington's commitment to the program.

The US has halted Afghan refugee admissions after an Afghan national, Rahmanullah Lakanwal, shot two US Na-

tional Guard soldiers near the White House in December. After the shooting incident, US President Donald Trump suspended visa issuance for Afghan passport holders for an indefinite period and ordered a review of existing Afghan immigration cases, Khaama Press reported.

Last month, several Afghan refugees living in Pakistan

urged the Pakistani government and Afghan authorities to resolve existing challenges through talks and provide them adequate time to return to Afghanistan gradually with dignity, the local media reported.

These refugees stated that rapid deportations and increasing pressure has caused serious challenges for Afghan residents. *IANS*

# White House says zero illegals released into US over past 9 months

WASHINGTON DC: White House Press Secretary Karoline Leavitt has said that no illegal immigrants had been released into the United States over the past nine months, calling it a "remarkable achievement" of the Trump administration.

Addressing reporters during a press briefing on February 5, Leavitt said, "Zero illegals were released into our homeland over the past nine months. This is a truly remarkable achievement."

She said the administration's immigration enforcement policies had contributed to a significant drop in crime across the country, despite criticism from Democrats and sections of the media.

"Even as Democrats and the liberal media are engaged in hysteria about this administration arresting and deporting violent criminal illegal aliens, the undeniable truth is

that deporting these individuals is one of the primary reasons why America's streets are safer today than they were one year ago," Leavitt said.

Citing newly released data, the Press Secretary said crime had declined sharply under President Donald Trump's leadership.

"The drop in crime is more proof that all that is required to improve public safety on our streets is a leader with the will to do what is necessary to protect law-abiding American citizens," she said.

Leavitt said nearly eight in ten Americans supported the deportation of illegal immigrants, while two in three backed the administration's requirement that state and local authorities cooperate with federal agencies and hand over criminal illegal immigrants held in local jails.

On immigration policy, she said President Trump remained firm on enforcement while seeking to keep the

government funded and operational.

"When it comes to any discussions about immigration policy, the President is never going to waver in his commitment to allow immigration enforcement efforts in this country," she said.

Leavitt also referred to a recent incident in which, four Americans were killed, by an illegal immigrant, saying, the individual had been paroled into the country by the previous administration using the CBP One app.

"That's not how immigration in this country should work," she said.

She said President Trump had urged Congress to pass the SAVE America Act, which she said would ensure compliance with federal election law by removing non-citizens from voter rolls and requiring voter ID and proof of citizenship for registration.

Leavitt also reiterated that the Office of the Director of National Intelligence held statutory responsibility for counterintelligence matters related to election security.

Responding to a question on whether President Trump remained committed to deporting an estimated 20 million illegal immigrants who entered the country under the previous administration, Leavitt said, "Yes, and the President has always been committed to that."

In a post on X later, Leavitt said newly released data showed the murder rate in America's largest cities had fallen in 2025 to its lowest level since at least 1900, marking the largest single-year drop on record.

She said, "President Trump promised to restore law and order to the United States. Newly released data proves he is delivering: the murder rate in America's largest cities plummeted in 2025 to its lowest level since at least 1900 -- marking the largest single-year drop in murders on record. This dramatic decline is what happens when a President secures the border, fully mobilizes federal law enforcement to arrest violent criminals, and aggressively deports the worst illegal alien offenders." ANI

## India, Canada agree to establish security, law-enforcement liaison officers during NSA Doval's visit

OTTAWA: India and Canada have agreed to establish security and law-enforcement liaison officers during a meeting with National Security Advisor (NSA) Ajit Doval and Nathalie Drouin, Deputy Clerk and National Security and Intelligence Advisor to the Prime Minister of Canada, as part of the former's visit to Ottawa.

According to a Ministry of External Affairs (MEA) release, at a meeting recently, as part of the NSA's two-day visit to the country, both sides agreed to build on their working relationship.

These were part of the regular bilateral security dialogue between India and Canada, during which the two sides acknowledged progress on initiatives to ensure the safety and security of their citizens and agreed on a shared work plan to guide cooperation on national security and law enforcement priorities.

As per the statement, the establishment of liaison officers is expected to streamline bilateral communications and facilitate timely information sharing on issues of mutual concern, including the illegal flow of drugs, particularly fentanyl precursors, and transnational organized criminal networks.

"During the meeting, it was agreed that each country would establish security and law-enforcement liaison officers and that their respective agencies would build on working relationships," the statement stated.

"The two sides acknowledged the progress on initiatives aimed at supporting the safety and security of their countries and citizens. They agreed to a shared workplan to guide bilateral cooperation on national security and law enforcement issues and to enable practical collaboration on respective priorities," the release added.

During the discussions, both countries also committed to formalizing cooperation on cybersecurity policy and information sharing on cybersecurity issues. They agreed to continue collaboration on matters related to fraud and immigration enforcement, consistent with domestic laws and international obligations.



## From classroom to community: Students build real-world AI solutions at Cordova High School through Suvidha International Afterschool AI program

**S**uvidha International Foundation (<https://suvidhainternational.org/>), a California-based 501(c)(3) nonprofit successfully organized the After-School Industrial AI Agent Development Program at Cordova High School, offering students a unique opportunity to gain hands-on experience in artificial intelligence while solving real-world problems that directly impact their community. The program was supported by the City of Rancho Cordova through its Community Enhancement & Investment Funds (CEIF). The five-month initiative started in September 2025 was thoughtfully designed to introduce high school students, grades 9 to 12, to AI and AI agent development without requiring prior experience. The curriculum progressed from foundational concepts to more advanced applications, enabling both beginners and experienced learners to steadily build confidence, technical skills, and problem-solving abilities.

As part of the program, students collaborated in teams to design and develop two impactful AI applications focused on addressing real community needs. The first project was a Customer Service AI Agent developed for the City of Rancho Cordova, created to help residents and local businesses quickly and easily find answers to common city service questions. This AI agent addressed challenges such as identifying the correct department to contact, navigating city resources, and understanding permits, trash services, billing, and other frequently asked questions providing accessible, 24/7 support beyond regular office hours. The second project was an Energy Efficiency AI Agent, developed in collaboration with SMUD, focused on helping Rancho Cordova homeowners, renters, and small businesses better understand and manage their energy usage. The AI agent offers around-the-clock guidance on energy-saving practices, local utility programs, and practical steps to reduce utility bills. Beyond individual cost savings, this project supports broader sustainability and environmental goals by encouraging energy efficiency and reducing overall demand on the power grid.

The program benefited 32 students, who gained valuable hands-on experience in Generative AI, Python programming, machine learning, and natural language processing (NLP). To ensure inclusivity and flexibility, additional Sunday evening make-up sessions were conducted to accommodate academic, athletic, and personal schedules. The curriculum was in-



tentionally structured to evolve over time, helping students understand how AI is applied in industries such as customer service and energy efficiency while preparing them for future STEM education and career pathways.

The program was initiated and coordinated by Bhaskar Vempati, Founder and President of Suvidha International Foundation, with the support of the Suvidha team, including Vandna Sharma, Avinash Maddy, Padmapriya Maddy, Balu Kodavatikanti, and Praveen Vempati. Instruction and technical mentorship were provided by Jothi Periyasamy, a Stanford alumnus and AI expert, along with his team, including Sathvika from Deep Science AI Foundation and team members from LLM at

Chalamcherla, and SMUD Directors Michael and Oliver, who provided valuable feedback to the student teams. The program concluded with a Grand Final AI Showcasing on Friday, January 30, 2026 at the Cordova High School Multipurpose Hall. The event brought together a distinguished group of attendees, including City of Rancho Cordova Mayor Gatewood, a nine-member SMUD delegation led by Board President Dave Tamayo, SMUD Directors Michael Champ and Oliver Daniels, FCUSD Board President Jennifer Laret, Cordova Recreation & Parks District Director Eric Sloan, Cordova High School administration including Principal Amy, Golden 1 representatives, local IT professionals, parents, and community

generation.

Mayor Garrett Gatewood, Council Member Siri Pulipati, and Council Member Joe Little commended Suvidha International Foundation and Jothi for organizing a high-quality After-School AI Program that empowered students with real-world AI skills and community-focused solutions. CEIF team members Randi Kay, Lindsay and Laura, Rick, Dave, YK Chalamcherla, Jennifer and Amy congratulated the students for their innovation and highlighted the value of strong partnerships in preparing students for future careers. The guests include Venu, Ramraj, Anupriya, Manish, Jagan, JP, Prasad, Syam, Siva, Prashanth, Srinadh, Ranga and Vashist.

Bhaskar Vempati and Jothi Periyasamy expressed gratitude to the City of Rancho Cordova, SMUD, FCUSD, partners, mentors, and volunteers for their support and congratulated students for their dedication and perseverance. Bhaskar also thanked Padmapriya and Manish for capturing the event pictures. A parent, Tripti, also thanked Suvidha, noting the program significantly increased her child's confidence, problem-solving skills, and interest in STEM.

# Federal demands for voter data, laws to limit access and challenges to state control of elections

**A**s the 2026 midterms approach, the Justice Department has demanded that nearly every state and Washington, DC, turn over election-related records, including full statewide voter registration lists and, in some cases, ballots from prior elections or access to voting equipment. The federal government has sued more than 20 States and Washington, DC, for refusing to comply, prompting concerns about federal overreach into states' constitutional role in administering elections. The requests involve highly sensitive personal information and have raised serious privacy and security concerns. At the same time, Congress is advancing election legislation that would tighten voter identification requirements, mandate voter roll purges, and restrict vote-by-mail. Experts warn that together these actions could affect who is able to vote and increase disputes over election outcomes. ACom briefing on Feb 6 examined how these developments could function as wild cards in the midterms and how

states and courts are responding.

John C. Yang, president and executive director of Asian Americans Advancing Justice | AAJC stated that any electoral reform should be based on the principle of "making voting easier, not harder," and carefully weigh whether restrictive laws

by 1.8 million compared to the previous election, with registered voters growing by 28% and actual voter turnout increasing by 37%; approximately 60% of eligible Asian American voters participated in the election. In several swing states, the number of Asian American voters even exceeded

official pointed out that election affairs are constitutionally controlled by state and local governments, and the president has no direct power to intervene in the actual operation of elections. He described recent actions at the federal level as mostly "political signals and marketing," which, while unusual and intimidating, have largely been blocked by the courts and have limited actual impact on grassroots voters.

Danielle Lang, Vice President for Voting Rights & Rule of Law, Campaign Legal Center; Adjunct Law Professor and Leading U.S. Voting Rights Litigator stated that recent court rulings have clearly defined the boundaries of executive authority in election matters. She pointed out that courts have repeatedly ruled that the federal government lacks legal basis for executive orders and the Department of Justice's requests for large amounts of voter data, and have issued injunctions against these measures. Lang added that the Department of Justice's attempt to collect voter data on a large scale has been rejected by the courts, which have determined that it does not fall within the scope of the Civil Rights Act.

impose a reasonable burden on voters. He pointed out that Asian Americans are the fastest-growing ethnic group in the United States, with their population increasing by more than 38% between 2010 and 2020, currently numbering approximately 24 million, and projected to reach 35 million by 2060; their voting influence cannot be ignored. In the 2020 election, the number of eligible Asian American voters increased

the margin of victory in the presidential election. He also emphasized that language barriers and restrictions on mail-in voting had a significant impact on the approximately 30% of Asian American voters with limited English proficiency.

# CDPH urges vaccination as measles cases rise across multiple counties recent cases include Shasta County outbreak of eight related cases

**What You Need to Know:** Recently, local health departments in Los Angeles, Orange, San Bernardino, Riverside and Shasta counties reported multiple cases of measles. Public health officials are investigating additional suspect cases. With this news and measles spreading in other parts of the United States, as well as international destinations, CDPH is strongly urging Californians to ensure they are fully vaccinated against measles.

SACRAMENTO: The California Department of Public Health (CDPH) is urging Californians to check their immunization status and get vaccinated against measles after local health departments have notified the state of multiple recent cases of measles. This includes an outbreak of eight related cases in Shasta County, the state's first measles outbreak since 2020. All of these individuals were either unvaccinated or had an unknown history of vaccination. Last week, CDPH issued a Health Alert notifying health care providers to be on the lookout for measles in patients presenting with a fever, rash and other symptoms consistent with measles.

"As a pediatrician and parent, I encourage families to make sure everyone gets up to date on their MMR vaccine, if they haven't already," said Dr. Erica Pan, CDPH Director and State Public Health Officer. "CDPH continues to coordinate with, and support, local health departments in their responses to stop measles from spreading further in our communities. The United States is experiencing the highest numbers of measles cases, outbreaks, hospitalizations and deaths in more than 30 years, driven by populations with low vaccination rates. We all need to work together to share the medical evidence, benefits, and safety of vaccines to provide families the information they need to protect children and our communities."

Cases have been reported in Los Angeles, Orange, San Bernardino, Riverside and Shasta counties. Two recent cases visited Disneyland on January 22 and 28 while infectious. Local health officials are

working with Disneyland Resort to notify potentially exposed employees, and members of the public that visited Disneyland on either date should contact their health care provider if they develop measles

measles, mumps, and rubella (MMR) coverage among kindergarteners for the 2024-2025 school year - the level of immunity needed to reduce the risk of community spread. To continue achieving this

Before traveling internationally, everyone 12 months and older should receive two MMR doses, and babies 6 to 11 months are recommended to get one dose of MMR vaccine. Families with children traveling to regions in the United States with ongoing outbreaks should consult with a health care provider about following immunization recommendations for international travel.

Families can check their vaccination status with the California Digital Vaccine Record (DVR) and schedule a vaccine appointment by visiting [MyTurn.ca.gov](http://MyTurn.ca.gov), or contacting their local pharmacy or health care provider. MMR vaccines are covered for most people through their health insurance plans, including Medi-Cal and regular health care providers. People having difficulty obtaining vaccines can contact their health care provider or local health department for help finding a place to get immunized.

#### About Measles

Measles is a highly contagious viral disease. Unvaccinated individuals, particularly young children and pregnant people, face the highest risk of severe illness and even death. Roughly 90% of those unvaccinated and exposed to measles will contract the disease. Symptoms include a fever that lasts a couple of days followed by a cough, runny nose, conjunctivitis (pink eye) and rash. Those infected can spread measles about four days before their rash starts to four days afterwards.

Measles remains common globally, including in Europe, Africa and Asia. There are also ongoing outbreaks in Canada and Mexico. Although the United States eliminated measles in 2000, cases have risen, with major outbreaks in Texas and South Carolina in 2025. California experienced a notable outbreak linked to Disneyland from December 2014 to April 2015, infecting 131 residents and others in six additional states, Mexico, and Canada. Due to California's currently high levels of immunization, the state is less likely to see sustained transmissions as has been seen in other states in recent years. However, transmission of measles is still possible, particularly in communities with lower immunization coverage.

As of February 9, 2026, a total of 17 measles cases have been reported statewide. Elsewhere in the United States, one of the largest outbreaks in over 30 years is happening in South Carolina with 920 associated cases.

California reported more than 95%

CDPH and the West Coast Health Alliance (WCHA) recently endorsed the 2026 American Academy of Pediatrics Recommended Child and Adolescent Immunization Schedule, ensuring all Californians receive access to evidence-based guidance on life-saving vaccines. #### Get Vaccinated

The MMR vaccine provides the best protection against disease and serious illness. It is important Californians check to see that they and their family members are up to date, as the number of measles cases has increased. In particular, it's important that families are up to date on all vaccines before traveling, including international travel and travel to domestic areas where there are measles outbreaks. It is also important to be up to date before visiting places or events where there are many people from other countries or regions of the United States, such as large sporting events, theme parks or airports.



## Indian-American Ashok Baddi announces bid for Michigan House

WASHINGTON: Indian American community leader Ashok Baddi has announced his bid for the Michigan House of Representatives, saying he is running to bring what he calls practical, people-first leadership to a diverse suburban district north of Detroit.

"I am running for the portion of state representative from Michigan District 56," Baddi told IANS in an interview.

Baddi, a longtime resident of Troy, said his decision was rooted in local ties. "I've been a resident of Troy for over a decade now. I've been working in the community, trying to help our community in various ways," he said.

He pointed to the district's growing diversity, noting that "almost 25 percent of the population is of Indian origin," with about 12,000 voters overall. "That is a very sizable number that can actually make or break an election," he said.

Baddi said his motivation to seek office came from a belief that change requires political engagement. "It is only through political will that we can actually make change happen," he said. "Once we are here, we are an American, as American as anybody else."

He said he decided to run toward the end of last year after years of political involvement. Baddi said he was previously active in the Democratic Party, serving as "a core team member for several fundraisers for the governor of Michigan" and helping campaigns "right from council elections to school boards."

Explaining his break from the Democrats, Baddi said his "core value system" aligns more closely with Republicans. He cited views on gender and school sports, saying, "I personally believe that there are two clear genders," while also saying a third gender "should have a right to live with all freedom."

Education is a central issue of his campaign. Baddi said he opposes efforts in Troy to eliminate honors programs. "I believe every child has a different learning capacity and capability, and it should remain so," he said. "If they're capable of learning, they should be allowed to do that."

An immigrant from Hyderabad, Baddi came to the United States in 2005 with his wife, a pediatric nephrologist. He described years spent in rural America, living

near farms in Georgia and Missouri. "We practically lived in about a 400-acre farm-land," he said, before later moving to Michigan.

On immigration, he said he favors legal pathways. "For me, getting into this country legally is a big yes," he said, adding that the United States is "the only country in the

world which has an open door policy."

Baddi said he is challenging Democratic incumbent Sharon McDonald, whom he previously supported. "I feel she has not delivered much to the community," he said, citing roads and education policy.

He acknowledged the financial hurdles of campaigning. "The dollar is the mother's milk of politics in America," Baddi said, urging greater political donations from the Indian American community.

Indian Americans have steadily in-

creased their political footprint in the United States, with a growing number serving in Congress, state legislatures and local offices. Michigan, home to one of the largest Indian American populations in the Midwest, has seen increased civic engagement from the community in recent election cycles. IANS



Man's chief delusion is his conviction that he can do. All people think that they can do, all people want to do, and the first question all people ask is what they are to do. But actually nobody does anything and nobody can do anything. This is the first thing that must be understood.

Everything happens. All that befalls a man, all that is done by him, all that comes from him-all this happens. And it happens in exactly the same way as rain falls as a result of a change in the temperature in the higher regions of the atmosphere or the surrounding clouds, as snow melts under the rays of the sun, as dust rises with the wind.

Man is a machine. All his deeds, actions, words, thoughts, feelings, convictions, opinions, and habits are the results of external influences, external impressions. Out of himself a man cannot produce a single thought, a single action. Everything he says, does, thinks, feels-

one's "whole mass,' to be really convinced that it is so and never forget it.

With this question of doing yet another thing is connected. It always seems to people that others invariably do things wrongly, not in the way they should be done. Everybody always thinks he could do it better. They do not understand, and do not want to understand, that what is being done, and particularly what has already been done in one way, cannot be, and could not have been, done in another way.

Everyone now is talking about the war. Everyone has his own plan, his own theory. Everyone finds that nothing is being done in the way it ought to be done. Actually everything is being done in the only way it can be done. If one thing could be different everything could be different. And then perhaps there would have been no war.

Everything is dependent on everything else, everything is connected, nothing is separate. Therefore everything is going in the only way it can go. If

all this happens.

Man cannot discover anything, invent anything. It all happens. 
people were different everything would be different. They are what they are, so everything is as it is.

## After the begums: Battle for the soul of Bangladesh has just begun

IRFAN CHOWDHURY

In the tea stalls of Bangladesh, where politics is consumed with the same sugary intensity as the cha, the mood is one of jittery anticipation. For 18 months the country has been a state in parenthesis. On 12 February that parenthesis would close. Voters will go to the polls in a unique double act: casting one ballot for a new parliament and another in a referendum on the "July Charter," a package of constitutional reforms designed to prevent the rise of another autocrat.

Yet the papers will feature a glaring omission. Awami League, the party of independence that mutated into its leaders' fief, is banned. Its leaders are in jail, in hiding or in Kolkata; its registration is sus-

pended on grounds of "crimes against humanity" committed during the "Monsoon Revolution" of 2024.

The mechanics of the vote are novel. For the first time the diaspora, in particular, the hardworking remittance heroes whose blood and sweat keep the central bank afloat, have voted by post. Polling hours have been extended to accommodate the referendum. But as campaign posters promising a corruption-free, prosperous nation plastered over the faded graffiti of the revolution, the question is not just who will win, but whether Bangladesh is jumping towards democracy or merely swapping one form of illiberalism for another.

### Restoration Of Old Order?

A synthesis of polling and analysis suggests a restoration of the old order, minus its recent empress. The Bangladesh Nationalist Party, battered

for 15 years, stands on the cusp of power. With the League proscribed, the only organized opposition comes from a strange alliance: Jamaat-e-Islami and the student-led National Citizen Party (NCP). This coalition hopes to be the dark horse. The Jamaat, once a pariah for opposing independence in 1971, has reinvented itself with startling efficacy. The NCP, led by Nahid Islam, a revolutionary turned politician, provides the fire.

The longevity of the Jamaat is noteworthy. While the BNP and the Awami League spent decades in a bitter rivalry, the Jamaat played a long game, focusing on social welfare and cadre discipline. It has quietly entrenched itself within the bureaucracy and hospitals, transitioning leadership through party rule books rather than bloodlines. It has survived multiple bans, post-1971 owing to huge public demand following its overt anti-independence activities, and again in 2024, during the previous regime's last-ditch

attempt to cling to power. It has endured sustained campaigns against its activities, including the execution of senior leaders convicted for alleged war crimes.

Understanding that it lacks the mass appeal for an outright parliamentary victory, it has concentrated its efforts in selected regions, such as Chittagong and Rajshahi, and cultivated influence within social services, banks, hospitals and religious institutions. Like other cadre-based ideological parties, Jamaat has proven its ability to rejuvenate and to adapt, shelving its longstanding demands for 'Sharia' (Islamic) law to organize underground, and now fielding religious minority candidates and winning university student-council elections. Despite this, its role in 1971 hangs around its neck, a history the BNP alliance has exploited on the campaign trail.

# Pakistan mosque blast: ISIS' growing shadow in the subcontinent

SRIJAN SHARMA

After nearly five years, the Islamic State (ISIS) has carried out a high-intensity terror attack in the subcontinent, targeting a Shia mosque in Pakistan and killing more than 30 people while injuring around 170. The last comparable attacks include the 2023 Khar bombings, the deadly Peshawar mosque bombing in 2022 that killed over 60 people, and the Abbey Gate bombing during the US withdrawal from Afghanistan in 2021, which claimed more than 170 lives.

After a relative lull, ISIS-Khorasan (ISIS-K) once again demonstrated its capacity for mass-casualty violence-this time through a suicide bombing car-

Data from 2021 reveals a sharp escalation in ISIS-K activity: the group carried out 334 attacks in Afghanistan-up from 83 in 2020-including five suicide bombings. However, between 2022 and 2023, ISIS-K was significantly weakened by sustained Taliban counter-offensives that eliminated key leaders. In early 2023, the Taliban killed Qari Fateh, ISIS-K's military chief, and Abu Saad Muhammad Khurasani, a senior ideologue and interim leader.

As Taliban pressure intensified, ISIS-K shifted into a more clandestine mode of operation, focusing on building deep cells capable of sustaining low-intensity attacks while remaining be-

100. Throughout 2022, ISIS-K maintained a high tempo of attacks inside Pakistan.

By the end of that year, however, the group's activities began to decline. The next major strike occurred nearly a year later, when ISIS-K carried out a suicide bombing in Khar, Khyber Pakhtunkhwa, during a rally of the Jamiat Ulema-e-Islam (F), killing more than 60 people and injuring over 200.

In 2024, ISIS-K began expanding externally into Central Asia while sustaining low-intensity, targeted killings in Pakistan. This pattern suggests a calculated strategy: exploiting weakened security environments, waiting for moments of distraction, and striking selectively to signal continued relevance and capability.

## Strategic Objectives In The AfPak Theatre

ISIS-K has consistently sought to demonstrate its presence through clandestine recruitment and targeted assassinations, punctuated by high-impact attacks designed to maximize shock value. This gap-driven strategy prioritizes lethality over frequency, a hallmark of ISIS-style operations aimed at reasserting relevance.

During 2022 and 2023, ISIS-K attacks in Pakistan became significantly more lethal, capitalizing on a deteriorating security environment marked by the resurgence of Baloch insurgent groups and the collapse of the ceasefire with the Tehreek-e-Taliban Pakistan (TTP). In July 2023 alone, when TTP and Baloch Liberation Army (BLA) attacks peaked, ISIS-K carried out the Khar bombings, exploiting the overstretch and distraction of Pakistan's security apparatus.

## The Khorasan Struggle

Following the US withdrawal from Afghanistan, ISIS-K gained a limited opening to expand its influence across the subcontinent. Its campaign began months earlier with attacks such as the Kabul school bombings and continued through the withdrawal period, culminating in the Abbey Gate bombing in August 2021.

low the radar. Even this strategy proved difficult to sustain. Taliban intelligence penetration and continuous raids in traditional ISIS-K strongholds such as Nangarhar and Kunar, along with operations in urban areas, fragmented the group further. As a result, ISIS-K activity in Afghanistan has largely been reduced to sporadic targeted killings of ideological and political figures.

## Shift Towards Pakistan

From 2022 onwards, ISIS-K gradually redirected its operational focus from Kabul to Pakistan. Initially, the group carried out low-intensity attacks, but within months escalated to mass-casualty violence, most notably the Peshawar mosque bombing that killed over 60 people and injured more than

## INDO-US TRADE DEAL SIGNED

The Indo-US trade deal has generated significant interest due to the growing strategic, economic, and geopolitical alignment between India and the United States. Both nations represent large, dynamic markets with complementary strengths, and a trade agreement could reshape economic ties for decades. However, while the potential benefits are substantial, there are also notable challenges and risks that must be considered. One of the most significant advantages of an Indo-US trade deal is the expansion of market access.

United States is one of India's largest trading partners, and a formal agreement could remove tariff and non-tariff barriers, enabling Indian goods particularly textiles, pharmaceuticals, engineering goods, and IT services, to compete more effectively in the American market. Similarly, American agricultural products, industrial goods, and technology sectors would benefit from easier access to India's fast-growing consumer base. This will also make Indian products become more competitive in international market.

Second, a trade deal would enhance investment flows. A stable and predictable trade framework could encourage US companies to increase foreign direct investment (FDI) in India, especially in manufacturing, clean energy, digital infrastructure, and supply-chain diversification. India's Production-Linked Incentive (PLI) schemes align with US interests in diversifying away from China, making the partnership economically strategic for both countries.

Third, an agreement would deepen strategic cooperation. The Indo-Pacific region is increasingly central to global geopolitics, and stronger economic ties would reinforce the broader strategic partnership between the two democracies. Enhanced trade cooperation would complement existing defense and technological collaborations such as the Quad, iCET (Initiative on Critical and Emerging Technologies), and joint military exercises.

Another benefit lies in technology transfer and innovation. The US leads in cutting-edge technologies, AI, semiconductors, clean energy and, biotech while India offers a large tech-skilled workforce and expanding digital ecosystem. A trade deal could facilitate joint ventures, R&D collaboration, and smoother technology flows.

On the flip side, despite the benefits, several challenges could complicate an Indo-US trade agreement. A primary concern is the asymmetry in economic interests. The US often pushes for greater market openness, strict intellectual property rules, and lower tariffs, while India traditionally adopts a more protectionist approach to safeguard domestic industries and farmers. These conflicting priorities may hinder negotiations. Indian agricultural and dairy sectors could face competitive pressure from heavily subsidized US producers. This could raise political resistance within India, where small and marginal farmers form a significant voting bloc. Third, the US seeks broader access for its digital companies and stronger data-flow commitments, which may conflict with India's data-sovereignty and digital-regulation policies. Differences over e-commerce rules, data localization, and privacy laws remain major sticking points. Additionally, US concerns about India's tariff structures often among the highest for major economies could slow progress. At the same time, India is wary of opening sensitive sectors like retail, agriculture, and healthcare to large US corporations.

Finally, geopolitical expectations tied to such a deal could create pressure on India to align more closely with US positions, potentially challenging India's traditional foreign-policy autonomy. For India to become a fully developed nation there are of course several risks. Let's hope Indian products and services become more competitive.



The 'Pavitra Rishta' actress penned a heartfelt note appreciating her mother for not just showering love and affection on her, but also on all those around her.




The actor said the film, based on a husband, wife, and girlfriend, depicts conflicts between couples and misunderstandings that arise in personal relationships.

Located on the banks of River Yamuna in Uttar Pradesh, Agra is a popular tourist destination as it is home to one of the 7 wonders of the world, the Taj Mahal. **Taj Mahal:** One of the Seven Won-


ders of the World, Taj Mahal is located on the banks of River Yamuna in Agra. It was built by the Mughal Emperor Shah Jahan as a memorial for his third wife, Mumtaz Mahal. It also houses the tomb of Shah Jahan himself. Constructed entirely out of white marble in the 17th century, Taj Mahal is one of the most beautiful monuments in the world.

**Agra Fort:** An architectural masterpiece, The Red Fort of Agra or Agra Fort was built by Emperor Akbar in 1573. It is located on the right bank of the River Yamuna and is made entirely of red sandstone.

**Tomb of Itmad-ud-Daulah:** Often referred to as the "Baby Taj Mahal", the tomb of Itmad-ud-daulah is a Mughal mausoleum and often regarded as a copy of the Taj Mahal. This is the first tomb in India made entirely of marble.

**Fatehpur Sikri:** Located at a distance of 40km from Agra, Fatehpur Sikri is a town in the Agra district and a famous tourist attraction. A city predominantly made of red sandstone, Fatehpur Sikri was founded in 1571 century by Mughal Emperor Akbar. [www.holidify.com](http://www.holidify.com)
