
discussed. My view is that when deportations take place, they need to take place humanely where those being deported are treated with appropriate dignity, not harassed or treated in inhumane conditions."

On trade, Khanna pointed out that one of the issues "corroding" US relations with China, Europe, and Canada is the large trade deficit, where the US buys more than it sells. Khanna emphasized that for the US-India relationship to strengthen, India should commit to purchasing as much from the US as the US buys from India.

Khanna told ANI, "America has a trade balance with India, one of the things that has corroded our relationship with China is a massive trade deficit where China is selling us all of these products and not

> buying our products. The same thing with Europe. We have a trade deficit with them. We have a trade deficit even with Canada. We need a balanced trade relationship. So I think what's important with India is that they commit to buying as much from the United States as

US Congressman Shri Thanedar calls tariffs 'big issue' ahead of Modi-Trump meeting

WASHINGTON DC: Indian-American US Congressman Shri Thanedar highlighted tariffs as a "big" issue ahead of Prime Minister Narendra Modi's meeting with US President Donald Trump, stating that trade, bilateral ties, and immigration are among the key topics that need to be addressed.

"This is an exciting time. PM Modi and Donald Trump have met two times be-

fore... I am looking forward to this meeting... There are a lot of issues that need to be talked about. The tariff is a big issue, the bilateral relationship, commerce, immigration issue, there are so many things going on... I hope a lot can get done," Thanedar said.

Earlier. Dhruva Jaishankar, Executive Director of the Observer Research Foundation America, suggested that an agreement might be reached to prevent a tit-for-tat trade dispute between India and the US.

"We may see some kind of agreement where both sides agree on a set of tariffs and another arrangement to ensure we don't get into a tit-for-tat type of trade dispute over the next four years... India is a very large producer of steel globally, so the possibility of this escalating is real," Jaishankar told ANI.



He also mentioned that the issue of illegal Indian immigrants and deportations by the US would be addressed.

"India has had a long-standing policy, not just with the US but with other countries as well... If they are identified as Indian and have overstayed their visas or are undocumented migrants, India is willing to take them back... India has been working with many countries to find mechanisms

> for identification... This is not a new policy... However, the optics of it have played very negatively in India... Talking seriously about what needs to be done and how this can be better managed will be helpful," he added.

Meanwhile, when asked if the Bangladesh issue would

be discussed during the meeting, Thanedar said he hoped it would be addressed.

"I hope they do. As a Congressman, I spoke a lot about it. I asked that they address the issue. The State Department under President Biden did issue some sanctions against Bangladesh," he said.

US: Senate moves forward with Tulsi Gabbard's nomination for Director of National Intelligence

WASHINGTON DC: The US Senate has voted along party lines to move forward with Tulsi Gabbard's nomination for director of national intelligence, paving the way for

a final confirmation vote, according to a report by Politico.

With the backing of 52 Senate Republicans, Gabbard is expected to be confirmed as the nation's top intelligence official soon. Forty-six Democrats opposed her nomination, and two senators were absent during the vote.

The vote was conducted under a procedural rule called cloture, which is often used for contentious Cabinet nominees like Secretary of Defense Pete Hegseth.

This rule permits up to 30 hours of debate before a final vote can take place. Gabbard had previously been approved by the Senate Intelligence Committee in a party-line vote following a heated confirmation hearing at the end of January.

Meanwhile, Senate Majority Leader John Thune in a floor speech said, "The intelligence community needs to refocus on its core mission, collecting intelligence and providing unbiased analysis of that information. That's what Tulsi Gabbard is committed to ensuring if she is confirmed to be DNI, and I believe she has the knowledge and leadership capabilities to get it done," NBC News re-

The final vote on Gabbard's nomination was scheduled for midnight, unless all senators agree to vote earlier. Following that, Senator Thune said that the Senate would proceed with a procedural vote on Robert F Kennedy Jr.'s nomination, nominated by Trump for the position of health

Gabbard, who was nominated by US President Donald Trump for the post, is a former Army Reserve lieutenant colonel, Democratic congresswoman, and 2020 presidential

and human services secretary.

candidate who switched to the Republican Party last year. She has, at times, referred to the tens of thousands of intelligence personnel she would oversee as members of the "deep state."

She had also raised questions over the US intelligence findings on the former Syrian regime's use of chemical weapons on its own people, and has echoed Kremlin's views about the cause of Russia launching war in Ukraine. *ANI*

She also addressed the significant threat posed by ISIS in Africa, particularly in the Sahel.

While delivering remarks at a UN Security Council Briefing on Threats to International Peace

and Security by Terrorist Acts on Monday (10 Feb.), Shea said, "Countering ISIS and other terrorist groups around the world is a top priority for the Trump Administration. President Trump has already taken decisive action in conjunction with the Somali government by directing precision airstrikes against ISIS in Somalia on February 1st."

She added, "As the Secretary-General's report highlights, ISIS affiliates in Central Asia, most notably ISIS-Khorasan, also pose a significant global threat. We remain concerned about ISIS-K's capabilities to plot and conduct attacks, as well as sustain recruitment campaigns, particularly in Afghanistan and Pakistan. ISIS has expanded the frequency and lethality of its attacks in the Sahel, making this region the global epicenter for fatalities from terrorist attacks." ANI

IMF scans Pakistan's judicial, regulatory system

ISLAMABAD: The International Monetary Fund (IMF) was scrutinizing the judicial and regulatory system of Pakistan as part of the ongoing \$7 billion Extended Fund Facility (EFF) to address governance and corruption vulnerabilities, according to the Ministry of Finance.

According to the Government of Pakistan, the IMF team will engage with financial, revenue, and election bodies in the country.

An assessment must be published in July sharing measures to address corruption and governance vulnerabilities, reports Dwan, quoting the Ministry of Finance. Under the United Nations framework, Pakistan is required to publish the corruption report immediately after a review.

A technical mission of the IMF is in Pakistan for a week-long examination of six key governance-related sectors and institutions, the ministry stated.

In October, Pakistan committed to the IMF to strengthen institutional capacities to fight corruption, support inclusive growth, and provide a level playing field for businesses and investments.

As a result, a structural benchmark had been set to publish by July 2025 a report on the Governance and Corruption Diagnostic Assessment (GCDA) to analyze critical governance and corruption vulnerabilities and identify priority structural reforms moving forward, the ministry said. *IANS*

"Hell will break out" if hostages not released by Saturday, Trump warns Hamas

WASHINGTON DC: United States President Donald Trump said Israel should end the ceasefire in Gaza and resume military action if all hostages are not released by the end of the week, Times Of Israel reported.

This came after Hamas announced a delay in releasing hostages scheduled for Saturday. Speaking with the reporters, Trump said that Israel might choose to disregard his ultimatum and the Saturday noon deadline, adding that he might speak to Prime Minister Benjamin Netanyahu.

"As far as I am concerned, if all of the hostages aren't returned by Saturday at 12 o'clock, I think it's an appropriate time. I would say, cancel it and all bets are off and let hell break out. I'd say they ought to be returned by 12 o'clock on Saturday," Trump said.

Trump's comments came hours after Hamas announced that it intended to delay the next release of Israeli hostages planned for Saturday, "until further notice," in response to what it claimed were Israeli violations of the ongoing hostage-ceasefire deal, Times of Israel reported.

In a post on X published before Trump spoke, Abu Obeida, spokesman for Hamas' armed wing Qassam Brigades, said that the handover of the hostages "who were scheduled to be released next Saturday ... will be postponed until further notice, and until the occupation commits to and compensates for the entitlements of the past weeks retroactively," CNN reported. ANI

Indian American physician and Community leader Dr. Sampat Shivangi passes away

r. Sampat Shivangi, a pioneering Indian-American physician, community leader, and advocate, passed away on Feb.10 in a hospital following a brain hemorrhage. He was in his early 80s. His life's work, spanning medicine, public health, and Indo-American relations, leaves behind an enduring legacy of dedication and impact.

Dr. Sampat Shivangi is an Indian-born American physician renowned for his significant contributions to healthcare, philanthropy, and public service. He began his medical education at Kasturba Medical College in Manipal, India, earning his M.B.B.S., and later obtained postgraduate degrees (M.D. and D.G.O.) from Karnataka Medical College in Hubli. In 1976, he migrated to the United States, where he completed a fellowship at Washington University School of Medicine in St. Louis, Missouri.

Throughout his career, Dr. Shivangi has held several prominent positions, including serving as an advisor to the U.S. Secretary of Health and Human Services from 2005 to 2008 and be-

His philanthropic efforts are extensive, both in the United States and India. Notably, he played a pivotal role in establishing a Hindu temple in Jackson, Mississippi, and has been a strong advocate for mental health, serving on the Mississippi State Board of Mental Health. In India, through the Dr. Sampat Shivangi Foundation, he has initiated projects in education,

Covered California reaches record-breaking 1.9M enrollees before open enrollment's Jan. 31 deadline

SACRAMENTO, CALIF.: Covered California has surpassed 1.9 million enrollees, bolstering its record-high enrollment before open enrollment's Jan. 31 deadline for California's remaining uninsured.

This open enrollment, 299,060 Californians have signed up for 2025 coverage as of Jan. 26, a 13 percent increase over the same period last year.

Another 1.638.954 Californians have renewed their health insurance plans, a 10 percent jump over the same date last year, with more than 100,000 total enrollees in 2025 as compared to the record enrollment in 2024.

"Uninsured Californians are taking advantage of the unprecedented financial

help available to help pay for coverage in 2025, as we have seen robust NORTHERN CALIFORNIA sign-ups throughout the AND SACRAMENTO VALLEY state and reached our alltime record sign-ups before the end of open enrollment," said Covered California Executive Director Jessica Altman. "With just days remaining to enroll, this is a pivotal moment to secure not just health insurance, but peace of mind and financial security for the rest of the year."

Once open enrollment ends on Friday, Californians will need to have experienced a major life change to enroll in health insurance through Covered California. So now is the time to sign up, whether it's on CoveredCA.com or through one of the 14,000 Licensed Insurance Agents or community partners available to provide you free, confidential assistance.

Residents of the Los Angeles and Ventura counties affected by the fires will have access to Covered California's special-enrollment period, which allows residents to sign up for health coverage for an additional 60 days from the date the state of emergency was declared. The special-enrollment period will continue through March 8.

Nearly half of the new enrollees have come from five Southern California counties (Los Angeles, Orange, Riverside, San Bernardino and Ventura), with nearly 150,000 sign- ups. Also, nearly 82,000 new enrollees identified as Latino, and over 52,000 identified as Asian Americans. Over 72,000 White Californians and over 9,000 Black Californians have enrolled, and over 58,000 Californians did not disclose their race or ethnicity.

Despite the continued progress, the data from the California Simulation of Insurance Markets (CalSIM), a model cre-

ated by the UCLA Center for Health Policy Research, showed that heading into open enrollment, there were nearly 1.3 million uninsured Californians who either qualified for subsidies through Covered California (591,000) or were eligible for Medi-Cal coverage (675,000), and they reside all over

This year, Covered California is offering more financial help for Californians than ever before. Building on the existing federal subsidies to help pay for health insurance premiums, Covered California is enhancing its cost-sharing reduction program that reduces the cost of accessing health care for consumers by lowering out-of-pocket costs, including eliminating deductibles in all three Silver cost-sharing reduction plans.

Californians who forgo health insurance will be subject to a tax penalty administered by the California Franchise Tax Board. The penalty for not having coverage the entire year will be at least \$900 per adult and \$450 per dependent child under 18 in the household. A family of four that goes uninsured for the whole year would face a penalty of at least \$2,700.

FOG Republic Day represents Indian States with mesmerizing cultural performances





Consul General Somnath Ghosh delivered the inaugural address, praising the dedication of Hindi faculty at various universities in the Midwest. He also com-



f you have a limited income and few re sources, you may receive various as sistance from the federal and/or state government. This month, we're going to discuss benefits that help with Medicare costs and provide cash assistance for food.

Q1 Can I have both Medicare and Medicaid?

Yes, you can have both Medicare and Medicaid. Federal law requires states to provide Medicaid to certain groups, which includes many older adults and people with disabilities. If you receive SSI (Supplemental Security Income), you are automatically eligible for Medicaid. For those who don't get SSI but want Medicaid as a senior, you need to meet limited income and asset requirements, which vary by state and change year to year.

For example, in California, a married couple can qualify with a monthly income of \$2,350, and CA does not count assets in determining Medicaid eligibility. On the other side, in Washington, the monthly income and asset limits are the same as SSI's, so only SSI recipients qualify for full Medicaid as seniors.

If you are approved for Medicaid as a senior, your state Medicaid will pay your Medicare Part B premium for Medicare Part B (and if applicable, Parts B and A). Medicaid can help with additional Medicare costs such as deductibles, coinsurance, and copayments. You'll also automatically qualify for Extra Help with Medicare-covered prescription drug costs. Beyond this, Medicaid can offer more services than Medicare alone, including long-term care, eyeglasses, and hearing aids.

Q2 I was determined I was not qualified for full Medicaid when I turned 65 and enrolled in Medicare. Is there any way to get help if I am not eligible for Medicaid for the elderly?

If you are not eligible for Medicaid and



can't afford Medicare costs, you may still qualify for a Medicare Savings Program (MSP). MSPs are a subset of Medicaid benefits sponsored by state Medicaid.

They help people with limited income and few assets pay for Medicare costs such as premium or

both premium and out-of-pocket expenses. You'll also get Extra Help with MSP approval.

There are three types of MSPs based on an individual's income level, and each type provides a different level of coverage. Under federal guidelines, a single individual may qualify if their monthly income is up to \$1,902 and assets are below \$9,430, while couples may qualify if their monthly income is up to \$2,149 and assets are under \$14,130.

However, some states, such as New York, have more flexible MSP eligibility criteria. In the state of New York, single individuals with income up to \$2,355 or couples with income up to \$3,189 per

month can qualify, and NY does not apply as asset test.

Please note. While MSPs provide substantial financial assistance, they do not

> include additional coverage such as dental, vision, or hearing aids. Please call us if you have any

questions or need assistance.

Q3 Did you know that only about half of eligible elders benefit from cash assistance for grocery shopping?

There is the Supplemental Nutrition Assistance Program (SNAP), which is the largest Federal nutrition assistance program. This program gives you a special debit card to help you buy food if you have a limited income and a few assets.

SNAP is a need-based program. That means you must meet certain financial requirements to qualify. According to federal guidelines, a household must meet both the gross and net income limits. For instance, a two-person household's gross monthly income must not exceed about

\$2,214, and net income must not exceed \$1,703. Additionally, their assets must be \$2,750 or less. However, if there's a member in the household aged 60 or older, they don't need to meet the gross income test, and the asset limit increases to \$4,250. These limits are updated each year.

While SNAP is a federal program, you must apply in the state where you currently live and meet the state's requirements, as each state manages its own application process, eligibility criteria, and benefit distribution. Some states, such as California, New York, and Washington, have income limits higher than the federal ones, so it is worth applying to see if you qualify.

Currently, only less than half of eligible older adults are participating, meaning over half may be missing out on this valuable support. Please consider applying to see if you are eligible.

Note: The primary residence (the house the person lives in) and one car that is used for transportation are typically not counted as assets for Senior Medicaid, Medicare Savings Program (MSP), and SNAP

Raisins, with their high iron content, assist in red blood cell production, improving oxygen and nutrient circulation throughout the body, including your scalp, and promoting hair growth.

Raisins have high antioxidant content including resveratrol that acts as a defense against the harmful effects of free radicals that can cause hair damage, hair thinning, aging, and even greying. Resveratrol also increases hair growth and overall appearance. All these nutrients including zinc can help with scalp health, strengthening hair follicles, promoting healthy hair growth, and maintaining hair's natural color and potassium helps to regulate moisture levels in the hair, preventing dryness and breakage.





Munching on a handful of raisins as a quick and healthy snack, not only improving hair health, but also complementing our overall well-being. Apart from being a delicious snack, raisins can be incorporated into various recipes for added hair-nourishing benefits. You can toss them into a salad, Kheer, Upma, or sprinkle them on top of oatmeal or yogurt, or even bake them into whole-grain muffins.

Raisin water is considered beneficial for our hair health. Raisin water produces collagen that supports hair

strength and elasticity. It also contains vitamin B, which is important for hair growth. Raisin water reduces inflammation, and prevents issues of dryness and dandruff. It also soothes irritated scalp and maintains a healthy balance of natural oils, flakiness, and itching. The natural oil present in raisins moisturize and nourish your hair, leaving it glossy, and a game changer for dull and lifeless hair.

How to make raisin water or Kishmish water?

Raisin water is a drink made from soaking raisins overnight.1) Boil two parts water, 2) Add one part raisins, 3) Turn off the heat, 4) Allow it to soak overnight, 5) Discard the raisins, 6) Drink the water.

The drink is a light golden brown color and has a nice natural sweetness to it.

How to use raisins in natural hair care?

One of the easiest ways to use raisins in natural hair care is to make a hair mask. Simply soak a handful of raisins in water overnight, and then grind them into a paste. Apply the paste to your hair, covering it completely, and let it sit for 30 minutes to an hour. Rinse the paste out of your hair with warm water, and then shampoo and condition your hair as usual.

You can also use raisins as a natural conditioner. Simply soak a handful of raisins in water for an hour, then strain out the water and mix it with coconut oil. Apply the mixture to your entire hair and let it sit for a few minutes and then massage it into your scalp and hair. Rinse the mixture out of your hair with warm water, and then shampoo and condition your hair as usual.

What are the benefits of raisin water?

The general benefits of raisin water include: 1) Minimizing skin aging, 2) Detoxifying your liver, 3) Reducing hunger, leading to weight loss, 4) Relieving constipation, 5) Growing thicker hair, 6) Managing polycystic ovary syndrome.

What are the 4 stages of the hair growth cycle

1) Anagen Phase: Also known as the 'Growth Phase' or 'Active Phase', is when the cells in the root of your hair are most rapidly dividing so more new hair is formed. During this phase, hair grows around half an inch a month [about six inches a year], and faster in the summer than in winter. This phase lasts an average of three to five years

2) Catagen Phase: Catagen Phase signals the end of

active hair growth and cuts individual hairs off from the blood supply and from the cells that produce new hair. Approximately three percent of all hairs are in this stage at any time and it lasts for around 10 days.

3) Telogen Phase: This Phase is a resting period when strands remain in their follicles but are not actively growing. An estimate of 10-15 percent of your hairs is in the Telogen Phase at any given moment. The Telogen Phase lasts around three months or 100 days.

4) Exogen Phase: During this final stage of the hair growth cycle, when individual hair strands are released from their follicles and fall out. Then the whole process begins again.

Raisins are a great ingredient for natural hair care, with their high concentration of vitamins, minerals, and antioxidants, they can help nourish and condition the hair, leaving it soft, shiny, and full of life.



Know Simple Ways to Lower Your Blood Sugar

bout one in three, or 98 million, Americans have prediabetes, where blood sugar has risen above healthy levels but is not high enough yet to be classified as diabetes. Nearly 1 in 6 adults, or 15.8 percent, have diabetes, according to the latest figures from the Centers for Disease Control and Prevention (CDC). The rate increases with age, rising to 17.7 percent for those 40 to 59, then to more than 1 in 4, or 27.3 percent, for adults age 60 and older. People with prediabetes have a higher risk of suffering from a heart attack or stroke in the future along with other heart disease issues even without full-blown diabetes. Uncontrolled blood glucose levels over a long period can affect multiple organ systems, including the nervous system, kidneys, eyes, heart, and blood vessels.

How to control our blood sugar?

Even though it seems difficult to get high blood sugar under control. However, medical experts say a number of simple steps can bring glucose levels back into a healthy range.

1. Know your blood sugar numbers: To start, you need to know where you stand. People who are between 35 to 70 years and overweight or obese get screened for prediabetes and diabetes. A fasting blood sugar test, anything below 100 milligrams per deciliter is considered healthy. A glucose level of 100 to 125 mg/dL is considered prediabetes and 126 mg/dL or higher is diabetes

Another test, hemoglobin A1C, measures a person's average blood sugar over two to three months as a percentage. A result of 5.7 to 6.4 percent is considered prediabetes and 6.5 percent or higher is diabetes.

- 2. Consider using a glucose monitor: People with diabetes are suggested to use continuous glucose monitors - wearable devices that provide ongoing data on blood sugar to track their levels. While those who don't have diabetes use the technology as well to keep tabs on their blood sugar. Continuous glucose monitors help with better understanding the immediate impact of lifestyle on glucose levels. For example, you can see how different food choices, different activity levels impact your blood sugar, then you can use that information to make a different choice the next time.
- 3. Do not complicate exercise: Incorporate regular but light physical activities such as a brisk walk of 150 minutes a week. Combing strength training with cardio is more effective for controlling

blood sugar than aerobic exercise alone. You should try to work all major muscle groups, including legs, hips, back, abdomen or core, chest, shoulders and arms because you need muscle to fight off insulin resistance. Therefore, if possible, aim to do weight-bearing exercise twice a week, Exercising 30 minutes after a meal may be optimal to help with blood glucose control.

4. Know foods with glycemic index: The glycemic index of foods is used for easy categorization. This is used to rate foods containing carbohydrates by how quickly they can cause blood sugar to rise. The leafy greens like spinach as well as beans, such as chickpeas and beans, which have all been linked to lower blood sugar levels. Recent research studies have found that those who ate a healthy diet emphasizing fruits, vegetables, legumes, whole grains, nuts, tea and coffee, while minimizing less healthy plant foods like refined grains and fruit juices along with animal-based proteins, had a lower risk of developing diabetes.

8. Fill a fourth of your plate with healthy carbs: Macronutrient like protein and fat has a place in a healthy diet. However, carbs should not cover half your plate. Try grams a day for women and 30 grams for men. Vegetables like lentils, nuts and fruits, especially those with edible skin, such as apples and pears, and edible seeds including berries are good sources

10. Have a good sleep: Adequate sleep is critical not only for diabetes management but in terms of metabolic diseases including weight management. Conversely, not getting at least seven hours of shut-eye nightly is associated with insulin resistance, according to a review of research. When that happens, the cells do not respond to that hormone as they

scale starts at zero and goes up to 100 for pure sugar.

It is important to know that the same food does not affect everyone's glucose level in the same way. How foods are prepared or if they have been combined with other foods can also affect blood sugar. For example, white potatoes can be healthful if they eat them with the skins,

- 5. Get professional help: Doctors and dietitians who regularly work with patients who have diabetes can help a person with prediabetes and create a road map for getting blood sugar back in a healthy range.
- 6. Cut back not just on sugar but also on all ultra--processed foods: Obvious blood sugar spikers like cookies, ice creams, and cake should be consumed in moderation. However, you also want to reduce foods that can cause glucose levels to rise quickly. Most people think it is the sweets they need to avoid, and that is true. Nevertheless, the starchy carbohydrates like bread, pasta, noodles and white rice are the most deadly culprits that will raise their sugar levels.
- 7. Follow balanced diet: A balanced diet that cuts carbs could help with weight loss which itself is protective against diabetes and quickly bring blood sugar back into a healthy range,
- 8. Fill half your plate with veggies: Load up your plate with vegetables such as dark

to have more foods like quinoa or faro, lentils and chickpeas, and brown rice and fewer processed carbs. Starchy favorites like corn or potatoes will raise your blood sugar.

9. Pump up the fiber: The American Diabetes Association (ADA) recommends that people with diabetes and those at risk for it eat at least 14 grams of fiber per 1,000 calories (or 28 grams for a 2,000calorie diet). The latest research in people age 50 and over, recommends 20 to 25 should - to efficiently take in sugar from the blood, convert it to energy-, and blood glucose rises. In addition, being sleep-deprived can make it harder to handle stress, which also contributes to the stew of toxic hormones such as cortisol linked to insulin resistance

Trump formally announces 25 pc tariffs on all steel, aluminum imports

WASHINGTON: US President Donald Trump has announced plans to impose 25 percent tariffs on all steel and aluminum imports coming into the United States "without exceptions or exemptions," raising concerns over its ramifications on South Korean and other exporters.

Trump signed two proclamations regarding the sweeping tariffs, while affirming a plan to announce "reciprocal" tariffs "over the next two days" -- duties on U.S. imports designed to match tariff rates that other countries impose on U.S. exports, reports Yonhap news agency.

During his first term, Trump imposed a 25 percent tariff on steel imports and 10 percent on aluminum imports on national security grounds. The new measures will remove exceptions, exemptions and duty-free quotas for U.S. trading partners, while raising the tariff on aluminum to 25 percent. They are set to take effect on March 4.

"Today, I am simplifying our tariffs on steel and aluminum so that everyone can understand exactly what it means. It's 25 percent without exceptions or exemptions, and that's all countries, no matter where it comes from," Trump told reporters as he signed the documents.

"If it's made in the United States, there is no tariff. All you have to do is make it in the United States. We don't need it from another country," he added. *IANS*

The Ministry of Trade, Industry and Energy held a meeting with officials from major local steel companies, including POSCO Holdings Inc. and Hyundai Steel Co., to discuss responses to the proposed US tariffs, according to ministry officials. *IANS*

Trump suspends US Foreign Corruption Act; Adani Group stocks surge

WASHINGTON: After US President Donald Trump signed an executive order to halt the enforcement of a law that prohibits US companies from bribing foreign officials, claiming that the restriction disadvantages American firms, all the listed stocks of the Adani Group witnessed substantial gains on Tuesday (11 February).

Trump has signed an executive order to ease the enforcement of the Foreign Corrupt Practices Act (FCPA).

The US President directed Attorney General Pam Bondi to suspend actions under the Act, until she establishes new enforcement guidelines, as outlined in a fact sheet on the executive order. Additionally, all current and past actions under the FCPA will be reviewed.

"Since its enactment in 1977, the Foreign Corrupt Practices Act (15 U.S.C. 78dd-1 et seq.) (FCPA) has been systematically, and to a steadily increasing degree, stretched beyond proper bounds and abused in a manner that harms the interests of the United States," according to a White House statement.

Current FCPA enforcement impedes the United States' foreign policy objectives and therefore implicates the President's ness overseas. Trump had considered eliminating the law during his first term.

"The President's foreign

Article II authority over foreign affairs.

The FCPA forbids any company or individual with US ties from offering money or gifts to foreign officials to secure busipolicy authority is inextricably linked with the global economic competitiveness of American companies. American national security depends in substantial part on the United States and its companies gaining strategic business advantages whether in critical minerals, deep-water ports, or other key infrastructure or assets," according to the statement.

"But over expansive and unpredictable FCPA enforcement against American citizens and businesses - by our own Government - for routine business practices in other nations not only wastes limited prosecutorial resources that could be dedicated to preserving American freedoms, but actively harms American economic competitiveness and, therefore, national security," it emphasized.

"It is therefore the policy of my Administration to preserve the Presidential authority to conduct foreign affairs and advance American economic and national security by eliminating excessive barriers to American commerce abroad," said the order.

In a significant development for the Adani Group, all its listed stocks witnessed substantial gains, after US President Donald Trump signed an executive order to ease the enforcement of the FCPA. IANS


NEW DELHI: Union Minister of Commerce and Industry, Piyush Goyal, recently outlined India's ambitious technological and infrastructural roadmap at the India-Israel Business Forum, emphasizing rapid advancements in 5G connectivity, infrastructure expansion, and public welfare programs.

He said, "By end of calendar 26 the entire country would be working only on 5G. We have already started developing our indigenous technology for 6G for telecom connectivity."

The minister underlined India's impressive infrastructure progress, stating that in the last decade, India has doubled its port capacity and expanded its airport network from 74 to over 150, with plans to increase this figure to 225 airports within the next five to six years.

The country has also made remarkable strides in highways and roadways while initiating 114 inland waterways to strengthen its transportation network.

On the public welfare front, Goyal emphasized the government's commitment to providing affordable housing, stating that

40 million homes have been built for the poorest sections of society in the past decade, with an additional 30 million set to be constructed in the next five years. He noted that this initiative will ensure 25 percent of the most underprivileged popula-

tion has a proper home.

Further, he underscored efforts to provide universal access to electricity and digital connectivity, with 160 million households already receiving clean drinking water through tap connections.

Goyal said, "We have ensured that every family in the country every home in the country going beyond even these 70 million gets electricity, gets digital connectivity. Already about 160 million homes have been connected with water from a tap directly at home. In the next 2, two and a half years, every home will receive water coming directly from a tap."

He added, "Every home in the country today has a cooking gas connection so they are not dependent on traditional means of cooking. We are now moving towards pipe gas connection in all the cities of the country."

In the energy sector, India has made rapid progress, ensuring universal access to cooking gas connections, reducing dependence on traditional biomass fuels. The country is now moving towards piped gas connections across all cities.

Reaffirming India's position as the fastest-growing large economy, Goyal expressed confidence that this momentum will continue for years to come, fueled by strong infrastructure investment and economic policies. *ANI*

"Indian Ambassador to Denmark, Manish Prabhat, DG Mathur, DG-elect Khanna discussed ISA's Sustainable Renewable Energy initiatives attracting global funding and technology, including from India and Denmark," the Indian Embassy in Copenhagen posted on X this week.

In 2021, Denmark signed a framework agreement on the International Solar Alliance with India and became the first country to ratify the International Solar Alliance Framework Agreement.

India and Denmark also collaborated in the ISA and during India's G20 presidency. Denmark participated in the working groups on climate, environment and energy transmission as a part of the Green Strategic Partnership between both nations.

The International Solar Alliance organized the third edition of the High-level Conference on New Technologies for Clean Energy Transition in November 2024.

It was held in collaboration with India's

Ministry of New and Renewable Energy, the Asian Development Bank, and the International Solar Energy Society.

A report on the 'Readiness Assessment of Green Hydrogen African Countries' by ISA and Denmark was released during the inaugural session of the event.

Sharing his insights on the report, Emil S. Lauritsen, Head of Strategic Sector Cooperation, Embassy of Denmark in New Delhi, stated, "This report is the first project under the umbrella of the memorandum of understanding for the green hydrogen partnership, which the Embassy of Denmark has inked with the ISA. *IANS*

Six American lawmakers write to US Attorney General against Adani's indictment

WASHINGTON, DC: Six US lawmakers have highlighted the Adani indictment in a letter written to the newly-appointed US Attorney General Pamela Bondi over "questionable decisions" made by the US Department of Justice (DoJ) under Joe Biden.

"Some of these decisions involved selectively pursuing and abandoning cases, often acting against America's interests at

home and abroad, jeopardizing relationships with close allies like India," the lawmakers said.

In the letter, the US Congressmen mentioned about the case against India-based company Adani Group.

US lawmakers Lance Gooden, Pat Fallon, Mike Haridopolos, Brandon Gill, William R

Timmmons and Brian Babin were who signed the letter written to Pamela Bondi.

"We would like to congratulate you on your recent Senate confirmation and appointment as Attorney General of the United States. In addition to the Senate's backing and President Trump's endorsement, we have full faith and confidence in your dedication and ability to serve our country. As you take the helm of the Department of Justice (DOJ) as our new Attorney General, we would like to bring your attention to some questionable decisions made by the DOJ under the Biden administration."

According to the letter, the case rests on the allegation that preparations were

made by members of the company in India to bribe Indian officials. The US lawmakers said that the US Department of Justice instead of deferring the case to Indian authorities decided to push forward and indict the company's executives.

India must protect its citizens' rights: Vikramaditya Singh

SHIMLA: The Public Works Department (PWD) Minister of Himachal Pradesh, Vikramaditya Singh has strongly criticized the way the United States has been deporting alleged illegal immigrants back to India, calling it a violation of human rights.

Singh expressed his discontent over the repatriation of Indians, stating that history has witnessed similar deportations in 2009, 2012, and subsequent years, but the present circumstances are different and more concerning.

"Our point is that we have seen such deportations in history in 2009, in 2012, and afterward as well. But the circumstances today are different. These individuals were handcuffed, shackled, and forcibly put onto US military aircraft before being deported to India, specifically to Amritsar. This is against human rights," Singh said.

Singh emphasized that while he does not support illegal immigration, the manner in which the deportation was carried out is highly objectionable.

"We are not supporting illegal immigration. If someone is living illegally in any country, it is the right of that country to deport them. We are not questioning that. But the way it was done, that is the issue," he said.

Drawing a comparison with Colombia, which arranged its own aircraft to bring back its deported citizens, Singh questioned why the Indian government failed to do the same.

"I hope strict action is taken": Father of a man who allegedly illegally migrated to US

AMBALA: A heart-wrenching tale of deception and despair has emerged from Ambala, Haryana, where a father has shared the story of his son's ill-fated attempt to migrate to the US.

The son, who owned a shop in Ambala, was lured by an agent who promised a quick and easy passage to the US. The agent allegedly took Rs 40-45 lakhs from the family, claiming that he would send the son to the US within a month.

However, the agent's assurances proved to be false. The son was taken through the notorious "donkey route," a treacherous and illegal border crossing, where he was forced to walk for hours. He was eventually caught by US authorities on January 19 and deported back to India.

Speaking to ANI, the father urged the government to take strict action against those who are sending people to the US illegally and duping them of their hard-earned money. He also said to file a complaint against the agent.

"My son had his shop here but he got lured by an agent. The agent said that he would send him there quickly. My son was adamant that he wanted to go there. The agent misled him and told him that he would send him there within a month. But the pension...I hope strict action is taken against those who are sending people duping them...We will complain against

U.S. Citizenship and Immigration Services (USCIS) announced that the initial registration period for the fiscal year 2026 H-1B cap will open at noon Eastern on March 7 and run through noon Eastern on March 24, 2025. During this period, prospective petitioners and representatives must use a USCIS online account to register each beneficiary electronically for the selection process and pay the associated registration fee for each beneficiary.

Prospective H-1B cap-subject petitioners or their representatives are required to use a USCIS online account to register each beneficiary electronically for the selection process and pay the associated \$215 H-1B registration fee for each registration submitted on behalf of each beneficiary.

If you are an H-1B petitioning employer who does not have a USCIS online account, you will need to create an organizational account. If you are an H-1B petitioning employer who had an H-1B registrant account for the FY 2021 - FY 2024 H-1B registration seasons, but you did not use the account for FY 2025, your existing account will be converted to an organizational account after your next log in

If you are an H-1B petitioning employer who does not have a USCIS online account, you will need to create an organizational account. If you are an H-1B petitioning employer who had an H-1B registrant account for the FY 2021 - FY 2024 H-1B registration seasons, but you did not use the account for FY 2025, your existing account will be converted to an organizational account after your next log in. First-time registrants can create an account at any time. You can find additional information and resources on the organizational accounts, including a link to step-by-step videos, on the Organizational Accounts Frequently Asked Questions page. These FAQs will be updated with FY 2026 information before the start of the initial registration period.

Representatives may add clients to their accounts at any time, but both representatives and registrants must wait until March 7 to enter beneficiary information and submit the registration with the \$215 fee. Selections take place after the initial registration period closes, so there is no requirement to register on the day the initial registration period opens.

The FY 2026 H-1B cap will use the beneficiary-centric selection process launched in FY 2025. Under the beneficiary-centric process, registrations are selected by unique beneficiary rather than by registration. If we receive registrations for enough unique beneficiaries by March 24, we will randomly select unique beneficiaries and send selection notifications via users' USCIS online accounts. If we do not receive registrations for enough unique beneficiaries, all registrations for unique beneficiaries that were properly submitted in the initial regis-

tration period will be selected. We intend to notify by March 31 prospective petitioners and representatives whose accounts have at least one registration selected.

The U.S. Department of Treasury has approved a temporary increase in the daily credit card transaction limit from \$24,999.99

to \$99,999.99 per day for the FY 2026 H-1B cap season. This temporary increase is in response to the volume of previous H-1B registrations that exceeded the daily credit card limit. Transactions more than \$99,999.99 may be made via Automated Clearing House (ACH). Use of ACH may require the payer to alert their bank in advance to remove any potential ACH block on their account. We will provide additional information before the start of the initial H-1B registration period.

An H-1B cap-subject petition, including a petition for a beneficiary who is eligible for the advanced degree exemption, may only be filed by a petitioner whose registration for the beneficiary named in the H-1B petition was selected in the H-1B registration process. Additional information on the electronic registration process is available on the H-1B Electronic Registration Process page. *USCIS*

"If a small country like Colombia could send its aircraft to bring its people back, why did the Indian government not send its own plane to the US? Why were these Indians not brought back in civilian aircraft, like before?" said Vikramaditya Singh.

He took a dig at Prime Minister Narendra Modi's relationship with US President Donald Trump, urging the government to take stronger diplomatic action.

"Our Prime Minister Narendra Modi repeatedly calls the newly elected US President Donald Trump his friend. If they are such good friends, then at least he should have ensured that these people were brought back on civilian planes rather than being shackled and deported in a humiliating manner." Singh said.

"Not allowing any media to cover this is unfortunate. These deportees are Indians. There must have been certain circumstances or shortcomings that forced them to take an illegal route to stay in the US. The Indian government should have taken proper steps to bring them back in a dignified manner and should have raised this issue firmly with the US administration." Singh said.

Asserting that India aspires to become a Vishwaguru (World Leader), Singh said that the government's actions must align with that vision. *ANI*

Trump rules out deporting Prince Harry: "He's got enough problems with his wife"

WASHINGTON DC: US President Donald Trump has ruled out deporting Prince Harry from the United States, despite ongoing litigation questioning the Duke of Sussex's immigration status, the New York Post reported.

In a recent interview with The New York Post, Trump made it clear that he does not want to take action against Harry.

"I don't want to do that," he said. "I'll leave him alone. He's got enough problems with his wife. She's terrible," Trump added while speaking with the New York Post.

This statement comes amid legal challenges involving Harry's visa, particularly from the Heritage Foundation,

which has raised concerns over Harry's potential failure to disclose past illegal drug use during his visa application process, the report added.

Trump took the opportunity to express admiration for Harry's estranged older brother, Prince William, calling him "a great young man." The two had met privately in Paris during the reopening of Notre-Dame Cathedral in December 2024, a meeting that stood in stark contrast to Trump's strained relationship with Harry and his wife.

The Duke and Duchess of Sussex have long been vocal critics of Trump. Meghan Markle referred to him as "divisive" and "misogynistic" in previous public statements, while Trump has regularly ridiculed Harry, claiming that the prince is "whipped" by Meghan. "I think poor Harry is being led around by the nose," Trump remarked in a previous interview, the New York Post reported.

The Heritage Foundation's lawsuit against the Department of Homeland Security has called into question Harry's honesty in his US visa application, citing admissions in Harry's autobiography Spare about his past drug use, including cocaine, cannabis, and psychedelics.

Nile Gardiner of the Heritage Foundation said, "Anyone who applies to the United States has to be truthful on their application, and it is not clear that is the case with Prince Harry," the New York Post reported.

The conservative think tank has also suggested that Harry may have received favorable treatment from the Biden administration after he and Meghan relocated to California in 2020, following their departure from the British royal family, a move widely known as "Megxit", the report added. *ANI*

Human breast milk may heal corneal wounds: Study

NEW DELHI: Using human breast milk may enhance the healing of the cornea -- the clear outer layer at the front of the eye, which helps the eye to focus light to help one see clearly, finds a study.

Corneal wound healing is a complex process involving cell death, migration, proliferation, differentiation, and extracellular matrix remodeling.

The study by ophthalmology researchers from the University of Colorado showed that when used on wounded corneas in animal models, human breast milk led to an increase in re-epithelialization -- a part of the wound healing process.

The wounded eyes treated with human breast milk showed higher levels of Ki67 -- a protein that's produced in cells that are actively dividing. Quick recovery is crucial in these kinds of eye injuries because it prevents infection that may cause further damage to the eye.

"The sooner that wound can heal, the better. Human breast milk seems to stimulate that process," said Mark Petrash, Professor of ophthalmology, from the varsity. IANS

Clot-busting meds can boost stroke patients' recovery by over 50 pc: Study

NEW DELHI: A team of Chinese researchers has found that clotdissolving medication - alteplase - can be key to improving stroke patients' recovery by more than 50 percent.

The team from Zhejiang University, presenting the research at the American Stroke Association's recent International Stroke Conference 2025, held in Los Angeles, US, reported that the medicine is effective when given up to 24 hours after the beginning of an ischemic stroke.

The golden hour for patients with stroke, which occurs when poor blood flow to a part of the brain causes cell death, is the first 60 minutes after symptoms begin, during which treatment is most effective. Till now the known window for effective treatment was up to 4.5 hours for some patients.

The study results show promise to patients suffering from stroke worldwide, who may not be able to access clot-dissolving medications within the time period, said Min Lou, Professor at the Second Affiliated Hospital of Zhejiang University's School of Medicine in China.

Their study was based on 372 stroke patients whose symptoms began 4.5


hours to 24 hours earlier. The participants were randomly split into two groups. While one group received the clot-busting medication alteplase, others were prescribed standard stroke care of antiplatelet therapy.

About 40 percent of participants treated with alteplase showed little to no disability after 90 days. Conversely, only 26 percent of those who received standard care had no disability. The findings show a 54 percent higher chance of functional recovery with alteplase.

However, the risk of brain bleeding was higher among those who received alteplase than among participants who did not (3.8 percent vs. 0.5 percent), but researchers believe this is a manageable risk.

Calling for more research, Lou explained, that the findings must be applied to other groups of people, especially in areas with different stroke risks and health care resources to understand the efficacy and safety of alteplase and other such medicines. IANS



IIT Roorkee team finds superbug's defense mechanism, to boost new treatments

ROORKEE: Scientists at the Indian Institute of Technology (IIT) Roorkee have uncovered a crucial regulatory mechanism in Acinetobacter baumannii -- a highly drugresistant superbug responsible for life-threatening infec-

Their study, published in the journal mBio, reveals how the pathogen controls its attack and defense systems,

paving the way for new treatment strategies.

Acinetobacter baumannii poses a serious threat in healthcare settings as it resists multiple antibiotics. It causes severe hospital-acquired infections, including pneumonia, bloodstream infections, and urinary tract infections.

To attack competing

microbes, the superbug uses the Type 6 Secretion System (T6SS) -- a bacterial "weapon". However, its mechanism for maintaining antibiotic resistance has remained unclear until now.

The research team, led by Prof. Ranjana Pathania, discovered that A. baumannii switches T6SS on or off based on environmental conditions. They found that a small RNA molecule -- AbsR28 -- plays a key role in this regulation, influenced by manganese levels.

When manganese levels are high, AbsR28 binds to an essential gene (tssM) required for T6SS function. This not only leads to its degradation but also prevents the activation of T6SS, said the researchers.

Increased manganese levels also enable A. baumannii to retain plasmid pAB3, which carries multiple antibiotic-

resistance genes.

"We found that when A. baumannii activates T6SS, it becomes more vulnerable to antibiotics and oxidative stress. So. the bacteria must carefully regulate this system to survive in different conditions." said Prof. Pathania.

"Our discovery sheds light on how this pathogen

adapts during infections, helping it evade both antibiotics and the immune system," she added.

The findings showed that targeting AbsR28 can help disrupt the superbug's regulatory system. This makes it more susceptible to antibiotics without directly attacking resistance genes. The discovery also opens new avenues for precision medicine and novel drug development against multidrug-resistant infections. IANS

Study uses clues from body to understand signaling in brain

VIRGINIA: Our biceps and brain cells might have more in common than we believed. According to a new study from the Lippincott-Schwartz Lab, a network of subcellular structures similar to those responsible for propagating molecular signals that make muscles contract are also responsible for transmitting signals in the brain that may facilitate learning and memory.

"Einstein said that when he uses his brain, it is like he is using a muscle, and in that respect, there is some parallel here," said Janelia Senior Group Leader Jennifer Lippincott-Schwartz. "The same machinery is operating in both cases but with different readouts."

The first clue about the possible connection between brain and muscle cells came when Janelia scientists noticed something strange about the endoplasmic reticulum, or ER - the membranous sheets and folds inside cells that are crucial for many cellular

Lorena Benedetti, a research scientist in the Lippincott-Schwartz Lab, was tracking molecules at high resolution along the surface of the ER in mammalian neurons when she saw that the molecules were tracing a repeating, ladder-like pattern along the entire length of the dendrites -- the branch-like extensions on brain cells that receive incoming signals. ANI

Australian homelessness services report surge in demand

SYDNEY: Australia's homelessness services have reported a major surge in demand for assistance amid the country's housing crisis.

According to a survey conducted by NGO Everybody's Home, 87 percent of Australia's frontline homeless support organizations experienced a major increase in their workload in December and January compared to previous years.

Among the organizations that were surveyed, 98 percent reported increased workloads last year and said they expect demand to continue rising in 2025.

Two-thirds of organizations said they have been unable to provide long-term housing solutions for clients, 71.7 percent reported increased waitlists and half said they have fewer resources per client than a year ago.

Everybody's Home spokesperson Maiy Azize said that the organizations reported "the worst summer on record" as high rental prices and the rising cost of living continue to impact Australians.

"The services at the coalface of Australia's housing crisis are at breaking point. They can barely keep up with the rising number of people facing housing stress and homelessness," Azize said in a statement. IANS

Rate cut to spur residential demand, lower home loan rates: Industry

NEW DELHI: The real estate industry has welcomed the much-awaited benchmark rate cut of 25bps by the Reserve Bank of India (RBI), saying lowered interest rates will further nudge homebuyers to buy an ownership home with an upgraded lifestyle.

The Central Bank's Monetary Policy Committee (MPC) cut the repo rate by 25 basis points to 6.25 percent. RBI Governor Sanjay Malhotra said the MPC has also unanimously decided to continue with a neutral stance and will focus on inflation while supporting growth. *IANS*

Affordable housing to get boost from reporate cut, tax exemption relief: Hiranandani

MUMBAI: Real estate business leader Niranjan Hiranandani said affordable housing segment will get yet another boost with the reduction in repo rate by the RBI monetary policy committee.

Managing Director of Hiranandani Group, lauding the Budget and its massive tax relief, said that the Finance Minister gave a big boost by raising exemption limit.

"I think RBI's now reduction is going to give the second big boost to the economy," Hiranandani said.

"Affordable housing will be the most delighted because in the last one, one-and-a-half years, there was a setback to affordable housing because of the higher interest rate impact," the real estate business leader told ANI.

China's growing tentacles in South Asia: How India is drawing inspiration from its ancient treatise to strategize national security MAJOR GENERAL S.G.VOMBATKERE (RETD.)

ndia's diplomatic relations with China are circum scribed by China's territorial claims along shared borders, with military deployments leading to confrontation or conflict. However, relative war-fighting capability apart, China has economic and technological advantage over India, and this asymmetry is increased due to India's heavy reliance on Chinese imports. [Ref.1]

The asymmetry is further accentuated by China's aggressively successful diplomacy on economic, political and military fronts, with all of India's smaller neighbors. [Ref.1] Thus, India is not in equilibrium with China, inasmuch as strategic diplomacy is concerned.

Apart from maintaining focus on China, in an increasingly complex world, India needs to urgently address and refine its wisdom with contemporary military practices, forging a unique and holistic approach to address modern security challenges. It is a "visionary initiative" by the Indian Army that seeks "to integrate age-old wisdom with contemporary military pedagogy". [Ref.2]

The Army published "Paramparik Bhartiya Darshan: Ranniti aur Netritva ke Shashwat Niyam" (Traditional Indian Philosophy: Eternal Rules of Warfare and Leadership), and is encouraging all ranks to read this book. [Ref.3]

Literature like Chanakya's Arthashastra underscores the importance of strategic partnerships, alliances and diplomacy, aligning with modern military practices such as international cooperation and soft power projection. Chanakya's teachings on statecraft and warfare are

The objective of Project Udbhav is to synthesize ancient studied by various institutions the world over. Similarly, the wisdom of Thirukkural, the classical Tamil text authored by Thiruvalluvar, the Tamil philosopher, advocates ethical conduct in all endeavors, including warfare. The Army holds that this aligns with modern military codes of ethics of just war and principles of Geneva Convention.

There are several learned treatises on statecraft in India's 5,000-years of cultural heritage. However, Government of India and the Indian Army have presently focused on Arthashastra. Indeed, a figure of Chanakya features prominently in a painting titled "Karam Kshetra - Field of Deeds", installed in the office of the Army chief. The painting portrays the Army as "guardian"

of Dharma, fighting not merely as a defender of the nation but to uphold justice and protect the nation's values", with "the strategic and philosophical wisdom of Chanakya". [Ref.4]

Arthashastra lessons in statecraft

Arthashastra is a respected treatise on statecraft, politics, economics, governance, and military strategy. It was written by Chanakya - also known as Kautilya - in the 4th century BCE. Arthashastra is sanctified as an upaveda, along with Ayurveda, Dhanurveda, Gandharvaveda and Shilpashastra.

Arthashastra's principles and precepts have guided rulers (using the word "king" to mean "raja") of small and large kingdoms or states in India since ancient times. A state was expected to have seven components ('saptanga') - king, council of ministers, capital city, its own territory, treasury, army, and foreign ally. The survival of a state required that its king was instructed in statecraft, and developed personal expertise in hand to hand combat.

Arthashastra is a prescriptive guide to a king on how to protect his state and increase his wealth by acquiring other kingdoms. [Ref.5] The assumption that the king of a neighboring kingdom will also protect his own kingdom and try to increase his own wealth, and is therefore a potential enemy, is the in-built realism of Arthashastra. Recognizing that competition between adjacent states is a given, Arthashastra also mandates effective governance through fair and just management of the business of the state, to complement military strength.

WHAT WILL HAPPEN TO GAZA?

President Donald Trump's recent statement to take over Gaza strip and turn it into a tourist spot by US in the Middle East, have made several Arab nations angry. But conquering Gaza is not new. The known history of Gaza spans 4,000 years. Gaza was ruled, destroyed and repopulated by various dynasties, empires, and peoples.

Originally a Canaanite settlement, it came under the control of the ancient Egyptians roughly 350 years before being conquered and becoming one of Philistine's principal cities. Gaza became part of the Assyrian Empire around 730 BCE. Alexander the Great besieged and captured the city in 332 BCE. Most inhabitants were killed during the assault, and the city, which became a center for Hellenistic learning and philosophy, was resettled by nearby Bedouins. The area changed hands regularly between two Greek successor-kingdoms, the Seleucids of Syria and the Ptolemies of Egypt, until it was besieged and taken by the Hasmoneans in 96 BCE.

The Gaza Strip, also known simply as Gaza, is a small territory, located on the eastern coast of the Mediterranean Sea; it is the smaller of the two Palestinian territories, the other being the West Bank, that make up the State of Palestine. Inhabited by mostly Palestinian refugees and their descendants, Gaza is one of the most densely populated territories in the world. An end of 2024 estimate puts the population of the Strip at 2.1 million.

Gaza is bordered by Egypt on the southwest and Israel on the east and north. Its capital is Gaza City and its largest city is currently Rafah. The territorial boundaries were established while Gaza was controlled by the Kingdom of Egypt at the conclusion of the 1948 Arab-Israeli war, during that period the All-Palestine Protectorate, also known as All-Palestine, was established with limited recognition and it became a refuge for Palestinians who fled or were expelled during the 1948 Palestine war. Later, during the Six-Day War, Israel captured and occupied the Gaza Strip, initiating its decades-long military occupation of the Palestinian territories.

The mid-1990s Oslo Accords established the Palestinian Authority (PA) as a limited governing authority, initially led by the secular party Fatah until that party's electoral defeat in 2006 to the Sunni Islamic Hamas. Hamas would then take over the governance of Gaza in the Battle of Gaza the next year, subsequently warring with Israel.

Trump has already announced 8bn dollar aid to Israel recently. What is his ultimate plan for the area, nobody knows. Is this the priority, for US to get involved in the complex conflict in the Middle East and make enemies with its Arab allies?

Trump should be concentrating on domestic issues like unemployment and up-skilling of the youth, to compete with rest of the world. Americans have given him the mandate to revive the US economy and fix issues, which were neglected by the Biden administration.

Where is "America First" the slogan that got him to the White House again?


