

### Death of Indian national in Russia: India calls for early discharge of remaining Indians from conflict zone

NEW DELHI: Reacting strongly to reports of the death of an Indian national in Russia, India reiterated its demand for the early discharge of the remaining Indians currently serving the Russian Army in the conflict zones.

"We have learnt of the unfortunate death of an Indian national from Kerala who had apparently been recruited to serve in the Russian Army. Another Indian national from Kerala, who was similarly recruited, has been injured and is receiv-

"We are working with the Russian authorities for early transportation of the mortal remains to India. We have also sought the early discharge and repatriation to India of the injured person. The matter has been strongly taken up with the Russian authorities in Moscow as well as with the Russian Embassy in New Delhi today. We have also reiterated our demand for the early discharge of the remaining Indian nationals," he added.

The plight of Indians fighting for Russia

India has maintained that the recruitment of Indian nationals into the Russian army in a conflict situation is not in consonance with the India-Russia diplomatic partnership, and has asked for the early release and return of all such Indian nationals. *IANS* 

### Biden administration to remove Cuba from US terrorism list

WASHINGTON DC: The Biden administration announced it will remove Cuba from the US state sponsor of terrorism list, reversing a designation made by Donald Trump's administration in 2021.

The White House in a press release 'Certification of Rescission of Cuba's Designation as a State Sponsor of Terrorism' quoted US President Joe Biden as saying, "Pursuant to the Constitution and the laws of the United States, and consistent with sections 1754(c) and 1768(c) of the National Defense Authorization Act for Fiscal Year 2019 (50 U.S.C. 4813(c) and 4826(c)), I hereby certify with respect to the rescission of the determination of January 12, 2021, regarding Cuba that the Government of Cuba has not provided any support for international terrorism during the preceding 6-month period; and the Government of Cuba has provided assurances that it will not support acts of international terrorism in the future."

On January 11, 2021, the US State Department designated Cuba as a State Sponsor of Terrorism for repeatedly providing support for acts of international terrorism in granting safe harbor to terrorists.

The US Embassy in Cuba in a press release had said, "The Trump administration has been focused from the start on denying the Castro regime the resources it uses to oppress its people at home and countering its malign interference in Venezuela and the rest of the Western Hemisphere. With this action, we will once again hold Cuba's government accountable and send a clear message: the Castro regime must end its support for international terrorism and subversion of US justice."

It added, "For decades, the Cuban government fed, housed, and provided medical care for murderers, bomb makers, and hijackers, while many Cubans go hungry, homeless, and without basic medicine. *ANI* 

### EAM Jaishankar to attend Trump's swearing-in ceremony on Jan 20

NEW DELHI: External Affairs Minister (EAM) S. Jaishankar will represent India at the swearing-in ceremony of US President-elect Donald Trump in Washington on January 20, according to a statement

from the Ministry of External Affairs (MEA).

The MEA noted, "On the invitation of the Trump-Vance Inaugural Committee, External Affairs Minister Dr S. Jaishankar will attend the swearing-in ceremony of President-elect Donald J. Trump as the 47th President of the United States of America."

The ministry further stated that Jaishankar will also engage with representatives from the incoming administration and other dignitaries during his visit.

Donald Trump is set to take the presidential oath of office at noon on January 20, administered by Supreme Court Chief Justice John Roberts on the steps of the US Capitol in Washington. Prior to this, Vice President-elect J.D. Vance will also be sworn in.

Last month, the Joint Congressional

Committee on Inaugural Ceremonies (JCCIC) announced "Our Enduring Democracy: A Constitutional Promise" as the theme for the 60th Inaugural Ceremonies. The theme pays tribute to the Founding

Fathers' commitment to preserving democracy for future generations.

As part of the inauguration, US flags will be flown at half-staff in honor of former President Jimmy Carter, who passed away at the age of 100. President Joe Biden ordered the flags to remain lowered for 30 days, ending at sunset


on January 28.

Trump's victory in the 2024 presidential election was certified by the United States Congress on January 6, clearing the path for his return to the White House. The certification officially validated the Electoral College results from November's election.


Inside the mandir, delegates offered prayers and closely admired the artistry of the intricately carved Ancient Civilizational Value tales on the mandir's facade.

# US SEC files lawsuit against Musk ahead of Trump inauguration

WASHINGTON: Just days ahead of Donald Trump's inauguration as the 47th US President, the Securities and Exchange Commission (SEC) has filed a lawsuit against his best ally Elon Musk over an alleged securities violation relating to his acquisition of Twitter (now called X) in 2022.

The SEC lawsuit alleged that the tech billionaire "failed to disclose his 5 percent ownership stake of Twitter in a timely manner", violating federal securities law.

The complaint, filed in federal court in Washington, DC, also claimed that the Tesla and SpaceX owner "waited to disclose the acquisition in order to build up a larger position in Twitter at a discounted price" said reports.

The lawsuit against Musk

came as Gary Gensler, Chairman of the SEC, is set to step down on January 20, the day

"As the SEC retreats and leaves office, the SEC's multi-year campaign of harassment against Mr. Musk culminated in the filing of a single-count ticky tak complaint against Mr. Musk," the lawyers said in a statement.

US President-elect has nominated Paul Atkins as the new SEC chief, who earlier served as SEC Commissioner and is expected to be a Trump ally.

Musk had bought Twitter for a whopping \$44 billion in October 2022. *IANS*

At least 24 percent of tasks across industries have the potential for full automation, while another 42 percent can be enhanced through AI, freeing up between 8-10 hours per week for knowledge workers," according to the EY India report.

GenAl is poised to transform every job, unlocking immense potential for productivity and economic gains.

"This revolution will fundamentally reshape jobs, driving productivity and innovation. Building talent pipelines and prioritizing upskilling must be at the forefront of every organization," said Rajiv Memani, Chairman and CEO, EY India.

By fostering public-private collaborations and investing in talent development, India can also become a global hub for AI skilled talent, he added.

The report stated that at an industry level, the largest productivity gains are expected in the services sector due to its higher labor share to gross output while manufacturing and construction will see smaller impact.

### India likely to see smartphone exports reach \$20 billion this fiscal

NEW DELHI: The country's smartphone market, which is projected to cross \$50 billion in value this year, is likely to see \$20 billion worth exports in FY25, riding on 'made in India' Apple iPhones.

In FY24, the country saw smartphone exports surpassing \$15 billion (with Apple's share at over \$10 billion). This fiscal, according to industry estimates, this figure is likely

to cross \$20 billion, further driven by iPhone exports.

Driven by the ongoing trend of premiumisation and thrust on local manufacturing, Apple and Samsung are leading the chart. The Indian smartphone market is evolving rapidly, with original equipment manufacturers (OEMs) increasingly focusing on premium launches to strengthen brand equity, showcase technological capabilities and improve profitability.

Owing to the production-linked incentive (PLI) scheme, Apple has already reached Rs 1 lakh crore in iPhone exports from India in the calendar year 2024.

Over the past four years, the Apple ecosystem has also generated 1,75,000 new direct jobs, with over 72 percent of these roles filled by women, as per the government data

stood at 5.8 crore units, which was increased to 33 crore units in 2023-24, with imports dropping significantly. Exports reached five crore units, and FDI increased by 254 percent, highlighting the PLI scheme's role in boosting manufacturing and investment.

The electronics sector in the country is projected to create 12 million jobs by 2027 - 3 million direct and 9 mil-

lion indirect roles.

Direct employment opportunities are likely to include employment for nearly 1 million engineers, 2 million ITI-certified professionals, and 0.2 million specialists in fields like AI, ML and data science, while non-technical roles are expected to contribute 9 million indirect jobs, highlighting the sector's immense potential to fuel economic growth, according to

a latest report by TeamLease Degree Apprenticeship.

The electronics industry has an ambitious goal of achieving \$500 billion in manufacturing output by 2030. To meet this target, the sector must grow five-fold over the next five years, bridging a \$400 billion production gap.

Currently, domestic production stands at \$101 billion, with mobile phones contributing 43 percent, followed by



### consumer and industrial electronics at 12 percent each, Back in 2014-15, domestic mobile phone production and electronic components at 11 percent. IANS

### India's automobile sales surge 11.6 pc to record 2.5 crore units in 2024

NEW DELHI: India's automobile sales surged by a robust 11.6 percent in 2024 to scale the highest-ever mark of 2.5 crore units compared to the corresponding figure of 2.3 crore units in the previous year, according to wholesale data released recently by the Society of Indian Automobile Manufacturers (SIAM).

With this, India remained the world's third largest car market last year.

"Positive consumer sentiments and the country's macroeconomic stability helped in propelling reasonable growth for the automobile sector across vehicle segments," said SIAM president Shailesh Chandra.

The growth has been primarily driven by the twowheeler segment which grew by 14.5 percent in 2024 as compared to previous year, posting sales of 1.95 crore units. In addition, passenger vehicles and three-wheelers posted their highest ever sales in a calendar year, he

Passenger vehicles (PV) grew by 4.2 percent in 2024 as compared to the previous year, with sales of around 43 lakh units. Three-wheelers posted a growth of 6.8 percent in 2024 as compared to the previous year, with sales of 7.3 lakh units.

The data for December showed passenger vehicle dispatches to dealers rose 10 percent to 3,14,934 units against 2,86,390 units in December 2023.

> Two-wheeler dispatches, however, witnessed a 9 percent

> > decline at 11,05,565 units over 12.12.238 units in December 2023. Threewheeler dispatches rose to 52.733 units in December from 50.947 units in December 2023,

SIAM said.

In the October-December quarter, passenger vehicles, commercial vehicles and three-wheelers posted their highest ever growth.

"The stable policy ecosystem of government in 2024, carrying on from the previous years, has helped the industry. As the new year commences with a positive sentiment being created through the Bharat Mobility Global Expo, this momentum would further propel growth in 2025." Chandra noted. IANS

### 3 Indian banks among top 25 global banks by market cap, ICICI standout performer

NEW DELHI: Three Indian banks -- HDFC Bank, ICICI Bank, and the State Bank of India (SBI) -- ended the fourth quarter (Q4) of 2024 at the 13th, 19th, and 24th spots in the top 25 global banks by market capitalization, respectively, according to a new report.

While HDFC Bank ended Q4 2024 with \$158.5 billion in market cap, ICICI Bank had a market cap of \$105.7 billion, and the SBI, \$82.9 billion, according to a report by GlobalData, a leading data analytics and research company.

Indian banks demonstrated resilience, with ICICI Bank emerging as a standout performer, with its market cap growing by 25.8 percent to \$105.7 billion, highlighting the strength of India's expanding digital banking and credit ecosystem.

However, HDFC Bank's market cap recorded a 1.6 percent increase to \$158.5 billion, due to rising competition and cost pressures.

The aggregate market capitalization of the top 25 global banks increased by 27.1 percent year-on-year (YoY), reaching \$4.6 trillion in the fourth quarter (Q4)



ended December 31, compared to the same period ended December 31, 2023.

JPMorgan Chase continues to remain the world's largest bank by market cap, recording an increase of 37.2 percent to \$674.9 billion by the end of Q4 2024.

Goldman Sachs witnessed a stellar 42.9 percent growth, which propelled it to ninth place in the chart from 13th position in the previous quarter.

Most of the stocks rose in Q4, benefiting from the US Federal Reserve's interest rate cuts, while other regional markets came under pressure amid worries over trade tariffs, according to the report.

According to Murthy Grandhi, company profiles analyst at GlobalData, the Federal Reserve implemented consecutive interest rate cuts of 25 basis points in November 2024 and December 2024.

"However, in December 2024, the Fed sparked a stock market sell-off by reducing the projected number of interest rate cuts for 2025. This adjustment was driven by concerns over persistently stubborn inflation," said Grandhi.

The report predicted that tariffs expected to be imposed under Donald Trump's administration and planned tax cuts in 2025 may offset each other.

However, risks such as rising sovereign debt, a stronger dollar, foreign outflows from emerging markets, geopolitical tensions in West Asia, China's economic stimulus, and the yen carry trade are key factors likely to influence market performance and economic growth. IANS

### HMPV cases in northern provinces declining: China

NEW DELHI: Cases of the Human Metapneumovirus (HMPV), a respiratory illness, is declining in the northern provinces, said Chinese officials.

Assuring that HMPV is a decades-old virus, Wang Liping, a researcher at the Chinese Center for Disease Control and Prevention, stated that the rise in case was due to better detection.

"At present, the rate of positive cases in human metapneumovirus detection is fluctuating, and the rate of positive cases in northern provinces is declining," said Liping, during a press briefing by China's National Health Commission.

"The rate of positive cases among patients aged 14 and below has started to decline," she

Liping noted the increase in recent years in the number of cases of the virus, first detected in the Netherlands in 2001, is due to better detection methods.

"The human metapneumovirus is not a new virus, and has been with humans for at least several decades," said Liping added. Earlier, several photos and videos emerged on social media showing hospitals in China swamped with people amid rising cases of HMPV -- causing respiratory illness -- and raising serious concerns of another pandemic akin to Covid-19. The Chinese government has dismissed this as an annual winter occurrence.

"Respiratory infections tend to peak during the winter season in the Northern Hemisphere. Recently, the National Disease Control and Prevention Administration of China held a press conference to share information about the prevention and control of respiratory diseases in China during the wintertime," said China's foreign ministry spokesperson Mao Ning.

"The diseases appear to be less severe and spread on a smaller scale compared with the previous year," Ning said.

Meanwhile, India has recorded about 10 cases, majorly from Karnataka, Tamil Nadu, Gujarat, and Assam. The majority of cases occurred in children between infants aged 3-month-old to 13 years. *IANS*

# Study links reel addiction with high BP in young, middle-aged people

NEW DELHI: Even as watching short videos or reels on social media platforms has become an integral part of the daily lives of young and middle-aged people, a new study shows that addiction to this can lead to high blood pressure.

The team analyzed data from 4,318 young and middle-aged people who self-reported screen time spent watching short videos at bedtime and also underwent medical examinations between January 2023 and September 2023.

They found that longer screen time spent watching short videos at bedtime was associated with higher hypertension prevalence.

"The screen time spent

watching short videos at bedtime was significantly associated with essential hypertension in young and middle-aged spent watching short videos at bedtime".

In addition, they also urged "control of body weight, blood



people," said the team, in the paper published in the journal BMC Public Health.

The researchers called for "strict control of screen time lipids, blood glucose, and uric acid levels, and improvement of poor lifestyle, such as a high-sodium diet," which can help reduce the risk of hypertension.

Previous studies have shown that prolonged mobile phone use, that is 30 minutes or more a week can increase the risk of high blood pressure or hypertension.

The study, published in European Heart Journal - Digital Health, a journal of the European Society of Cardiology (ESC), indicates that low levels of radiofrequency energy emitted from mobile phones have been linked with an increase in blood pressure.

According to the World Health Organization, nearly 1.3 billion adults aged 30 to 79 years worldwide have high blood pressure. It is a major risk factor for heart attack and stroke, as well as a leading cause of premature death. *IANS* 

## Obesity may affect survival rates in children with cancer: Study

NEW DELHI: Obesity at the time of cancer diagnosis in children may affect the survival rates, according to a recent study.

Over 390 million children and adolescents aged 5-19 years were overweight in 2022, including 160 million who were living with obesity, as per data from the World Health Organization (WHO). Obesity is a known precursor to many non-communicable diseases like diabetes, hypertension, and cancer.

"Our study highlights the negative impact of obesity among all types of childhood cancers. It provides the rationale to evaluate different strategies to mitigate the adverse risk of obesity on cancer outcomes in future trials," said Thai Hoa Tran from the Centre

Hospitalier Universitaire Sainte-Justine in Montreal, Canada. The team conducted a retrospective study on 11,291 children newly obese at the time of diagnosis.

Compared with patients without obesity at the time of initial cancer diagnosis, those with



diagnosed with cancer from 2001 to 2020, across Canada.

Of these children, aged 2 to 18 years, 10.5 percent were

obesity had lower rates of 5-year event-free survival (77.5 percent versus 79.6 percent) and overall survival (83.0 percent versus 85.9 percent).

After adjusting for factors including age, sex, ethnicity, neighborhood income quintile, treatment era, and cancer categories, the team found that obesity at diagnosis was linked with a 16 percent increase in the risk of relapse. There was also a 29 percent increase in the risk of death, revealed the study, published in the journal Cancer.

The negative impact of obesity on prognosis was especially pronounced in patients with acute lymphoblastic leukemia and brain tumors, said the team.

The study "also reinforces the urgent need to reduce the epidemic of childhood obesity as it can result in significant health consequences," Tran said. IANS

# Fiber in diet may boost the body against infections: Study

WASHINGTON: A new study has found that the composition of the gut microbiome helps in predicting how likely a person will succumb to potentially lifethreatening infection with Klebsiella pneumonia, E.coli and other bugs -- and it may be altered by changing your diet.

The group of bacteria called Enterobacteriaceae, including Klebsiella pneumonia, Shigella, E.coli and others, is present at low levels as part of a healthy human gut microbiome. However, certain catalytic factors such as increased inflammation in the body, or by eating contaminated food these bugs can cause illness and disease. In extreme cases, too much Enterobacteriaceae in the gut can be life-threatening.

Researchers have used computational approaches including AI to analyze the gut microbiome composition of over 12,000 people across 45 countries from their stool samples. They found that a person's microbiome 'signature' can predict whether a person's gut is likely to be colonized by Enterobacteriaceae. The results are consistent across different states of

health and geographic locations.

The researchers identified 135 gut microbe species that are commonly

journal Nature Microbiology.

Notable among the protective gut species is a group of bacteria called



found in the absence of Enterobacteriaceae. It likely protects against infection. The results are published in the

Faecalibacterium, which produces beneficial compounds called shortchain fatty acids by breaking down fiber in the foods we eat.

This seems to protect against infection by a range of disease-causing Enterobacteriaceae bugs.

The researchers suggest that eating more fiber in our diet will support the growth of good bacteria -- and crowd out the bad ones to significantly reduce the risk of illness.

In contrast, taking probiotics -- which don't directly change the environment in the gut -- is less likely to affect the likelihood of Enterobacteriaceae infection.

"Our results suggest that what we eat is potentially very important in controlling the likelihood of infection with a range of bacteria, including E.coli and Klebsiella pneumonia because this changes our gut environment to make it more hostile to invaders," said Dr Alexandre Almeida, a researcher at the University of Cambridge's Department of Veterinary Medicine and senior author of the paper.

He added: "By eating fiber in foods like vegetables, beans and whole grains, we can provide the raw material for our gut bacteria to produce short-chain fatty acids -- compounds that can protect us from these pathogenic bugs."

### Cambodia records 46 percent drop in dengue cases in 2024

PHNOM PENH: Cambodia reported 18,987 dengue cases in 2024, a sharp decline of 46 percent from 35,390 cases in the year before, said a Ministry of Health's recent report.

"The disease killed 46 people last year, down 53.5 percent from 99 deaths a year earlier," the report said.

Leang Rithea, National Dengue Control Program manager and deputy director of the National Center for Parasitology, Entomology,

and Malaria Control, attributed the success to efforts to distribute larvicides, mosquito repellents and other materials to households to prevent a large-scale outbreak, Xinhua news agency reported.

"Parents should take their sick children to health centers or state hospitals within 48 hours if they suspect that their kids are

infected with a dengue virus," he told Xinhua.

Rithea also urged households to fill in puddles around their houses, saying that the puddles are the sources of mosquitoes.

Dengue fever is a viral disease transmitted through the bite of an Aedes mosquito.

The disease causes an acute illness that usually follows symptoms such as headache, high fever, exhaustion, severe muscle and joint pain, swollen glands, vomiting and rash.

In the Southeast Asian country, the peak of the dengue epidemic period is in the rainy season from May to Octo-

Earlier, Huy Rekol, Director of the National Centre for

Parasitology, Entomology and Malaria Control, said malaria cases in the Southeast Asian country plummeted by 74 percent from 1,384 cases in 2023 to only 355 cases in 2024.

Malaria is mainly found in the tropical and subtropical regions of the Americas, Asia, and Africa. The term malaria comes from the Medieval Italian phrase mala aria,



Malaria is common in tropical areas where it's hot and humid. In 2020, there were 241 million reported cases of malaria throughout the world, with 6,27,000 deaths due to vector-borne disease. The majority of these cases occur in Africa and South Asia. IANS

SYDNEY: Australian researchers have found that DNA repair may determine how cancer cells die following radiotherapy in a new study that may help improve cancer treatment and cure rates.

To understand how cancerous tumor cells die after being subjected to radiotherapy, scientists from Sydney's

Children's Medical Research Institute (CMRI) followed irradiated cells for one week after radiation therapy by using live cell microscope technology, said an announcement by CMRI, Xinhua News agency reported.

"The surprising result of our research is that DNA repair, which normally protects healthy cells, determines how cancer cells die following radiotherapy," said Tony Cesare, head of the CMRI Genome Integrity Unit.

He said that the study found that DNA repair processes can recognize when overwhelming damage has occurred,

such as from radiotherapy, and instruct a cancer cell how

When DNA damaged by radiation was repaired by a method called homologous recombination, they found that cancer cells died during reproduction, a process called cell division or mitosis.

Cesare said that death during cell division goes unnoticed by the immune system so does not activate the desired immune response.

However, he said that cells that dealt with radiation-

damaged DNA through other repair methods survived cell division but released DNA repair byproducts into the

"To the cell, these repair byproducts look like a viral or bacterial infection. This causes the cancer cell to die in a manner that alerts the immune system, which is what we do want," Cesare said.

The team showed that blocking homologous recombination changed the way cancer cells died to evoke a strong immune response.

The researchers said that the discovery will make it possible to use drugs

that block homologous recombination to force cancer cells treated with radiotherapy to die in a manner that alerts the immune system to the existence of a cancer that needs to be destroyed. IANS

### Costly therapies to foster Alzheimer's market growth globally: Report

NEW DELHI: New expensive but disease-modifying treatments are expected to foster Alzheimer's disease market growth globally, according to a re-

The report by GlobalData, a data and analytics company showed that the growth will particularly be visible in eight major markets -- US, France, Germany, Italy, Spain, UK, Japan, and China.

The report forecasted that the Alzheimer's disease market in these countries to grow from \$2.4 billion in 2023 to \$19.3 billion by 2033 at a compound annual growth rate (CAGR) of 23.4 percent.

This will be primarily driven by the entry of expensive disease-modifying therapies (DMTs) into the market, which will likely result in increased treatment rates as more options become available. An ageing global population leading to an increase in prevalent cases, and the launch of novel symptomatic therapies for the treatment of agitation and psychosis associated with Alzheimer's disease will also contribute to the growth.

By 2033, DMTs are expected to dominate the global Alzheimer's disease market, contributing 73.5 percent of the market, with drugs targeting amyloid beta making up the majority of this, the report said.

Philippa Salter, Managing Neurology Analyst at GlobalData, said that Eisai/Biogen's Legembi (lecanemab) and Eli Lilly's Kisunla (donanemab) will become the top-selling drugs for Alzheimer's, and "will generate global sales of approximately \$3.6 billion and \$3.8 billion, respectively, by 2033"

The report also noted barriers for these DMTs, which will limit their integration into clinical practice. Frequent IV administration and access to positron emission tomography (PET) and magnetic resonance imaging (MRI) scans are key economic and operational limiting factors for access to these drugs.

"In addition to logistical factors, these new DMTs are significantly more expensive than the current highly genericised symptomatic treatments used in the management of AD, providing a further access challenge in the form of reimbursement/payer restrictions," Salter said

To counter these, drugmakers are probing alternative routes of administration. Several oral latestage products in the pipeline can enable easier integration into clinical practice.

These include Anavex Life Sciences' ANAVEX2-73 (blarcamesine), TauRx Therapeutics' LMTX (hydromethylthionine mesylate), and Novo Nordisk's NN-6535 (semaglutide).

The new DMTs are only considered moderately effective, so significant opportunity remains for more effective DMTs that do not just slow progression but also stop the disease, with prevention being the end

Beyond DMTS, drugs that can effectively improve cognition in the late stages of the disease, as well as more effective options for secondary symptoms such as agitation and psychosis also provide opportunities for developers. IANS

### I had been searching for a meaningful way to talk about violence against women: filmmaker SANDHYA SURI

MUMBAI: Violence, gender dynamics, and personal empowerment, 'Santosh', the United Kingdom's official entry for the 2025 Academy Awards for the Best International Feature Film category had been brewing in writer and director Sandhya Suri's mind for long.

Reflecting on the origins of the movie, Suri tells IANS that she had been searching for a meaningful way to talk about violence against women for a long time.

"She said, "When I was in India researching and working with various NGOs, I came across an image. There were nationwide protests following the Nirbhaya gang rape case and this was an image from Delhi of a huge crowd of angry female protesters, faces contorted with rage, and a line of female police officers, forcing them back. One of them had such an enigmatic expression, I was fascinated by her".


She continued, "What a gulf between her and those protesting, what power her uniform wielded and what powerlessness not to feel safe as an ordinary woman. When I started researching female police constables, I learnt of the government scheme of 'appointment on compassionate grounds' in which eligible dependents of

deceased police officers can inherit their jobs".

Spending time with many such widows, she realized some had previously led very sheltered lives, never even leaving the house without their husbands or relatives until they started their police training.

"I was struck by the journey: from housewife to widow, to policewoman. That was a journey I wanted to write about, and one I wanted to watch," she said.

The film revolves around a



young widow who inherits her late husband's job as a police constable in rural India and investigates a murder. This is the first time the UK has selected a Hindi-language film for this category. Having studied mathematics as an undergraduate, Suri says she did not want to dissect films the way she did with English literature.

Talking about the time when she was a teacher of English in Germany, she recalled, "Making films was what excited me, not analyzing them. So I decided to go to film school as a postgraduate, leaving the door open for something entirely different".

Her background in mathematics, she explains, helped her develop a unique way of thinking, which she carried over into her filmmaking approach. Having trained in documentary filmmaking at the National Film

and Television School (NFTS) in the UK, the director, who has made documentaries including 'I for India', 'Around India with a Movie Camera', and the narrative short film 'The Field', tells that work on 'Santosh' began in 2016.

"The script was in good shape after the Sundance Scriptwriters' Lab, but the real work was researching, refining details, and fleshing out the characters. The film's

protagonist, Santosh, a female constable, didn't fit the typical mold seen in many films set in India. She was not a diaspora character discovering her roots or an upper-middle-class protagonist fluent in English. Santosh does not speak English. She is a constable. I wanted to keep that authentic," says the director. *IANS*



Experts at this week's briefing provided an in-depth analysis of these diseases and whether the US is sufficiently equipped to manage outbreaks. The meeting focused on the global challenges of emerging infectious diseases and the impact of climate change on disease transmission, providing guidance for the prevention and control of future health crises.

Dr. William Schaffner, Professor of Medicine in the Division of Infectious Diseases at the Vanderbilt University School of Medicine that we need to strengthen the emergency response capabilities of hospitals and establish a more efficient monitoring and early warning system globally.

At the end of the meeting, experts made suggestions for future prevention and control work. They believe that technological innovation is key, but it must be combined with practical applications to truly solve public health challenges. In addition, strengthening public education and international cooperation are also indispensable elements in responding to the health crisis. Dr. Peter Chin Hong said that although humans have advanced technology, only by implementing it into policies and actions can we truly protect people's health.

Healthcare providers emphasized the importance of staying current with vaccinations. Anyone uncertain about their vaccination status should consult their healthcare provider to ensure proper protection. Through vigilance and proper preventive measures, communities can work together to control these threats.

### Ginger Carrot Soup

**MADHUMATI TYAGI** 

his is flavorful Ginger-Carrot soup. With a touch of spice and a hint of warming ginger, it is the perfect balance of savory and sweet. This diabetes-friendly recipe would pair well with Almond flour roti or low GI rice and Dal.

#### Ingredients:

1 lbs. -Carrots (peeled and chopped)

1 - Onion (chopped)

2 clove - garlic (minced)

2 tbsp - olive oil

2 tbsp - fresh ginger (grated)

1 tsp - ground coriander

1/4 tsp - ground turmeric

1/4 tsp - salt

1/4 tsp Black pepper powder/chili powder

4 cup - low sodium vegetable broth

1 cup - unsweetened coconut milk

Fresh cilantro (for garnish)

#### Instructions:

In a large pot, heat the olive oil over medium heat. Add the chopped onion and sauté until translucent, 4-5 minutes.

Add the minced garlic and freshly

grated ginger. Sauté for about 1-2 minutes or until fragrant. Stir in the coriander and turmeric. Cook for another minute to toast the spices.

Add the chopped carrots to the pot and sauté for a few minutes, coating them with the aromatic spices.

Pour in the vegetable broth and bring the mixture to a gentle simmer. Cover the pot and let the carrots cook until they are tender.

Once the carrots are cooked, use an immersion blender to puree the soup until smooth or carefully transfer the soup to a blender and blend until smooth, then our it to the pot.

Stir in the coconut milk and season the soup with salt and pepper/chili powder to taste.

Let the soup simmer for a few more minutes.

Serve the spiced ginger carrot soup hot, garnished with chopped fresh cilantro.



### Mint Cilantro Chutney/ Green Chutney

#### Ingredients

- 2 cups Cilantro leaves (Dhaniya)
- 1 cup Mint leaves (Pudina)
- 2 Green Chili or as per your taste
- 1" inch Ginger or 1 tablespoon grated
- 3 cloves Garlic
- 2 teaspoon roasted Cumin powder
- 1/2 teaspoon salt, you can also use black salt as well and adjust to taste
- 1 teaspoon sugar (optional, adjust to taste)
- 1 tablespoon lime juice or tamarind juice
  - 1/2 or less cup water

#### Instructions

- Add all the ingredients to the blender.
- Blend at low speed until the ingredients start to mix, then increase the speed and blend to a smooth paste. You might have to stop and stir the ingredients couple of times
- Chutney is ready. Enjoy right away or freeze for later.

#### Variations:

• Yogurt - Adding yogurt to this chutney reduces the spiciness and adds a refreshing touch to the chutney. I would suggest adding 1/3 cup yogurt to this recipe.

#### **GEETHA PATIL**

• Grated Coconut or Roasted Peanuts-This adds a thick texture to the chutney. If you want to use the chutney to make sandwiches, coconut is a great addition. Add 1/ 3 cup of either to this recipe.

 Onion - In North India, it is common to add a little onion to the chutney. I would add 1/4 cup of chopped onion.

Storing: Store in refrigerator up to 4 days in an airtight container. You can also store in small containers or ice cube trays in the freezer. Defrost one at a time in the refrigerator and enjoy.

### 258 Pakistanis, deported from seven countries

KARACHI: In yet another major embarrassment for Pakistan, as many as 258 of its citizens were deported from seven countries, including Saudi Arabia, the United Arab Emirates (UAE), and also 'all-weather friend' China in the last 24 hours, local media reported recently.

According to Pakistani immigration officials, out of the 258 individuals who arrived at Karachi's Jinnah International Airport, 244 were deported on emergency travel documents and only 14 had valid Pakistani passports. While only 16 deportees were arrested for having a 'suspicious identity', the rest were released after mere questioning.

Pakistan's leading news channel Geo News reported that Saudi Arabia deported 232 people, that included seven beggars, individuals caught performing Hajj without permits and sent back after they had completed their sentences besides several Pakistanis who had overstayed in the country or found to be working without sponsorship or beyond the validity of their visas. The report stated that 112 people were deported by the Saudi agencies due to complaints from their sponsors and 63 faced other charges.

Among the 21 people deported from the UAE, four were found to be involved in drug trafficking. IANS

### USCIS updates filing procedures for form I-140

U.S. Citizenship and Immigration Services today announced a Federal Register notice (FRN) providing updated procedures for submitting a Form I-140, Immigrant Petition for Alien Workers, accompanied by a permanent labor certification, application for Schedule A designation, or national interest waiver (NIW) re-

On June 1, 2023, the U.S. Department of Labor (DOL) implemented a new system for permanent labor certifications, called the Foreign Labor Application Gateway (FLAG), and revised the Application for Permanent Employment Certification (Form ETA-9089) for use within the FLAG system. The revised Form ETA-9089 collects more detailed information about the job opportunity, including specific worksite locations, telecommuting options, and the foreign worker's qualifications. Employers who file Form ETA-9089 through the FLAG system and who receive a labor certification approval generally receive a 2-page Final Determination from DOL electronically.

The instructions to Form ETA-9089 state that only a signed Fi-

nal Determination must be submitted with the Form I-140 petition as evidence of a permanent labor certification approval. This

NEW DELHI: US Ambassador to India Eric Garcetti recently emphasized the strong bond between America and India, stating that America sees its future with India, and India sees its future with America, adding that the two nations are better when they are together.

He highlighted the importance of people-to-people ties, saying that the more connections Americans have with Indians, the more opportunities will arise for economic and educational exchanges.

Speaking on the theme 'The United States and India: Building Bridges for Our People', Garcetti said that the more ties Americans have with Indians, the more ways they can find to grow economic and educational exchanges.

Garcetti said, "We never know what the future holds, but I'll say this to my fellow Americans, the more ties that we have to more Indians, and the more ways we can find to grow our economic and educational exchanges, the stronger America and India will both be. In a world that too often cedes space to forces that seek to divide us, both internally and internationally, let us be a voice as we have been, to care for each other across the things that too often separate us, to care across geography and religion, language and income, identity and so much more."

"Let's prove any haters wrong the way we always have, by meeting, instead of tweeting, by investing, instead of protesting, by connecting instead of objecting and by bringing people together, acknowledging in this day and age, there will always be some divisive voices, but let's never mistake the loudest or most clickable comments for being the most representative. We know that there are Americans and Indians who are invested in this relationship and overwhelmingly our populations want this relationship to deepen," he added.

He noted that democracy, although challenging to manage is the best system and that diverse populations like those in India and the US make life more interesting. Garcetti praised the resilience of the India-US relationship, which has been fostered over 230 years since the establishment of the first US diplomatic mission in Kolkata.

He noted that democracy is tougher to manage than non-democracy and called the former the "best system." He said that Americans love Indians and Indians love Americans. He said that there have been 230 yrs of cooperation between India and the US since US established diplomatic mission in Kolkata.

We've worked to streamline visa processing to keep up with this incredible demand. Since becoming ambassador, we've increased our visas by more than 60 percent, and eliminated wait times for all visa types except for first-time visitor visas, where the wait time is down 75 percent from our peak, still much further to go, I know, but a great accomplishment, and we added a record number of new hires as consular officers to this mission. We've implemented new technologies. We've even used AI to analyze some of the ways we can get better and the result for a second year in a row, we issued more than one non-immigrant visa, including a record number of visitor visas. More than five million Indians currently hold a United States visa '

"In 2024, the US mission to India met visa interview demand for all first-time student visa applicants, ensuring that every student could arrive on time and their parents could feel calm about their child going to the United States. The United States Citizen and Immigration Service has completed more than 1600 relative petitions. ### PE investment in India's real estate rose to \$2.82 billion in April-Dec of FY25

MUMBAI: The private equity (PE) investment in Indian real estate increased by 6 percent to \$2.82 billion during the first nine months (April-December) of Financial Year 2024-25, according to a report by real estate firm ANAROCK.

"The average deal size saw a notable increase of 32.5 percent, climbing from \$88.5 million in nine months of 2023-24 to \$117.3 million in the same period of 2024-25," said Shobhit Agarwal, MD & CEO - ANAROCK Capital. "This jump underscores the impact of large-scale transactions on the market, with the top 10 deals comprising 93 percent of total PE transactions."

Multi-city deals dominated the transaction table in the first nine of FY25. In terms of cities, Bengaluru and Hyderabad led the transaction tables with 11 percent and 10 percent deal shares, respectively.

In the first nine months of FY25, the industrial and logistics sector captured 62 percent of total investments, significantly surpassing both the office and residential sectors, which attracted 14 percent and 15 percent, respectively. "The fact that the share of private equity investment in the residential sector rose to 15 percent, up from 12 percent in the same period last year reflects the increased activity in the housing market," says Aashiesh Agarwaal of ANAROCK Capital.

However, stronger pre-sales and higher participation from PSU banks in construction finance may reduce the demand for high-cost private equity financing. This may require PE funds to get into earlier stages of project lifecycles to maintain IRRs, or to engage in special situations investments.

While Indian commercial real estate markets saw strong leasing, this segment saw muted PE activity due to geopolitical concerns and high interest rates, which impacted valuations. That said, the sector's strong operational performance is likely to continue, and an expected decline in interest rates will revive PE investments in the space, the report states. IANS



### How Los Angeles fires magnify deepening insurance crisis in California?

LOS ANGELES: The devastating wildfires in Los Angeles have wiped out tens of thousands of homes and businesses, which could inflict a 150 billion US dollars wound as reported by local media Accuweather. The rising risk of wildfires and related costs are adding to a crisis in California's insurance market.

Daunted by the many natural hazards California is prone to, major insurers like Heritage have withdrawn from California. This has left many homeowners without insurance or reliant on California's state-mandated FAIR Plan, originally designed as a last resort for fire insurance

For neighborhoods like Pacific Palisades, one of the hardest hit by insurer withdrawals, the situation is dire. This affluent area with thousands of multi-million-dollar homes has experienced many policy non-renewals, and a significant portion of its properties now rely on the FAIR Plan, exposing the state's already strained system to potentially devastating financial risks.

These fires, exacerbated by climate change, highlight how traditional finance tools like home insurance are becoming increasingly ineffective against the

"Strengthening the state's FAIR Plan has been a key priority ... to get people the reliable and affordable insurance they need ... and these upgrades will help stabilize the entire market while providing more stability for those who already depend on it," said Newsom in a previous statement to the press.

But some insurers are running for the hills. "There are so many claims in California from wildfires, earthquakes and mudslides, you name it, that to continue to offer policies in that state would have driven our insurance company bankrupt," a claims adjuster for a large national insurance company told Xinhua off the record.

Over 450,000 Californians now have had to fall back on California's FAIR plan, which has seen its coverage exposure skyrocket to 458 billion dollars, nearly triple the mounting risks.

Wildfires are not new to California, but their destructive potential has grown due to warmer temperatures and human development. Climate change leads to heavier rainfall in spring, fostering vegetation that later becomes fuel during dry seasons, upping the odds of an outbreak.

Add the powerful Santa Ana winds to that powder keg, and even a small spark can ignite a massive blaze. These fires spread rapidly, consuming homes built in the wildland-urban interface and areas where development meets natural landscapes, thus exacerbating the destruction.

In response to the crisis, California Insurance Commissioner Ricardo Lara recently implemented reforms aimed at stabilizing the market. Insurers are allowed to use catastrophe models for rate-setting, incorporate fireprevention efforts by homeowners, and adjust premiums

to cover reinsurance costs.

In exchange, these insurers must maintain coverage in high-risk areas proportional to their statewide market share.

The commissioner has also issued a one-year moratorium preventing insurers from canceling policies in affected areas. This provides temporary relief for homeowners but does not address the systemic issues. Insurers retain the right to decline policy renewals after this period, leaving many residents in precarious positions, Xinhua news agency reported.

The FAIR Plan, already burdened by increasing demand, will face even greater financial pressure from the current fires. The plan's reserves are insufficient to cover claims for tens of billions of dollars in damages, forcing private insurers to contribute, which could lead them to reconsider their participation in California's market. This precarious situation exposes the fragility of the insurance system in the face of growing climate risks.

Premiums are expected to rise, and many homeowners may still find themselves underinsured due to rising rebuilding costs and widespread disasters. IANS

### Hardeep Puri demands Kejriwal's clarification on 'Sheesh Mahal' budget

Stating that Amaravati would be developed as the best model city, he was confident that it would create a record of sorts in the country.

The signs of a Guru are as follows:



### Decolonizing the mind: South Asia yet to come out of its British colonial-era laws

outh Asian countries which were once as a whole known as the In dian subcontinent share some common traditions, values, culture, and history. But one thing that they share the most is their colonial legacy which is still in effect to this day largely in the realm of Law. In South Asian countries, mostly India, Pakistan, and Bangladesh we see the use of colonial-era laws. Some of these laws are outdated and outright repressive, even in Britain these laws are not in use.

In today's postcolonial South Asia, we still see the use of The Penal Code of 1860, the police act of 1861, the Evidence Act of 1872, and the Official Secrecy Act of 1923. All of these laws were extremely oppressive and were used to repress the native population. The depressing thing is that these laws are still to this day being used to oppress the general population of the region. For example, section 5 of the Official Secrets Act of 1923 states, "Any com-

thoritarian, this is one of the reasons why South Asian countries have not been able to achieve their democratic aspirations. In Bangladesh, the Digital Security Act of 2018 uses some provisions that are inherited from colonial law. For example, section 32 of the DSA criminalizes the breaching of government secrecy, and section 28 of the DSA was incorporated from section 295A of the Indian Penal Code. Although the new Interim government is planning to remove the DSA with the Cyber Security Act, nonetheless the DSA can be remembered as a relic of authoritarianism in Bangladesh that stemmed from the colonial era law. In Pakistan, we see that it's legal foundation is based on colonial period common laws and the Indian Independence Act of 1947 made it applicable to

munication not in the interest of the state is illegal". This was at odds with the interest of the citizens living in the colonial state structure. This Official Secrets Act is still used in Bangladesh, India, and Pakistan.

Another example of such law is section 377 of the Indian Penal Code 1860 which states that "Whoever voluntarily has carnal intercourse against the order of nature with any man, woman or animal, shall be punished with [imprisonment] for life, or with imprisonment of either description for a term which may extend to ten years, and shall also be liable to fine". The section was abolished on September 6, 2018, by the Indian Supreme Court stating that this violates a person's privacy and their sexual rights. The section also criminalized homosexuality and is still in use in Bangladesh and Pakistan.

#### Tendency towards autocracy

American-Pakistani historian Ayesha Jalal argued that the British colonial government introduced laws that suppressed Indians, and also emphasized that these British policies and regulations are contradictory with democratic values and are augovernment has scrapped colonial laws it has replaced these laws with more rigorous ones. For example, in a new legislation the duration of police custody has increased from 15 days to 60, and in special cases can last up to 90 days. This has concerned human rights groups.

In Pakistan, the Lahore High Court changed its sedition law of the Indian Penal Code of 1860. In 2023, Lahore High Court deemed this law to be unconstitutional. This is a huge win for freedom of speech in Pakistan. However, some laws are still in use today and can be attributed to negative use. In 2017, in an article by Amnesty International's South Asia Director, the writer said that "crude colonial-era laws have been unleashed against government critics, new laws have been invoked against critics online, and brutal practices have endured in areas afflicted by conflict".

# The Third Eye: Terrorism on the US soil

he terror attack carried out by an ISIS convert -- Shamsuddin Jabbar -- at New Orleans's famed Bourbon Street on New Year's Day, has drawn attention to the reality that Islamic radical forces were down but not out and were present across the world as 'sleeper cells' and 'lone wolves' determined to execute their plans -- primarily against the US-led West and their allies.

Terrorism by definition is a resort to 'covert' violence for a perceived political 'cause', calling for a degree of 'commitment' that was determined by 'motivation'.

Since the faith-based motivation behind the call of Jehad could be very strong indeed, it is not surprising that a 'radicalized' First, it is reported that in recent months a few terror suspects were already on the radar of the FBI from which it could be inferred that the US was not beyond the reach of Islamic radicals, particularly at a time when cyber channels and social media were being freely used for indoctrination of vulnerable citizens.

The challenge for American security agencies had suddenly enlarged as they have the responsibility of unearthing all such channels and neutralizing them -- this in fact is the case with the security setup of all democratic countries as well.

mind could even take on a 'suicide mission' like what Shamsuddin did.

He is said to be a lone wolf according to the evidence surfacing so far.

Born in Texas -- Shamsuddin had rented an accommodation in New Orleans to plan the attack.

Given the seriousness of the incident, US President Joe Biden and First Lady Jill Biden visited New Orleans to meet the families of the victims.

In the background of this case of terrorism on US soil, three serious developments would add to the geopolitical concerns of President-elect Donald Trump.

for a spell, remained in active service till 2015 and reportedly put in his papers in 2020 as Staff Sergeant.

His case showed that 'radicalization' can influence even educated and reasonably well-employed persons and not only the poor and the frustrated youth -- Jabbar though was said to be in financial trouble after his first divorce.

In one of the videos made before the incident, he talked of the 'war between the believers and non-believers' and acknowledged his allegiance to ISIS.

A leaflet of ISIS was said to have been recovered from the back of his truck.

It may be mentioned that the

'war on terror' led by the US following 9/11, was essentially an American combat against Islamic radicals headed by Al Qaeda in Afghanistan and its competitor, the Islamic State of Iraq and Syria (ISIS) in the second theatre of the said 'war'.

In Afghanistan despite the 'war on terror', the US was compelled to withdraw its troops from there after getting into an agreement with the Taliban backed by Al Qaeda and witnessing the reinstallation of the Kabul Emirate headed by Taliban, in 2021.

That Pakistan had cleverly played a mediatory role at Doha and helped the Islamic Emirate of Afghanistan intending to acquire 'strategic depth' against India, is another story.

Shamsuddin Jabbar must have watched with possible admiration how Islamic radicals had stood their grounds against the might of the 'US-led world coalition'.

This draws attention to the third aspect of the New Orleans episode which is that the terrorist in this case became an admirer of ISIS rather than Al Qaeda because it is ISIS that had become the face of Islamic radical forces -- after Osama bin Laden and his successor in Al Qaeda, Ayaman Al Zawahiri, had been eliminated by the US in special military operations.

The attack at New Orleans fully conformed to the modus operandi of terrorists.

The attacker used a rented pickup truck to run over the crowds on pavements celebrating New Year's Day and opened indiscriminate fire killing a total of 14 innocent people and injuring 35 others.

os Angeles county officials said the death toll from wildfires had risen to 24. Many are believed to be missing, and over 12,000 structures damaged or, destroyed in six simultaneous wildfires that spread across the County starting last Tuesday. Dangerous dry winds returned last Sunday, to whip up furious gusts of infernos that scorched communities to rubble and left thousands homeless. The dry winds, which originate from inland deserts, fanned flames and blew embers up to 2 miles (3 km) ahead.

LOS ANGELES

Santa Anna winds peaked 120 mph but believed to have slowed down to 30-40 mph by Sunday. Some aerial firefighters scooped water out of the Pacific Ocean and dropped water and retardant. At the same time, land crews with hand tools and hoses held the line of the Palisades Fire as it encroached on the upscale Brentwood section and other populated areas of Los Angeles.

California Governor Gavin Newsom said he was launching a "Marshall Plan" to rebuild the ravaged city. The National Weather Service has warned of worsening weather conditions ahead. Over 1,53,000 residents and 57,000 structures are under evacuation orders, and another 1,66,000 residents have been warned of potential evacuation. About 50,000 customers were without power for few days. The death toll is expected to mount when fire rescue fighters can enter and search ravaged structures.

The fires have consumed about 56 square miles (145 square km) an area larger than San Francisco. Tens of thousands of people remained under evacuation orders and new evacuations were ordered last week Friday evening, after a flare up on the eastern side of the Palisades Fire. Allegations of leadership failures and political blame have begun and so have investigations. Gov. Gavin Newsom ordered state officials to determine why a 117 million-gallon (440 million-liter) reservoir was out of service and some hydrants had run dry.

Meanwhile, Los Angeles Fire Chief Kristin Crowley said city leadership failed her department by not providing enough money for firefighting. She also criticized the lack of water. Eaton Fire north of Pasadena and Altadena, which has burned more than 7,000 structures. LA Mayor Karen Bass, who faces a critical test of her leadership as her city endures its greatest crisis in decades, said several smaller fires also were stopped.

The level of devastation is jarring, even in a State that regularly confronts massive wildfires. No cause has been determined for the largest fires and early estimates indicate the wildfires could be the nation's costliest ever. A preliminary estimate by AccuWeather put the damage and economic losses so far between \$135 billion and \$150 billion.

Overflowing with kindness, volunteers overflowed at donation centers and some had to be turned away at locations including the Santa Anita Park horse racing track, where people who lost their homes sifted through stacks of donated shirts, blankets and other household goods. Wildfires also ripped through Hollywood celebrity homes costing millions. The area where most of the homes have swimming pools but very few fire hydrants. Time for California Governor and City Mayor to reflect upon putting priorities in place as climate change takes a toll on most places.


