UNITED NATIONS: India has denounced Pakistan as "a global epicenter of terrorism" and called it an irony that Islamabad claims to be at the forefront of fighting terror.

"Pakistan is a global epicenter of terrorism, harboring more than 20 UN-listed terrorist entities and providing state support to cross-border terrorism," India's Permanent Representative Parvathaneni Harish said recently at the Security Council.

"Hence it is a supreme irony when Pakistan pats itself on the back as being at the forefront of the fight against terrorism," he said.

"India," he added, "has been a victim of acts of terror perpetrated by this country through terror groups such

as Jaish-e-Mohammed (JeM) and Harkat ul Mujahidin (HuM), among dozens of others."

Responding to Pakistan's Deputy Prime Minister Ishaq Dar raising Kashmir, Harish said, "In fact, it is Pakistan that is in illegal occupation of parts of Jammu and Kashmir.'

He pointed out that the people of Jammu and Kashmir region again in last year's election made their adherence to India clear.

"The people of Jammu and Kashmir have only last year taken part in a successful election and have voted in large numbers to choose their government," he said.





without any relevance, this time it was during a Council session on multilateralism and reforming global governance. Dar

claimed that the people of Pakistan had been denied their right to self-determination and the Security Council has a responsibility to ensure that its resolutions are implemented. But the Security Council resolution he was alluding to, No. 47 adopted on April 21, 1948, requires the Pakistani government to withdraw "tribesmen" and Pakistani nationals who entered Jammu and Kashmir and "to prevent any intrusion into the State of such elements and any furnishing of material aid to those fighting in the State".

Dar said that Pakistan "has been at the forefront of the fight against terrorism" and listed several terrorist groups -- Daesh, Al-Qaeda, TTP, ETIM, IMU, and emerging right-wing extremist groups -- that "must be opposed with equal determination". Left out of the list was the JeM, which attacked India's Parliament in 2001; the HuM, which hijacked an Indian airplane, and the Lashkar-e-Taiba, which carried out a terror campaign against Mumbai in 2008, killing about 170 people. *IANS*

"They have a lot more money": Trump questions USD 21 million fund for voter turnout in India

WASHINGTON DC: Following the US Department of Government Efficiency (DOGE) decision to cancel USD 21 million fund marked for 'Voter Turnout in India', President Donald Trump said that India, with its growing economy and high taxation rates, did not need such financial support.

While he acknowledged his respect for India and its Prime Minister, Trump criticized the idea of funding voter turnout initiatives in the country.

While signing executive orders at Mara-Lago, this week, Trump said, "Why are we giving USD 21 million to India? They have a lot more money. They are one of the highest taxing countries in the world in terms of us; we can hardly get in there because their tariffs are so high. I have a lot of respect for India and their Prime Minister, but giving USD 21 million for voter turnout?"

On February 16, DOGE posted a list of cancelled US taxpayer-funded initiatives with a mention of USD 21 million earmarked for "voter turnout in India."

The DOGE, led by Elon Musk announced cancelling a USD 22 million funding intended for "voter turnout in India".

In a post on X, DOGE listed the number of spendings by the US taxpayer that have been cancelled, including "USD 21M for voter turnout in India."

"US taxpayer dollars were going to be

spent on the following items, all of which have been cancelled," the Musk-led department announced.

Bhartiya Janta Party's Amit Malviya took to his X to react to the announcement. "\$21M for voter turnout? This definitely is

external interference in India's electoral process. Who gains from this? Not the ruling party for sure!" his post read.

Other funding cancelled by the US department included USD 10 million for "Mozambique voluntary medical male circumcision."

"USD 486M to the 'Consortium for Elections and Political Process Strengthening,' including USD 22M for an 'inclusive and participatory political process' in Moldova and USD 21M for voter turnout in India," DOGE said

A USD 29 million intended for "strengthening the political landscape in Bangladesh" and a USD 39 million for "fiscal federalism" and "biodiversity conservation" in Nepal was also cancelled.

Similarly, USD 1.5 million for "voter confidence" in Liberia, USD 14 million for "social cohesion" in Mali, USD 2.5 million for "inclusive democracies in Southern Africa," and USD 47 million for "improving learning outcomes in Asia" were also cancelled by DOGE. *ANI*

'Jammu and Kashmir will always be integral part of India'

NEW YORK: India's Permanent Representative to the United Nations, Ambassador Parvathaneni Harish, reaffirmed that Jammu and Kashmir is and will always remain an integral part of India and strongly condemned Pakistan's misinformation campaigns.

He also emphasised the democratic choice made by the people of Jammu and Kashmir in the legislative assembly elections after Pakistan's Foreign Minister Ishaq Dar raised the Kashmir issue at the UNSC.

While delivering India's statement at the Open Debate in the United Nations Security Council on Practicing Multilateralism, Reforming and Improving Global Governance, Harish said, "The deputy PM and Foreign Minister of Pakistan have referred to an integral and inalienable part of India, the union territory of Jammu and Kashmir in his remarks. I would like to reaffirm that the union territory of Jammu and Kashmir has been, is, and will always be, an integral and inalienable part of India." ANI

Sam Pitroda's statement on China an insult to Galwan martyrs: Sudhanshu Trivedi

NEW DELHI: Senior Bharatiya Janata Party (BJP) leader and spokesperson Sudhanshu Trivedi termed the statement of the Indian Overseas Congress Chief, Sam Pitroda on China as an insult to the martyrs of Galwan.

In an exclusive interview with IANS, Pitroda said India needs to change its mindset and give up the notion that China is an enemy country.

Trivedi said that India is continuously progressing un-

der the leadership of Prime Minister Narendra Modi and added: "But, some forces are trying to influence it. The kind of statement that Indian Overseas Congress President Sam Pitroda has given regarding China today has made it clear that the Congress party's agreement with China has been expressed in broad daylight."

The senior BJP leader said, "It is a matter of concern that the kind of statement that Sam Pitroda has made is a very deep attack on India's identity, diplomacy and sovereignty of India. He (Pitroda) has said that there is no dispute of any kind with China, that is, India itself is taking an aggressive posture. The Government of India, under the leadership of Prime Minister Narendra Modi, wants good and cordial relations with every

country of the world. But, national self-respect, security, and strength are paramount for us."

Trivedi added: "Before Pitroda's comments today, Congress leader Rahul Gandhi had also given such statements many times. Rahul Gandhi had said during a foreign tour that China has done a good job in reducing unemployment."

He called Pitroda's statement an insult to the martyrs of Galwan. "Is this not an insult to the martyrs of Galwan? Our soldiers were martyred in Galwan. But, despite this,

if the Congress Overseas Chief speaks such language, then it is condemnable. This is a grave insult to the sacrifice of the Indian Army," the Rajya Sabha MP asked.

Speaking to IANS, Pitroda said that India's approach has been confrontational from the beginning. "Our attitude is that of confrontation from day one, and that attitude creates enemies, and that creates certain support in the country. I think we need to change that pattern to assume

that China is the enemy from day one. It is not just to China, but to everyone..."

"I don't know what is the threat from China. I think this issue is often blown out of proportion because the US has the habit of defining an enemy," he said.

The Congress leader said, "I think the time has come for all of us to learn, increase communication, collaborate, operate and co-create and not have this command and control mindset. China is around... China is growing .. you know you got to recognize that and respect that ..." *IANS*

From Sheikh to ISI: Gaurav Gogoi, wife's alleged foreign connections spark further controversy

NEW DELHI: The controversy surrounding Congress MP Gaurav Gogoi's wife Elizabeth's alleged connections to Pakistani intelligence agency ISI is intensifying as Assam Chief Minister Himanta Biswa Sarma and BJP leaders continue to raise con-

cerns.

In a series of posts on X, Sarma has escalated his attacks on Gogoi, accusing him of associations that could undermine national security. The accusations revolve around Elizabeth Colburn, a British national, and her extensive background working with entities allegedly linked to Pakistani agencies. Sarma claims that Elizabeth, despite her marriage to Gogoi, retained her UK citizen-

ship for 12 years and worked closely with individuals tied

The BJP's narrative includes several key allegations. Elizabeth's non-Indian citizenship: Sarma raised serious questions about why Elizabeth, after 12 years of marriage to an Indian national, has not yet adopted Indian citizenship.

Ties to Pakistani officials: It is alleged that Elizabeth

worked for LEAD Pakistan, an organization allegedly connected to Pakistani government interests, including those of the military and intelligence services. Sarma has pointed to her long stay in Islamabad and close working relationship with Ali Tauqeer Sheikh, a figure reportedly associated with Pakistan's planning commission and linked to the ISI.

Gaurav Gogoi's engagement with Pakistan High Commission: The BJP is also questioning

Gogoi's visit to the Pakistan High Commission in 2015, despite India's protests over Pakistan's interference in internal matters. Sarma claims that at the time, Gogoi was a first-term MP with no official foreign policy credentials. *IANS*

"Russia wants to stop barbarianism... It's senseless war": US President Donald Trump

WASHINGTON DC: Following the talks between the United States and Russia on ending the war in Ukraine, President Donald Trump expressed his belief that Russia wants to put an end to the conflict, citing the toll the war has taken on soldiers, including Ukrainians, Russians, as well as North Koreans.

He called the war "senseless" and emphasised that it should never have occurred, asserting that it would not have happened under his leadership.

On being asked about the talks between US officials and Russian representatives over ending war, Trump said that he is "much more confident" and "the talks were very good."

While signing executive orders at Mar-a-Lago Trump said, "Russia wants to do something. They want to stop the barbarianism that's going on over there. Soldiers are being killed by thousands on a weekly basis. Apart from Russian and Ukrainian soldiers, a lot of Koreans have been killed."

Trump added, "We want to end it. It's a senseless war. It should have never happened; it would have never happened

if I were President."

Notably, Russian Foreign Minister Sergey Lavrov held talks with US Secretary of State Marco Rubio, and other officials, focusing on a broad range of issues, including the situation in Ukraine, with both sides ex-

pressing a commitment to resolving the conflict and addressing its root causes.

After more than four hours of talks in Saudi Arabia, the US and Russia agreed on four key principles, Rubio said. These include appointing a high-level team to help "negotiate and work through the end of the conflict in Ukraine" in a way that's "acceptable to all the parties engaged," CNN reported.

However, Ukrainian President Volodymyr Zelenskyy, who was not part of the discussions, stated that Ukraine would not "give in to Russia's ultimatums" and emphasised that he would refuse to sign any agreement made without Ukraine's participation.

In a post on X, the Russian Foreign Ministry wrote, "FM Sergey #Lavrov and Presidential Aide Yury #Ushakov held talks with Secretary of State @ SecRubio, National Security Adviser @michaelgwaltz, and US Special Envoy to the Middle East @ SteveWitkoff. The Sides agreed to establish #RussiaUS dialogue." ANI



India, Qatar aim to double annual trade in five years from existing USD 14 billion

NEW DELHI: Prime Minister Narendra Modi held bilateral talks with Qatar Amir Sheikh Tamim Bin Hamad Al Thani on 18 February, with the two leaders discussing trade, investment and energy and recalling historic trade linkages and deep-rooted people-to-people ties between the two countries.

PM Modi appreciated the Amir of Qatar for bringing a large delegation of top Qatari business for business on this visit.

India and Qatar have also signed an agreement to elevate the bilateral relationship to a strategic partnership.

Addressing a special briefing, Secretary (CPV & OIA) in the Ministry of External Affairs, Arun Kumar Chatterjee, said the two sides have to set a target to double the bilateral trade in the next five years.

He said Qatar Amir is accompanied by a high-level delegation comprising minis-

ters, senior officials and business leaders.

"Amir of the State of Qatar Sheikh Tamim Bin Hamad Al Thani last visited India in March 2015. When PM Modi paid his second visit in February 2024, he had invited His Highness Amir to pay a state visit to India.....this morning, His Highness Amir was received by President of India Droupadi Murmu and PM Modi at Rashtrapati Bhavan, where he was accorded a ceremonial welcome. President will meet His Highness Amir in the evening today and also host a banquet reception in honor of Amir and accompanies delegation...PM Modi held bilateral talks with His Highness Amir at Hyderabad House. Both leaders recalled the historic trade linkages, deep-rooted people-topeople ties and robust bilateral relations between both countries," Chatterjee said.

"To elevate the relationship to a strategic partnership, India and Qatar have signed an agreement in this regard today. Trade, investment and energy were among the major topics of discussion between the two leaders today. The trade today between India and Qatar is about USD 14 billion annually. Both sides have agreed to set a target to double this in the next 5 years," he added.

The senior MEA official said that Qatar

is also an important partner for investments in India.

Qatar's sovereign wealth fund, Qatar Investment Authority currently has about USD 1.5 billion FDI in India...both leaders today identified a number of areas in which Qatar Investment Authority can increase investments in India...Prime Minister appreciated His Highness Qatar for bringing a large dedication of top Qatari business for business on this visit. *ANI*

EAM Jaishankar to visit South Africa for G20 Foreign Ministers' Meeting

NEW DELHI: External Affairs Minister (EAM) S Jaishankar will visit South Africa to participate in the Group of 20 (G20) Foreign Ministers' Meeting from February 20-21, the Ministry of External Affairs said.

As per the Ministry of External Affairs, the EAM will visit Johannesburg at the invitation of South Africa's Minister of International Relations and Cooperation, Ronald Lamola.

The EAM's participation in the G20 meet will further strengthen India's engagement with the G20 countries and bolster the voice of the Global South in this important forum, the MEA noted.

The External Affairs Minister is also expected to hold a few bilateral meetings on the margins of the Foreign Ministers' Meeting.

Notably, South Africa assumed the G20 Presidency from December 1, 2024,

through to November 2025.

The G20 comprises 19 countries including Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkiye, United Kingdom, and United States, in addition to two blocs; European Union and the African Union.

The G20 Presidency rotates annually among the members and is selected from a different regional grouping of countries. The 19 member countries are therefore divided into five groups comprising a maximum of four countries each. *ANI*

Speaking about the weakness, she


said, "I think the 200. Or 300 million people whose life we need to change for lying at the bottom and I think that should be our priority and we should be able to sort this out in the next decade."

She noted that the greatest opportunity for the country is the adoption of technology at scale. "Whether it is artificial intelligence, green energy, genomics, I think that's what India will do".



What are your rights?

resident Donald Trump's mass deportation project is ramping up, with federal deportation efforts now including large-scale radios across sanctuary cities, including New York City. The crackdown targeted undocumented immigrants with criminal records. More than 200,000 people believed to be undocumented have been arrested over the past 30 days, according to data from Immigration and Customs Enforcement. The majority countries of origin were South and Central America, but ICE data shows a significant number of arrests of Indians, Chinese, and Russians. Speakers at the EMS briefing discussed how immigrants can protect themselves when ICE agents show up at homes, workplaces, and even schools.

According to statistics, the number of illegal immigrants arrested in major cities such as Los Angeles, San Francisco, and New York has increased significantly in recent months. Even in areas that call themselves "sanctuary cities," federal immigration law enforcement officers are unable to completely prevent raids. Immigrant rights organizations point out that this policy not only affects new immigrants crossing the border, but also puts some immigrant families who have integrated into the local community and have

stable jobs at risk of separation.

Viridiana Carrizales, Founder, ImmSchools said there are 5.5 million children born in the United States to at least one undocumented parent. U.S. law stipulates that regardless of the child's identity or the identity of his or her parents, they all have equal access to pre-K12 education, and schools are not allowed to ask about the identity of children and parents when admitting students. When ICE and other law enforcement officers are at school, they are not allowed to ask about the identities of children and parents without permission.

Amanda Alvarado-Ford, Deputy Directing Attorney, Immigration Institute of the Bay Area reminded undocumented immigrants that they have basic legal protections regardless of their status. When questioned by Immigration and Customs Enforcement (ICE) or the Department of Homeland Security, any individual has the right to remain silent and not answer questions about their immigration status or residency status. Law enforcement officers must have a valid search warrant to enter a private residence. For undocumented immigrants who have lived in the United States for more than two years, it is recommended to retain important documents including water and electricity bills, bank records, rental contracts, etc., for use in legal defense when necessary.

131 Pakistanis deported from 12 countries for legal offences

KARACHI: 131 Pakistani nationals have been expelled from 12 different countries due to various legal violations including drug-related offences, illegal entry, and failure to comply with employment regulations, The News International reported recently.

Authorities in multiple nations carried out these deportations, citing breaches of local laws, with some individuals facing immediate removal upon arrival.

According to immigration sources, Saudi Arabia led the deportations, sending back 74 Pakistani citizens for alleged involvement in drug trafficking and violating employment agreements by leaving jobs without prior notice. The United Arab Emirates (UAE) also deported several Pakistani nationals, charging them with illegal entry, theft, and drug-related offences.

In one case, a person was denied entry upon arrival and immediately sent back to Pakistan, while another individual was deported from the UAE following allegations of attempting to take their own life.

Apart from these two major deporting nations, other Pakistani nationals were expelled from Oman, Cambodia, Bahrain, Azerbaijan, Iraq, and Mexico. Furthermore, in a separate incident, two individuals suspected of human smuggling were deported from Mauritania and Senegal, as per reports by The News International. ANI

UK immigration in 2025 may see visa overhauls: Yash Dubal, UK visa and immigration expert

MUMBAI: Through the year 2025, the UK immigration policy may see further changes as the Government continues to grapple with high net migration and hence, we may see some visa categories scrapped altogether, or overhauled, particularly categories which have attracted fewer applicants, such as the fast-track Global Talent visa, observed the UK Immigration Outlook 2025 Note released by AY & J Solicitors, a London-based visa and immigration advisory.

Throughout 2025 net migration in the UK will continue to decline as a result of the measures already implemented, but for the next few years at least it will remain high because manpower shortages will continue across eventful year for immigration policy. Measures were introduced to reduce numbers, which directly affected many Indians who were planning to live, work and study in Britain. Healthcare visa applicants and student visa applicants were banned from taking dependents with them.

A Y & J Solicitors also observed that the new Labour government remained committed to bringing the numbers down further. The Note stated that it planned to do so by identifying the skills gaps in the UK workforce being filled by migrant workers and encouraging employers to train domestic workers to fill those roles.

With anti-immigration stance in the country like the US, both skilled and unskilled, the job seekers will find the door to the US closed, or increasingly hard to get through under the Trump administration. Hence, more Indian skilled workers will be looking to the UK.

New Zealand net migration falls in 2024

WELLINGTON: New Zealand had a net migration gain of 27,100 in 2024, down from a net gain of 128,300 in 2023, which was a feature of New Zealand's history to experience ups and downs in net migration, according to the statistics department Stats NZ.

The ups and downs in net migration have been much larger in 2023 and 2024, said Stats NZ international migration statistics spokesperson Sarah Drake.

Annually, net migration rose by just over 100,000 in 2023 and fell by a similar amount in 2024, Drake said, adding there was still a net migration gain overall.

Fewer migrant arrivals of non-New Zealand passport holders contribute to the fall in New Zealand's net migration in 2024, she said, adding the overall net migration gain in 2024 was just below the long-term average net gain of 29,100 before the Covid-19 pandemic.

Changes in migration are typically due to a combination of factors, including relative economic and labor market conditions between New Zealand and the rest of the world, and immigration policy in New Zealand and other countries, Xinhua news agency reported.

Net migration gain of non-New Zealand citizens continues to fall, with a provisional annual net migration gain of 74,200 non-New Zealand citizens in 2024, down from the net gain of 171,600 in 2023, with citizens of India, the Philippines, and China accounted for two-thirds of the fall in annual net migration of non-New Zealand citizens, statistics show. IANS

India, US don't compete as much as they complement each other: Goyal

MUMBAI: Union Minister of Commerce and Industry, Piyush Goyal said India and the United States do not compete as much as they complement each other, and discussions are underway with various stakeholders, both within and outside the government, to strengthen trade ties between the two nations.

India's efforts to double trade with the United States to \$500 billion by 2030 were underscored by the Union Minister in his virtual address at the NDTV Profit Conclave.

"This is a relationship between two friendly nations, trusted partners, and powerful democracies. We do not compete as much as we complement each other," said Goyal.

The Union Minister highlighted that India's position in global trade negotiations had been strengthened due to its focus on protecting domestic industries from non-market economies that lack transparent trading systems. "Our biggest concern has been economies that do not give equal access to India when we are trading with them. To protect domestic industries, higher tariffs have often been resorted to," he stressed. *IANS*

India aims to triple its textile exports to Rs 9 lakh crore by 2030

NEW DELHI: India's textile exports have reached Rs 3 lakh crore and the goal is to triple this to Rs 9 lakh crore by 2030 by strengthening domestic manufacturing and expanding global reach, the government has said.



India is the sixth-largest exporter of textiles globally, contributing 8.21 percent to the country's total exports in 2023-24.

The sector holds a 4.5 percent share in global trade, with the United States and European Union accounting for 47 percent of India's textile and apparel exports, according to the Ministry of Textiles. *IANS*

US tariffs on steel sector unlikely to impact India materially: Crisil

NEW DELHI: The US tariffs on the steel sector are unlikely to impact India because only 2 percent of the country's total finished steel exports in the first nine months of this fiscal were to the US, Crisil Intelligence reported.

The US move to slap a flat 25 percent tariff on steel imports from March 12, compared with multiple types of lesser levies previously, will have a three-fold impact.

"One, it will lower the exports of its trade partners as local production rises, but India is unlikely to be impacted materially because only 2 percent of its total finished steel exports in the first 9 months of this fiscal were to the US," said Sehul Bhatt, Director-Research, Crisil Intelligence.

Two, there will be a diversion of exporter inventory to other importer-nations at aggressive prices, especially in a milieu of increasing global competition.



This could bring down the prices of steel in India, already trending at 4-year lows, further.

"That means the Indian government may have to step in with safeguard duty to support domestic capacities. The timing and quantum of this will be crucial," Bhatt noted.

Three, incremental production by US mills will mean a reduction in the steel scrap avail-

able for exports.

That is because, as much as 70 percent of the steel industry there uses the electric arc furnace process, which typically involves converting scrap to produce steel.

At present, India sources 14-15 percent of its scrap requirements from the US.

Key import sources for the US include Canada, Brazil, Mexico

and South Korea. In 2024, the US witnessed a sharp rise in steel exports from Vietnam, Taiwan and Brazil.

While, on the one hand, the US tariffs may open up a portion of the US market for India's steel exports, on the other hand, the surplus steel produced by Japan and South Korea may be diverted to the Indian market, according to a latest ICRA report. *IANS*

100 pc FDI to help Indian insurance sector reach \$222 billion by 2026

NEW DELHI: The Indian insurance sector has witnessed impressive growth over the last two decades and the government's allowance of 100 percent foreign direct investment (FDI) in the sector would further accelerate growth, attracting significant foreign capital and boosting innovation, according to a new report.

India's insurance sector has witnessed significant growth and development over the past few years.

The domestic insurance market has grown at a CAGR of 17 percent over the last two decades and is expected to reach a size of \$222 billion by 2026, according to a TeamLease Regtech report.

In Bengaluru, along the main business corridors rental and capital rates for Grade A commercial offices witnessed significant upward movement.

Outer Ring Road (ORR), North Bengaluru, and

Whitfield saw a higher volume of Grade A floor plate transactions due to availability and specifications resulting in range-bound cap rates between 8.0 percent-8.5 percent.

In Bengaluru, the commercial supply was well behind uptake resulting in lower vacancy while Mumbai's office supply has increased sixfold year-on-year, resulting in a strong market, according to Colliers' 'APAC Cap Rates Q4 2024' report

ing the highest during the year. However, the increased supply kept the rental increases in check except for certain micro-markets as more options became available.

Ajay Sharma, Managing Director, Valuation Services, Colliers India, said that Bengaluru has witnessed improved transaction volumes in organized retail, with rising capital values in high-street areas attributed to increased consumer activity during the festival season, leading to higher revenue shares.

In Mumbai, industrial transaction volume has been slightly lower on a year-on-year basis.

However, the supply has increased in the market by 15 percent in Mumbai. Based on this, cap rates have been stable in Q4 2024. CPI inflation jumped significantly to 5.22 percent in December 2024, with the preceding 3-month average at 5.63 percent.

"This increase in inflation is attributed to the significant growth in urban inflation from Q3 2024," said Sharma. *IANS*

USAID effectively ran India's National Family Health Survey from 1990s: Sanjeev Sanyal

NEW DELHI: Sanjeev Sanyal, member of the Economic Advisory Council to the Prime Minister (EAC-PM) has said those concerned about USAID's interference in Indian elections should be equally concerned about USAID's tentacles in India's medical system and social policies.

In a post on X social media platform, Sanyal said that USAID "effectively ran India's National Family Health Survey (NFHS) from the 1990s till it was stopped two years ago".

"This is the most important medical dataset in India and drives a lot of health policy. Not only were we allowing a foreign agency to harvest our medical data but, by allowing them to design surveys and direct analysis, we were letting them influence our national health responses," he emphasized.

Equally worryingly, much of the NFHS questionnaire was deliberately skewed to support certain social narratives, according to the ace economist.

"The questionnaire for men, for instance, is only 29 pages but that for women is 94 pages. A lot of the additional questions are deliberately worded to elicit a narrative of intra-family violence against Indian women. Must say, very slyly done," he further stated.

According to Sanyal, late Bibek Debroy and he strongly pushed back against this (including publicly in newspaper columns).

Eating veggies may reduce risk of liver cancer by 65 pc: Study

NEW DELHI: Eating vegetables can help reduce the risk of liver cancer by 65 percent, according to a study.

The study, led by researchers from the INSERM, the French National Institute of Health and Medical Research, focused on patients diagnosed with cirrhosis -- scarring (fibrosis) of the liver caused by long-term liver dam-

They examined the benefits of eating vegetables and or fruits among these patients Of the 179 patients analyzed, 20 were diagnosed with hepatocellular carcinoma (liver cancer).

The team found that a total of 42.5 percent of patients with cirrhosis had insufficient fruit and/ or vegetable consumption.

"A 65 percent reduction in the

incidence (new cases) of liver cancer (hepatocellular carcinoma) was observed in patients diagnosed with cirrhosis consuming more than 240 gram per day of vegetables," the research-

The researchers, however, found no evidence of an association between fruit consumption and hepatocellular carcinoma.

The team said that the association between fruit and vegetable consumption and the risk of HCC



is poorly documented in the population of cirrhotic patients. However, "such knowledge is crucial for adapting HCC prevention messages," they noted, in the paper published in the journal

Liver cancer is the sixth most frequent cancer worldwide, mainly represented by HCC, accounting for about 85-90 percent.

Main causes of disease of underlying chronic liver disease are alcohol and viral hepatitis, while it also includes overweight and obesity, consumption of foods contaminated with aflatoxins (that is, toxins produced by molds).

The researchers called for larger studies "to assess the benefits of fruit regarding the risk of HCC", and to provide evidence for promoting fruit and vegetable consumption in patients with liver cirrhosis. IANS



Maternal paracetamol use may raise ADHD risk in kids by age 10: Study

NEW DELHI: Children, especially females, born to women who took acetaminophen (paracetamol) during pregnancy may be at a higher risk of developing childhood attention deficit hyperactivity disorder (ADHD) by the time they age 10, claimed a study.

The study, published in the journal Nature Mental Health, showed that children whose mothers had biomarkers of acetaminophen present in their plasma had a 3.15 times higher likelihood of an ADHD diagnosis.

The findings showed that the link was stronger among females than males. Girls of APAP-exposed mothers showed a 6.16 times higher likelihood of ADHD. However, the association was found to be weaker and non-significant in males.

Paracetamol is widely used during pregnancy, accounting for an estimated 70 percent of pregnant individuals in the US, Europe, and Asia.

Even though paracetamol has been classified as a low-risk medication by regulatory agencies such as the US Food

and Drug Administration and the European Medicines Agency, evidence is mounting to suggest that it can potentially increase the risk of adverse neurodevelopmental the University of Washington, US, analyzed plasma biomarkers of acetaminophen (APAP) exposure in a cohort of 307 African American mother-child pairs.


dren by age 8-10, they said in the paper. In the study, APAP metabolites were detected in 20.2 percent of maternal plasma samples.

Placental gene expression analysis of a subset of 174 participants indicated sex-specific transcriptional changes. In females, APAP exposure was associated with up regulation of immune-related pathways, including increased expression of immunoglobulin heavy constant gamma 1 (IGHG1).

Increased IGHG1 expression was statistically linked to ADHD diagnoses, with mediation analysis suggesting that APAP's effect on ADHD was partly mediated through this gene's placental expression, the researchers said.

The findings align with prior epidemiological studies and experimental animal research linking prenatal APAP exposure to neurodevelopmental disruptions.

The current study eliminated the bias concerns raised in previous studies where APAP use was self-reported by using objective biomarker measurements, they said, while calling for further studies. IANS

Researchers identify new type of blood test to identify children at risk of diabetes

LONDON: King's College London researchers have discovered a novel link between lipids and disorders affecting children's metabolism. This finding may provide an early warning system for ailments, including liver dis-

Scientists have developed a novel blood test that uses lipids to identify children who are more susceptible to obesity-related problems, such as type 2 diabetes, liver, and heart disease. The study was published in Nature Medi-

Lipids have traditionally been thought to be fatty acids in the body, either good or bad types of cholesterol or triglycerides, fats found in the bloodstream that are the most common in the human body.

Recent studies from the same group of scientists have suggested that the picture is more complex.

The researchers propose that blood plasma testing machines already in use in hospitals could assist medical professionals in identifying early disease indicators in children more quickly and facilitate their access to appropriate treatment. ANI

1 in 6 US parents support teenagers getting laser hair removal, chemical skin peels: Study

NEW DELHI: Every sixth parent in the US is in support of their teenage children indulging in non-surgical cosmetic procedures such as laser hair removal, chemical skin peels, teeth whitening and dermal fillers, according to nationwide study published recently.

The study led by the University of Michigan Health CS Mott Children's Hospital, based on a national poll showed that more than 16 percent parents believe that teenagers should be allowed to receive these types of aesthetic treatments for any reason as long as they have approval from their guardians.

But, half of parents only support teenagers getting non-surgical cosmetic procedures if there's a valid reason. While 50 percent said the reason should not be "being bullied about appearance", less than 40 percent say improving mental health is a good reason.

"Parents were conflicted about the circumstances under which non-surgical cosmetic procedures are appropriate for teenagers," said Mott Poll Co-Director and Mott pediatrician Susan Woolford.

"Interestingly, similar proportions of parents rated the validity teenagers wanting to look good for a special occasion on par with wanting the procedures due to mental health bullying," Woolford added.

The nationally representative poll is based on

responses from 989 parents of children ages 13-17 surveyed in August 2024. The increased popularity of these procedures may be associated with social media content that exposed teenagers to idealize images of faces and bodies, Woolford said.

Teenagers are susceptible to feeling insecure about their appearance when compared to digitally altered pictures depicting an appearance that is probably unattainable naturally," she said. "This problem is exacerbated by the pressure to post pictures of themselves to garner validation."

However, it's important for parents to find ways to help teenagers understand the distortions presented in the media while also exploring their reasons for wanting to change their appearance, she said.

"If a teenager asks for a non-surgical cosmetic procedure, parents should consider the emotional and mental health implications," she said.

Further, the poll showed that parent opinions of the age at which youth should be able to obtain such services also varied. More than half selected 18 years of age or older, 27 percent said ages 16-17 was old enough and 17 percent said 15 or younger was also






'Bad Girl' wins NETPAC Award at Rotterdam International Film Festival

Tier 2 and 3 cities emerge growth drivers in India's warehousing sector

MUMBAI: India's total warehousing stock reached 533.1 million square feet last year, with emerging tier 2 and 3 cities now contributing approximately 100 million sq ft, or about 18.7 percent of the total stock, according to a report released last week

This shift represents a fundamental change in the country's logistics map towards hub-and-spoke model, improving last-mile delivery capabilities as envisioned during the implementation of goods and service tax (GST), said the report by leading real estate firm JLL.

The Indian warehousing market has experienced remarkable growth in major cities since implementation of GST. Growth is now expanding to emerging tier II-III cities as hub and spoke model is playing out. The emerging cities saw noteworthy 100 million sq ft of stock in 2024, a four-fold increase since 2017, the report stated.

The growth in these emerging cities is driven by several factors. The e-commerce boom, particularly the widespread 'click and buy' trend, is transforming India's warehousing. This has led to increased demand for fulfillment centers closer to end consumers. Companies are also setting up smaller warehouses in these cities to improve delivery times and reduce logistics costs. *IANS*

GCC leasing surges to 31 pc of total market, Bengaluru leads

MUMBAI: Global Capability Centers (GCCs) have leased 22.5 million square feet (mn sq ft) in 2024, accounting for 31 percent of total leasing volumes, according to the latest office market assessment by real estate consultancy Knight Frank India.

Of this, 50 large deals (over 100,000 sq ft each) totaled 12.1 mn sq ft, while 56 mid-sized deals (50,000 - 100,000 sq ft) contributed 4.4 mn sq ft. Additionally, 223 smaller deals (under 50,000 sq ft) accounted for 5.5

mn sq ft of leased space, the report states.

Among cities, Bengaluru recorded the highest total GCC leasing at 9.33 mn sq ft, 66 percent of which (6.18 mn sq ft) came from large deals -- marking a 191 percent surge in absorption. Hyderabad followed, with GCC transactions totaling 5.06 mn sq ft, of which 67 percent (3.41 mn sq ft) were in the large office space category.

Chennai with 89 and NCR with 53 deals also saw good uptake



by GCCs in 2024.

Bengaluru emerged as the dominant market, capturing 42

percent of total GCC leasing volumes with 100 lease transactions -- the highest among all cities. Across the top eight cities, GCCs executed 329 leasing deals in 2024. Bengaluru led with 100 transactions, followed by Chennai with 89 deals. Both cities saw the highest number of leases in the sub-50,000 sq ft category, Chennai recorded 73 deals in this segment, the highest among all cities, followed by Bengaluru with 66 deals.

In the mid-sized office segment, Hyderabad led with 15 deals, while Bengaluru followed closely with 14 deals. *IANS*

Mega Dharavi redevelopment project completes over 50,000 door-to-door surveys

MUMBAI: The Dharavi Redevelopment Project (DRP) which aims to transform Asia's biggest slum into a modern urban hub, has completed a record of more than 50,000 door-to-door surveys.

The world's largest, \$3 billion redevelopment project in Mumbai's Dharavi by the Adani Group has been gaining massive local support.

The latest numbers in the surveys are touted as the highest in the history of Mumbai Slum Rehabilitation Authority (SRA), which is a big boost for the survey teams and Dharavi residents, who are eager for the redevelopment to move forward.

According to the latest survey figures, numbering has been completed for 85,000 tenements, while over 50,000 tenements have undergone door-to-door surveys.

Around 1.5 lakh tenements will be rehabilitated, ensuring better housing, infrastructure, and economic opportunities while preserving the dignity of Dharavi's

According to a spokesperson of



Navbharat Mega Developers Pvt Ltd, the Adani Group-backed agency doing the redevelopment, after multiple failed attempts in the past decades, Dharavi's redevelopment has finally taken off.

"Once completed, this project will set a global benchmark for human-centric slum redevelopment. This milestone

shows that we are committed to moving forward with benchmark facilities," the spokesperson added.

In December last year, Dharavi Redevelopment Project Private Ltd (DRPPL) rebranded itself as Navbharat Mega Developers Private Ltd (NMDPL) - matching the company's promise of building a modern, inclusive and vibrant community.

Unlike other slum rehabilitation projects, residents will not be placed in high-rise slums but in well-planned townships, with appropriate facilities like wide roads, green spaces, and proper water and sewage systems etc. These townships will have multimodal transport hubs.

According to the spokesperson, the townships will include schools, healthcare facilities, playgrounds, community centers and shopping complexes.

"This redevelopment, as well as infrastructure, will not only improve the lives of relocated Dharavikars but also enhance infrastructure and living conditions of the neighborhood and Mumbaikars at large," the spokesperson added.

NMDPL is a special purpose vehicle (SPV) formed as a joint venture between the Maharashtra government and the Adani Group. The name Navbharat, which means "New India," reflects the massive potential this project holds in shaping a better tomorrow. IANS

Flexible workspace sector in India reaches all-time high gross leasing volume

NEW DELHI: India's flexible workspace sector registered an all-time high gross leasing volume (GLV) of 12.4 million square feet (MSF) in 2024, a recent report showed.

This marks a 57.5 percent year-on-year

Flexible workspace sector inbusiness centers, coworking centers and managed

Among India's top flexible workspace markets, Bengaluru led with 3.4 MSF of leasing volume, nearly doubling its previous year's

3 times growth in GLV, reaching 1.9 MSF, a testament to rising demand in India's financial capital.

Delhi NCR at 2.3 MSF GLV, Hyderabad at 1.6 MSF GLV, and Pune at 1.6 MSF GLV, also emerged as strong flexible

workspace hubs, said the report.

With new companies (GCCs) entering the country and existing companies prioritizing operational flexibility, cost efficiency and end-to-end customization, demand for agile, dynamic, managed office solutions continues to surge, said Ramita Arora, Managing Director Bengaluru and Head - Flex, India, Cushman & Wakefield.

According to the data, evolving business priorities, the need for flexibility, the

> shift toward hybrid work models and strong enterprise demand for managed office solutions fuelled historic highs in flex seats leased.

About 224,000 seats were leased in 2024, by end occupiers, from flexible workspace operators, a 44 percent increase over 2023 (156,000 seats).

In terms of cities, Bengaluru again dominated with a 29 percent share (64,000 seats) in total seats leased in the year and maintained its status as India's leading flexible workspace market.

Bengaluru was followed by Pune (39,000 seats), Delhi NCR (38,000 seats), and Mumbai (28,000 seats), with shares of 18 percent, 17 percent and 12 percent, respectively in total seats leased. IANS



B'desh Foreign Affairs Advisor-EAM Jaishankar discussed possibility of holding Yunus-PM Modi meeting: reports

DHAKA: Touhid Hossain, the Foreign Affairs Advisor to the interim government in Bangladesh led by Muhammad Yunus, emphasized on the importance of starting the discussions for renewal of the Ganges Water Sharing Treaty during his meeting with India's External Affairs Minister (EAM) S. Jaishankar held in Muscat recently, the Bangladeshi media reported.

"Diplomatic sources said that the meeting between the Bangladesh Foreign Affairs Advisor and the Indian Foreign Minister in Muscat lasted less than half an hour. During the discussion, the two emphasized the importance of working to overcome the challenges that have arisen in the current context of bilateral relations. During their discussion, the topic of organizing a meeting between the Chief Advisor Professor Muhammad Yunus and Indian Prime Minister Narendra Modi on the sidelines of the BIMSTEC Summit to be held in Bangkok, Thailand, in April also came up," reported Bangladesh's leading daily Prothom Alo.

Quoting Bangladesh Foreign Ministry's

statement, the local media in Dhaka mentioned that during the meeting, that was held on the sidelines of the 8th Indian Ocean Conference (IOC) in Oman's Muscat recently, Hossain also highlighted the importance of holding the meeting of SAARC Standing Committee and urged the Indian government to consider the

Hossain and Jaishankar expressed hope that border-related issues will be resolved through discussions at the meeting.

"Met Foreign Affairs Advisor Md. Touhid Hossain of the Interim Government of Bangladesh. Conversation was focused on our bilateral relationship, as also on BIMSTEC," EAM Jaishankar posted on X after his meeting with Hossain last week-

EAM Jaishankar and Hossain had last met on the sidelines of the UN General Assembly in New York in September. marking the first high-level engagement between India and Bangladesh's interim government after former Prime Minister Sheikh Hasina's ouster in August 2024

Both the countries also recognized the challenges in bilateral relations and discussed the necessity to work together to address those," the reports detailed.

With a three-day Director General-level conference of the border guards of the two countries starting in New Delhi, both

EAM Jaishankar and Hossain had last met on the sidelines of the UN General Assembly in New York in September, marking the first high-level engagement between India and Bangladesh's interim government after former Prime Minister Sheikh Hasina's ouster in August 2024.

Even though India continues to bat for the normalization of relations between the two neighboring countries, the current regime in Dhaka has faced massive criticism for making groundless accusations and also targeting minorities, especially the Hindu community in Bangladesh, since the mass uprising of students and the dramatic fall of Hasina's Awami League government, last year.

In December, Foreign Secretary Vikram Misri visited Dhaka, conveying New Delhi's concerns, especially those related to the safety and welfare of minorities in Bangladesh, to the top leadership of the interim government.

The 6th Bay of Bengal Initiative for Multi-Sectorial Technical and Economic Cooperation (BIMSTEC) Summit is scheduled in Bangkok, Thailand, from April 2-4, later this vear.

Bangladesh, which will take over as the next chair of BIMSTEC at the summit, is hoping for a Yunus-PM Modi meeting taking place during the Bangkok event. IANS

BEIJING: The update made by the US Department of State in its online fact sheet on America's relations with Taiwan has drawn flak from China, with the latter accusing the Trump administration of serious regression for its position on Taiwan, CNN reported.

As per CNN, China has accused the Trump administration of "serious regression" in its position on Taiwan, after the State Department removed a line from its website stating that the US does not support Taiwan independence.

According to the CNN, the State Department dropped the phrase "we do not support Taiwan independence" as a part of the "routine" update to its online fact sheet on US relations with Taiwan last week.

The change was welcomed by Taipei but triggered one of the strongest rebukes from Beijing since Donald Trump returned to the White House.

Citing Chinese Foreign Ministry, CNN reported that China urged the US to "immediately correct its mistakes" over the removal of the line, or risk "further serious damage" to China-US relations.

"The US State Department's revision of the list of facts regarding US-Taiwan relations represents a serious regression in its stance on Taiwan...(and) sends a seri-

> ously erroneous message to the separatist forces advocating for Taiwan independence," ministry spokesperson Guo Jiakun said at a regular news conference, CNN reported.

> "This is further evidence of the US stubbornly adhering to the er-

roneous policy of using Taiwan to contain China. We urge the US to immediately correct its mistakes," Guo added further.

In a statement to CNN, the State Department described the wording change as part of a standard update. "As is routine, the fact sheet was updated to inform the general public about our unofficial relationship with Taiwan," a State Department spokesperson said and also added that America committed to its "one China policy" - a line that is still stated in the updated fact sheet, as per CNN. ANI

Yunus govt turning Bangladesh into terrorism hub: Sheikh Hasina

NEW DELHI: The ousted Prime Minister of Bangladesh accused the Mohammed Yunus-led interim government of turning the nation into a hub of terrorism and lawlessness. She also vowed to return home assuring help to families suffering and delivering them justice.

She said that Yunus himself has said that he has no experience in running a nation, then he should refrain from doing so, accusing him of remaining silent as dozens of police officers were killed last year during student-led riots against her quota reforms and allowing lawlessness to take over.

"Yunus has no experience of running a government. He dissolved all inquiry committees and unleashed the terrorists to butcher people. They are destroying Bangladesh. We will out this government of terrorists. Inshallah," said Hasina.

While addressing the Awami League supporters online from India recently, she said, "I will return. The killers will face justice in Bangladesh. Their reckoning will happen on Bangladeshi soil. Perhaps

that's why Allah has kept me alive."

After laying low since the coup and subsequent ouster from Bangladesh, Hasina has started to address her party workers and reach out to her supporters through speeches and messages virtually. Unable to stop her from reaching out to her core supporters, the interim government and the protesting student outfits are up in arms and resorting to extreme measures.

On one hand, the interim government

has started to submit dossiers to the Indian Government for her extradition to Bangladesh. On the other hand, the students' outfits riled up and even destroyed the memorial residence of the founding father of Bangladesh, Sheikh Mujibur Rahman, at Dhanmondi 32 in Dhaka.

Last week while addressing the media on the sidelines of the World Governments Summit in Dubai, Yunus vowed that he would not allow key figures from the ousted Sheikh Hasina regime to escape punishment, noting that the people of Bangladesh would not forgive his administration if they fail to bring them to justice. "We'll bring her (Hasina) to justice. It has to happen, otherwise people will not forgive us," Yunus said.

"We have already initiated the legal process, and we hope it will proceed smoothly so that we can bring her to justice. It is essential that this happens, otherwise, people will not forgive us," Yunus was quoted as saying by the leading Bangla daily, Prothom Alo. *IANS*

Can Pakistan sustain its bold policy reforms?

akistan's journey towards progress has always been a story of resilience, determination, and ambition. In a region fraught with economic and political challenges, the country has often been seen as struggling to keep up. However, the Pakistan Reforms Report 2025 presents a different picture - one of transformation, efficiency, and forward-looking policies that signal a commitment to real change. Compiled by Mishal Pakistan, a governance and economic research institution, the report highlights over 120 reforms implemented within just 11 months, painting a hopeful yet pragmatic outlook for the country's future.

For a country that has battled economic instability for decades, the figures presented in the report are surprisingly reassuring. Inflation, which peaked at an alarming 38% in May 2023, has been brought down to just 4.1% by December 2024. Such a drastic decline is no coincidence-it reflects deliberate fiscal discipline, smart monetary policies, and a focused effort to restore economic confidence.

Similarly, Pakistan's foreign exchange reserves have climbed from a precarious \$4.4 billion to a robust \$11.73 billion, providing much-needed financial security. This growth is crucial not only for investor confidence but also for shielding the economy from external shocks. A shrinking trade deficit, down from \$27.47 billion to \$17.54 bil-

lion, further supports the idea that Pakistan is moving toward a more sustainable e c o n o m i c model.

Beyond the numbers, these improvements translate into

something more meaningful: relief for ordinary citizens. Lower inflation means reduced costs of essential goods, increased purchasing power, and an improved standard of living. A more stable economic environment fosters job creation, business growth, and long-term prosperity.

workforce by 150,000 positions. On the surface, such a move might seem harsh, raising concerns about unemployment. For years, an overstaffed and sluggish bureaucracy has been a major hurdle in governance, draining national resources without adding proportional value. Another critical reform is ensuring that at least 33% of government board members are women. This move is more than just a symbolic gesture; it marks a tangible shift toward inclusivity in decision-making. Women have historically been underrepresented in governance structures, and this policy sends a strong message that their voices are not just welcome but necessary for Pakistan's progress. If sustained, this could lead to broader changes in corporate and institutional leadership, fostering a more balanced and diverse governance ecosystem.

Investment and industry

For years, Pakistan's investment climate has been plagued by red tape, regulatory confusion, and policy inconsistency. The report, however, suggests that the tide is turning. The signing of 34 Memorandums of Understanding (MoUs) with Saudi Arabia, totaling \$2.8 billion, reflects growing international confidence in Pakistan's economic potential. These agreements, spanning energy, infrastructure, and technology sectors, could provide a muchneeded boost to industrial growth.

Beyond the 2024 elections:

Sustaining democracy and development in Jammu & Kashmir

ALLEN DAVID SIMON

ammu & Kashmir held elections after a decade in September-October 2024 and for the first time following the 5th August 2019 abrogation of Article 370 (special status of the State of Jammu and Kashmir) and reorganization of the state into a union territory, which had made it subject to greater New Delhi control.

The October 2024 Jammu & Kashmir elections marked a shift in the Indian government's approach towards militant separatists from marginalization to electoral inclusion. While uncertainties remain over the inclusion of political extremists into the electoral fold, the results of

forms the frontline in the hostilities between India and China-Pakistan that have become the dominant feature of South Asian geopolitics.

What the elections signified

The October 2024 results gave the INDI Alliance, comprising the National Conference (NC), Indian National Congress (INC) and Communist Party of India (Marxist), a majority of 49 seats in the 90-member legislative assembly. The comeback of the biggest player in the Kashmir valley, NC from 15 in 2014 to 42 (23.43% votes) in 2024, coupled with the massive fall of Peoples' Democratic Party (PDP) from 28 seats to just six

the election decisively showcase a disjuncture in the political affiliation of Hindu and Muslims inhabiting the region. The geopolitically contested region has historically been politically volatile with a need for transforming the relations and re-established people's trust in the Indian government.

A historically unstable yet strategically important region, Jammu & Kashmir is a land contested between India, Pakistan and China, even though it is largely administered by India. These elections, though local, shape the geopolitical status of South Asia. Moreover, Jammu & Kashmir's recent discoveries of lithium have given it a seminal role in the global semiconductor wars and the Sino-Indian rivalry. Located between three nuclear powers, Jammu & Kashmir

seats (8.87% votes) has ended the bipolar competition between the Valley parties. In parallel, the fall of the INC to only six seats has ended its relevance in the Jammu region. This coincides with the emergence of the Bharatiya Janata Party (BJP) with 29 seats (25.64% votes), with all seats from the Jammu region where the BJP has been able to consolidate, making the BJP the principal opposition in the union territory legislature.

The less-than-eager BJP-led Union government held elections in response to the Supreme Court verdict in December 2023 ruling that the Indian government must ensure that election is held for the legislature in Jammu and Kashmir within a year. The Modi government's apprehension in granting statehood for Jammu and Kashmir

and to relinquish administrative powers to an autonomous regional government is not without cause. The Chinese aggression along the Line of Actual Control in the Ladakh region and the ever-present Pakistani threat across the Line of Control makes Indian insecurities a justified one. Having fought both Pakistan and China for control over the region, Indian policy has always leaned towards securing a firmer grip over the region.

Regional-religious divide

The outcome shows a clear disjuncture between the two areas and the two communities constituting Jammu & Kashmir. The Muslim majority Kashmir valley gave a clear verdict in favor of the INDI alliance, whereas the Hindu majority Jammu region gave overwhelming support to the BJP. This may further fracture the two communities in the region, which has already suffered through the 1990 genocide and exodus of the Kashmiri Pandits. While the Hindu vote stood firm with the BJP, its failure to win goodwill in the Kashmir valley reflects how Article 370 remains a key poll issue for Kashmiri Muslims. Reports over the BJP's less than discrete engagement with secessionist politicians, allegedly to fragment the Muslim vote in the Kashmir valley between the established NC, PDP and smaller secessionist parties, had left the established parties disgruntled. The Union government was accused of using the lieutenant governor (the union territory's constitutional head) to act as the long arm of New Delhi.

INDIA'S AVOIDABLE TRAGEDIES

ndia's most auspicious religious festival, Kumbh Mela, held every 12 years, has taken toll of 18 more lives including women and children at New Delhi Railway Station on February 15. Information available in public domain points to at least five red flags, which should have alerted the Railways to action. The question is was any official or body actually monitoring for signals in real-time to preempt such a tragedy? The answer is a big "NO".

Every railway station, like any public space, has a crowd-holding capacity. Shouldn't a surge in passengers have been prevented inside the station both by the Railway administration and the local Police. The surge of railway bookings and unreserved-seat sales should have been enough of a red flag for the railway admin to immediately increase personnel at key areas around the station.

According to reports from various sources more than 1500 tickets were sold every hour and approximately 8000 tickets were sold between 6 to 8 pm daily during the days of the Kumbh Mela. On the tragic day, more than 10,000 tickets were sold. As a result of surge in ticket sales, the number of passengers swelled on the platforms towards Ajmeri Gate, where several eastbound trains, including those to Prayagraj, were scheduled.

The thousands of passengers crowding the station platforms, foot-over bridges, and stairways, the clustering of trains at designated platforms, formed the recipe for the stampede. With little to no space to move, even a single announcement of a platform change or, of trains with similar-sounding names would be enough to trigger a disaster. Passengers might decide to switch trains, or travelers finding themselves on the wrong platform, would rush to new announcements. As the station, its platforms, and over bridges became overcrowded, confusion over train announcements of trains having 'Prayagraj' in their names triggered the stampede.

At time of the stampede, around 60 Railway Protection Force (RPF) and 20 Delhi Police personnel were stationed across the 16 platforms of New Delhi Railway Station, the report said. During festivals, such as Holi, Deepawali, Chhath, and Durga Puja, a major socio-religious event like the Maha Kumbh also sees a surge in passenger and pilgrim movement on railway routes passing through Uttar Pradesh, Bihar, and Delhi.

According to a news report in January, Indian Railways had announced it would operate around 13,000 trains, including 10,000 regular and 3,000 special trains, over the 50 days during the Kumbh Mela in Prayagraj. And why not? It's the largest peaceful gathering of people in the world. With around a week remaining until the end of the Maha Kumbh, over 50 crore devotees is estimated to have attended the largest religious gathering in the world. The railways introduced special trains and implemented specific entry and exit routes at various stations to manage crowds. However, despite these measures, the stampede in New Delhi occurred. It reveals the handling of such large crowds probably needs more efforts than were in place. And appears that Indian officials haven't learnt nor trained to manage such crowds.

In addition to the tragic Saturday more than 30-people were estimated killed and hundreds injured, at the Kumbh Mela site due to stampedes earlier.
