# MOTHER OF ALL DEALS

"Mother of all deals": EU Commission President says they stand on "cusp of historic trade deal with India"

DAVOS: European Commission President Ursula von der Leyen has stated the European Union is close to finalizing a Free Trade Agreement with India and noted that some describe it "the mother of all deals".

Addressing the World Economic Forum in Davos, she stressed Europe's intent to expand trade and international cooperation.

She also referred to the scale of the proposed trade deal with India.

"There is still work to do. But we are on the cusp of a

historic trade agreement. Some call it the mother of all deals. One that would create a market of 2 billion people, accounting for almost a quarter of global GDP," von der Leyen said.

The President of the European Commission said she will travel to India next weekend. She said the visit is aimed at taking forward work on the proposed trade agreement and added that there is important work to be done to strengthen economic relations and deepen cooperation between Europe and India.





Addressing the World Economic Forum in Davos, she

stressed Europe's intent to expand trade and international cooperation.

She also referred to the scale of the proposed trade deal with India.

"There is still work to do. But we are on the cusp of a

historic trade agreement. Some call it the mother of all deals. One that would create a market of 2 billion people, accounting for almost a quarter of global GDP," von der Leyen said.

The President of the European Commission said she will travel to India next weekend. She said the visit is aimed at taking forward work on the proposed trade agreement and added that there is important work to be done to strengthen economic relations and deepen cooperation between Europe and India.

Placing the proposed India agreement in Europe's larger global trade approach, von der Leyen said Europe remains open to doing business with partners worldwide.

"Europe will always choose the world, and the world is ready to choose Europe," she said.

She said Europe's focus is on building a stable, well-regulated environment that encourages investment, boosts trade, and supports sustainable economic growth.

Along with trade and investment, von der Leyen identified energy as a major pillar of Europe's growth

agenda, saying Europe intends to build an energy union that can deliver homegrown, reliable and cheaper energy to support economic expansion. She added that Europe needs an "urgency mindset" to address energy challenges and ensure a sustainable future.

Speaking on wider strategic priorities, von der Leyen said Europe has achieved more in defense in the past year than in the decades earlier, with member states increasing investments to record levels. She also noted that three leading European defense technology startups have reached unicorn status, reflecting Europe's growing innovation and strength in the defense sector.

President of the European Council Antonio Luis Santos da Costa and European Commission President Ursula von der Leyen will be Chief Guests at India's 77th Republic Day celebrations.

The two EU leaders will undertake a three-day State Visit to India from January 25.


During the visit, the leaders will also co-chair the 16th India-EU Summit on January 27. President Costa and President von der Leyen are scheduled to meet President Droupadi Murmu and will hold restricted as well as delegation-level talks with Prime Minister Modi.

An India-EU Business Forum is also expected to be organized on the sidelines of the India-EU Summit.

India and the European Union have been strategic partners since 2004 and the 15th India-EU Summit was held virtually on July 15, 2020. ANI

# India, EU cementing economic ties amid growing global uncertainties

NEW DELHI: The India-EU summit scheduled for January 27 comes as part of the steady strengthening of economic relations between the two sides amid growing uncertainties in global markets triggered by the US tariff turmoil and dramatic geopolitical shifts in the world order.

The summit to be hosted by Prime Minister Narendra Modi and co-chaired by European Council President Antonio Costa and European Commission President Ursula von der Leyen will witness the adoption of a document by both sides to announce the conclusion of FTA negotiations, after which the agreement will go through the necessary legal procedure and ratification by the European Parliament and Council.

The EU, as a bloc, is India's largest trading partner in goods. For FY 2024-25, India's total trade in goods with the EU was worth about USD 136 billion, with exports around USD 76 billion, and imports at USD 60 billion.

From 2019 to 2024, India-EU bilateral trade in services exhibited steady growth, with Indian exports increasing from EUR 19 billion in 2019 to EUR 37 billion in 2024. Imports from the EU also saw an increase, reaching EUR 29 billion in 2024.

Prime Minister Narendra Modi and European Commission President von der Leyen had already laid the foundation for cementing ties between the two sides

with the establishment of the India-EU Trade and Technology Council in April 2022, during the latter's official visit to India, as a strategic coordination mechanism to tackle challenges at the nexus of trade, trusted technology, and security.

The is led to an MoU on Semiconductors and an MoU between Bharat 6G Alliance and EU 6G Smart Networks and Service Industry Association were signed in November 2023 and March 2024, respectively.

in 2016, was adopted in November 2024.

European Investment Bank supports India's climate and energy transition by financing projects in sustainable transport and urban mobility, such as urban rail and metro in some of the Indian cities.

Other areas of cooperation between India and the EU include offshore wind energy, development of gas infrastructure in India, the reduction of methane emissions, investments and transfer of technology.

An agreement for R&D cooperation in

Other activities include ongoing discussions on Artificial Intelligence, joint research projects in High Performance Computing, and startup collaborations in electric vehicle batteries.

India and the EU also enjoy close ties on energy and climate

The EU has been a partner organization to the International Solar Alliance, spearheaded by India, since 2018. The Phase III of India - EU Clean Energy and Climate Partnership (CECP), established

peaceful uses of nuclear energy was also signed between India's Department of Atomic Energy and EURATOM in July 2020.

Addressing a media briefing in Kandy recently, the Front's Secretary, Shastrava and Tripitaka scholar, Kavissara Thero of Nuwara Eliya, said that the future of Buddhist indigenous communities in the Chittagong Hill Tracts under significant threat, Sri Lankan media outlet Ceylon Wire News reported.

# Babbar Khalsa terrorist was released by Biden Admin, says DHS

WASHINGTON: A suspected Babbar Khalsa International (BKI) terrorist from India was released into the interior of the United States under the Biden administration before being arrested by Immigration and Customs Enforcement (ICE), the Department of Homeland Security (DHS) said.

Harpreet Singh is wanted in India in connection with terrorist activities that included planning more than a dozen grenade attacks on police officials. He is linked to BKI, which has been designated as a foreign terrorist organization.

According to the Department of Homeland Security recent statement, he entered the country illegally in Arizona on January 27, 2022. He was then released into the interior of the country under the Biden administration, the DHS said.

ICE arrested Singh in April 2025, according to the DHS recap of enforcement actions taken under the leadership of President Donald J. Trump and Secretary of Homeland Security Kristi Noem since January 20, 2025.

DHS released the statement highlighting what it described as the "worst of the worst" criminal illegal aliens ICE took enforcement action on during President Trump's first year in office.

"On President Trump's first day in office, he unleashed ICE to target the worst of the worst criminal illegal aliens, including pedophiles, murderers, gang members, terrorists, and rapists," said Assistant Secretary Tricia McLaughlin.

"Today, we thank our law enforcement for a record-breaking first year of achievements, including more than 670,000 removals and two million self-deportations. DHS is committed to continuing to remove dangerous illegal aliens from American

gang leaders, violent offenders and repeat criminal illegal aliens from multiple countries.

DHS cited the case of Khor Bozorov, a criminal illegal alien from Uzbekistan wanted in his origin country for belonging to a terrorist organization. ICE arrested Bozorov in Kansas on November 9 while he was working as a commercial truck driver.

Another case involved Jaan Shah Safi, an Afghan national who entered

communities. 70 percent of ICE arrests are of criminal illegal aliens who have been convicted or charged with a crime in the U.S. We will not rest until American communities are free of the scourge of illegal alien crime."

Since January 20, 2025, ICE has taken enforcement action against dangerous criminals, DHS said, detailing dozens of cases involving alleged terrorists,

the United States under 'Operation Allies Welcome.' Safi allegedly provided support to the Islamic State of Iraq and Syria-Khorasan (ISIS-K), and his father is a commander of a militia group in Afghanistan, DHS said. ICE arrested Safi in Waynesboro, Virginia in December 2025.

Another MS-13 leader, Rene Escobar-Ochoa from El Salvador, faces an INTERPOL Red Notice for drug trafficking and conspiracy to commit murder and was arrested by ICE in July 2025. IANS

## Pakistan using films to advance anti-India narrative, promote Khalistani agenda: Report

ISLAMABAD: Pakistani cinema is being leveraged to push anti-India narrative and manipulate religious symbols for political objectives, with critics warning that such strategies undermine the sanctity of holy sites, politicize heritage, and turn art and religion into tools of state power, a recent report said.

"It is being observed in Pakistan that cinema is increasingly being used as a tool to intensify anti-India activities, particularly those linked to Khalistan. Those individuals who face difficulties in producing films or songs promoting Khalistan due to restrictions in India appear to be taking full advantage of this situation. They go to Pakistan, carry out their activities without any restrictions, and then make the content go viral on social media," a report in 'Khalsa Vox' detailed.

"Because of this regressive mindset among Pakistanis, a situation has emerged where, on one hand, the whole of India and Indian Punjab are attracting global attention due to rapid economic growth, institutional reforms, and social progress, while on the other hand, Paki-

stani Punjab remains trapped in corruption, scams, and long-standing misgovernance," it added.

According to the report, rather than confronting its domestic failures, Pakistan is increasingly relying on an anti-India narrative with state-supported media houses, social media influencers, YouTubers, and filmmakers being mobilized to divert attention and shape public opinion through cultural production.

"In any case, the weaponisation of cinema is not a new phenomenon. For decades, Pakistani films and television serials have portrayed Sikh characters—especially Sikh women—from an extremely narrow and deeply controversial perspective. Many productions use tropes such as Islamization or 'conversion romance,' which numerous Sikh commentators consider insulting and ideologically biased," it noted.

The report highlighted that the decision to film at sacred Sikh sites – especially Nankana Sahib, the birthplace of Guru Nanak Dev Ji – has drawn widespread criticism. IANS

## Sindhi leader claims Pakistani army, ISI behind terror attack on Chinese restaurant in Afghanistan

BERLIN: Shafi Burfat, Chairman of the Jeay Sindh Muttahida Mahaz (JSMM), accused the Pakistani army and the Inter-Services Intelligence (ISI) of being directly or indirectly involved in orchestrating the terrorist attack on a Chinese restaurant in Afghanistan.

The remarks came after an explosion outside a Chinese restaurant in Kabul, the capital of Afghanistan, on January 19 caused multiple casualties, including the death of one Chinese citizen.

Condemning the attack, Burfat asserted that such acts of terrorism are not isolated incidents but are carried out by extremist and terrorist groups nurtured, protected, and strategically deployed by Pakistan's military establishment, particularly under the direction of the ISI. IANS

## "Greenland is not a natural part of Denmark, is it?" Russia says

MOSCOW: Russian Foreign Minister Sergey Lavrov has said that Greenland was not a "natural part of Denmark."

Addressing a news conference recently, Lavrov said several countries own parts of colonies, which is a flagrant violation of the UNSC Charter.

"If we talk about Greenland, well, that's part of the issue that has to do with the consequences of the colonial era, starting with the 13th century. Greenland essentially, was a Norwegian colony, starting with the 18th, till the very beginning of the 20th century was the Denmark's colony. And by the mid-20th century, an agreement was signed, according to which it is part of Denmark, not as a colony but as an associated territory. It was associated with the European Union. But in principle, Greenland is not a natural part of Denmark, is it?" he said.

Lavrov said that the problem of former colonial powers holding on to colonies is a problem which is becoming more urgent.

"It was not a natural part of Norway or Denmark. It was the colonial acquired state. Well, people got used to that. That's the other matter. But the problem of former colonial powers, well, it is something that is becoming more urgent," he said.

Lavrov further said that there are 17 territories, which are still dependent on ruling powers, listing out the regions, and said that these issues will be raised even in the future.

"According to the UN, there are 17 territories that either do not have sovereignty or are directly dependent on their ruling powers. Unlike and at odds with the UNSC resolution, France keeps the island of Mayotte. Judging by all of the decisions of the United Nations. It keeps part of the Comoros. The UK keeps the Malvinas. In violation of multiple resolutions of the United Nations General Assembly. Britain also keeps the Mauritius island of Tagus, archipelago. There are multiple examples, French Polynesia, Epirus islands that are still kept by the French Republic. Therefore, these issues will be raised in the future as well," he said. ANI

**Scientists find hidden synapse hotspots in the teen brain: Study**

WASHINGTON DC: The scientists have discovered that the adolescent brain does more than prune old connections. During the teen years, it actively builds dense new clusters of synapses in specific parts of neurons.

These clusters emerge only in adolescence and may help shape higher-level thinking. When the process is disrupted, it could play a role in conditions like schizophrenia.

Adolescence is a defining stage not only for social and physical growth, but also for how the brain develops. During this time, advanced mental abilities such as planning, reasoning, and decision-making continue to mature.

Even so, scientists still lack a complete understanding of how the brain's complex networks are shaped during this critical period.

At the heart of brain development are synapses, the functional connections between neurons that allow information to flow through the brain. For decades, researchers believed that synapse numbers steadily rise during childhood and then decline during adolescence. ANI

## Local leadership key to improving infant, maternal health: IIM Lucknow study

NEW DELHI: Affirmative action in local government leadership can significantly help improve health outcomes, particularly infant survival and maternal prenatal care, in India, according to a study, led by researchers at the Indian Institute of Management (IIM) Lucknow.

The study, published in the Proceedings of the National Academy of Sciences (PNAS) journal, offers important insights into how structural interventions can address long-established social and health inequities.

The findings showed that vil-

lage clusters with affirmative action in local leadership recorded significantly better health outcomes.



Infant mortality rates were significantly lower in villages led by local representatives.

Maternal health indicators also improved, including higher odds of receiving at least two prenatal visits, tetanus vaccinations, and

prenatal supplements by the second trimester.

"Our study found that local

leaders from historically disadvantaged groups made decisions on health and education spending that appear to address some structural inequalities in local communities," said Prof. K. G. Sahadevan from the varsity.

By using a quasi-experimental design, the research team focused on the impact of leadership reservation for Scheduled Castes (SC) in India's local governments, the smallest units of governance responsible for delivering essential public services such as health and education. IANS

mittee, WEF.

The experts noted that custom API integrations, including vendor fees, manpower time, testing effort, and leadership oversight, can typically cost at least \$2,500 each.

But, with ABDM, "one certified integration replaces multiple bespoke interfaces, and the system-wide savings can instead strengthen clinical care, cybersecurity, and citizen engagement".

The same approach used in large public or private hospital networks, diagnostic chains, and integrated care systems has significantly helped "reduce IT duplication and long-term maintenance costs".

The experts noted that "investing in interoperable systems, preventive care, and digital capacity" can yield real and rising returns.

They argued that the upcom-

ing Future Health Districts project under the India Pathfinder initiative is another best investment that India is making.

The project "aims to test ABDM-aligned, outcome-linked models in collaboration with state governments and partners," the report said.

"Over three to five years, it will



work to improve indicators such as screening rates, maternal-health follow-ups, and claims-processing times. Each district that succeeds becomes proof of what investable digital health can deliver," it added.

The report also flagged major disparities such as gaps in health coverage, financing pressures, and system inefficiencies in the country.

"These highlight the need to redirect resources toward high-return investments -- particularly digital infrastructure, prevention, and interoperable systems," stated the experts.

They recommended reframing health as a crucial driver of economic prosperity and national stability; strengthening interoperable digital systems; and channeling philanthropic health funding toward measurable outcomes.

"The lessons emerging from ABDM, Future Health Districts experiments can guide low and middle-income countries seeking scalable, interoperable and affordable solutions," the report said. IANS

# Swedish study reveals when fitness and strength begin to fade

STOCKHOLM: A long-running Swedish study has followed adults for nearly five decades, uncovering when physical decline truly begins. Fitness and strength start slipping around age 35, then worsen gradually with age.

The encouraging twist: adults who began exercising later still improved their physical capacity by up to 10 percent. It's a powerful reminder that staying active matters, even if you start late.

A long-running Swedish study conducted at Karolinska Institutet has followed people for 47 years to examine how fitness, strength, and muscle endurance evolve during adulthood. The findings show that physical performance begins to decline around age 35.

The research is part of the Swedish Physical Activity and Fitness study (SPA), which tracked several hundred randomly selected men and women between the ages of 16 and 63.

Published in the *Journal of Cachexia, Sarcopenia and Muscle*, the study offers rare long-term insight into how physical

capacity changes over decades rather than snapshots at a single point in time.

Earlier research in this area relied on cross-sectional data, comparing different age groups rather than following the same individuals.

nearly half a century, making it one of the most comprehensive efforts of its kind.

**Fitness Declines After 35, but Activity Still Helps:**

The results show that both fitness and

physical decline continues gradually and tends to speed up with advancing age.

Despite this pattern, the researchers found encouraging evidence that exercise remains valuable at any stage. Participants who became physically active during adulthood increased their physical capacity by 5-10 percent.

"It is never too late to start moving. Our study shows that physical activity can slow the decline in performance, even if it cannot completely stop it. Now we will look for the mechanisms behind why everyone reaches their peak performance at age 35 and why physical activity can slow performance loss but not completely halt it," says Maria Westerståhl, lecturer at the Department of Laboratory Medicine and lead author of the study.

The research is ongoing. Next year, the participants will be examined again when they reach age 68. The team hopes to better understand how changes in physical performance are connected to lifestyle choices, overall health, and underlying biological processes. ANI

## Physical activity in adolescence may ward off breast cancer risk later: Study

NEW DELHI: Adolescent girls who actively partake in recreational physical activity can have significant protection against risks of breast cancer, according to a study.

Researchers from the Columbia University Mailman School of Public Health in the US showed that recreational physical activity may be associated with breast tissue composition and biomarkers of stress in adolescent girls.

In the study, girls who reported engaging in at least two hours of recreational physical activity in the prior week, compared with none, had lower percent water content in breast tissue -- an indicator of lower breast density and lower concentrations of urinary biomarkers linked to stress.

The findings, published in the journal *Breast Cancer Research*, shed new light on how physical activity during adolescence -- a critical period of breast development -- may influence biological pathways related to future breast cancer risk.

"The importance and urgency of this

research are underscored by the rising incidence of breast cancer in young women and the alarmingly low levels of recreational physical activity observed both in this study and among adolescents globally," said Rebecca Kehm, Assistant Professor of Epidemiology at Columbia Mailman School of Public Health.

implications for breast cancer risk," Kehm added.

The study aligns with previous research in adult women showing that higher levels of physical activity are associated with lower mammographic breast density, a key predictor of breast cancer risk.

During adolescence, participants self-reported past-week engagement in recreational physical activity, including both organized and unorganized activities, and completed clinic visits that included blood and urine collection as well as breast tissue assessments.

The average age of girls in the study was 16 years. More than half (51 percent) reported no recreational physical activity in the past week. Seventy-three percent reported no participation in organized activities, and 66 percent reported no participation in unorganized activities.

The team noted that additional longitudinal studies are needed to determine how these adolescent biomarkers may translate into breast cancer risk later in life. IANS

## Hyaluronic acid may help improve gynecological cancer treatment: Study

NEW DELHI: In the first-ever study, Australian researchers have demonstrated the feasibility and safety of using stabilized hyaluronic acid (sHA) gel during radiation treatment for gynecological cancers.

The gel is already approved by Australia's Therapeutic Goods Administration for use in prostate cancer radiation treatment.

The team led by experts from Monash University investigated hyaluronic acid gel for the first time in women as a means to gently create more space between the tumor and the rectum during MRI-guided brachytherapy -- a type of internal radiation treatment.

By creating this space, clinicians aimed to reduce radiation exposure to the rectum, allowing a higher dose of radiation to reach the tumor with more effective targeting, reducing damage to healthy tissue, and potentially improving treatment results. IANS

Nag said that language AI can significantly enhance citizen engagement, griev-



## Human heart regrows muscle cells after heart attack: Study

NEW DELHI: In a world-first discovery, scientists in Australia have found that the human heart can regrow muscle cells after a heart attack, raising hopes for future regenerative treatments for heart failure.

The study, published in Circulation Research, revealed that while parts of the heart remain scarred after a heart attack, new muscle cells are also produced, a phenomenon previously seen only in mice and now demonstrated in humans for the first time, Xinhua news agency reported.

"Until now we've thought that, because heart cells die after a heart attack, those areas of the heart were irreparably damaged, leaving the heart less able to pump blood to the body's organs," said Robert Hume, research fellow at the University of Sydney and first author of the study.

"In time, we hope to develop therapies that can amplify the heart's natural ability to produce new cells and regenerate the heart after an attack," said Hume. /IANS

## Gold prices jump over 4 pc to hit record high

NEW DELHI: Gold futures on the MCX surged over Rs 4,100 or, 4 percent on 21 January, to a fresh record high, as investors jumped to buy safe-haven assets amid fears of a widening US-EU trade conflict and a softer dollar.

MCX gold February futures, rose 4.25 percent to Rs 1,56,970 per 10 grams. Meanwhile, MCX silver March futures rose 2.71 percent to Rs 3,32,451 per kg.

International markets also saw new peaks as US gold futures jumped to \$4,849 per troy ounce on COMEX. COMEX silver consolidated in the \$92.5-\$95.7 range.

The rally followed reports that the United States plans tariffs on eight European countries from February 1 and could raise duties to 25 percent in June. European countries are reportedly considering anti-coercive measures, using trade defense mechanisms designed to counter economic pressure from foreign governments.

The medium-to-long-term outlook of silver remains exceptionally bullish, with scope toward \$110-\$120 in 2026 under sustained supply constraints and industrial demand, according to analysts.

In MCX silver futures, immediate upside targets are placed at Rs 3,30,000-Rs 3,32,000, with scope to extend toward Rs 3,35,000-Rs 3,50,000 over the coming months, they said. IANS

## Security risk, political uncertainty in Pakistan pose hurdles for investors

NEW DELHI: Pakistan is unable to attract sufficient domestic or foreign investment because of poor governance, bad law and order situation, weak judicial system, bureaucratic hurdles and political uncertainty, according to an article in the Karachi-based Business Recorder.

The article lists the security situation as a major problem which has not improved for decades. "The country is ranked second on the Global Terrorism Index and the attacks are not receding. How is one supposed to invest in such a situation? Even domestic investors have shifted their capital to safe havens. Similarly, the law and order situation in the country is also forcing investors to move to safer avenues," the article points out.

For many domestic investors, the fear of political victimization, combined with the lack of judicial protection, discourages them to invest. Political instability is a major hurdle. Political parties are after one another driven by vendetta and not by national interest.

In the 1990s, Pakistan used to

attract more FDIs than India, but the equation has flipped completely. For example, in 1992, Pakistan attracted \$336.5 million in FDI, while India attracted only \$276.5 million. Now the trajectory has completely changed; in 2024, Pakistan only managed \$2.7 billion, while India attracted \$27.1 billion, which is almost 13 times higher, the article points out.

Citizens witness strikes, lockdowns and closure of main roads for weeks, affecting businesses adversely. In developed democracies, there are consistencies of policy regardless whichever party is in the government. Regrettably, the case is different in Pakistan.

Likewise, regulatory burdens and red tape are another nightmare. Instead of facilitation, regulations are often used as a tool of control. Compliance is very time consuming. If someone wants to install an electricity or gas connection, he has to wait for months. If one wants faster service, then one has to grease the palm of the authorities.

Similarly, opening a bank account is a herculean task, providing endless documents like utility bills, proof of income and so on. Company registration takes even more long and hectic documentation. Why would someone put his hard earned money in a process full of hurdles? On top of that, repatriating money or profit is also a struggle. IANS

## Easing defense FDI norms could be a game-changer for India: Report

The central economic argument is that raising the automatic route cap to 74 percent will make India a more attractive destination for large defense firms by offering greater operational control, stronger intellectual property protection, and clearer ownership rights.

These factors, it opined, multinational defense companies often require before committing large capital and technology transfers. IANS

# IBM CEO calls for AI sovereignty in India with focus on real-world applications at Davos

DAVOS: IBM Chairman and CEO Arvind Krishna has urged Indian entrepreneurs to build local capabilities across semiconductors, model development and real-world applications to build stronger "AI sovereignty" in India.

Speaking at the World Economic Forum (WEF) annual meeting in Davos, Krishna said smaller, specialized AI models are rapidly closing the gap with large foundational models and now account for nearly 95 percent of consumption.

"The underlying ecosystem whether it's semiconductors, model building, or usage applications is where the big breakthroughs will come for India," he told NDTV Profit.

IBM Chairman mentioned China's DeepSeek as an example of how success in the AI sector follows multiple failed attempts. He argued that specialized AI systems trained on local datasets from Indian healthcare, defense and legal domains are necessary for building effective domestic applications, also urging a culture of ex-

perimentation and tolerance for failure.

India focuses on a suite of focused, sector-specific small models that can deliver productivity gains across industries, the minister said, adding that the country attracted \$70-billion investment into AI-enabling infrastructure, including data

## India belongs to 1st group of AI nations, remains biggest supplier of services: Ashwini Vaishnaw

DAVOS: India clearly belongs to the first group of AI nations as AI architecture comprises five layers - application, model, chip, infrastructure, and energy -- and we are actively working across all five, Union Minister for Electronics and IT, Ashwini Vaishnaw, has said.

Outlining India's approach to Artificial Intelligence (AI) the minister emphasized large-scale AI diffusion, economic viability, and techno-legal governance, during a panel discussion at the World Economic Forum (WEF) annual meeting in Davos.

The discussion was moderated by Ian Bremmer, (President and Founder, Eurasia Group), and other panelists included Brad Smith (Vice-Chair and President, Microsoft); Kristalina Georgieva (Managing Director, IMF); and Khalid Al-Falih (Minister of Investment, Saudi Arabia).

"At the application layer, India will probably be the biggest supplier of services to the world," he said, adding that return on investment (ROI) in AI comes from enterprise-level deployment and productivity gains, not from creating very large models alone.

Vaishnaw observed that nearly 95 percent of AI use cases can be addressed

with models in the 20-50 billion parameter range, many of which India already has and is deploying across sectors.

Vaishnaw, however, cautioned against equating geopolitical power with ownership of very large AI models.

He noted that such models can be switched off and may even create economic stress for their developers.

deployment increasingly relies on CPUs, smaller models and emerging custom silicon, reducing dependency on any single country and challenging the notion of AI dominance through scale alone.

Identifying availability of GPUs as a major constraint, he said India has adopted a public-private partnership model, empanelling around 38,000 GPUs as a common national

The government's Rs 7,280 crore scheme for Sintered Rare Earth Permanent Magnets (REPM) is expected to act as a force multiplier for India's broader semiconductor manufacturing ambitions by ensuring secure access to strategic materials. IANS

## India likely to join US-led Pax Silica maintaining strategic autonomy

NEW DELHI: In the war between China and the West to secure critical mineral supply chains needed for advancing AI initiatives, New Delhi may lean towards Pax Silica, a US-led initiative but without sacrificing strategic autonomy, according to reports.

India's participation in Pax Silica would help India scale collaborations with advanced economies, attract investment and deepen supply chain resilience, the report noted. However, India will be keen to ensure that its strategic autonomy is not diluted through its participation in the Pax Silica.

Pax Silica initiative brings together an initial group of countries closely tied to semiconductor manufacturing and advanced technology supply chains, including Singapore, Israel, Japan, South Korea, Australia and the United Kingdom. It is designed to address vulnerabilities exposed by over-concentrated supply chains that underpin everything from consumer electronics and automobiles to cutting-edge AI systems. IANS

NEW DELHI: England cricketers Rehan Ahmed and Adil Rashid have received their visas to travel to India for the upcoming ICC Men's T20 World Cup 2026, starting next month, according to ESPNcricinfo.

## US bill targets citizenship revocation

**WASHINGTON:** A US senator has introduced a bill that would make it easier for the administration to revoke the citizenship of naturalized Americans who commit serious crimes, large-scale fraud, or have links to terrorist organizations.

Republican Senator Eric Schmitt of Missouri said the legislation is needed to protect the integrity of American citizenship. The bill is called the Stop Citizenship Abuse and Misrepresentation, or SCAM, Act.

Schmitt said recent fraud cases show that the current system is too weak. He pointed to a major welfare fraud scandal in Minnesota that involved naturalized citizens. He said people who commit serious crimes after taking the oath of citizenship show they never deserved it.

"American citizenship is a privilege," Schmitt said in a statement. He said those who commit felony fraud, serious crimes, or join terrorist groups fail to meet the basic standards of citizenship. He said they should be denaturalized because they never met the legal requirements in the first place.

The SCAM Act would expand the grounds for starting civil denaturalization cases. These would include committing major fraud against federal, state, or local welfare programs, affiliating with a designated foreign terror-

ist organization, or committing aggravated felonies or espionage.

Under the bill, criminal convictions or admissions within 10 years of naturalization could be treated as strong evidence that citizenship was obtained through concealment or misrepresentation. That could lead to the revocation of citizenship and removal from the country.

Several conservative immigration and policy groups endorsed the proposal. They said the bill would strengthen national security and protect public funds. They argued that denaturalization is a civil process and has long been allowed under US law.

In past debates, critics have warned that expanding denaturalization powers could create fear among immigrant communities. They have said citizenship should not be easily questioned once granted, except in clear cases of fraud.

Under current law, the government must meet a high legal standard to revoke citizenship. It must show that naturalization was illegal or obtained through willful misrepresentation.

Immigration and citizenship remain sensitive political issues in Washington. Proposals like the SCAM Act are expected to draw close attention in the US and abroad, including in countries such as India, which has large immigrant communities in America. IANS

## Foreign maids under South Korean govt's pilot project overworked, underpaid: Survey

**SEOUL:** Foreign housekeepers employed locally under a government pilot project launched two years ago were severely underpaid and had to do extra work that was not agreed upon, a recent survey showed.

In September 2024, the Seoul metropolitan government launched its foreign maid pilot

program and allowed the entry of 100 people, mostly from Southeast Asia, including the Philippines, to work as housekeepers at more than 150 households in the city.

The project, which ended in December last year, was aimed at tackling the shortage of locals willing to work as maids and to support women in continuing

their careers, reports Yonhap news agency.

According to the survey, respondents said they received an average of 1.92 million won (US\$1,303) in monthly wages during the first six months of the project.

The amount is less than half the average monthly payment received by South Koreans in 2024,

which was 3.74 million won.

When deducting costs, such as residential expenses and insurance payments, their net monthly wages were only 1.18 million won, the survey showed.

Some respondents said they were requested to work outside of their job descriptions, such as washing dishes, caring for pets

and tutoring kids in English.

"We must ... reevaluate the value of child care, recognize the economic value of housekeeping labor, and foster a virtuous cycle of providing high-quality housekeeping services and jobs," said Professor Lee Mi-ae of Jeju National University, who conducted the survey. IANS

# Trump says "ICE is removing some of the most violent criminals" amid Minneapolis immigration crackdown

WASHINGTON, DC: US President Donald Trump defended intensified federal immigration enforcement following a deadly Immigration and Customs Enforcement (ICE) operation in Minneapolis, sharply criticizing Minnesota leaders and the backlash to the raids while reiterating his hard-line stance on immigration.

In a Truth Social post, Trump wrote that "ICE is removing some of the most violent criminals in the World from our Country, and bring them back home, where they belong." He questioned why Minnesota officials were resisting the enforcement efforts and urged them to stop what he described as shielding violent offenders.

"Why is Minnesota fighting this? Do they really want murderers and drug dealers to be ensconced in their community?" Trump wrote, framing the issue in terms of crime and public safety.

Trump also criticized protesters opposing ICE raids, calling them "highly paid professional agitators and anarchists" and alleging that state politicians were using the unrest to divert attention from alleged political scandals.

"The crooked Governor and 'Congresswoman' Omar, who married her brother, don't mind because it keeps the focus of attention off the 18 Billion Dollar, Plus, FRAUD, that has taken place in the State! Don't worry, we're on it!" Trump posted.

Trump's remarks come as tensions remain high in Minneapolis following the fatal shooting of 37-year-old Renee Nicole Good during a federal immigration enforcement operation, triggering protests and renewed debate over ICE tactics and the use of force.

Minneapolis has witnessed tense demonstrations against the Trump administration's deployment of federal agents to the city for an immigration crackdown, raising questions over what these officers can do on the ground and how Trump can respond, CNN reported.

As the protests have intensified, Trump has threatened to take the extreme step of invoking the Insurrection Act to crack down on the unrest, CNN reported. Department of Homeland Security Secretary Kristi Noem has also suggested that people may be asked to "validate their identity" in some cases.

Amid these developments, the Pentagon has ordered around 1,500 active-duty soldiers to be prepared for a possible deployment to Minnesota, The Hill reported, citing multiple media reports quoting unnamed defense officials.

News outlets said the troops are from

the Army's 11th Airborne Division, based at Joint Base Elmendorf-Richardson in Alaska, which specializes in cold-weather operations. The unnamed defense offi-

"The Department of War is always prepared to execute the orders of the Commander-in-Chief if called upon," chief Pentagon spokesperson Sean Parnell said in a statement to The Hill.

Trump has threatened to invoke the 1807 Insurrection Act, hours after a federal officer shot and injured a man recently in Minneapolis, sparking the latest wave of protests.

"If the corrupt politicians of Minnesota don't obey the law and stop the professional agitators and insurrectionists from attacking the Patriots of I.C.E., who are only trying to do their job, I will institute the INSURRECTION ACT, which many Presidents have done before me, and quickly put an end to the travesty that is taking place in that once great State," Trump wrote in a post on Truth Social.

However, Trump said there was no need to invoke the law at present, telling reporters, "I don't think there's any reason right now to use it, but if I needed it, I'd use it."

The shooting of a Venezuelan migrant, which was reported to have taken place after a federal officer was attacked while following the man on foot during a traffic stop, further escalated tensions in a city already unsettled after the death of Renee Good earlier this month.

The Insurrection Act allows the president to deploy military troops domestically to contain civil unrest. The last time it was invoked was in the early 1990s. ANI

## Trump administration condemns protest at Minnesota church, DOJ opens investigation

MINNESOTA: President Donald Trump has sharply condemned the Minnesota incident in which anti-ICE demonstrators entered a church during a worship service on a Sunday.

The US president said that federal authorities will not tolerate interference with religious worship.

White House Press Secretary Karoline Leavitt, in a post on X wrote, "President Trump will not tolerate the intimidation and harassment of Christians in their sacred places of worship. The Department of Justice has launched a full investigation into the despicable incident that took place earlier today at a church in Minnesota."

The disruption occurred at Cities Church in St. Paul, Minnesota, where a group of protesters stormed the sanctuary during a Sunday service over online

claims that one of the church's pastors also serves in a senior role with US Immigration and Customs Enforcement (ICE).

Videos circulating on social media showed chanting and demonstrators inside the church as services were un-

broader wave of protests that have erupted across the Minneapolis-St. Paul area following the fatal shooting of Renee Nicole Good, a 37-year-old Minneapolis resident fatally shot by an ICE agent earlier this month - a case that

has intensified tensions between federal agencies and local communities.

Responding to the church incident, the Department of Justice announced it has opened a civil rights investigation into the protest to determine whether federal laws were violated. ANI

Kashmiri Hindu groups in US renew justice call on Exodus Day

WASHINGTON: Kashmiri Hindu advocacy groups in the United States on renewed their call for justice, restoration and secure rehabilitation of the community, marking January 19 as Exodus Day.

In a statement, the Kashmir Hindu Foundation and Panun Kashmir described the date as a reminder of what they called the systematic displacement of Kashmiri Hindus from the Valley.

The groups said January 19 symbolizes a "deliberate and sustained process of ethnic cleansing" that uprooted an indigenous community. They said Kashmiri Hindus lost not only homes but also roots and civilizational identity.

They rejected what they called symbolic gestures, selective amnesia, and tourism-focused narratives as inadequate responses.

Sunanda Vashisht, writer and political commentator and Chairperson of the Jonaraja Institute of Genocide and Atrocities Studies, said the crimes could not be seen as a single historical episode.

"Genocide is not an event; it is a process aimed at wiping out or severely weakening particular identity-based groups. These groups are perceived as a threat to the offenders' identity or dominance," she said. IANS

# How soaring costs are reshaping health care access?

**O**ne out of every five dollars spent in the US is related to health care, according to a new KFF study. Health care expenditures are now 18% of America's GDP.

Costs are expected to rise further as the ACA's enhanced premium tax credits expire. With the expiration of the Affordable Care Act (ACA) premium tax credit, healthcare and insurance costs continue to rise. As many states recently ended their ACA open enrollment periods, many insured individuals have found that their monthly premiums have almost doubled this year. As open enrollment ends this week in many states, millions of Americans enrolled in ACA plans have signed on to monthly premiums at double the cost. Four million people are expected to drop out of health insurance coverage entirely. And small businesses are scrambling to insure their employees even as premiums sharply rise. Speakers this week discussed the factors behind the high cost of coverage and care, including pharmaceuticals, and offered options for addressing the widening gap in health care access.

Merith Basey, Executive Director, Patients for Affordable Drugs stated that the persistently high drug prices in the United States are primarily due to pharmaceutical

companies maintaining market monopolies through the patent system. Drug prices are entirely set by the pharmaceutical companies themselves, with a lack of government negotiation mechanisms. She pointed out that research shows that once generic drugs enter the market, the prices of existing drugs can decrease by an average of 39%; if there are five to six competitors, the price reduction can even reach 95%. Therefore, pharmaceutical

expected to reduce the medication costs for more Medicare beneficiaries.

Dr. Neale Mahoney, Professor of Economics at Stanford University and George P. Shultz inaugural fellow at the Stanford Institute for Economic Policy Research said high health care prices simultaneously impact federal budgets, businesses and households. Healthcare-related spending currently accounts for about a third of the federal budget, and the

of healthcare personnel is equally crucial, including relaxing restrictions on physician training quotas, foreign healthcare personnel, and expanding the scope of practice for nursing and advanced medical personnel, in order to shorten waiting times and improve accessibility to healthcare.

Anthony Wright, Executive Director, Families USA pointed out that with the expiration of the ACA's extended premium tax credit in January, many families have experienced drastic changes in their premium expenses. Families that previously paid only tens of dollars or even zero dollars per month now have to bear hundreds of dollars.

For those aged 50 to 60, some families have spent as much as \$10,000 to \$15,000 on health insurance this year. Wright cited preliminary data indicating that approximately 1.4 million people have lost insurance or switched to lower-coverage plans due to rising premiums, and this may only be the tip of the iceberg. He pointed out that many people automatically renewed their policies at the beginning of the year, and with the grace period ending, even more people may be unable to afford the high premiums and lose their coverage in the coming months.

companies have long used various means to delay the launch of generic drugs. She points out that this drug price negotiation mechanism has been in effect within the Medicare system since January 1st of this year, and the new prices of some drugs included in the negotiations (including diabetes medications, insulin, and cancer and immunotherapy-related drugs) are about 63% lower than before. She says that more high-priced drugs are expected to be included in the negotiations in batches over the next few years, which is





# Prominent community leaders complete Houston Marathon: Different journeys, shared purpose, to support Sewa

HOUSTON, TX: Sewa International volunteers and runners had an incredible experience at the Chevron & Aramco Houston Marathon on Sunday, January 11, 2026—an event that showcased the very best of Houston's spirit and community. As part of Sewa's Run for a Reason program, he also raised a record \$6,700—made possible by generous donors.

Equally inspiring was Mr. Swatantra Jain's run. A well-known entrepreneur, community leader, and dedicated philanthropist, he completed his very first marathon at the age of 78, proving that age is just a number. He began the day expecting to run only a few miles, but when his grandchildren cheered him on at Mile 6, he made a decision: why not go all the way to 13.1 miles? With grit, determination, and a strong will, he pushed through to the finish





## Greenland, great power politics, and India's strategic imperative: a realist geopolitical analysis

**A**t first glance, Greenland may seem irrelevant to Indian strategic planners. With a population of around 57,000 and located thousands of kilometers from South Asia, it appears far removed from India's immediate concerns. Yet recent developments have revealed how Greenland has become a geopolitical flashpoint, exposing deeper realist dynamics of power competition, resource access, alliance shaping, and strategic positioning among major powers. These developments matter even to distant states because structural shifts in global power reshape the international environment in which all states operate.

allied deterrence and early warning.

### Arctic as New Theatre of Power Competition

Realist theory predicts that great powers will seek to secure relative advantage and prevent rivals from dominating key strategic spaces. The Arctic, previously seen as peripheral has become precisely such a space. Climate change is accelerating this shift: the Arctic is warming nearly four times faster than the global average, reducing sea ice and exposing new maritime routes and resource potential.

Routes such as the Northern Sea Route and the Northwest Passage can significantly shorten shipping distances between Asia and Europe by up to 40 % compared with the traditional Suez route, reshaping future global trade patterns and imposing new considerations for naval logistics and commercial connectivity. For realist scholars like Alfred Thayer Mahan, command of sea lanes and strategic waterways is central to global power.

Greenland's proximity to emerging Arctic sea lanes thus increases its structural significance, making it a pivot in geo-economic as well as military competition.

### Geography as Structural Power

In realist international relations, as articulated by theorists like Kenneth Waltz, states operate in an anarchic system where no authority enforces peace or order. Under such conditions, geography becomes a structural determinant of power, not a backdrop. Greenland's location, lying



The Arctic and Greenland are believed to hold vast deposits of critical minerals, including rare earth elements, uranium, nickel, iron, and other materials crucial for advanced technologies, defense systems, and clean-energy infrastructure. A 2023 European Commission survey identified that Greenland could contain deposits of 25 of the 34 materials considered critical for industrial and technological development.

## Lodha Developers' net debt rises 15 percent in Q3

MUMBAI: Real estate firm Lodha Developers Limited has reported a 15 percent increase in its net debt during the October-December quarter (Q3 FY26), reaching Rs 6,170 crore.

The rise is attributed to the company's aggressive land acquisitions aimed at expanding its business, according to its key business updates to exchanges.

For comparison, the company's net debt was Rs 5,370 crore at the end of September 2025.

Despite the increase, Lodha Developers said its net debt remains well within manageable limits.

"Even with significant investments in business development over the first nine months of this fiscal year, our net debt stood at Rs 61.7 billion, well below our ceiling of 0.5x net debt to equity," the company noted.

During the December quarter, Lodha acquired five land parcels across key regions, including the Mumbai Metropolitan Region, Delhi-NCR, and Bengaluru.

These acquisitions were made through outright purchases as well as partnerships with landowners.

The Mumbai-based company plans to develop primarily housing projects on these sites, with an estimated total revenue potential of Rs 33,800 crore.

In a notable move last month, Lodha Developers partnered with MRG Group to develop two projects in Gurugram -- marking its entry into the Delhi-NCR housing and commercial real estate market. *IANS*

## AMC clears encroachments near Vatva Lake, demolishes around 450 illegal structures

AHMEDABAD: The Ahmedabad Municipal Corporation (AMC) carried out a major demolition drive against illegal constructions in the Vatva Extension area of the city, targeting encroachments around a lake near the Vatva police station.

## High-end housing becomes India's largest residential segment for 1st time

MUMBAI: India's residential market saw a structural shift in CY2025 as the high-end housing segment category became the market's leading segment for the first-time ever, accounting for about 26.8 percent of transactions, with around 27 percent share, a recent report said.

The report from CBRE South Asia Pvt said the segment's share has more than doubled since 2022 from 11.8 percent to 26.8 percent, driven by rising household incomes, lifestyle upgrades and sustained NRI interest.

Luxury segment recorded 70 percent year-on-year growth in 2025 with the fourth quarter alone witnessing roughly 62 percent annualized increase, the report said.

The Q4 2025 saw roughly 62,500 units sold and about 60,100 units launched, with Mumbai, Pune and Delhi-NCR supplying more than 60 percent of new launches.

Mumbai, Pune, and Delhi-NCR also dominated the supply side, contributing more than 60% of all new launches during the quarter.

"The emergence of the high-end segment reflects a maturing buyer base that is prioritizing



lifestyle, longevity, and asset quality. The sector will likely be anchored by calibrated supply infusion, ensuring that new inventory is aligned with delivery realities," said Anshuman Magazine, Chairman & CEO, India, South-

"Although underlying fundamentals remain strong, macroeconomic headwinds may prompt a segment of homebuyers to maintain a watchful stance in the near term. Still, sustained premiumisation

housing landscape in the coming quarters," he added.

The overall trend highlighted a maturing housing market, increasingly driven by quality, aspiration, sustainability, and long-term value creation.

Gaurav Kumar, Managing Director, Capital Markets and Land, CBRE India, said that the developers have closely aligned their offerings with demand dynamics.

RBI's monetary easing and GST rationalization continue to provide strong tailwinds, reinforcing confidence and demand in the housing sector, Kumar added. *IANS*

## 'India's property sentiment ticks up, market enters 2026 on steadier footing'

MUMBAI: The stakeholder sentiment in India's property market stabilized with a positive bias at the end of 2025, as market enters 2026 on steadier footing, a recent report said.

The report from Knight Frank and NAREDCO showed that the 'Current Sentiment Score' edged up to 60 in Q4 2025, up

from 59 in Q3, while 'the Future Sentiment Score' was 61, unchanged from the prior quarter, both remaining in the "optimistic zone."

"The readings underscore a market supported by improving macroeconomic visibility, easing inflation, and steady funding conditions," the report highlighted.

Around 52 percent respondents signaled improving economic momentum with 50 percent reporting improved funding availability, the report said.

Despite remaining below 2023-24 peaks, resilient office demand, improving liquidity, and stable domestic economic conditions support positive expecta-

tions amid global uncertainties.

The real GDP growth of 8.2 percent in Q2 FY2025-26 versus 5.6 percent a year earlier was cited as a confidence driver. Easing inflation, accommodative monetary conditions, and continued public capital expenditure have strengthened visibility on growth, the report said.

"High-frequency indicators continue to point to sustained economic momentum, helping offset global uncertainty and supporting real estate fundamentals," said Shishir Baijal, International Partner, Chairman and Managing Director, Knight Frank India. *IANS*

# Can you sell a property to a developer?

Selling a house is a strategic move as it allows a property owner to secure funds for reinvesting in a bigger home. In many major cities in India, where land is limited and the scope for redevelopment is higher, many builders are eyeing redevelopment and joint development projects. Hence, selling a house to a builder can be a profitable option for property owners. However, this can be a legally complex process that involves multiple approvals and regulatory compliance. In this guide, we will delve into the legal aspects of selling a property to a developer in India.

## Selling a property to a developer vs selling to a buyer

Selling a property outright to a buyer differs from selling it to a developer in many ways. In the former case, the sale process is simple and involves signing a sale deed and transferring property ownership to the new buyer. The approach of independent buyers is quite different when it comes to evaluating properties. Buyers mostly look at the livability aspects, the property's condition and location advantages. ## Types of sale transactions when selling to a builder

Property owners can choose different transaction methods when planning to sell their property.

### Direct sale

This is a simple transaction in which the owner sells the property to the developer at a mutually agreed price. The process involves signing a sale deed and transferring ownership of the property to the developer. This is mostly seen in independent houses and small plots. The seller's responsibility ends after the property transfer is completed.

### Joint development

This trend is seen in metro cities and urban areas where the development rights

of the property are shared between the landowner and the builder. A joint development agreement (JDA) is signed between the two parties. The builder takes responsibility for the reconstruction, including securing the necessary approvals. After development is completed, profits or revenue are shared between the owner and the builder as per the agreed terms. This pro-

cess is legally complex, involving registration of the JDA.

### Redevelopment

Redevelopment trends are seen in cities such as Mumbai, Pune and Bangalore. In this model, housing societies allow developers to redevelop the society, which often has older buildings, and to construct new properties within the complex. Developers typically sign deals with existing building owners by selling the newly constructed properties. The redevelopment process is also complex, like joint developments, where builders sign redevelopment agreements and seek approvals from the society and other local authorities.

### Why do builders buy private properties?

## Luxury homes above Rs 1 crore capture 63% market share despite 11% market volume decline

NEW DELHI: Premium-housing units priced at Rs 1 crore and above saw 6 percent year-on-year (Y-O-Y) growth in unit sales during 2025, highlighting market premiumization trends despite an 11 percent decline in the overall residential market.

According to a press release by JLL, total residential sales fell to 270,323 units in 2025, yet the market demonstrated a clear shift toward higher price segments. Apartments priced above Rs 1 crore increased their market share from 53 percent in 2024 to 63 percent in 2025, while the mass segment's share contracted from 47 percent to 37 percent.

The surge in premium demand was most prominent in the Rs 1.5-3.0 crore category, which recorded a 19 percent increase in sales compared to the previous year. Despite the drop in volume, the total sales value across India climbed by approximately 11 percent Y-O-Y to around Rs 5,57,100 crore. This growth in value amid a decline in unit sales confirms a transition toward higher-value transac-

tions as buyers prioritize quality projects.

"India's residential market experienced a premiumization shift in 2025, with properties above INR 1 crore growing 6% Y-O-Y while mass housing below INR 1 crore fell by 30% during the period. Despite an 11% drop in total pan India housing unit sales, total sales value climbed by around 11% Y-O-Y to around INR 5,57,100 crores, demonstrating buyers' preference for qual-



ity developments over price premiums. This healthy sales value performance amid sales unit decline confirms the market's successful transition toward higher-value transactions, validating developers' premiumization strategies and buyers' appetite for premium offerings," said Samantak Das, Chief Economist and Head of Research and REIS, India, JLL ANI

## Market share of homes priced above Rs 1 crore reaches 63 pc in India in 2025

MUMBAI: The housing market in India demonstrated clear premiumisation trends with sustained demand in higher price segments, as apartments above Rs 1 crore increased their share to 63 percent in 2025 from 53 percent in 2024, reflecting buyers' preference for value-driven purchases despite overall volume decline, as per report showed.

This was especially evident in the Rs 1.5-Rs 3.0 crore category, which saw demand increase by approximately 19 percent compared to 2024, according to the report by JLL.

Chennai emerged as standout performer with exceptional 31 percent on-year growth, reaching 14,837-unit sales.

While all other cities saw a decline in

sales, Bengaluru, Mumbai and Pune each surpassed 50,000 units, collectively capturing 63 percent of annual sales. These three cities demonstrated market resilience during moderation phases, supported by robust employment, established infrastructure, strong purchasing power and quality lifestyle amenities, said the report.

The fourth quarter of 2025 saw varied city-level results, with Chennai and Delhi NCR sustaining their housing sales momentum, led by Chennai's remarkable 86 percent YoY growth.

Home prices across India's seven major cities sustained their upward momentum throughout 2025, with annual price appreciation ranging from 6 percent to 13 percent across markets. IANS

# India must recalibrate its grand strategy to face emerging geopolitical headwinds

**2**026 opened with displays of U.S. muscle power, intended to revive the Monroe Doctrine and reinforce American security dominance, an approach that had come under scrutiny after Israel's strikes on Qatar escalated tensions in the Middle East last year. The Trump administration made clear commitments regarding its sphere of influence and signaled its willingness to reassert the Monroe Doctrine in its National Security Strategy (NSS) released in November. Within two months, the U.S. carried out a military operation in Venezuela to topple the Maduro regime, demonstrating both its strategic will and seriousness in translating doctrine into action.

## The Monroe Doctrine

Under the Trump administration, the Monroe Doctrine has been reshaped into an offensive deterrent tool rather than a quiet diplomatic, soft-power, and collective-security construct. Earlier, the U.S. relied on pragmatic calculations and preventive diplomacy to address security and strategic challenges within its sphere of influence. The Obama administra-

tion even declared that the Monroe Doctrine was over, favoring soft power to maintain influence.

In contrast, the Trump administration rechristened it the "Donroe Doctrine," which seeks not only to secure the U.S. sphere of influence but also to assert an overt America First mindset through dominant tactics reminiscent of the Cold War era. During Trump's first term, Washington gradually began rethinking the Monroe Doctrine and incorporating it into its strategic calculus, but this process remained cautious. In the second term, however, the Donroe Doctrine has been accelerated and implemented through three distinct strategies.

First is transactionalism, in

which the U.S. focuses on maximizing interests through power bargaining, leaving little room for diplomatic maneuver. Trade negotiations during Trump's second administration exemplify this increasingly aggressive transactional approach.

Second is the use of credible threats-sanctions and the overt threat of force as instruments of coercive diplomacy to protect U.S. security and strategic space. While coercion has long been central to U.S. strategic thinking, it has become more direct and forceful under Trump's second administration, as demonstrated by Operation Absolute Resolve against Venezuela and the escalation of tariff wars.

Third is unilateralism, re-

flected in withdrawals from international organizations, tariff politics, unilateral military actions, and power-centric approaches to conflict management. These actions are designed to foreground an American-first approach rather than collective or multilateral engagement. The sharp unilateralism of Trump's second administration is intended to send a strategic message to the global order about the revival of U.S. hegemony.

Although these features differ significantly from the original Monroe Doctrine, its core objective remains unchanged: protecting the U.S. sphere of influence. In essence, the Donroe Doctrine is a blueprint for blitzkrieg-style diplomacy that globalizes an America-first approach. It echoes the Cold War-era concept of "preponderant power," which argues that a single dominant state-such as the U.S. in the post-Cold War era-can prevent major wars by maintaining overwhelming military, economic, and political strength, thereby deterring rivals and enforcing stability.

## India's Grand Strategy

India has placed strategic autonomy at the center of its approach to navigating the contested global order. This strategy rests on multi-vector diplomacy and diversification-moving beyond fixed superpower orbits while remaining engaged with them to advance India's interests. While lessons have been learned from the shortcomings of the Non-Aligned Movement, strategic autonomy has now evolved into a broader grand strategy through which India deploys both hard and soft power to assert and negotiate its security and strategic interests.

## TRUMP ACCELERATES MULTIPOLAR WORLD-ORDER

**G**lobal geopolitics entered a turbulent phase marked by the resurgence of economic coercion, military intervention, and regional diplomacy that together could reshape the existing world order. Central to these changes is U.S. President Donald Trump's assertive use of tariffs as foreign policy leverage, most recently targeting several European allies over acquiring Greenland and a series of contentious military and diplomatic actions across the world.

At the core of economic restructuring is Trump's tariff escalation against eight major European countries (Denmark, Norway, Sweden, France, Germany, the United Kingdom, the Netherlands, and Finland) in connection with his controversial push for control over Greenland. Announcing a baseline 10% tariff starting February 1, rising to 25% in June if demands aren't met, the move triggered market volatility, weakened the euro, and prompted concerns of a new trade war with U.S. allies. The International Monetary Fund has warned that these geopolitical tensions including Trump's trade actions, could threaten global economic growth and disrupt supply chains worldwide. Critically, this marks a shift from tariffs as defensive tools to instruments of strategic coercion, challenging traditional trade alliances. Europe's unified response condemning the tariffs and threatening countermeasures underscores widening rifts within NATO and the transatlantic alliance.

In Latin America, U.S. military intervention in Venezuela, including the capture of President Nicolas Maduro has tested international norms. Global reactions varied: many governments condemned the action as a breach of sovereignty, while some Western nations offered tacit support or cautious acknowledgment. Analysts see this intervention not only as a demonstration of American military reach but as part of a broader pattern where great powers seek influence by decisively shaping political outcomes beyond diplomacy.

In the Middle East, the shadow of conflict has persisted. Despite diplomatic efforts involving new frameworks like the "Board of Peace", an initiative championed by Trump to mediate the Gaza situation many global leaders express caution, fearing it could undermine the United Nations' role and create parallel power structures.

Meanwhile, conflict dynamics in Ukraine remain a central pillar of global instability. Recent escalations, including the use of ballistic missiles, continue to draw strong international response and highlights enduring tensions between Russia and the West, complicating prospects for a negotiated settlement.

In Iran, a combination of internal protests and external pressure has created a delicate balancing act. While widespread demonstrations have been met with harsh suppression; regional actors like Turkey have advocated restraint, highlighting a broader desire among some Middle Eastern nations to avoid direct confrontation.

Against the backdrop of U.S. China trade competition and ongoing geopolitical friction, these developments suggest a world transitioning toward MULTIPOLAR WORLD ORDER, where economic might, military capability, and diplomatic coalitions intersect in unpredictable ways. Echoing expert assessments, we may be seeing the erosion of a unipolar, rules-based order toward a landscape shaped by regional powers, flexible alliances, and transactional foreign policy.

The cumulative effect could be a more fragmented international system where strategic interests rather than collective frameworks guide major powers, presenting both risks of conflict and opportunities for new diplomatic configurations. As China has already acquired global economic powerhouse status, the present scenario may have accelerated it to become world leader, replacing America.


Two people have been injured in a collision between a truck and a car. The injured have been taken to a nearby hospital for treatment.

Such protection typically includes armed security personnel, escort vehicles, and coordinated movement planning, especially during public appearances. While exact security categories are not always officially disclosed for privacy and safety reasons, the actor has often been seen moving with a trained security detail in Mumbai and other cities.

His frequent portrayal of nationalist and military roles, coupled with outspoken public positions on certain issues, has also been cited as a factor behind precautionary measures. It is important to note that security cover in India is periodically reviewed based on threat assessments by intelligence agencies and can be scaled up or down accordingly. IANS

## "ODISHA'S SACRED COASTAL TOWN KNOWN FOR THE JAGANNATH TEMPLE"

Puri in Odisha is one of the four must-visit pilgrimage sites for Hindus because of Jagannath Temple that forms the part of Char Dham in India. Puri is a beach city located on the coast of Bay of Bengal, which is one of the favorites among people of West Bengal for a short trip.

**Puri Beach:** Puri Beach is one of the finest coastlines in East India, bordering the Bay of Bengal and is located at a distance of 35 km from the Sun Temple. With the sun gleaming on the pristine waters of the beach, the place is ideal for holiday makers looking for some solitude.
